## CONFERENCE MINUTES

### MORNING SITTING

The forty second annual Conference of the Virginia District, Pilgrim Holiness Church, convened on the District Camp Ground at Roanoke, Virginia at 9 A.M. on August 12, 1963. Rev. Eldon Hotle, District Treasurer, led the congregation in singing the old hymn, "Glory To His Name" after which Rev. G. A. Castevens, Pastor of the Roanoke Church, led in prayer.

District Superintendent, Rev. W. A. Massey, then introduced General Superintendent Doctor William H. Neff to the conference as the permanent Presiding Chairman. Appropriate remarks were given by the Superintendent in appreciation of the presence of the General Superintendent of the Church.

Doctor Neff, in lieu of more formal scripture reading requested scripture quotations from the assembled delegates, after which the speaker stressed three things which were essential to a successful spiritual conference.

#### ***A. Divine Light To Guide Us Amidst The Complexities of Conference.***

The first conference of the Christian Church is recorded in Acts, Chapter 15. We can likewise expect the help of the selfsame Holy Spirit as we meet to do business for the King.

#### ***B. Divine Love to Unite Us in Christian Fellowship.***

#### ***C. Divine Grace to Sustain Us Admist the Tensions and Strife of Life.***

With the closing of a blessed district camp we should have ample grace to see us through the sessions of this conference. However, it should be noted that occasionally a gracious camp meeting leaves the saints of God emotionally and mentally exhausted. Dr. Neff related the incident of a lady who said that God had forsaken her simply because she could no longer feel His blessed presence. The speaker told the lady that her trouble was not religious at all but a physical one.

We need to recognize that emotions are cyclic and do not affect our basic covenant relationship with God. Dr. Neff related the incident of watching a baseball game played by teen-age negro players. When a member of the team hit a home run the entire group was happy and hilarious. However, a little later when a member struck out at a critical time in the game the same group was very downcast and filled with gloom.

We need to be aware that God is not tied to our emotional reflexes. We are joined in a Covenant relationship with God that is far deeper than sheer emotionalism. Too often, when the emotional stirring of camp is over, Satan takes advantage of people to make them question God and His continued presence in their lives. We need to relate our full salvation to our humanities and not

cast away confidence in God whenever our religious feelings may falter. Then, we can only remind God in times of stress and strain that the Covenant relationship with Him still stands.

The Speaker concluded the devotional message by explaining that Dr. Paul Thomas would normally have been present to preside over this conference but was in England attempting to perfect the organization of the Pilgrim Holiness Church in the British Isles.

Following the completion of the Chairman's opening message the Roll Call was completed by the Secretary.

The Reception Committee introduced the following visitors:

The District Statistician, Rev. C. A. Simmons, gave his report, and it was received with an expression of appreciation. There was a question concerning the item of "Interest". This should be money paid on money that has been borrowed.

Report of the Sunday School Promotional Secretary, Rev. Charles Carroll, was presented and accepted by conference vote.

## AFTERNOON SITTING

The afternoon session opened at 1:30 P.M. with song and service led by Rev. Kenneth Taylor.

Prayer by Rev. B. L. Puffenbarger.

The Chairman, Rev. Neff, addressed the laymen of the Conference on the subject of "Seven Ways To Help Your Pastor."

1. *Let him know of Spiritual needs.* Inform him, do not order him.
2. *Constructive Criticism:* This should be done in an understanding and helpful way. A wise Pastor does not resent criticism.
3. *Attend Church consistently.*
4. *Carry your share of The Church Load.*
5. *Tell your Pastor about new people in your community.*

**6. *Share The Visitation Load.***

**7. *Be The Pastor's Friend.***

The minutes of the first session of the Conference were read and accepted as read.

Rev. Henry V. Langford, Associate Secretary of the Alcohol Education Council, Inc., of Virginia Churches, spoke to the Conference concerning the work of this Council. There are 10 participating denominations in the State. He urged our Conference to join the Council. They have a program of: (1) Total Abstinence, (2) Education, (3) Rehabilitation, (4) Legislation. The Conference voted to become a member of the Council and to leave the matter of the amount of contribution to the District Council to decide.

The Resolution Committee reported as follows:

No. 2 - Carried as amended to read, "That No. 5 paragraph (1) on page 34 be changed to read, that each pastor and local church board shall raise an offering on the first Sunday of May for the District Camp Meeting expenses and forward the same to the District Treasurer. If this free will offering does not amount to \$1.00 per member, the needed amount to make the difference is to be taken from the Church Treasury."

- No. 3 - Carried.
- No. 4 - Carried.

No. 5 - Carried as amended: "We recommend that each Church pay their pastor's hospitalization insurance if at all possible, unless a working pastor has insurance through the company of his employment."

No. 6 - Carried.

The Elections were the next order of business. The District Superintendent appointed the following as tellers: Revs. Howard (Chairman), Carroll, Clough, Sherwood, Hotle, Davis, and Cook.

Convened at 6:15 P. M. with the singing of "We'll Work Til Jesus Comes".  
The Conference was led in prayer by Rev. J. A. Howard.

The head teller reported that Rev. G. A. Castevens was elected as one of the Advisory Members of the Council. Bro. Neff asked that the five highest names be used on the next ballot. These names were: J. H. Fralin, I. T. Dunn, D. L. Reynolds, G. Puffenbarger, and C. A. Simmons. Mr. J. H. Fralin was elected on this ballot. It was moved, seconded and carried that we vote on the three highest. Rev. I. T. Dunn was elected as the third Advisory Member of the Council.

Rev. E. B. Hotle resigned as District Treasurer so the Conference elected Rev. Arlie Cook as District Treasurer.

The report of The Board of Education and Examination was read and accepted by the Conference. It was as follows:

The Committee on Memoirs was presented by its chairman, Mrs. T. K. Knapp. The report contained a list of those who had passed on to be with the Lord this year. A special tribute was paid to our former District Superintendent Rev. J. E. Guill.

After the business of the Conference was finished, Dr. Neff conducted an ordination service in which Rev. Kenneth Taylor was ordained.

Moved, seconded and carried that the District Council take care of all unfinished Conference business including the editing and approving of the afternoon and evening sittings of the Conference minutes.

Moved, seconded and carried that we adjourn.

The 1963 Conference adjourned by singing the Doxology. Thus ended the forty second District Conference of the Virginia District.



## **DISTRICT SUPERINTENDENT'S REPORT**

Christian greetings and a sincere welcome to our presiding officer and General Superintendent, Dr. William H. Neff, and to the delegates and friends of the forty-second conference of the Virginia District of the Pilgrim Holiness Church.

Truly God has been good in giving us another year to labor in His Vineyard and privileging us to meet in this important gathering of the district. We are here to hear reports of the past year and to lay plans for the future. May the Holy Spirit so direct that the actions of this conference may pave the way for definite accomplishment in Kingdom interests.

During the past year our hearts have been saddened by the loss of two ordained Ministers. Rev. J. E. Guill, who devoted many years of service in the district, fourteen of which he served as the respected Superintendent. The other was Mrs. W. S. Allred, who was a long time member of the district and will best be remembered for starting the church at Christiansburg and continuing as pastor for approximately eleven years. They have entered into the glory that is the hope of all who are in Christ. May the memory of their Godly lives inspire us to be faithful until, we too, receive the "Crown of Life".

### **STATISTICAL AND FINANCIAL STATUS**

Several churches have shown a very good gain in church membership. Those that lead in net gain are Charlottesville with an increase of 11, Covington 10, Martinsville 10, and Warwick 10. A number of others realized a lesser increase. I regret to report, however, that a number of churches have lost and as a district we have shown a small loss.

The over-all district finances have been very good and have shown a small increase over the previous year. However, we only paid 54.2 percent of the United Stewardship Fund assessment. This is one tenth of one percent less than last year. There are five churches that have paid the District Budget, United Stewardship Fund, and pastors tithe a hundred per cent. They are Beulah, Norfolk, Remlik, Richmond First, and Roanoke. However, there are several churches that have shown improvement over the last year that did not meet all three items in full. I am confident we could realize marked increase with a concerted and cooperative effort on the part of all pastors and churches.

### **PROPERTY GAINS AND IMPROVEMENTS**

I shall not attempt to mention every detail but mention the major gains and improvements. Christo has re-decorated the interior of the church auditorium

and Sunday School rooms. Newport News purchased a nice parsonage and re-decorated church auditorium and Sunday School rooms. Remlik has purchased a nice parsonage. Beulah is completing a thorough renovation of the interior of the parsonage including the laying of a new floor and installation of a hot water heating system. Danville has made extensive renovation of the church building and has added one new Sunday school room in the basement. Boissevain has redecorated the interior of the parsonage. Richmond Emmanuel is nearing completion of four nice Sunday school rooms. Radford has waterproofed the outside walls of the church basement, insulated the attic of the parsonage and modernized the kitchen and bath room. Richmond First remodeled the parsonage kitchen. Salem has added three nice Sunday school rooms. Staunton installed new storm windows and doors on the parsonage. There have been a number of improvements on the camp ground including the purchase of 200 folding chairs, painting the kitchen and dining room, the water system has been improved to supply adequate hot and cold water, much needed major electrical changes and wiring have been done, and the camp has been connected to the county sewer line. The cost of camp improvements has exceeded five thousand dollars.

### **YOUTH CAMP**

The youth camp was the largest we have had. One hundred and twenty-five young people registered. Many of them sought the Lord at an altar of prayer. Our District Youth President, Rev. D. L. Reynolds, together with the Youth Council and staff provided efficient leadership and the Lord was pleased to bless and give success.

### **HOME MISSIONS**

I am happy to report that the new church at Warwick is making good progress in every respect. There has been good gain in the Sunday school, church membership, and in finances. The district has been carrying the payments on the lot. They are much in need of a church building. Construction will begin as soon as a loan may be secured. Let us pray that the financial need may be met so that continued progress may be realized. It is hoped we may soon be in position to open a new work in the near future.

### **SUMMARY**

The past year is reviewed with a deep sense of gratitude to God and the pastors who have faithfully prayed and worked to advance God's cause. Also, I appreciate the faithful members who have loyally supported and stood back of the work. We thank God for the souls that have been won, but how great is the task before us! I am concerned over the lack of vision and spiritual lethargy so prevalent today. The Lord has a job for us to do. There is no easy and flippancy answer as to how best to accomplish it. I readily confess that I do not

have the answer but there is one who does and I trust as we pray and plan together we may discover the Divine directive and resources that make for progress. It is my firm conviction that He ever leads forward.

As we turn our attention to the future may it be with prayer and purpose to garner new souls for the Kingdom. Let each pastor and church determine by God's help that the coming year will be one of increased spirituality, numerical growth in the Sunday school, youth society, and church membership. With this we should strive for financial gain that more may be accomplished in the local church, the general church, and district.

It has been a joy to serve God and the Pilgrim Youth another year. For the success we give God the glory, for the failures we stand ready to share the blame.

We are thankful to God for His Divine Presence and leadership through another year. We are grateful also for the cooperation of our District officials, Pastors and Youth leaders.

I visited all of our Zones at least once this year and some of them twice. We appreciate the leadership of our Zone presidents. Our Zone meetings have been well attended and there seems to be an increase of interest in each zone.

We are happy to report at least a small gain in membership in our Youth Societies, and one Society that had been inactive for a few years was revived. The Hopewell Youth Society was reorganized with 17 members.

## **YOUTH CAMP**

What the best procedure would be I am not sure, but will at least suggest an answer in our goals.

Another year has rolled swiftly into the past. It was a year of opportunity to serve Christ and His Church. One of the greatest privileges a Christian has is to be part of the Sunday School movement. The Sunday School is not separate from the Church but is a vital arm of the Church. I believe God is holding us responsible either for its success or failure. For our report I have two divisions. Statistical and personal.

I wish I could report that our district again showed a gain in Sunday School attendance, but in examining the above record, we show a slight loss over the previous year. Let us all now make a frank appraisal of the conditions of our Sunday Schools and ask God to help us in the coming year as never before!

We are happy to note that a larger number of our Sunday Schools showed a gain in attendance than in a few previous years. There were twelve schools showing a gain, fifteen showing a loss and one remaining the same. Five of our schools showed excellent gains. They are as follows:

All of these Sunday Schools are to be commended and we rejoice with them for their excellent progress. Doran is to be congratulated for having a second year of good growth after such a phenomenal gain last year. Doran is tied with Danville for the second highest Sunday School of the district. Salem is still the largest school in attendance.

There are ten churches that are participating in the Standard of Excellence. An increase of two this year. Twelve of our schools are now competing in the DECADE OF PROGRESS. This is a gain of 5 over last year. The beautiful ship trophy will be awarded this year to the Staunton Church, with 11,950 points.

Covington was a close runner up with 10,100 points. Both of these schools are newly enrolled in the Decade of Progress and Standard of Excellence. We would like to see all of our churches participating in the coming year.

### PERSONAL

It was my privilege to travel in March with the Rev. O. D. Emery, General Secretary of Sunday Schools and Youth to three area meetings of the state for Sunday School seminars. Richmond First, Staunton and Roanoke were the host churches. Excellent attendance prevailed in each meeting with many teachers and officers present. The high point of each meeting was the challenging address, "Keys to Sunday School Growth", by Rev. Emery.

I have endeavored to promote the Sunday Schools of our district through a monthly report and also through a district wide contest held in February and March. There were many hinderances during the contest with bad weather and much sickness, however, thirteen churches showed gains. Warwick and Covington were the winning churches

One of the most helpful provisions that the General Church has sponsored for its promotional secretaries is the Youth and Sunday School leaders Conference. It was my privilege to attend this annual meeting last August.

In conclusion, there is only one way under God for Virginia Sunday Schools to go this coming year, and that is FORWARD! There will be many problems, but the Sunday School movement was not started in an easy atmosphere. Robert Raikes started and maintained his first Sunday School under very unfavorable conditions. The streets in the area in which he lived were filled with children, sinful and vile. They knew little or nothing about God, only to take His name in vain. There were many battles in that early day in England but there came a day when throngs of scholars gathered to be taught.

The story is told that a friend came to visit Robert Raikes, who was now an aged man. Raikes led his friend to the spot in a back street where his first Sunday School was started. Robert Raikes uncovered his head and closed his

eyes. He stood for a moment, in silent prayer. He then turned toward his friend, while tears rolled down his cheeks, and said, "This, my friend, is the very spot on which I stood a number of years ago when I saw the destitution of the children, and the desecration of the Sabbath by the inhabitants of this city. As I stood here, and asked myself, CAN NOTHING BE DONE? a voice answered TRY! "I did try," said Raikes, "and see what God has done!"

The challenge of all Sunday School workers today is still "Try, and keep on trying!" Don't we see and hear the call of Jesus Christ anew, "Go out into the highways and hedges, and compel them to come in, that my house may be filled"? Surely, no one would dare remain idle in the face of what Jesus has commanded us to do. There is much to be done and so little time to do it. May God help each of us go Forward this year.

## **DISTRICT RESOLUTIONS**

### **YOUTH**

1. Be it resolved that the District Council appoint two of its members to serve with the Youth Council in planning the date and place of the Youth Camp and other related activities. This committee to meet at least twice each year.

2. Be it resolved that the Youth Zone Chairman plan a rally each month during the school year and be it further resolved that the Zone Chairman shall coordinate all zone rallies and that the Youth President be informed of said rallies and, if possible, be present at each zone rally during the Conference Year. During each rally an offering shall be taken to help defray the President's travel expenses.

### **SUNDAY SCHOOLS**

1. Be it resolved that Sunday School Enrollment for each school be corrected at the beginning of each calendar quarter. Names shall not be dropped from the roll unless they were absent at least four Sundays of the quarter, sickness excepted.

2. Be it resolved that Sunday School Workers meetings be held in strategic locations over the District so as to accommodate groups of churches.

### **DISTRICT CAMP**

1. Be it resolved that we have a District Camp Committee. The District Superintendent shall serve as Chairman. Other members of the committee shall be chairmen of the following sub-committees: Advertising, Finance, Tabernacle and Dining Room.

2. Be it resolved that a set of rules be drawn up by the District Council governing the dormitory and camp ground. Said rules shall be posted in conspicuous places. Further, the District Council shall appoint two men to serve as policemen to enforce these rules.

3. Be it resolved that this Conference (1963) authorize the District Council to investigate the possibilities of developing a trailer camp on our District Camp Ground, with the authority to proceed with the development of same, if deemed advisable. (District Council Resolution).

4. The District Camp Committee met July 19, 1963, in the afternoon at the Staunton Pilgrim Church with two members present. After discussion the following resolutions were made relative to the building of cottages on the camp Ground:

a. Resolved that all cottages shall be constructed of cinder block with concrete floor and asphalt roof. Single cottages should be 24' x 22' and double cottages should be 32' x 22'. Each owner shall have the privilege of finishing the interior as he desires.

b. As long as the grounds are kept clean, electric costs paid and everything conducted properly, owners of cottages may use them at times other than during the camp period.

c. The District shall charge a fee of \$30.00 to lease space for a single cottage and \$50.00 for a double cottage space. Furthermore, any transfer of ownership of cottages may be done only after District Council and Camp Board approval.

d. A fee of \$2.50 shall be charged for a cottage for the period of the annual Camp to cover lights and ironing privileges. Cottages, with additional appliances such as electric refrigerators, etc., shall be charged \$6.00 for the same period.

e. The workmanship on each cottage must meet the standards established by the Camp Committee. A contract of regulations is to be drawn up between each cottage owner and the Camp Committee.

#### ***DISTRICT SUPERINTENDENT***

1. Be it resolved that whenever there is a change in the office of the District Superintendent, the District Council shall endeavour to place the retiring Superintendent in a satisfactory pastorate, if he so desires.

2. Be it resolved that the District superintendent be authorized to inform each church board whose deeds are not filed correctly according to the Manual to make such necessary changes within the conference year. In the future it is further resolved that copies of deeds of all newly acquired properties be filed with the Superintendent.

3. Be it resolved that a report on the amount of insurance carried on various properties in the District be filed with the District Superintendent.

4. Be it resolved that the District Superintendent appoint a Home Missionary Committee of two members to serve along with him in formulating the District Home Missionary program.

5. The District Superintendent shall be granted two weeks vacation with pay.

## **ANNUAL CONFERENCE**

Be it resolved that as far as possible all appointments of committees be made so that all committees can meet simultaneously. Further, that all committees shall meet at the call of the chairman and have their business ready for presentation at the opening session of the annual conference.

### **LOCAL PASTORS**

1. Be it resolved that each pastor support the District Camp with his presence and that he strongly urge his people to attend and support the camp. Local churches shall provide the regular support of the pastors while they are in attendance at Camp.

2. Be it resolved that each pastor strive to bring the total Advocate subscription to the total number of families represented within his church and Sunday School membership.

3. Be it resolved that all pastors within a radius of one hundred miles of the Camp Ground be required to come on a date set by the District Council prior to Youth and Regular Camp to make preparations and clean the buildings and grounds. If those who are supposed to come cannot be present, they shall send a fee of ten dollars to secure local help. At the close of the District Camp the same shall apply to those living over one hundred miles from the Camp Ground.

### **MEMORIAL JOURNAL**

Be it resolved that because of the faithful labors of our late and beloved former District Superintendent, Rev. J. E. Guill, the 1963 Virginia District Pilgrim Holiness Church Conference Journal be dedicated to his memory. (Committee Rec.)

### **LOCAL CHURCHES**

1. Be it resolved that each local church in the Conference shall provide the utilities for the parsonage. The Conference shall also provide the utilities for the District Superintendent.

2. Be it resolved that each local church treasurer furnish a monthly financial report to the church bulletin board, covering all receipts and disbursements. The local board shall then endeavour to make the necessary adjustments to bring up the financial obligations to both the District and General Church.

### **JOURNAL MINUTES**

1. Be it resolved that the report of receipts and expenditures for the District Camp be prepared and placed in the District Minutes of the following year.

2. Be it resolved that the Editing Committee Classify all resolutions appearing in the Conference Journal under appropriate headings such as Youth, Annual Resolutions, etc.

1. Whereas the General Board of the Pilgrim Holiness Church has authorized the Pilgrim Pension Plan, Inc. to make loans of pension funds to local Pilgrim Holiness Churches under such conditions as require active participation on the part of Pilgrim Holiness Church Districts,

therefore, be it resolved by the Annual Conference of this District that the District Council, District Trustees, and all District Officials be, and they are hereby authorized to do and perform all acts required of them in the consummation of authorized loans to local Pilgrim Holiness Churches of this District, subject however, to the limitations set forth in said Resolution of the General Board of the Pilgrim Holiness Church authorizing said loans.

2. Be it resolved that the Virginia District assume its proportionate part of the Pilgrim Holiness Church Advancement Program as outlined by the recent General Conference. The goals for our District are: One new church organized each year for the next four years with an overall 7% increase in church membership.

3. Be it resolved that a permanent date be set for the District Ministerial Convention with the District Council making arrangements for the program and the workers.

### **WAYS AND MEANS RESOLUTIONS**

#### **DISTRICT COUNCIL**

1. Each representative and pastor of each church which comes up to the end of the conference year without budgets paid in full, shall meet with the District Council prior to Conference and give an explanation of its failure to meet such commitments. (Budgets shall include District, General Stewardship and Ministerial Tithe.)

2. Paragraphs 2 and 3 of Section 149 of the Manual of the Pilgrim Holiness Church shall be brought to the attention of the local church boards and treasurers by the pastors. The provision of the Manual relative to specified giving shall be adhered to and a sound financial plan be worked out for raising budget quotas.

3. Two hundred feet across the front of the Camp Ground be sold at a price to approximate one hundred dollars per front foot. The proceeds from this

sale would be used to pay off indebtedness on the Camp Ground and provide much needed facilities.

### **LOCAL CHURCHES**

1. Each local treasurer shall forward to the District Treasurer all offerings for general and district funds and the pastor's tithes by the last day of each month and that a receipt for same be sent to the sender immediately. All general church funds shall be sent to the General Treasurer by the last day of each month.

2. The local treasurer shall withhold the tithe of the pastor's salary and shall send this to the District Treasurer each month along with other district and general church funds.

3. Our churches shall be advised of the General Board Resolution of May 12, 1960 relative to a recommendation that each local church pay the assessment fees for pastor and wife in the Ministerial Benefit Association and that the District cover fees for the District Superintendent and his wife.

4. Where churches have no adequate method of raising District and General Funds the Dime Book System shall be used.

5. Travel Expenses of the District Superintendent on his visits to the churches shall be raised as follows: Churches with less than 40 members shall pay eight dollars per visit; churches with over 40 members shall pay twelve dollars per visit.

6. Each local church shall pay the Conference fee of \$4.00 per ministerial and lay delegate; the church shall pay the fee for unstationed ministers who are members and present at the Conference.

7. Each church shall contribute 10% of the regular offerings of the Church and Sunday School to be sent to the District Treasurer each month for district obligations. Each church shall raise its General Stewardship fee obligation of \$8.00 per member by the method best suited. General Fund monies shall be sent to the District Treasurer on a monthly basis.

8. Each church shall pay the pastor's hospital insurance, except where working pastor is already insured.

### **YOUTH**

Each Youth Society shall send \$1.00 per month to the Y. P. District Treasurer and each church or unorganized society send a free-will offering to the District Y. P. Treasurer. This sum shall be used for operational expenses, with any balance being reserved for the next District Youth Camp. The District



Treasurer shall send quarterly notices of the assessments to the youth societies which shall be read in regular Young People's Society meeting.

### **DISTRICT**

1. The District Conference shall pay the following amounts to the respective district officers:

District Statistician.....	\$ 45.00
District Treasurer.....	225.00
District Secretary.....	75.00
District Sunday School Promotional Secretary.....	50.00
District Youth President.....	50.00

2. The District Council is authorized to rent the District Parsonage with the provision that the premises be vacated during Youth and Regular Camps. The proceeds from this rental shall go into the regular treasury to help defray expenses.

3. Each of the following shall apply to the respective groups:

a. Each pastor and local church board shall raise an offering on the first Sunday of May for the District Camp Meeting Expenses and forward same to the District Treasurer.

b. The engaged singers for District Camp shall be paid a sum not to exceed that paid one Evangelist. This sum shall be reserved to pay the singers whether the party consists of one, two, or more workers.

c. The assessment of \$10.00 for all ministers with a salary of \$40.00 or less per week and \$15.00 for those ministers whose salaries exceed \$40.00 per week and these amounts be placed in the Camp Expense Fund.

4. The District Council is authorized to work with any local church in procuring loans using the financial standings of the Conference as reflected in the Property Statements of the Journal, the combined Conference Equity and the current District Treasurer Balance Sheet, as the basis of negotiation for such loans.

5. The Home Missionary (Church Extension) Calendars shall be used by our churches as the method of raising funds for District Church Expenses.

6. All official travel in District interests is set at seven cents per mile.

7. Each church in the district shall present its pastor with a donation of food, etc., at least monthly.

8. The District Superintendent's salary shall be set at eighty dollars per week, with the addition of utilities, gas, lights, phone and fuel. The District shall pay his remittance to the Pilgrim Pension Fund and his Hospitalization Insurance. Official travel shall be covered by district funds at the rate of seven cents per mile plus meals, lodgings, and road tolls.

9. A determined effort shall be made throughout the District to secure one hundred or more friends who will pledge ten dollars per year as a supplementary fund for the District Camp Meeting Expenses.

10. Whereas there is a growing need for a Group Plan Ministerial Insurance Hospitalization Policy, and whereas, we have an offer of such insurance from Blue Cross/Blue Shield, all active (full time) ordained and licensed ministers (excluding missionaries) be included in the eligible list by the conference and that we adopt one of two plans presented by the Blue Cross Representative.

The Youth Conference of the Virginia District convened on August 10, 1963 at 1:30 P.m.

The meeting was opened by Rev. Dale Reynolds, the district youth President.

Brother Alfred Hurlburt led the conference in singing, "Since Jesus Came Into My Heart," after which Rev. C. M. Muse led in prayer.

Rev. Reynolds then turned the conference over to Rev. W. A. Massey, who presided.

The minutes of the previous conference were read by the secretary and were approved as read.

This was recommended by the committee. It was carried by vote.

Rev. Reynolds appointed the following to be tellers: James Castevens, David Bayse, Sidney Stallings and Maynard Doss.

The election of district youth officers was now held. Rev Charles Carroll was re-elected as vice-president. Rev. Robert Clough was re-elected as secretary. Rev. Alton Davis was re-elected as treasurer.

There was a motion to adjourn at 4:00 P.M.
