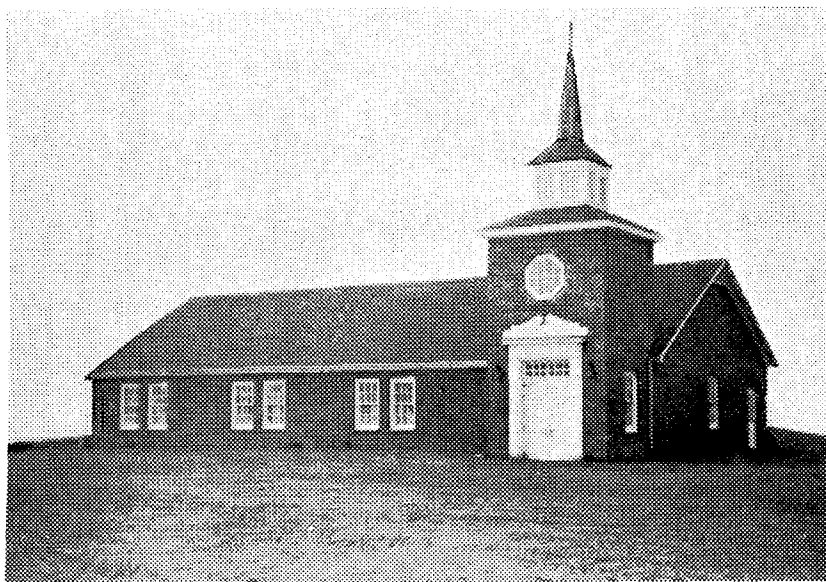


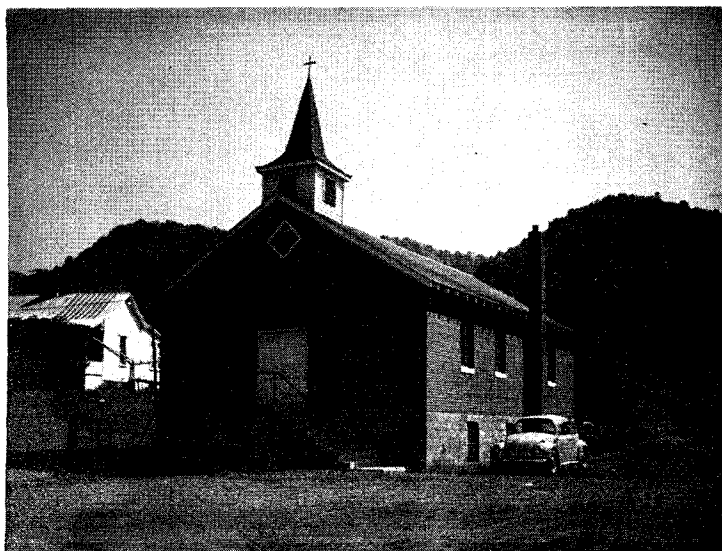

CONFERENCE MINUTES

FIRST SITTING

The forty-sixth Annual Conference of the Virginia District of the Pilgrim Holiness Church convened in Roanoke, Va. August 14, 1967 at 9:00 A. M.

The District Superintendent, Rev. W. A. Massey welcomed the delegates to the conference. Rev. B. L. Puffenbarger led the conference in singing "The Solid Rock." We were then led in prayer by Rev. G. A. Castevens.

Rev. W. A. Massey introduced Dr. Paul F. Elliott, our General Superintendent and presiding officer, to the Conference. Dr. Elliott expressed his appreciation in being here in the conference, also in being able to enjoy the last week-end of the camp. He stated he would address the conference later combining his address with the Ordination message.

Dr. Elliott called the conference to order. The District Secretary called the roll. There was a motion to set the conference bar using the first ten rows of two sections of the tabernacle and the platform. Motion carried.

The time of the sittings were set. The first sitting ending at 11:45 A. M. The second sitting beginning at 1:30 P. M. and ending at 4:30 P. M. The third sitting (if needed) beginning at 6:30 P. M. until the conclusion of the conference.

A motion prevailed calling for the first order of business of the afternoon sitting to be the Ordination Service. The motion carried.

The Chairman asked if there were any more organizational matters to be taken care of. There being none, he then called for the conference reports.

District Superintendent Rev. W. A. Massey read his report to the conference. This report was received by a rising vote of appreciation and a hearty "Amen."

The Assistant Superintendent, Rev. G. A. Castevens, gave an oral report which was accepted.

The report of the Auditing Committee was read by Rev. J. A. Howard and accepted by the conference.

The District Treasurer's report was given which was received with appreciation.

The Statistical report was read by Rev. G. W. Puffenbarger in the absence of the district statistician. This report was accepted.

The report of the District Sunday School Promotional Secretary was presented and accepted. Awards were given to the Sunday Schools having made outstanding achievements.

The Conference Chairman then called for a five minute recess.

The Reception Committee introduced Dr. Clyde Parker and Dr. Fred Hill from Southern Pilgrim College. Dr. Hill gave a brief testimony. Dr. Parker, president of Southern Pilgrim College, then reported to the conference concerning the College. This report was received by a hearty "Amen."

Mrs. G. A. Castevens, president of the District Missionary Society, gave a glowing report of their activities over the past year. This also included a financial report. A motion to receive this report was carried.

The PELT report was given and received. The director, Rev. Charles Carroll, urged all the churches to launch this program.

The director of CYC, Rev. W. B. Derr, gave his report which was accepted.

The Chairman of the Educational and Examining Board gave his report which was received.

The District Secretary read the report of the Memoirs Committee. Dr. Elliott called for a moment of silent prayer after which Rev. W. C. Bradley led the conference in prayer.

Rev. B. L. Puffenbarger reported to the conference the work of the State Alcohol Education Council. The report was received with appreciation for the work being done in this field.

The session was recessed by expiration of time.

SECOND SITTING

The second sitting was opened by singing "Rock Of Ages" and "Am I A Soldier Of The Cross." We were led in prayer by Rev. G. A. Castevens.

Rev. W. A. Massey presented Rev. Merdith Davis, pastor of Radford, Va., as a candidate for Ordination. Bro. and Sis. Davis were asked to take seats on the first row for the service.

The Scripture—selected verses from I Timothy 3—was read by Rev. D. L. Reynolds; II Timothy 4:1-8 was read by Rev. Paul Sherwood; and Titus 3:1-11 was read by Rev. Arlie Cook.

Dr. Elliott addressed not only the candidate but also the entire conference. He spoke on the subject, "Qualities I Admire In A Leader I Am Asked To Follow." These qualities are:

1. The Quality to lead.
2. One who knows where he is going.
3. One who shares responsibility with others.
4. One who is a good example.
5. One who has initiative.
6. One who has personality.
7. One who is bold.

Dr. Elliott then addressed the candidate asking the prescribed questions from the Manual. Bro. Davis was asked to kneel at the

altar with Bible in hand. Dr. Elliott gave the Charge and led in the Ordination prayer. The members of the conference joined in extending congratulations to Bro. and Sis. Davis.

The Chairman, resuming the business of the conference, called for the report of the Resolutions Committee.

Resolution #1—Carried.

Resolution #2—Carried.

Dr. Elliott read a proposal from the General Board to the effect that a Comity Committee from each District be appointed to work in connection with a like Committee from the Wesleyan Methodist Church Conference to make a study of District boundaries, etc.

A motion prevailed to have the District Council to either serve or appoint the Committee. Motion carried.

A motion was passed to hold elections of officers at this point in the conference. The following were appointed as tellers: Rev. J. A. Howard, Rev. D. L. Reynolds, Rev. Charles Carroll, Rev. Meredith Davis, Rev. Carlton Clendaniel, Rev. W. C. Bradley, Mr. J. D. Fralin, and Mr. Jesse Holder.

We were then recessed by expiration of time.

THIRD SITTING

The Conference re-convened at 6:30 P. M.

The Reception Committee presented Rev. Elden Hotle from Leakesville, N. C. to the conference. Rev. Hotle gave a testimony and was granted an honorary seat in the Conference bar.

Rev. G. A. Castevens asked to speak. He stated that Bro. and Sis. Massey had labored faithfully among us for nine years and felt it fitting that the Conference present them a love offering. It was moved and carried to do so and the Conference carried out Dr. Elliott's suggestion that it be a March offering.

The Report of the Ways and Means Committee was called for.

The Ways and Means Committee read the following Recommendation from the District Council which was approved:

Some of our churches have been continually delinquent in payment of their budgets. The Church Manual states: "Any Church or pastor failing to raise the United Stewardship Fund without good reason shall be denied a voice in the annual conference (Sec. 169; Ph. 9). The latest Conference Journal, of our District, further implements this with the following statements: "Each representative and pastor of each church who comes up to the end of the conference year without budgets paid in full, shall meet with the District Council, prior to the Conference and give an explanation for its failure, to meet such commitments (Budgets shall include: District, General Stewardship and Ministerial Tithe.)" We feel that the District Superintendent and District Council have done all that they can do to remedy the situation, and that it is the responsibility of this conference to hear the reasons for these churches being delinquent, and determine further actions; therefore, be it resolved that all churches that have not paid their obligations in full, which include: District Budgets, United Stewardship Fund, Ministerial Tithe and Superintendent's Travel, be given, for their benefit as well as for the conference, the opportunity in this conference to explain the reasons for their failure to meet these obligations.

We suggest the following answers be sought:

1. How many years have you been delinquent in this respect?
2. What are your reasons for failure in paying the required budget?
3. Have you, or are you making plans to remedy this situation?
4. Will you put forth diligent effort to make your Church a 100%er this year?

The District Treasurer showed a chart showing those churches which were delinquent in meeting their District and General Church obligations along with the amounts paid. The pastors or representatives of each church were called upon to give reasons why these obligations were not met.

The Ways and Means Committee presented a Recommendation substitute for #1, page 26 of the 1967 Conference Journal. This rec-

ommendation was adopted.

The secretary of the Resolutions Committee presented a resolution having to do with expressions of appreciation. It was approved by saying, "God bless you."

A motion prevailed to have the District Council read and approve the minutes of the conference and to take care of any unfinished business. Motion carried.

A motion to adjourn was carried. The conference sang the Doxology after which Rev. W. A. Massey dismissed in prayer.

The junior membership plan affords an excellent means for tying our children and young people to the Church. There were 10 churches that showed increase in membership. Doran leads the district with a net gain of 19. Warwick is a close second with a net gain of 18.

According to the reports reaching me there were seven churches that paid the United Stewardship Fund, District Budget, and ministerial tithe 100 per cent. They are: Beulah, Norfolk, Remlik, Richmond First, Roanoke, Salem, and Staunton. Some others paid two of the items 100 per cent, but fell short on one item. Our General Secretary-Treasurer reports that the district paid 65 per cent of its United Stewardship Fund. It is regrettable that we were 35 per cent below our assessment. This district is capable of doing much better, but it requires the help of all.

There have been some fine property gains and improvements. I shall mention the ones reported to me:

The Staunton Church has purchased new lots in a good location, and the church is looking forward to the time when it can build on this new site.

A nice church building, together with the furnishings, has been purchased at Swords Creek, Va.

Beaverdam Church installed new carpet, refinished the church floor and did some painting on the interior of the Church. The exterior has also been painted.

The Doran Church has added new stone to a part of the exterior of the church thus completing the recent addition and improvements.

The Hopewell Church installed a new water heater in the parsonage, new kitchen tile and painted two rooms. The Church auditorium has been re-decorated.

The Mineral Church has put in a rest room and painted and completely re-decorated the exterior of the church.

Richmond Emmanuel is now in the process of renovating the present church building and adding a Sunday School unit.

Vinton has put new carpet in the church, re-decorated two Sunday School Class rooms and put a carpet strip on the stairway of the parsonage. All of this was done at an approximate cost of \$700.00.

Waynesboro has continued its major building and renovation program including the purchase of new pews. The building is nearing completion.

For other improvements that may not have been mentioned I would say thank you to pastors and churches.

Both youth camps were a success this year. We are grateful to the District Youth leaders and the corps of faithful workers who gave themselves and their time to make this possible. The youth camps are a vital part of the youth program and we should continue our efforts to reach a greater number of the young people.

It has been my privilege to organize one new church with 23 charter members at Swords Creek, Va. A church building and furnishings have been purchased at a bargain. It was through the interest Rev. E. C. Price had shown that this fine group decided to become Pilgrims. These people are enthusiastic and eager for spiritual things. The prospects for the work are good. The church will be presented at this conference.

Another work has been opened in Fredericksburg, Va. Rev. Carlton Clendaniel is the pastor and he and Mrs. Clendaniel are faithfully working in this new field with the assistance of two fine Pilgrim laymen from another district, Mr. and Mrs. Archie Moore. The work has been doing well and contacts are being made. It is hoped this work may become a fully organized church this coming year. The prayers, support and continued interest of the district are needed to realize this goal.

Through the proper committees goals for the new year will be presented. Let us not only adopt them in the Conference, but may we return to our respective churches to seriously and sincerely work to reach them. We must constantly strive for spiritual, numerical and financial gains. Many more churches should be added to the 100 per cent group by paying the United Stewardship Fund, District Budget, and ministerial tithe in full. Let us through our church services, revivals, Sunday Schools, Youth Societies, PELT, and CYC, lay-visitation, and above all through prayer, fasting and faith push forward and win souls for Christ. "The fields are white unto harvest." The time to reap is now!

REPORT OF PELT DIRECTOR

Mr. Chairman, and delegates to the Forty-sixth annual conference of the Virginia District Pilgrim Holiness Church: Greetings in Christ's Name!

Since its founding in May of 1930, the Evangelical Teacher Training Association (ETTA) has had nearly one million persons receiving training for Christian service. In 1963, our denomination through the Sunday School and Youth Department set up a training program called P.E.L.T. (Pilgrim Evangelical Leadership Training) and contracted with E.T.T.A. for their text books and for Credit. More and more of our people are seeing the need for a broader program of Christian education within the local church. This last year our Sunday School and Youth Department launched the "Sunday Evening Training Program" which would include, along with other programs, courses in PELT.

Every Christian leader must realize that a call to Christian service is a call to preparation and we all are greatly in need of more dedicated leaders in our churches. The PELT Preliminary courses could be taught in your church are Old Testament Survey in Law and History, Old Testament Survey in Poetry and Prophecy, New Testament Survey, Understanding Children and Youth, Teaching Techniques and Sunday School Success.

In our District this year, we have ten certified instructors. One of these, Rev. Wm. Derr, of Staunton church, taught the course, New Testament Survey and had an enrollment of 18 with 9 certificates given for credit. One other church (Remlik) completed this year a course started last conference year. Within the last two years four courses have been taught in our district. Staunton is to be commended for having a course each of the last two years.

GOALS

This year I would like to see all of our pastors become certified instructors and several of our qualified laymen.

A second goal would be to have at least six churches presenting a PELT course. I would be most happy to assist any pastor in setting up a course in your church.

DISTRICT RESOLUTIONS — 1967

SUNDAY SCHOOLS

1. Be it resolved that Sunday School enrollment for each school be corrected at the beginning of each calendar quarter. Names shall not be dropped from the roll unless they were absent at least four Sundays of the quarter, sickness excepted.

2. Be it resolved that Sunday School Workers meetings be held in strategic locations over the District so as to accommodate groups of Churches.

3. Be it resolved that each Sunday School of the Virginia Conference strive for the following gains:

(a) Those with average attendance 50 or less strive for a numerical goal of seven (7) for this fiscal year, 1967-'68.

(b) Those with average attendance more than 50 strive for a numerical goal of ten (10) for this fiscal year, 1967-'68.

DISTRICT CAMP

1. Be it resolved that we have a District Camp Committee. The District Superintendent shall serve as Chairman. Other members of the Committee shall be chairmen of the following sub-committees: Advertising, Finance, Tabernacle, and Dining Room.

2. Be it resolved that a set of rules be drawn up by the District Council governing the dormitory and camp grounds. Said rules shall be posted in conspicuous places. Further, the District Council shall appoint two men to serve as policemen to enforce these rules.

3. The District Camp Committee met July 19, 1964, in the afternoon at the Staunton Pilgrim Holiness Church, with two members present. After discussion the following resolutions were made relative to the building of cottages on the camp grounds:

(a) Be it resolved that all cottages shall be constructed of cinder block with concrete floors and asphalt composition roof. Single cottages should be 24' x 22' and double cottages should be 32' x 22'. Each owner shall have the privilege of finishing the inside as he chooses.

(b) As long as the grounds are kept clean, electric costs paid and everything conducted properly, owners of cottages may use them at times other than during camp period.

(c) The District shall charge a fee of \$30.00 to lease space for a single cottage and \$50.00 for a double cottage space. Furthermore, any transfer of ownership of cottages may be made only after District Council and Camp Board approval.

(d) A fee of \$2.00 shall be charged for a cottage for the period of the annual Camp to cover cost of lights and ironing privileges. Cottages with additional appliances such as electric refrigerators, etc., shall be charged \$6.00 for the same period.

(e) The workmanship of each cottage must meet the standards established by the Camp Committee. A contract of regulations is

to be drawn up between each cottage owner and the Camp Committee.

DISTRICT SUPERINTENDENT

1. Be it resolved that whenever there is a change in the office of the District Superintendent, the District Council shall endeavor to place the retiring Superintendent in a satisfactory postorate, if he so desires.

2. Be it resolved that the District Superintendent be authorized to inform each church board whose deeds are not filed correctly according to the Manual to make such necessary changes within the Conference year. In the future it is further resolved that copies of deeds of all newly acquired properties be filed with the District Superintendent.

3. Be it resolved that a report on the amount of insurance carried on various properties in the District be filed with the District Superintendent.

4. Be it resolved that the District Superintendent appoint a Home Missionary Committee of two members to serve along with him in formulating the District Home Missionary program.

5. The District Superintendent shall be granted two weeks vacation with pay.

ANNUAL CONFERENCE

1. Be it resolved that as far as possible all appointments of Committees be made so that all committees can meet simultaneously. Further, all committees shall meet at the call of the chairman and have their business ready for presentation at the opening session of the Annual Conference.

2. Be it resolved that Resolution number 2 on Page 31 of the 1965 Conference Journal be deleted.

3. Be it resolved that all matters pertaining to District Youth work be placed in a separate section in the District Minutes. This includes Youth Executive Directory, Youth Zone Chairmen, Conference Minutes, Ways and Means Report, Resolutions, Standing Rules and Treasurer's Report.

LOCAL PASTORS

1. Be it resolved that each pastor support the District Camp with his presence and that he strongly urge his people to attend and support the camp. Local churches shall provide the regular support of the Pastors while they are in attendance at camp.

2. Be it resolved that each pastor strive to bring the total Advocate subscription to the total number of families represented within his Church and Sunday School membership.

3. Be it resolved that all pastors within a radius of 100 miles of the Camp Grounds be required to come on a date set by the District Council prior to Youth Camp to make preparations and clean the buildings and grounds; those who live beyond 100 miles of the

Camp Grounds be required to come on a date set by the District Council, prior to District Camp to make preparations and clean the buildings and grounds. All pastors shall remain after the camp and clean the buildings and grounds.

Be it further resolved that any pastor who cannot be present shall secure someone in his place and pay that person a fee of \$10.00.

4. Whereas no standard procedure has been established by the General Church to determine what shall constitute a pastoral call; therefore, be it resolved that the Virginia District shall establish the following as its procedure for reporting pastoral calls. Each personal call to the home or hospital shall constitute a pastoral call. Further, each person called on shall be counted as one call. Example—if a father and mother with three children are visited by the pastor and only the father and mother are church members the pastor shall report it as two pastoral calls on members and three pastoral calls on non-members. Further, a call at a home where no one is home shall be counted as one call.

LOCAL CHURCHES

1. Be it resolved that each local church in the Conference shall provide the utilities for the parsonage. The Conference shall provide the utilities for the District Superintendent.

2. Be it resolved that each local Church Treasurer furnish a monthly financial report for the Church bulletin board covering all receipts and disbursements. The local church board shall then endeavor to make the necessary adjustments to bring up the financial obligations to both the District and General Church.

3. Be it resolved that in keeping with the spiritual renewal program, "The Time Is Now", advanced at our spring ministerial convention, that we urge each church in our conference to organize a prayer and fasting league.

The objectives shall be as follows:

(a) It shall not replace the regular church prayer meeting; we recommend Thursday of each week to be established for this league to operate.

(b) The League Membership shall be encouraged to pray for:

1. General interest of the Church.

2. Unsaved of the local community, church and Sunday School.

(c) Church Membership Gain:

1. Endeavor to realize a five per cent net gain in Church Membership.

(d) Sunday School Attendance Gain:

1. To strive for the following gains in the Sunday School:

a. Sunday Schools with average attendance 50 or less strive for a numerical gain of seven (7).

b. Sunday Schools with average attendance more than 50 strive for a numerical gain of ten (10).

2. To pay the United Stewardship Fund, District Budget, Pas-

tor's tithe in full and encourage the support of the Penny-A-Meal offering for District Home Missions.

4. To better acquaint new members received into the Pilgrim Holiness Church, resolved that each church give one year's subscription of the Pilgrim Holiness Advocate and a copy of the Pilgrim Holiness Church Manual to said member's home.

JOURNAL MINUTES

1. Be it resolved that the report of receipts and expenditures for the District Camp be prepared and placed in the District Minutes of the following year.

2. Be it resolved that the Editing Committee classify all resolutions appearing in the Conference Journal under appropriate headings, such as Youth, Annual Resolutions, etc.

DISTRICT AND GENERAL CHURCH

1. Whereas the General Board of the Pilgrim Holiness Church has authorized the Pilgrim Pension Plan, Inc. to make loans of pension funds to local Pilgrim Holiness Churches under such conditions as require active participation on the part of Pilgrim Holiness Church Districts; Therefore, be it resolved by the Annual Conference of the District that the District Council, District Trustees, and all District Officials, be, and they are authorized to do and perform all acts required of them in the consumation of authorized loans of local Pilgrim Holiness Churches of this District, subject however, to the limitations set forth in said resolutions of the General Board of the Pilgrim Holiness Church authorizing said loans.

2. Be it resolved that the Virginia District assume its proportionate part of the Pilgrim Holiness Church Advancement Program at outlined by the recent General Conference. The goals for our District are: One new Church organized each year for the next four years with the overall 7% increase in Church membership.

3. Be it resolved that a permanent date be set for the District Ministerial Convention with the District Council making arrangements for the program and the workers.

APPRECIATION

1. Whereas we appreciate the splendid cooperation of the ministers and laymen who helped to make this Conference possible, and have been enriched by the presence and leadership of our esteemed District Superintendent, Reverend Mr. W. A. Massey, and our honorable General Superintendent of the Eastern area, Dr. Paul F. Elliott in this Conference,

Therefore be it resolved that this Conference express its gratitude by a rising vote of thanks and a hearty "God bless you"; and be it further resolved that we give an anniversary gift of \$50.00 from the District Treasury to our District Superintendent, Reverend Mr. W. A. Massey and our first lady, Mrs. Louise Massey, who will be celebrating their twenty-fifth wedding anniversary on September 1, 1967.

WAYS AND MEANS RESOLUTIONS — 1967

DISTRICT COUNCIL

1. Each delegate and pastor of each church who comes up to the end of the conference year without budgets paid in full, shall meet with the District Council on Saturday afternoon of the District Camp, prior to the Conference and give an explanation for its failure, to meet such commitments and that the District Secretary notify the delinquent churches of the time that they are to meet the Council. (Budgets shall include, District, General Stewardship, and Ministerial Tithe and Travel.)

2. Paragraphs 2 and 3 of section 149 of the Manual of the Pilgrim Holiness Church shall be brought to the attention of the local church boards and treasurers by the pastor. The provision of the Manual relative to specified giving shall be adhered to and a sound financial plan be worked out for the raising of budget quotas.

3. Four hundred feet across the front of the Camp Grounds be sold at a price of approximately one hundred dollar per foot frontage. The proceeds from this sale would be used to pay off the indebtedness on the Camp Ground and provide much needed facilities.

LOCAL CHURCHES

1. Each Local Treasurer shall forward to the District Treasurer all offerings for general and district funds and the pastor's tithe, by the last day of each month and a receipt for the same shall be sent to the sender immediately. All general church funds shall be sent to the General Treasurer by the last day of each month.

2. All ordained and licensed ministers, except active and retired missionaries, shall pay their ministerial tithe to the District Treasurer monthly through the local church by withholding the ministerial tithe or otherwise, or by direct remittance to the District Treasurer.

3. Our churches shall be advised of the General Board Resolution of May 12, 1960 relative to a recommendation that each church pay the assessment fees for pastor and wife in the Ministerial Benefit Association and that the District cover fees for the District Superintendent and his wife.

4. Where churches have no adequate method of raising District and General Funds the dime book system shall be used.

5. Travel expenses of the District Superintendent on his visits to the churches shall be raised as follows:

Churches with less than 40 assessable members shall pay \$8.00 per visit; and churches with more than 40 assessable members shall pay \$12.00 per visit.

6. Each local church shall pay the conference fee of \$4.00 each for the pastor, retired ministers, and District officials who are members of its congregation. The local churches shall also pay the conference fee and travel expense of their lay delegates.

7. Each church shall contribute 10% of the regular offerings of the Church and Sunday School to be sent to the District Treasurer

each month for District obligations. Each Church shall raise its United Stewardship Fund of \$9.50 per member by the method best suited. General monies shall be sent to the District Treasurer on a monthly basis.

8. We recommend that each church pay its pastor's hospitalization insurance if at all possible, unless a working pastor has insurance through the company where he is working.

9. Whereas, the need of a District Parsonage is evident and an effort to build one has been hindered by lack of funds, be it resolved that at least \$500.00 of the Superintendent Fund be set aside each year, if possible, until sufficient money is accumulated to make a substantial down payment. The balance could be handled by the rental allowance.

10. We recommend that each church send at least \$10.00 to the District Treasurer by February 15 to help support Alcohol Education Council.

11. Whereas our United Stewardship Fund is prorated to a Home Missionary Church in the following manner: $\frac{1}{4}$ the first year, $\frac{1}{2}$ the second year and $\frac{3}{4}$ the third year, full responsibility the fourth year, therefore, be it resolved that our district budget of 10% be prorated in the following manner: 2% the first year, 4% the second year, 6% the third year and the full 10% the fourth year.

12. Inasmuch as the District ministerial conventions are held each year for the specific purpose of aiding the ministers in their work for the Church, therefore, we recommend that each church pay the pastor's expense to make possible his attending. The expense shall include transportation and meals.

13. Since there are so many new communities in Virginia with a growing population, and Pilgrim Churches could be established if funds were available, we recommend that each pastor urge the members of his congregation to seriously consider leaving a stipulation in a will or insurance policy to help sponsor a home missionary church in the Virginia Conference. If a substantial amount be given, the new church could become a memorial church to his memory, bearing his name.

14. Inasmuch as additional funds will be needed for the 1968 merging International Conference; therefore, be it resolved that the District Treasurer be authorized to make up any deficit in the General Conference Fund from the District Parsonage Reserve Fund.

1. The District Conference shall pay the following amounts to the respective officers:

2. The District Council is authorized to rent an apartment in the house on the camp ground, with due care to persons renting said

property, and this rental arrangement will be for the benefit of the camp ground.

3. Each of the following shall apply to the respective groups:

(a) Each pastor and local church board shall raise an offering on the First Sunday of May for the District Camp Meeting Expenses and forward the same to the District Treasurer. If this free-will offering does not amount to \$1.00 per member, the needed amount to make the difference is to be taken from the Church Treasury.

(b) The engaged singers for the District Camp Meeting shall be paid a sum not to exceed that paid the Evangelist. This sum shall be the limit for the singers whether the party consists of one, two or more workers.

(c) The assessment of \$10.00 for all ministers, except missionaries with a salary of \$40.00 or less per week; and \$15.00 assessment for ministers whose salaries exceed \$40.00 per week shall be paid to the Camp Expense Fund, by the beginning of each District Camp, whether the minister is present or absent.

4. The District Council is authorized to work with any local church in securing loans using the financial standings of the Conference as reflected in the property statements of the Journal, the combined Conference equity and the current District Treasurer Balance Sheet, as the basis of negotiation for such loans.

5. The Home Missionary (Church Extension) Calendars shall be used by our churches as the method of raising funds for District Church Extension.

6. All official travel in the district shall be paid at the rate of 7c per mile.

7. The District Superintendent's salary shall be set at \$100.00 per week, with the addition of utilities, gas, lights, phone, water, and fuel. The District shall pay his remittance to the Pilgrim Pension Fund, and his hospitalization insurance. Official travel shall be covered by District Funds at the rate of 7c per mile, plus meals, lodgings and road tolls. The rental allowance for the District Parsonage shall be set at \$80.00 per month.

8. A determined effort shall be made throughout the District to secure one hundred or more friends who will pledge ten dollars per year as a supplementary fund for the District Camp Meeting expense.

9. The District Superintendent shall be paid the equivalent of one week's salary as a Christmas gift.

10. We recommend that each church of 35 members or less send \$5.00 annually to help defray the expense of the District Ministerial Convention. The Churches that exceed 35 members shall send \$10.00 annually. The designated amounts are to be paid to the District Treasurer by the end of February of each year.

11. We recommend that the second Sunday of September be designated as Tabernacle Day and the pastors shall present the pledge

cards to their congregations and urge liberal offerings for the Tabernacle, or a special offering to be received monthly, on the Roanoke Camp Grounds.

12. Whereas the Assistant Superintendent is asked to fill in for the Superintendent, therefore, be it resolved that he be paid 7 cents per mile travel and \$15.00 per meeting. This is to be paid from the Incidental Fund.

13. Inasmuch as it seems more difficult each year to secure helpers to prepare the camp grounds for meeting; therefore, we recommend that the local churches of the camp meeting area arrange with the camp management to do certain phases of the clean up work in the evenings after work; and that all other churches assume a definite responsibility by payment of \$10.00 from each church with a membership of less than 25, and that each church with a membership of more than 25 pay \$20.00. This is over and above the present responsibility of each minister which is already stated in our minutes. Said fees are to be paid by June 1 to the District Treasurer.

YOUTH CONFERENCE MINUTES

The Virginia District Youth Conference convened at the District Camp Ground at Roanoke, Virginia, on Saturday, August 12, 1967. The Rev. D. L. Reynolds, Youth President, opened the meeting. The Rev. The following reports were presented:

The District Youth Treasurer's report was read and received by the conference.

All Zone Leaders' reports were given and received with appreciation.

All local church Youth Presidents' reports were given and received with appreciation.

Dr. Elliott remarked about our men in service. He asked that each youth society remember our men in the service of our country.

The Resolution Committee reported. The following resolution was read and approved:

1. Be it resolved that the Rovinco Zone be separated from the Western Zone and be re-established as formerly:

Western Zone—Radford, Salem, and Christiansburg.

Rovinco Zone—Roanoke, Vinton, and Covington.

The Ways and Means Committee reported. The following resolution was read and carried:

1. Whereas, there is a delay in receiving the utility bills for the District Youth Camps; we recommend that for each camper of the Junior and Senior Camps that the District Youth Treasurer pay .75c per camper to the District Treasurer to cover the utilities, (Electric, gas, local phone calls, refuse disposal, etc.)

Election of officers was the next order of business and the following were elected:.

President—Miss Louise Carlton.

Vice President—Rev. Paul Sherwood.

Secretary—Rev. Arlie Cook.

Treasurer—Rev. William Derr.

The conference passed that due to expiration of time that the Youth Council elect the zone chairmen from the nominations from the District Council.

The new president was given some time to think before she appointed her committees.

Rev. Paul Sherwood expressed his appreciation for the fine work the outgoing president, Rev. D. L. Reynolds, had done in his seven years as president.

A motion was made and passed that the conference go on record by expressing their appreciation for the fine leadership Rev. Mr. Reynolds had given the Virginia District Youth Society, by standing and saying a hearty Amen (meaning, IT IS SO).

Conference was adjourned by the newly elected District Youth President, Miss Louise Carlton praying the prayer of dismissal.

I greet you in the Name of the One "which is above every name" that is given, the Name of Christ.

God in His goodness has allowed us the privilege to meet together again and share our reports and make our plans for the District Youth work. I trust His Grace will overshadow us, His wisdom will be our guide and His will be done.

I would like to take this opportunity to express my appreciation to our District Superintendent, Rev. W. A. Massey and the District Youth Council, for their cooperation in the youth program. Also, for the patience and support of all the other members of the Virginia Conference.

The longer I pastor and the more I work with the young people of our District, the greater is my feeling, that the hope of our Church lies with its youth. May God help us to put forth every effort possible to utilize the potential of our younger generation and to save them for God and the Church. My feelings are expressed in the words of our General Sunday Schools and Youth Secretary, Rev. O. D. Emery, "so little done, so much to do." YOUTH CAMPS

Juniors and Rev. R. L. Prendergrast from North Carolina preached to the Seniors. God honored the preaching of the Word by both of these evangelists. Many young people found pardoning grace and help at the altar.

I want to thank all the young people for their cooperation during the camps. It is a thrill to see how some of our youth have grown in the Lord from year to year. The staff worked hard and did a fine job in both of the camps. Without their excellent help the youth camp would never succeed.

YOUTH ZONES

I have visited most of the zones this year and appreciate the leadership of our zone chairmen and the cooperation of all our societies in these zones. Reports have come of outstanding rallies and a growing interest in the zone activities. I think the reports of our chairmen in the conference will show an up-grading in the quality of our zone rallies.

LOCAL YOUTH SOCIETIES

I want to commend the local youth society presidents for their efforts throughout another year. The records that we have available at this time show that we have had a gain of over 3% in membership for the year. This is small, but it is in the right direction. Let me urge pastors and other youth leaders to do all you can to create more interest in the young people's work of your church. Capitalize on the Youth Week activities and the C. Y. C. program to build your society.

The Sunday Evening Training Hour, authorized by the International Conference in June 1966, can be adopted for great advantage in many of our churches. In such a program you will have your pre-school, C. Y. C., P. Y. S., and PELT in one evening service.

GOALS

The opportunities for service to God and the Church through the Youth Program are tremendous. Young people are on the move today. Their force and influence are being felt around the world. They need guidance. If we, as a Church, fail to give them direction, other forces will. Let us give ourselves to the tasks that we face in this conference year, in our local societies, our zone activities and our district program.

With the help of God, let us aim to accomplish the following:

1. More CYC Chapters for our younger youth.
2. An upgrading of our P.Y.S. through more expressional activities.
3. At least 8 rallies in every zone.
4. 175 enrolled in the youth camps next summer.

Let us commit ourselves to these goals, realizing that "without Christ we can do nothing", but that "we can do all things through Christ who strengthens us".

Thank you for allowing me to serve as your District Youth President for the last seven years. It has been a joy to work with our youth. We have some of the best in the world. I have sought to approach my responsibilities with dedication. I wish I could have had more time to give to this great work. My accomplishments have been far from what I would have liked to have seen, but I trust that some lasting good has been done. I feel that a change in youth presidency would be in divine order; therefore, I humbly submit my resignation and pledge my support to the one you choose as your leader for the following year.

YOUTH CONFERENCE STANDING RULES

1. Be it resolved that each Zone Chairman give an annual report to the Youth Conference of the activities of his Zone.

2. Be it resolved that each local pastor advise his Youth Society President as to the dues of one dollar per month, and 10% of the regular offerings to be sent to the District Youth Treasurer.

2. Be it resolved that the Standing Resolutions and Ways and Means resolutions from the Youth Conference be listed as such in a separate section of the conference journal under "Youth Conference."

4. Whereas, in the past, the minutes of the District Youth Conference have not been approved until the following Youth Conference and whereas, the minutes of the District Youth Conference go into the conference journal not having been approved, be it therefore resolved that the minutes of the District Youth Conference be approved by the District Youth Executive Council before said minutes are placed in the Conference Journal.

5. Be it resolved that the host church for the Youth Rally count one point for each person towards the Youth Banner, other participating churches count one point per person plus one point per mile up to twenty-five (25) miles one way. Also an extra point per person is given all persons between the ages 13 - 35 years.

6. Whereas the youth camp has outgrown our present facilities, therefore, be it resolved that we have two separate youth camps in the future; ages 9-12, and 13-teens. Further that the District Youth Council schedule the date for said camps.

7. Be it resolved that in the event of a change of local youth presidents, the outgoing president shall prepare the annual report for the incoming president to give at the District Youth Conference.

8. Be it resolved that a Zone Committee be set up. This will consist of an assistant Zone Chairman, a Secretary and Treasurer. These members will assist the Zone Chairman.

9. Be it resolved that each church bring to the first Zone meeting

of said church two recommended candidates of the active membership for the office of assistant Zone Chairman, Secretary and Treasurer.

10. Be it resolved that the pastors and local youth presidents or representatives within the Zones serve as advisory members of the Zone committee in planning zone rallies.

11. Be it resolved that the zone committee meet immediately following each zone rally.

12. Be it resolved that the District Youth President attend the first Zone Rally of each zone for the purpose of organizing and explaining the duties of the Zone committee and that the Youth President work out a schedule for this first meeting only.

YOUTH RESOLUTIONS

1. Be it resolved that the District Council appoint two of its members to serve with the Youth Council in planning the date and place of the Youth Camp and other related activities. This Committee to meet at least twice a year.

2. Be it resolved that the Youth Zone Chairman plan a rally each month during the school year and be it further resolved that the Zone Chairman shall co-ordinate all Zone Rallies and that the Youth President of the District be informed of said rallies and, is possible, be present at the first Zone rally during the Conference year. At this rally an offering shall be taken to help defray the travel expense of the District Youth President.

3. Be it resolved that the Rovinco Zone be separated from the Western Zone and be re-established as formerly:

Western Zone—Radford, Salem, Christiansburg.

Rovinco Zone—Roanoke, Vinton, Covington.

YOUTH CONFERENCE WAYS AND MEANS

1. We recommend that each youth society shall send \$1.00 per month to the District youth treasurer and each church or organized society send a free-will offering to the District Youth Treasurer. This sum shall be used for operational expenses, and any balance shall be reserved for the next District Youth Camp. The District Youth Treasurer shall send, at the beginning of the Third Quarter, a notice of assessments to the Youth Society Presidents which shall be read in a regular Youth Society meeting.

2. We recommend that the District Youth President's salary be established at \$100.00, and we further recommend that the payment be made from the District Youth Treasury.

3. We recommend that the Youth Camp fee be \$10.00 per camper, and we further recommend that the fee be \$9.00 per camper for any church sending in five or more campers to each camp.

4. We recommend that after all Zone expenses have been paid, 50% of the balance remaining in the Zone treasury be retained by the Zone and 50% of the balance be forwarded to the District Youth Treasurer.

5. We recommend that 10% of the regular offerings of the local youth society be sent to the District Youth Treasurer. 5% of this to be sent on to the General Sunday School and Youth work and 5% to be kept for the District Youth work.

6. We recommend that 3 cents per mile be paid to all Youth Camp workers who incur transportation expense to and from Youth Camp.

7. Whereas, there is a delay in receiving the utility bills for the District Youth Camps; we recommend that for each camper of the Junior and Senior camps that the District Youth Treasurer pay 75c per camper to the District Treasurer to cover the utilities. (Electric, gas, local phone calls, refuse disposal, etc.)

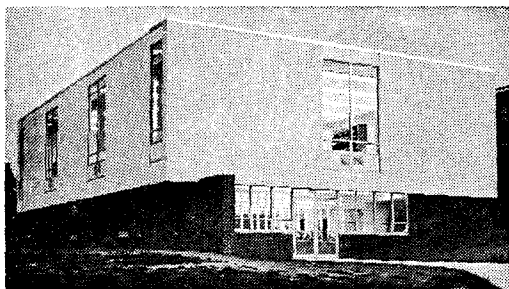

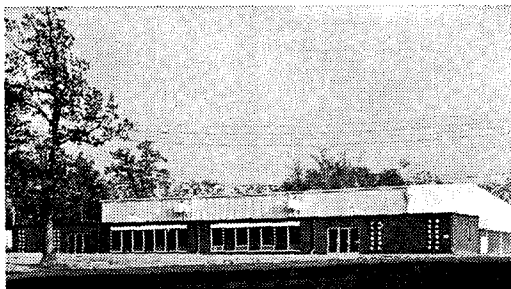
