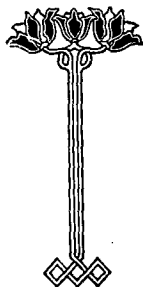

JOURNAL OF PROCEEDINGS

First Business Session

Wednesday Morning, October 12, 1921

The Second Annual Assembly of the West Virginia District of the International Holiness Church convened at Barboursville, W. Va.

The session opened at 9 a. m. with songs, prayer and Scripture reading, J. F. Woods, District Superintendent, in the chair; E. W. Miller, Secretary.

Minutes of last Annual Assembly read and approved with two minor corrections.

Moved and carried that the four front rows of seats in the middle row be reserved for voting members of the convention.

Committee on Resolutions—Moved and carried that the Chair appoint three. Appointed Harry F. Woods, J. A. Fields, J. C. Brillhart.

Moved and carried that the election of officers be set for the first business of tomorrow morning session.

Report of District Superintendent and Assistant District Superintendent read and accepted.

Moved and carried that ministers' reports be limited to ten minutes. District Treasurer's report read and accepted.

Moved and carried that the business sessions adjourn at 11:30 a. m.

Second Business Session

Thursday Morning, October 13, 1921

Third Business Session

Friday Morning, October 14, 1921

Resolved, That we as an Assembly assure Brother R. G. Taylor, editor of our Church Paper, of our support, that an offering be taken in this assembly for the indebtedness of this paper, and that the District Superintendent devise means whereby this need shall be brought before all of our Churches.

Va., October 11 to 16, ask the called or regular General Assembly to change the last clause of paragraph 101 on page 42 of our Manual, which reads: "As well as to shun and have no association with or membership in secret societies or lodges which are oath-bound," to read: "As well as to shun and have no association with or membership in labor unions, neither in secret societies or lodges which are oath-bound."

C. which reads "The pastor shall be chosen by not less than a three-fourths vote of all members of the advisory board, a majority vote of the board shall be sufficient to dismiss him," to read, "The pastor shall be chosen by not less than a three-fourths vote of all members of the advisory board, and their choice shall be confirmed by a majority vote of all members of the Church present and voting at a meeting called for this purpose; a said dismissal is confirmed by a majority vote of all the members of the Church present and voting at a meeting called for that purpose."

Whereas, This would deprive them of a vote and voice in the affairs of the Church of which they are pastor, be it

Resolved, That this Assembly ask the General Assembly to rule that a preacher and his wife, if he has a wife, in taking a new pastorate automatically becomes a member of the Church he takes charge of, and thus automatically drop his membership from the Church he is leaving, or to which he originally belonged.

However, In case a pastor gives up a charge, he may have the privilege of transferring his membership back to his home Church, or other Church of his choice, merely by notifying in writing the clerk or pastor of such Church.

DISTRICT SUPERINTENDENT'S REPORT

During the last year God has been very good to us in sparing our lives. While men and women have been falling all around us, not one of our preachers have been called away by death during the year, for which our hearts are very grateful. Two of our preachers have changed their membership to another district, namely, Brother J. T. Johnson and wife have transferred to the Kentucky district, and Brother Roscoe Templeton to the Ohio district. Brothers Ash, Cook and Gothard have united with the Nazarene Church.

The general condition of the Church over the district is good, and there has been an increase in membership over last year of 45, making a total membership in the district to date of 346. The total amount reported as having been received during the year for all purposes is \$12,377.93, of which amount \$1,833.07 was given for missions, \$11,806.69 of the total was given by the Church and \$571.24 was given by the Sunday Schools.

The Church at Barboursville built a good parsonage at the cost of \$2,663.82 (this does not include labor donated). Of this amount \$865.16 has been paid, leaving a balance of indebtedness on the parsonage of \$1,798.66.

The total valuation of our Church property in the district as reported is \$76,800.00, and the total indebtedness on all property is \$6,144.66.

During the year we have organized two Churches, one at Williamson, also one at Wayne. This Church, under the pastorate of Sr. Hollenback, is growing, and they are now erecting a new church building 30x40 feet.

After having the District Secretary write different firms for prices on canvas seats for the tent, we found we could get folding chairs cheaper, so we ordered 180 from the Huntington Seating Co., which seated the tent nicely.

I want to recommend and urge our pastors that they comply with Paragraph 86 of our Manual and urge the members to tithe into the Church treasury, using a certain per cent for the pastor's support and set a MINIMUM amount he shall receive, the balance to be used as the Advisory Board may direct, setting aside a certain portion for Missions, Schools, Paper, etc. I feel by so doing our work will be better looked after and our Missionaries will be better supported.

Since our last Assembly I have visited each Church in the district twice and have done what I could to help them in any way that I could. On account of the Church at Wayne having just been organized and needing my especial help, I have visited it more than any of the rest. Along with my work as District Superintendent I have been in the evangelistic work and have traveled 9,291 miles, have helped in 13 revivals and three camp meetings; 593 persons knelt at the altar during these meetings (outside of Cincinnati, Huntington and Kingswood camp meetings). Of this number 333 professed to pray through, 246 were regenerated and 87 sanctified.

I have preached during the year 311 times, have baptized 13 persons by immersion and seven babies by sprinkling, preached three funerals.

I have received for support from the district \$419.47; other sources \$783.43.

I have helped in four revivals, have preached 121 times; pastored the Logan Church seven months; visited all the Churches in the district; made 150 pastoral calls; had 195 seekers at the altar, nearly all claiming to be saved; baptized two babies; marriages, one; received for support from Logan Church while pastor, \$729.38; received from state work, \$47.35, other sources \$200.65; total \$977.38.
