Second Business Session, Thursday Morning, Sept. 28, 1922

Opening—The second business session opened at 8:00 a. m. by devoticnal exercises, consisting of singing of three songs; prayer led by Sr. J. C. Wakefield and reading of scripture found in the 4th chapter of first Corinthians, with many spiritual comments. Prayer by District Superintendent J. F. Woods.

Reading of minutes—Minutes read and approved with the exception of reports, which upon motion duly seconded and carried, were omitted from reading.

2 HEADYUNNILL PILGRIM HOLINESS SHIJR Roll Call—The names of Rev. G. M. Cunningham, J. A. Fields and Sr. A. Pearl Winslow were added to the roll. All present in last session answered "Present" except Bro. G. W. Jack and Samantha Adams, of Nine Mile church.

Committee on Resolutions—The Chair named as this committee the following: Rev. Harry F. Woods, L. G. Peters and J. C. Wakefield.

To Be Excused from Assembly Bar-Moved and seconded that no one be excused from the Assembly without first obtaining their consent.

Reports continued—J. A. Field, assistant district superintendent, report accepted; J. C. Wakefield, district treasurer, report accepted; Logan church, G. M. Cunningham, pastor, Alice Taylor, delegate, accept; Huntington church, Pastor absent, Sr. Jennie Thorniley, delegate, accept; Huntington church, Sr. Isa Malonay, Sunday School delegate, accept; Wayne church, Bertha Hollenback, pastor, Ora Kazee, delegate, accept.

Preachers' Reports—J. C. Wakefield, L. G. Peters, Wm. L. Dawson, Harry F. Woods, A. Pearl Winslow, John Cochran, J. R. Hatcher, Louise Haskell, F. C. Maynard, E. A. Perry, B. C. Reed, Bertha Roberts, T. B. Stanger, John Stewart, E. B. Welch. Each of these reports was accepted in order.

Lost Motion—Moved and seconded that the district superintendent elected for next year be required to visit the churches when possible instead of alternating with the assistant district superintendent. Motion lost after discussed.

Resolutions Suggested—The Chair here took up the matter of possible changes that may prove of advantage in our Church Manual, and suggested several places to the Committee on Resolutions that he thought well to consider, throwing each suggestion open for discussion by the Assembly in order that the said committee may take them under advisement.

Adjournment—On expiration of time, dismissed by Bro. G. M. Cunningham.

Third Business Session, Friday Morning, Sept. 29, 1922

Opening—This session opened at 8:00 o'clock by devotional exercises consisting of singing, prayer led by Rev. J. C. Brillhart, pastor of the Huntington church; song, scripture reading by the Chair from 1st Tim. 3rd chapter, and prayer.

Roll Call—same as last session with addition of J. C. Brillhart and Richard Harrold, delegate from Logan church, and omission of Bryan Edmond, whom the Assembly excused at last session.

Reading of Minutes—Minutes read and approved as read, the reports being omitted on motion duly seconded and carried.

ELECTION OF OFFICERS

Adoption of Rules-Moved and seconded that the rules governing the last General Assembly be adopted. Motion carried.

Tellers-The chair appointed as tellers, Bro. J. C. Wakefield and Bro. J. C. Brillhart.

District Superintendent—J. F. Woods receiving all but two votes the secretary declared him elected.

Assistant District Superintendent—J. A. Fields elected on second ballot and confirmed by Chair.

Secretary—E. W. Miller elected on first ballot and confirmed by Chair.

Assistant Secretary—Moved and seconded that we elect an assistant secretary with the understanding that said assistant is to take the place of Bro. Miller at the General Assembly if he can't go. Motion carried. Bro. Harry F. Woods elected and confirmed by the Chair.

Treasurer-J. C. Wakefield elected on first ballot and confirmed by the Chair.

Members of Council-Sr. Hattie Hickman, Bros. J. C. Brillhart and J. S Hatten elected on first ballot and confirmed by the Chair.

Examining Board—One member to be elected in place of L. G. Peters, term expiring. Rev. J. A. Fields receiving majority vote, the Chair declared him elected.

Delegates to the General Assembly—Moved and seconded that we elect one at a time; motion carried. (31 preachers and deaconnesses entitles the district to 6 delegates; 365 members in the district entitles the district to 2 delegates). First, J. S. Hatton elected on second ballot. Moved and seconded that we re-consider the action taken to vote for one delegate at a time; motion carried. Moved and seconded that we vote for the remaining 5 delegates on the next ballot; motion carried. This ballot showed the following elected as delegates: Sr. Hattie Hickman, Bro. G. M. Cunningham, Bro. J. C. Brillhart, Bro. Cecil Phillips and Sr. Bertha Hollenback.

Lay Delegates-Albert Phillips and C. W. Becket, both from Huntington church, were elected on second ballot.

Expense of Delegates-Counted at a total of \$145.10, including the 10c per capita to cover meals and lodging.

Fourth Business Session, Saturday A. M., Sept. 30, 1922

Opening—Opened with devotional exercises consisting of songs, prayer by Bro. Frazier, another song, scripture lesson, 6th chapter of Epensians.

Roll Call-Bro. H. J. Frazer added.

Reading of Minutes—Minutes read and approved with correction of some addresses.

Toler Church excused from the list of those failing to bring in their allotment of the expenses of delegates to General Assembly.

Members excused from assembly—Sr. Bertha Hollenback and Ora Kaze, Cecil Phillips; J. S. Hayton and G. M. Cunningham.

Pledges to State Work—Bro. Cecil Phillips, for Toler and Williamson churches, \$50.00; Bro. J. S. Hayton, for Nine Mile Church, \$25.00.

Offering for Sr. Winslow taken, amounting to \$10.00.

Offering for Dist. Sup.t—Moved and supported this offering be taken first thing after devotional services tomorrow night.

Report of J. H. Marcum read and accepted.

Report of Examining Board—We, the examining board recommend the following: J. S. Hayton for ordination; Harry F. Ensley for license to preach and Sr. Mary Riggs for deaconess license.—J. C. Brillhart, J. C. Wakefield, J. A. Fields.

Sr. Riggs—Moved and seconded that license be granted Sr. Mary Riggs as deaconess. Carried unanimous.

Harry Ensley—Moved and seconded that this Assembly grant preacher's license to Bro. Harry Ensley. Carried unanimous.

J. S. Hayton—Moved and seconded that this Assembly recommend the ordination of Bro. J. S. Hayton. Carried unanimous.

Moved and seconded that \$1.00 each be added to railroad fare for delegates attending the General Assembly.

Moved and seconded that we make up this deficit at this time. Offering taken amounting to \$9.20, the deficit being \$6.00.

Report of Committee on Resclutions—Moved and seconded that we have reading of entire report first and then take up report one paragraph at a time. Carried.

No. 1. Be It Resolved: That we, the 13th annual District Assembly of the West Virginia district, ask the called General Assembly to change the clause of paragraph 139, which reads: "And if it be known that a candidate for this office be a divorced person," to read: "And if it be known that a candidate for this office be a divorced person who is re-married."

No. 2. Be it further Resolved: That a ruling be inserted in the Manual of the International Holiness Church which shall prohibit anyone who

has been divrced and who is living in a state of wedlock with a second party, or one who is married to a divorced person, from being licensed or ordained to preach the Gospel in said church.

No. 3. Resolved: That the called General Assembly be asked to change paragraph 61, section 2, which reads: "He or his assistant shall without fail visit each church within the district at least once a year," to read: "He or his assistant shall, without fail, visit each church within the district at least quarterly; and if the district be too large for him to make the visits quarterly himself, he shall divide the same with his assistant alternately."

No. 4. Resolved: That the called General Assembly be asked to pass a ruling which shall cause the trustees of church property to constitute a part of the Advisory Board of the church.

No. 5. Resolved: That the called General Assembly be asked to devise and insert after paragraph 112, some method of procedure for church trial to guide Advisory Board in administering said discipline.

No. 6. Resolved: That this District Assembly create an office of District Missionary Secretary-Treasurer: That this Assembly elect some eligible person to fill said office: That his duty shall be to receive all missionary moneys of the district and forward the same to the General Missionary Secretary of the I. H. Church: That each church of the district, instead of forwarding their money to the General Secretary, shall forward it to the District Secretary, who shall forward the same for them.

No. 7. Resolved: That each pastor of the West Virginia District shall endeavor to raise a minimum of 50c a month per capita of church membership; said money to be applied to foreign missions, and to be raised separate and apart from missionary offerings taken in camp meetings.

No. 8. Resolved: That the West Virginia District Assembly ask the called General Assembly to draft uniform report blanks; a separate blank for each office, and that said blanks be suited to conform to the general needs of the church.

Adoption—Each of the above resolutions were adopted upon motion duly seconded and carried.

Missionary Secretary-Treasurer elected: K. C. Lawrence elected by ballot.

Moved and seconded that the Secretary write Bro. Lawrence advising him of his election and informing him of his duties.

Moved and seconded that this Assembly return a vote of thanks to the Huntington church for their royal entertainment. Carried.

Moved and seconded that the minutes of this Assembly be printed. Carried.

Moved and seconded that the money for printing minutes be taken from the State Treasury and that the pastors of the different churches make an effort to reimburse the treasury. Carried.

Moved and seconded that the Chair appoint a committee for having minutes printed and that the District Superintendent put his O K on said minutes before putting them in the hands of the printer for final printing. Chair appointed J. C. Brillhart and E. W. Miller.

Moved and seconded that the matter of blanks be left to the Resolution Committee. Carried (see resolution).

Moved and seconded that we extend time limit of session until all business is completed. Carried.

Moved and second that Bro. G. M. Cunningham be excused. Carried,

Moved and seconded that the Secretary make a copy of these resolutions and the ones passed in last Assembly for the Superintendent to take to the General Assembly. Carried. Moved and seconded to adjourn. Carried.

DISTRICT SUPERINTENDENT'S REPORT

TO THE THIRTEENTH ASSEMBLY OF THE I. H. CHURCH OF WEST VIRGINIA DISTRICT:

We are again assembled after one of the most strenuous years the church has ever had, yet God has helped us to gain some ground, but "There is much land ahead to be possessed." We are now beginning one of the most important assemblies we have ever held, for we must consider recommending to the General Assembly such changes to our manual as we feel would glorify God. I trust we shall do this prayerfully and in a God-fearing spirit.

In our last annual report we reported two new churches organized, one at Williamson and the other at Wayne. The church at Wayne has erected a new church building, has held three revivals this year and has paid more than two thirds of the indebtedness of their church. The church at Williamson has a good church building under construction. They now have it enclosed and expect to soon finish it. The church at Ft. Gay has started to put in the foundation for a new concrete church building 40x60 feet, which they expect to finish in time to have a revival in this winter.

During the year we have organized two new churches, on at Nine Mile, W. Va., and the other at Tolar, Ky. The church at Nine Mile is the Mission church Bro. Ash had charge of for a number of years and at their request we organized them into an I. H. Church and they gave us a warranty deed to the property.

The church at Tolar, Ky., is the result of our State Tent work under the direction of Bro. J. C. Wakefield, assisted by Bros. Hatfield and Baker. These brethren have done good work and have left a record behind them that they need not be ashamed of. As Tolar is just over the boundary line of West Virginia, the district superintendent of Kentucky suggested to me that we take this church in our district which we did and they will have delegates at this Assembly.

We were compelled to buy a new tent this year. The expense of the tent work has been very heavy and the offerings very light and there is now a deficiency in the State Treasury that must be met at once for we feel the laborer is worthy of his hire. The spiritual condition of the church in the district as a whole is very good with the exception of a few places where there seems to be a tendency to ease up a little to keep the good will of the world, but I am praying God will keep us too hot for the world.

We now have a membership of 375, an increase over last year of 29 mmbers. I feel we ought to urge on our converts the need of getting into a good spiritual church. Let us do this in the future.

The total valuation of our church property as reported in this district is \$86,834.75, showing an increase over last year of \$10,034.75. The indebtedness is about \$9,000.00.

Since our last Assembly I have visited each church in the district twice, giving them from two to three days each time. I have also visited the Tent work four times and have done what I could to help them. I have received as support for this work including my traveling expenses \$314.43. At the Assembly last year there was a resolution passed that each pastor should raise a sum equivalent to \$1.00 per capita of the membership of his church for the support of the district superintendent above the freewill offering that was to be taken on his visit to the churches. If any of the pastors have complied with the resolution I have not heard of it. A few individual members have handed me an offering saying it was for that purpose.

Shortly after the assembly last year Bro. Wolfe accepted the pastorate of the Ashland Heights church at Ashland, Ky., and has transferred his membership to the Kentucky district.

I want to call the attention of this assembly to our school at Kingswood, Ky. It is starting off this year with a large student body and a good faculty, with Bro. C. G. Taylor as president. They are contemplating putting in a heating plant this fall and need your prayers and help. As president of the board of trustees I have spent about nine weeks this summer in the Ohio and Indiana districts in the interest of the school trying to awaken our people to take care of their own work and see that it was supported.

During the year in my district, evangelistic and school work, I have traveled 10,194 miles, have attended about 450 services, preached 398 times; 458 have knelt at the altar and 234 have professed to be either saved or sanctified. I have received for support from all sources \$1570.99.

The Lord was pleased to give us a gracious time during the past year. Our school is of great interest. We have good teachers, obedient scholars and are spiritually advancing to a great extent.
