Held at Williamson, W. Va. October 9 to 14, 1923 The Fourteenth Annual Assembly of the Pilgrim Holiness Church convened at Williamson, W. Va., opened Tuesday evening, October 9, 1923, with a lively song service, followed by a refreshing spirit of prayer, led by Rev. A. R. Miller of Huntington, W. Va. The order of the following service was a platform meeting. Different ministers and delegates gave glowing testimonies after which an altar call was given to which five persons responded. Out of this number three claimed victory.

Moved and seconded that we adjourn. Carried.

#### FOURTH BUSINESS SESSION Saturday, October 13th

The fourth business session opened at 8 a.m. with devotional exercises consisting of singing No. 45 in "The Praise and His Glory" songs entitled "All I Need," and No. 78, "Pentacostal Power," followed by prayer led by Bro. E. F. Dirton, after which Bro. J. F. Woods read and commented on the 3rd chapter of James. Minutes read. Roll call.

Moved and seconded that a committee be appointed to have the minutes printed and that an offering be taken by each church during the month of October; also that the evangelists give an offering and from the offerings we reimburse the treasury and pay for this year's printing. Motion carried.

Motion to adjourn. Dismissed in prayer by Bro. Joy.

#### DISTRICT SUPERINTENDENT'S REPORT

To the Fourteenth Annual Assembly of the Pilgrim Holiness Church of the West Virginia District. I hereby submit the following

report:

Since our last Assembly we have again changed our name, but we have not lost anything in age, and I trust our children are still bearing the resemblance of our mother church, The Apostolic Holiness Church, both in looks and by their lives and that our preachers are still holding up before the world a topless heaven and a bottomless hell, and a Christ whose blood saves and cleanses from all sin. I have every reason to believe that they are doing this as I have come in personal touch with most all of them in my visits to the churches, and find they are seeking the old paths.

Since our last Assembly one of our preachers and one of our preacher's wives have preceded us to the Glory World, namely Bro. Rice Peters and Sister Reed, wife of Bro. B. C. Reed, of Fort Gay. Both of these saints left a glowing testimony that there was no dark river to cross, but that a convoy of angels was awaiting for them to escort them into the presence of Jesus, and that instead of darkness there was a great ray of light; death had lost its sting to them and they left this world shouting the praises of God. I recommend that there be a committee appointed to draft a resolution of condolence to this bereaved wife and husband.

After consulting with the State Council we placed Rev. Harry F. Ensley in charge of the State tent work this summer. He has been assisted by his good wife and Bro. Wilky Hatfield; also Sister Susie Miller has been with him since the State camp meeting held at Huntington. God has been blessing these workers this summer and as a result of their faithfulness under the guidance of the Holy Ghost we now have a new church at Ravenswood which we organized with a membership of 25. At this time we also took an offering of cash and pledges for the building of a new church to the amount of \$1,000.00

During the year I have dedicated two new church buildings in this district, one at Williamson and the other at Bramwell. Both of these edifices are well built and are buildings we need not be ashamed of. The church at Williamson cost approximately \$13,000.00 and the one at Bramwell \$10,000.00. At the time for the dedication of these churches each of them had an indebtedness of \$5,000, but God helped us to raise this amount by cash and pledges before we dedicated them. At Fort Gay they have been having a struggle getting their church building erected and have been very much discouraged, but are now pushing it to completion and expect to be able to worship in it before cold weather comes.

I have held six revival meetings in West Virginia since our last Assembly at the following places: Nine Mile, Hemphill, Naugatuck, Williamson, Fort Gay and Bramwell. I have also preached nine times for Bro. Ensley in the State tent, have visited each church twice and some of those that needed help I have visited oftener. During the

year I have attended about 460 services and have preached 394 times. The result of these preaching services were, 318 knelt at the altar. Just how many prayed through I do not know but the judgment will tell.

In my evangelistic and State work this year I have traveled 19,933 miles and have received for support \$2,030.23. My traveling expenses have been about \$600.00. This district has done more for my support this year than ever before as the following churches have paid all or part of their \$1.00 per capita for the support of the District Superintendent: Huntington church has paid last year's per capita tax and \$53.00 on this year's; Bramwell church and Logan church have paid all their per capita for this year, while Ona church has paid \$13.00 and Barboursville has paid \$3.00. My total receipts from this district including my evangelistic work and my traveling expense was \$915.31.

We now have a membership of 399, according to the reports I received from the churches, which makes an increase over last year of 24 members, but there may be an error as I see by our last year's minutes that the church at Fort Gay reported 40 members and this year they reported to me 27 members with a loss of one member during the year, and as we organized a church this year of 25 members I think they have made a mistake.

The total valuation of our church property in this district is as follows: Huntington church, \$61,000; Williamson church, \$15,000; Bramwell church \$10,000; Barboursville church, \$8,000; Logan church, \$5,000; Fort Gay church, \$5,000; Ona church, \$4,500; Wayne church, \$3,500; Nine Mile church, \$2,500; Tolar church, \$450; making a total of \$114,959, showing an increase over last year of \$28,124.25.

I want to call your attention as an Assembly to our state camp meeting which is held at Huntington each year. One of the objects in the minds of the Huntington church when they built the large church was to have a place where people could gather from all over the State once a year whether they were able to pay for their entertainment or not. They have always entertained those from a distance free giving those who were able a chance to make a free will offering. They have always endeavored with the State Council to get the best workers for this meeting. It is therefore a real treat for those who attend.

She had not been long with us until she began to advocate a church building and started a building fund and when some wanted to built some place outside of Bramwell because they could not get a lot in Bramwell, she would strenuously object, saying God would yet open a place in Bramwell, and He did and we give Him all the glory. Sister Hickman has practically given the best of her life for the work here. She has climbed the mountains administering to the physical and spiritual needs of the people of this vicinity until she has broken her health so that she was compelled to give up the pastorate five months ago and has not been able to do very much of anything since. We will never be able to express our gratitude to her or show our appreciation of her work for us. We have now called Bro. E. Joy for our pastor and are awaiting his acceptance of the call. We are expecting a good year next year.
