Moved and supported that, inasmuch as Brother J. C. District Superintendents report to the Fifteenth annual Assembly of the Pilgrim Holiness Church of West Virginia, in session at Logan, W. Va., Sept. 23 to 28 inclusive.

This has been a very busy year, a year which has taken much prayer and waiting on God, as there have been many perplexing questions come up for decision; one of which was one of our churches, after due notice had been given for two weeks by announcement from the pulpit that the annual meeting would be held on a certain night for the election of officers of the church, there was two less than a majority of the resident members present, the election was held, the result of which did not please some who were not present, an appeal was made to the district superintendent that the election was not legal; a quorum not being present according to paragraph 115 of the Manual.

I, therefore, recommend that a resolution be drafted by this Assembly and sent to the General Assembly to change paragraph No. 116, by adding: "It shall be announced two Sundays previous to the meeting; one-third of the resident members shall constitute a quorum".

I also recommend that there be a resolution drafted and sent to the General Assembly that we as the Pilgrim Holiness Church, go on record that we have no sympathy nor affiliation with the Ku Klux Klan.

Death has again invaded our ranks since our last Assembly by taking one of our pioneer preachers, Brother Frank Dirton; he was preparing to come to this Assembly when the master called him to the Great Assembly at four o'clock last Sunday morning.

Also our dear Brother Wakefield our District Treasurer, was bereaved by the loss of his precious wife who had stood by him and had counseled with him for years, both of these deaths were very sudden, but both of them were ready for the call having their lamps trimmed and burning. I recommend that a committee be appointed to draft a resolution of condolence and that a copy of the same be sent to the bereaved loved ones.

God has enabled us to put two tents in the field this year, having bought Brother Ash's tent for \$225.00; of this amount we have paid \$100.00, leaving a balance of \$125.00; this tent has been in and near Clarksburg and has been under the direction of Brother Welch and Brother Calbert Holstein this proved to be a hard field, but the workers were faithful and did their best.

The other tent was under the direction of Brother Hayton our State Evangelist this year, and was pitched first at Princeton and has been in that comunity all summer closing with the second meeting at Princeton with the result of a church being organized at that place with a membership of ten.

During the year there has been four churches organized in this district; one at Stringtown, one at Parkersburg, one at Jarrolds Valley and one at Princeton.

The church at Farkersburg has done remarkably well as they were only organized October 31, with nine members, they called Bro. H. F. Ensley as their pastor and under his leadership with the help of the Lord, they have erected a building for worship 40x60 feet at a cost of about \$7,000.00 including furnishings; of this amount they owe less than \$3,000.00. On Sunday, August 3, with a congregation of less than one hundred people the Lord helped me to raise the indebtedness and we then dedicated the building to the Lord. We also had the privilege of raising the indebtedness on a church building in Jackson, Ohio, on December 31, and of dedicating the same to our God. One church which we organized last year at Tolar, Ky., has affiliated with the Kentucky District.

During the year I have conducted and assisted in sixteen revivals and camp meetings in five different states, six of these meetings were held in this district as follows: Logan, Fort Gay, Wayne, Naugatuck, Bluefield, Parkersburg; also assisted in the District Camp meeting at Huntington.

I have visited each church twice this year and some oftener as the needs demanded, have also visited each of the tents in the field, I have attended 332 services and have prached 260 times, preached two funeral sermons; there were about 400 knelt at the altar and 254 professed to be either saved or sanctified.

I have traveled 10,132 miles, my traveling expense has been about \$300.00. I have received for support \$1,582.75.

RESOLUTIONS

We, the Resolutions Committee, submit the following resolutions:

1. Inasmuch as some other districts of the Pilgrim Holiness

Church have found ministerial conventions to prove themselves beneficial in bringing closer fellowship and harmony, among the brethren and blessing to the church where held.

Therefore, be it resolved, that we, the assembly of the West Virginia District, adopt a resolution to the effect that we meet at least once a year; the place of meeting to be decided by a vote of ministers and deacons. All ordained and licensed ministers and deaconesses and local preachers shall be members of this convention.

2. Whereas, it is usually difficult for a newly organized church to borrow money for the erection of a church building and, whereas, God's work is often hindered because of the financial strain therefore.

Be it resolved, that each church in the West Virginia District, raise an amount each year equivalent to one dollar per capita and this to be sent to the District Treasurer, the same to be deposited on a savings account in the bank for building purposes only, designated the Church Extension Fund.

Be it further resolved, that this money shall not be loaned without the approval of the District Council and then only when notes are given to be paid back at a given time, the money to go back to the treasury to be used only for building purposes.

- 3. Resolved, that Article 116, page 45, be amended by adding: "It shall be announced two Sundays previous to the meeting, one-third of the resident members shall constitute a quorum.
- 4. Resolved, that the office of the District Missionary Secretary-Treasurer be abolished.
- 5. Be it resolved that we amend Article 139, Page 54, to read thus: "And if it be known that a candidate for this office is a divorced person and who is living in a state of wedlock with another party, or who is married to a divorced person of such state, or vain, etc."
- 6. As there has been some discussion as well as question relative to a person obtaining a church letter and retaining it for different periods of times before depositing it in another church, be it resolved: We limit the validity of a church letter to six months, and if he or she being a minister will not adhere to such resolution, no recognition of his or her credentials shall be given after the expiration of such time.
- 7. Whereas there is some agitation to the effect that our general church school be removed from Kingswood, Ky., and making it a home for the aged, etc. Be it resolved, owing to the fact the school is now well under improvement, also it being centrally located, and is becoming prominent in the minds of many of our people, We retain it at its present location.
- 8. Inasmuch as the name of this church has been changed three times in less than nine years, which has caused some misunderstanding and making it difficult to obtain clergy rates, be it resolved, even though we do consolidate with other bodies of similar doctrine and belief, we retain our present name P H. C.

9. Whereas, the manual of the P. H. Church, in paragraph No. 101, puts the church on record against all oathbound societies, and whereas, it is curently reported and many believe that many holiness preachers have united with the Ku Klux Klan.

Therefore, be it resolved, that we, as the General Assembly of the P. H. Church hereby go on record, that we have no sympathy, nor affiliation with th Ku Klux Klan, nor any other organization that prescribes a man because of his color or his creed.

11. We recommend that the annual assembly of the West Virginia District be held the Tuesday following the Third Sunday of September and continue over the Fourth Sunday and that the Assembly year begin and close September 15; that all quarterly reports be made to end as follows: First quarter December 15; Second quarter March 15; Third quarter June 15; Fourth quarter September 15. That the annual reports to the Assembly be from September 15 to September 15, (with the exception of this year, which will begin Septemer 21 and end September 15.

We further recommend that the District Superintendent on his last quarterly visit to the churches, preside over the annual meeting of the church in connection with the District Superintendent meeting.

12. We recommend that the following resolution be sent to the General assembly.

There shall be regular monthly business meetings of the advisory board of the local church held the first week of each month at this meeting, the treasurer shall give an itemized report of all receipts and disbursements.

- 13. Resolved, that our District Superintendent, in co-operation with our District Secretary-Treasurer, arrange with General Missionary Superintendent for a Missionary from the field to go over our District and conduct a Missionary service in each of our local churches at least once a year.
- 14. Be it resolved, that each advisory board or building committee in West Virginia District, who may expect to build or purchase anything in relation to Church extension, which will necessitate the borrowing of money from the Church Extension Fund, shall hereafter meet for council in a body or by committee with the District Council of West Virginia District and they, together, determine the kind of tuilding or materials or other necessary things for church extension, as are found to be in keeping with the future possibilities of the development of the particular church.
- 15. Resolved, that Article 152, page 59 of manual be changed to read: "Three years" instead of "two years" to correspond with Article 174, page 64.
- 16. Resolved, that this, the Fifteenth Annual Assembly of the West Virginia District, do hereby express our appreciation of the hospitality of the Logan Pilgrim Holiness Church and wish to heartily

thank them for the same, and ask for a rising vote of thanks by delegates at the services Sunday morning.
