REPORT OF DISTRICT SUPERINTENDENT

To the seventeenth annual Assembly of the Pilgrim Holiness Church convened at Parkersburg, W. Va., August 31 to September 5, 1926. Dearly Beloved: Inasmuch as this is my first report as Dist. Supt., I realize it will fall very short of the splendid reports you have been hearing the past fifteen years; but I assure you I have done my best.

This has been the busiest year I have ever experienced in my ministerial life. Have had to face some very difficult problems but spent much time in prayer and feel that God has wonderfully helper us out.

I believee thru the co-operation of our pastors and preachers we have made some progress in the district this year. Have spent my entire time on the district. Have erganized two churches, althowe have not made a special effort in that direction but have endeavored to get our present churches on a good working basis.

Death has invaded our ranks since last assembly and taken away one of our pioneer preachers, our dead Erother G. M. Cunningham who slipped away last November. Brother Cunningham died on the battlefield after years of faithful service for God and souls. I am sure we miss him in our ranks. But he kept the faith and finished his course and Gcd said. "It is enough, come up higher." We recommend that the committee on condclence write a letter of sympathy to his widow. I have visited each of the churches four times except Ona, which I visited three times. We visited some of the churches several times. Visited the State Tent once at Dunbar while Sr. Hickman, Bro. Hayton and Sr. Hall were there, in meeting. Helped Sr. Hickman and Sr. Hope Patish in another tent meeting at Dana, W. Va. We organized a church as a result of this meeting. Have held and helped in six special meetings during the ten months of my labors on the district.

Have made 65 calls. Freached 175 times. Anointed and prayed with forty-three persons for healing. Had seventy four seckers. About thirty claimed to be sanctified and twenty-pre saved or reclaimed. Valuation of our church property in the state is\$128, 0.0.0 with an indebtedness of \$12 206.50. We feel in the translation of our beloved brother Cunningham, we have lost one of the most self-sacrificing preachers in our district. For more than ten years he Evangelized the mountains of West Viginia, holding meetings in school-houses, private homes, halls, tents and in the open-air. Often having nothing to eat only as he gathered wild berries or fruit. And no place to sleep but a school-house or tent in which he was preaching. But always cheerful and never seemed to feel that he was making a sacrifice.

He was especially gifted in music both instrumental, and vocal; and his singing and playing blessed thousands of people. One of his favorite songs was "It Won't be Long, It May be Soon."

While preaching in a school-house at Naugatuck, W. Va., he was taken ill and rushed to a hospital at Louisa, Ky. He walked up the steps, but a few minutes after entering the hospital he became unconscious and died in less than two hours not regaining consciousness. But left a glowing testimony before entering the hospital he was ready to go.
