JOURNAL OF PROCEEDINGS

Opening address by Dr. P. W. Thomas

FIRST SESSION

The Tenth Annual District Conference of Wisconsin Pilgrim Church convened at 9:00 a.m. August 18, 1965, at Burr Wesleyan Camp Grounds, Burr Ridge, Wisconsin, with General Superintendent, Dr. P. W. Thomas presiding.

The conference was opened by singing "Where Jesus Is, Tis' Heaven There", with Rev. Twining leading the singing. Miss Ethyl Jordan offered prayer.

The roll was called by Sec. Rev. Clinton E. Woods. Seven ministers and six laymen were listed on the roll; all were present and answered the roll call.

The Conference Bar was set at the first three rows of seats in Harmony Hall. William Blann made the motion to set the time of Conference sessions at 8:30 a.m. to 11:30 a.m. and 1:15 p.m. until business is finished. Carried.

Rev. and Mrs. James McMahon, supply pastor and wife of the Pardeville Church and Miss Ethyl Jordan, retired World Missions Missionary, were introduced to the conference and granted honorary seats within the bar.

Dr. Thomas presented Dr. Hawkins (upon his arrival) to the conference. Dr. Hawkins gave his well wishes to the Conference, and then turned the floor back to Dr. Thomas.

Dr. Thomas addressed the Conference. He used the scripture - Heb. 2:32-33. Dr. Thomas threw out the challenge: Is our best enough? He contended it was not. He challenged the Conference to be sharp shooters for the Lord, to go home and pull things to definite ends, and get something done for the Lord. Our definite should be spiritual. We should spend more time in prayer, sacrifice, and practical devotion. In our work for the church, we should reach more souls for the sake of fellowship, beginning with the children and young people. The challenge to get all reports in on time, along with definite plans to meet financial goals was presented. He stated that money represents time and energy, all we have belongs to God. The churches should be kept in good repair, clean, and in good order. This can all be done by Faith in God and the Gospel message; by faith in ourselves and each other. He then concluded by set, g, "The Lord will win the battle, God said, 'I will build my church and the gates of Hell shall not prevail against it.' The Conflict has to be won in our own souls."

The message was concluded by prayer and the singing of "I'll Live For Him."

Rev. W. R. Dudley, District Superintendent, gave his report, which was received and adopted with warm words from Dr. Thomas and the Conference.

Rev. W. R. Dudley presented the "Waging War Report" and Pattern of Progress.

William Blann made the motion that we bring the Pattern of Progress to the ministerial meeting as suggested by Rev. Dudley. Rev. Johnston seconded the motion, and there was discussion of the same, with the motion being carried.

The Conference Action Committee Report was read by Mr. W. A. Blann. This included the adoption of The Pattern of Progress, Waging War, and the proposed budget.

Upon expiration of time, the first session was adjourned.

Second Session

Dr. Thomas called the second session of the Conference to order at 2:30 p.m.

The minutes of the first session were read and approved.

The Report of the Memorials Committee was read by Mrs. Clinton Woods, Mrs. William Blann, and Miss Nancy Dudley. The report was then adopted.

The Memorial service was opened by the singing of the humn, "What a Friend We Have in Jesus". Prayer was offered by Rev. Clinton E. Woods. The scripture was read, after which Rev. M. W. Twing sang a solo entitled "Each Step I Take". The report was accepted and received by the standing and singing of "Shall We Gather at The River."

Recess

The Second Session was reopened by a message from Dr. Hawkins. This was a stirring message on "Ye Are My Witnesses". He spoke on making our witness appropriate and meaningful. He stated that the Bible is the authority of all things. We live in a troubled world and we should always be prepared to give our witness to any needy soul. One way this is done is by the way we face our troubles. With God on our side, no one can stop us. He admonished the Conference to live so that people will see Christ in their lives. Project your lives to others through your personalities. At the close of the message, the hymn "Let the Lower Lights Be Burning" was sung by everyone.

To our esteemed General Superintendent Dr. P. W. Thomas, Secretary of Church Extension Dr. R. C. Hawkins, distinguished delegates and guest:

We have met for the grand occasion of the 10th Annual Conference of the Wisconsin District. We reflect on the past with gratitude for the manifold blessings He has bestowed upon us.

In my close association with you I have learned to love and respect you. I sincerely thank you for your labor of love that has made the progress of the Church possible. May God reward you richly and grant you a successful future.

The District Council members have given generously of their time and talent in the planning and operating of the District. Thank you and may God reward you richly for your faithfulness to this responsibility.

I thank God for the high caliber and definitely spiritual men who served on the District in Camp Meeting and Revival. Thank you Dr. William H. Neff, Rev. David Keith, Rev. M. W. Twining and Rev. Jerald Lavy.

The Missionary Societies have made fine contributions to many of the World Mission's project and have also provided many of the meals for the Camp Meeting. Many thanks to

the Missionary Society President and the ladies of the Societies in the local Church.

I appreciate the work of the Sunday School Promotional Sceretary. Thank God for the gains that have been made this year.

Many thanks to the District Youth President for providing a good spiritual program for our District Youth. The Youth Camp and New Year's Eve Banquet and Watch Night Service were highlights in the Youth Program of the year. I appreciate Rev. O. D. Emery taking time out of his busy schedule to be the speaker for the New Y ear's Eve Banquet.

In my visits to the Churches I am impressed with the spirit and quality of the fine laymen God has allowed us to fellowship. I thank you for the fine contribution you you make in interest, time and finances to keep your Church going. May God frant that your number double during the next quadrennium and the blessings of God be commensurate with the increase.

PROGRESS

Thank God, this year has shown some gains in Sunday School Attendance and Church Membership. God has helped us to overcome some of the financial deficit. The spirit of revival was manifested in the Camp Meeting and in several of the Churches during the year.

The Exeland Church has taken steps to improve the plumbing system at the parsonage. They are planning to regrade the ground around the Church in order to keep the water from soaking through the wall. The Hillsboro Church has improved the Church and parsonage by redecorating the interiors. Plans are in hand to put in a new front entrance. The Milwaukee Church has improved the Church by installing a gas conversion unit in the furnace and installing new doors at the front entrance. Plans for further improvments include a new roof, additional radiation in the Sunday School rooms, interior and exterior painting. The Pardeeville Church burned to the ground on December 9, 1964. They are to be congratulated on the fine way they have rebuilt and furnished their Church. They are looking forward to dedicating the new Church Building this Fall. The Sheboygan Church has improved the basement by paneling the walls around the front and rear stairs. The Sparta Church is in good repair and has not required additional building. The statistical report will reveal their progress along with the other Churches, for we have not made mention of gains in membership and Sunday School in my report.

PLANNING

I present for your prayerful consideration a program for progress: "WAGING WAR". It is my prayer that you will take it and adapt it to your Church and God will help you to work it to His glory and the increase of His work.

WAGING THE WAR

A PATTERN OF PROGRESS TO BE IMPLEMENTED DURING THE 1966 - 1970 QUADRENNIUM.

There is no easy way to wage the relentless warfare that is Church Extension. Still

it is a great honor to be in God's Army. To endure hardness as a good soldier ia one mark of deep devotion to God and dedication to our task.

This is an offensive warfare. We are to win souls, lead them into the way of holiness and on to Christian maturity and thus advance the work of God. This is intensive warfare that requires our best. The wresting of territory from the enemy is an ardous task, but we are assured of Divine leadership and Divine strength that will enable us to win the war. The systematic method to wage this offensive warfare during the coming quadrennium follows:

- I. WAGING WAR ON OUR KNEES
 - 1. Essentially a spiritual warfare.
 - 2. Develop the devotional life of the Officers & Members.
 - 3. Develop meaningful Prayer Meetings.
- II. WAGE WAR TO ENLARGE YOUR CHURCH
 - 1. Build road around those of small potential.
 - 2. Enlarge those with good potential.
 - a) Provide adequate housing for future.
 - 3. Enlist the best possible Captains (Laymen).
 - 4. Plan for a well fed army (ministry of edification).
 - 5. Draft new recruits.
 - a) Organize CYC.
 - b) Lay visitation in every Church.
 - c) Reach for the men.
 - d) Increased emphasis on Sunday night evangelism.
- III. WAGE WAR FOR PROSPERITY
 - 1. Set up an annual budget in your Church.
 - 2. Check on it every month.
 - 3. File a copy of the budget with the District Superintendent.
- LV. WAGE WAR OF PLANNED AGGRESSION
 - 1. Make each service meaningful, and have a planned purpose.
 - 2. Regular monthly meetings:
 - a) Official Board.
 - b) Sunday School Board.
 - c) Sunday School Workers Conference.
 - 3. Achievement goals:
 - a) Keep them in tip-top spiritual condition.
 - b) Aid them with problems.
 - c) Inform them of Church matters.
 - d) Inspire them to achieve.
 - 4. Systematic reports:
 - a) Regular monthly reports from each department of the Church.
 - b) Pastor give written report to the District Superintemdent by the 10th of each month.
 - c) District Superintendent send compiled report to Church Extension Secretary by the 25th of each month.
- V. WAGE WAR ON SPECIFIC BATTLE FIELDS
 - 1. Plan carefully each area of attack. leave nothing to "chance".
 - 2. Each Church strive for the following goals:
 - a) 10% annual membership increase.
 - b) 10% annual Sunday School attendance increase.

c) Bigger and Better Young Peoples Society.

d) Bigger and Better Missionary Society.

e) $Bi_{\ell \in E}$ er and Better Mens For Christ Fellowship.

IN MEMORY OF

Otto Brossman was born to earthly parents, Emilie and Herman Brossman, March 20, 1894, in Milwaukee, Wisconsin.

He was 'born again' April 19, 1951 - the first convert in the first revival held during Dedication Week at the Milwaukee Pilgrim Church. His conversion was genuine, and lasting. His life was completely changed and all who knew him, knew him as a new man. His life was exemplary. STANDING RULES

Section I Sunday School and Youth

1. The offerings taken at District Sunday School Promotional Meetings shall be sent to the District Treasurer. It is to be expected that these offerings adecuately cover the expenses involved (\$10. min. ave. per meeting.) (1962)

2. Each Church in the District shall contribute one of its Sunday School offerings semi-annually to the expenses of the District Sunday School Board. This fund will cover the cost of the following items:

A. Purchase of reference books and magazines subscriptions for the use of the District Sunday School Board.

B. Correspondence, report forms, and mailing expense to the churches in the district.

C. Travel and expenses of the promotional secretary to meetings of the National Sunday School Association within the State of Wisconsin, and to our National Sunday School Leader's Conference. (1961)

Section II Camp Meeting

1. The Camp Meeting Board shall be composed of the District Council. (1958)

2. Retired Pilgrim Ministers and their wives shall be given concessions due to the regular ministry; such as reduction of rates during camp meeting, etc. (1959)

Section III District Superintendent and District Council

1. A meeting shall be held by the District Supt. each September to familiarize the ministers of the District with the current program for the new year. (1959)

2. An installation service shall be conducted by the District Supt., or someone appointed by him, for each incoming pastor to a local church within the district. (1958)

3. The District Supt. shall appoint all committees. A list of appointments shall be submitted to the District Council for approval. (1958)

4. All evangelists within the church and also all Christian workers that represent works outside our denomination, shall be approved by the District Council or the District Supt. before conducting services in our churches. (1956)

5. The District Supt. shall be chairman of the Educational and Examining Board. (1958)

6. An offering shall be received by the churches at the visits of the District Supt. This amount is to be sent by the local treasurer to the District Treasurer in addition to the budget. It is to be expected that these offerings

adequately cover his traveling expenses. (1958)

7. All District Officials shall be paid travel expense at the rate of 3ϕ per mile, plus meals when traveling for District work approved by the Council. (1958)

c

8. The District Treasurer shall pay the conference contribution to the Pilgrim Pension Plan for the District Supt. (1958)

9. The District Treasurer shall reserve 5% of the District Budget for covering the expenses of the Delegates to the General Conference. (1958)

10. No assessment shall be livied against the Churches without the consent of the District Conference or Council. (1958)

Section LV Business Practice

1. Each Church shall be required to have adequate insurance protection, includingpublic liability. (1958)

2. Three members of the District Council shall be appointed by the Council to be the District Trustees. (1958)

3. The local church treasurers shall balance their books at the end of gach month and forward all District and General funds immediately to the District Treasurer, (1958)

4. The District Supt. and the pastors of our churches shall be given two weeks vacation with pay. (1958)

5. Pastors shall be limited to 15 days away from their respective fields in revivals unless approved by the Destrict Council. (1958)

6. All plans for building, remodeling, or financing of any construction to cost in excess of \$500. shall be submitted to the District Council for approval before construction is begun. (1958)

7. Unorganized churches may form a Pilgrim Fellowship. (1958)

d. All unstationed ministers shall submit annual reports to the District Supt. and Statistician. (1958)

9. A Conference Action Committee of 5 members shall bring all matters of legislation and finance to the conference. They shall meet one month prior to conference and send a copy of all proposed action to Pastors to be presented at his local church. (1958)

10. All Committees and District leaders shall submit to the District Sec. by September 15, the dates of planned conventions, rallies, etc.; these and other dates of importance shall be included in the calendar of events to be compiled by the Secretary and distributed to each pastor. (1959)

11. The District Supt. shall appoint a District Reporter to provide news coverage regarding District and General Church activities. Articles shall be written in best form possible and shall be approved by the District Superintendent.

Copies of news articles shall be given to each paster for his local newspaper. (1959)

12. In the election of church delegates to the District Conferences, specific consideration shall be given the following:

a. He shall be able to properly represent his local church in any conference action.

b. The local church shall instruct the delegate with regard to any proposed conference action. (1959)

13. The District Treasurer shall be bonded. (1958)

14. The Fiscal Year for the District shall be April 1, to March 31.

Section V. Memorials and Memoirs

1. The Memorial committee shall be also the memoirs committee, and shall pay tribute to those of our membership who have deceased during the conference year. (1958)

Section VI Conference Journal

1. All district resolutions shall become standing rules on year after their adoption, and the date shall be inserted parenthetically. (1958)

2. The Conference Action Committee shall meet before publishing the official minutes in order to advise with respect to the portion pertaining to the standing rules and the report of the said committee. (1960)

Section VII Special Pastoral Duties

1. Each pastor shall teach a class in Manual for all new members or other members of his church who have not had the opportunity to attend such a class previously. This class is to be offered at least once a year. (1958)

Section VIII Budget

1. The local church assessment for District expense shall be 5% of all local church offerings. This amount shall not include Sunday School offerings, Building Funds, Evangelistic or other Special offerings raised for General Church purposes. (1960)

2. The local church District assessment (5% of the regular offerings) and special offerings received for District operations, is not always adeouate to cover all of the cost incurred; in order to distribute income equitably, be it resolved that the income from these sources, be disbursed on the following percentage basis:
