Journal of Proceedings.

FIRST BUSINESS SESSION.

West Terre Haute, Ind., Oct. 6, 1914.

The eleventh annual convention of the Apostolic Holiness Church of Indiana convened in the A. H. Church of West Terre Haute, Ind. The business session opened with song and prayer at 2:30 p. m, Oct. 6, 1914, W. J. Crider in the chair. The office of the State Secretary and Treasurer being vacant because of their absence a motion was made and seconded that the chair appoint officers pro tem to fill these vacancies. H. W. Cochran was appointed Secretary and L. A. Mathers Treasurer.

After the enrollment of preachers and delegates, regular business was taken up. Voted that first three rows of chairs and side chairs as far back as third row be reserved as conference bar.

Moved, seconded and carried that chair appoint all committees. Committees appointed. Resolutions Committee, Mrs. Gertrude Davis and Miss Hester Bowman. Finance Committee, J. W. Williams, L. A. Mathers and Earl Davis. Auditing Committee, James Booth and R. E. Clegg.

Moved and seconded that the convention provide for the expense of publication of the minutes of the convention. Carried.

Moved and seconded that we adjourn to meet again Wednesday, Oct. 7 at 9 o'clock a. m. Carried.

SECOND BUSINESS SESSION.

Second business session, Oct. 7th. Opened with song and prayer. After the roll call and reading of the minutes of last session, preachers, delegates and visitors who lately arrived were asked to enroll.

The question of a State Camp Meeting for the coming year was taken up and discussed. After the discussion a motion was made and carried to combine the State Convention and Camp Meeting.

Moved and carried that instead of calling a special evangelist for our camp meeting, our own workers do the preaching and that the State Superintendent appoint the preacher for the hour.

On motion it was decided to table the question of location of State Camp Meeting and Convention.

Moved and seconded that State Officers be elected Thursday morning, Oct. 8.

Moved and seconded that State Superintendent investigate all Church deeds and in case of dissatisfaction advise that they be made over and that a copy of each deed be recorded with our State Secretary.

On motion made and carried the convention adjourned to meet again at 2 p. m.

THIRD BUSINESS SESSION.

Third business session, Oct. 7, 2 p. m. Meeting opened with song and prayer, a sweet spirit prevailing over all.

The newly arrived preachers, delegates and visitors were asked to come forward and enroll.

After the roll call the minutes of the last session were read and accepted.

Moved and seconded that the matter of location of the State Camp Meeting be lifted from the table. Carried.

A motion was then made and carried that the Chair appoint a committee to act in conjunction with the State Superintendent in relation to appointing time and place of State Camp, their action to be submitted to the convention for their approval or rejection.

As some of the delegates were expecting to leave, the following Church reports were heard at this time.

Nelson Chapel Church of New Philadelphia, Ind.—Bro. Harry Holden has been our pastor the past year; have regular preaching services once a month. Have had one revival and one tent meeting, held by our State Evangelist, H. W. Cochran, in which some were saved and sanctified and the Church was strengthened and the prospects for the future look better. We appreciate the work done by our pastor and are praying for a time of victory this year.

In connection with the other services of the Church we have held eighteen prayer meetings. Amount of money raised for the pastor and other expenses of the Church, \$199.69. Offering for convention expenses, \$1.75. R. E. Clegg, Delegate.

Newton Stewart, Ind. Report of Church to the Eleventh Annual Convention of the Apostolic Holiness Church of Indiana, held at West Terre Haute, Ind.—H. L. Holden, Pastor. Present membership, 17. Held one revival during the year; one conversion and one sanctification. Amount of contributions, \$90.00. Paid to pastor, \$50.00. Paid to evangelist, \$30.00. Amount for incidental expenses, \$10.00. We have a Sunday School of enrolled members, including teachers and officers, of 35. Use Apostolic Holiness literature. Total offerings for quarter, \$4.88. Total expenditures, \$3.75. Balance in treasury, \$1.13. Church sends \$2.00 towards convention expenses. G. T. Spears, Delegate.

Brownstown.—Church organized Aug. 18, 1914, with the following members and officers: Elijah Pruitt, clerk; Chas. Hammond, treasurer; Wm. Hammond, elder; Grace Hammond and Mary Pruitt, deaconesses; Annie Bennett, Marie Bennett and Bessie Corbet. Held one revival, with the following results: 14 saved and 3 sanctified. Amount of offerings, \$48.00; expenditures, \$48.00. We have no Church building at present, but are taking steps to build. Amount given by subscription toward building, including both money and lumber, \$330.00. The outlook for the future is good. Are trusting God for victory. Elijah Pruitt, Delegate.

College Corner.—Have been without a pastor most of the year. Bro. Hans Sweeder came to us towards the latter part of the year. Present membership, 11. Spiritual condition poor. Have held two revivals and one tent meeting during the year. Five professed conver-

sion. Amount given towards pastor's support, \$66.65. Amount of Church debt, \$340.00. Amount paid on Church debt, \$10.00. Amount of Church expenses, \$26.11. Balance in treasury, \$5.50. Have a Sunday School of an average attendance of 18. Amount of S. Schcol collections for the year, \$14.43. Amount given to foreign mission, \$7.00, sent to Bros. Shirley and Joy in Africa and \$5.00 to South America. Balance in S. School treasury, \$3.28. Amount sent as convention offering by Church, \$2.03. H. Sweeder, Pastor and Delegate.

Jasonville.—Spiritual condition good. We held two revivals during the year and one tent meeting. Bro. W. J. Crider held the two revivals, in which there were six that professed to be saved and sanctified. Bro. Crider, assisted by Bro. and Sister Earl Davis, held the tent meeting, in which there were 18 professed to be saved and sanctified. During the remainder of the year there were 18 more professions of conversion and sanctification, making a total of 42. Number of accessions to the Church, 29. Dismissals, 1. Total membership at present, 54. We held one all-day meeting at Eel River and at the close of the afternoon service 20 were buried in baptism. We call for the State Camp Meeting combined with the convention next year. We ask that our present pastor be returned. Treasurer's report—Total tithings and collections, \$503.47; paid for evangelistic service, \$151.93; for missions, \$9.50; towards convention expenses, \$5.00; towards pastor's support, \$84.83; for general Church expenses, \$194.45; total, \$449.71; balance in treasury, \$54.76. Sunday School report—School in good condition; average attendance, 75; total collections, \$48.08; total expenditures, \$37.67; balance in treasury, \$10.41. Grover Bemis, Delegate.

On motion the convention was adjourned at this time to meet again at 8 a. m. Thursday.

FOURTH BUSINESS SESSION.

Oct. 8th, 8 a. m. Meeting opened with song and prayer. The spirit of the Lord was manifestly present. The new arrival of delegates were asked to enroll, after which the roll was called. The minutes of the last session were then read and approved. The convention proceeded then to elect officers for the ensuing year.

Moved and carried that Chair appoint tellers. The following were appointed: R. E. Booth and J. W. Williams.

The result of the election was as follows: State Superintendent, W. J. Crider, Orleans, Ind.; Assistant Superintendent, H. W. Cochran, East Enterprise, Ind.; State Secretary, James Booth, Jasonville, Ind.; Treasurer, L. A. Mathers, Orleans, Ind.; Earl E. Davis, Mrs. Earl E. Davis, Orleans, Ind., and Floyd Honchell, English, Ind., Advisory members.

Moved and carried that we elect the same number on Foreign Missionary Board as heretofore. The following were elected: L. A. Mathers, Miss Maud Shirley and E. E. Davis, Orleans, Ind.

Moved and carried that Chair appoint State Evangelist and State Missionary Evangelist. H. W. Cochran was appointed State Evangelist and E. E. Davis and wife State Missionary Evangelists.

Moved and carried that Chair appoint three candidates for examining committee on course of study, afterwards to be elected by vote of convention, to serve, one for one year, one for two years and one for three years.

The election resulted as follows: E. E. Davis elected to serve for one year, James Booth for two years and H. W. Cochran for three years.

Moved and carried that Chair be a permanent member of the examining committee.

On motion made and carried the convention adjourned to meet again at 2 o'clock p. m.

FIFTH BUSINESS SESSION.

Oct. 8th, 2 p. m. The fifth business session was called to order by the Chair. After prayer the roll was called. Newly arrived delegates were enrolled, after which the minutes of the last session were read and accepted.

Regular business was then taken up. Moved and carried that our next Annual Convention, which was voted to be held in connection with the State Camp Meeting, be held at Jasonville, Ind., with free entertainment, and that entertainment to be provided for by offerings and donations for our several Churches.

The Chair then called for a report of the Camp Meeting Committee. The committee reported their decision as to the time for the Camp Meeting and Convention, Aug. 20-30, 1915. The report was accepted. Moved and carried that L. A. Mathers have 300 copies of the minutes of the convention, now in session, printed.

Moved and carried that Chair appoint committee to edit minutes for publication.

The following Church reports were then heard and accepted:

Muncie, Ind. Report from Oct. 29, 1913, to Sept. 20, 1914. Spiritual condition not so good as it has been, but improving. We have a few faithful ones that are really holding onto God and going through with Him. We rent our building at \$6.00 per month, but are taking steps to build and have on hands for the purpose of buying a lot \$94.40 and subscriptions to the amount of \$60.00. Total, \$154.40. We hold five and sometimes six services a week. We have taken in 12 new members during the year, making our membership 34. Number of Church Board meetings held during the year, 10. The morning and evening offerings have amounted to \$293.96; paid out to pastor, \$165.81; for miscellaneous expenses, \$119.55; for convention expenses, \$6.00; total, \$291.36; balance in treasury, \$2.60. We have a Sunday School of an average attendance of 49; average collection, \$1.16. Amount sent to foreign missions from Sunday School, \$7.50. F. M. Stewart, Delegate.

Terre Haute, Ind.—Report of the Apostolic Holiness Church of Terre Haute. Church has been in pretty bad condition. Have had several seekers at the altar, but they did not stand long. Have had three Church meetings. What few members we have left are clean and we are praying since we changed our location that God will bless and give us souls. We have a good pastor, who is doing all for us he can. Report sent in by Mrs. Ida Kelley, Secretary.

Medora, Ind.—As far as number is concerned we are not in as good condition as we have been, as the Tongue people captured some of our number and we dismissed them. Our present membership is 13, but with the few we have left we feel that we are in better shape

spiritually than ever before. We own our Church building, but are not quite free of debt. Amount of indebtedness, \$14.95. We have had preaching every two weeks when possible. There has been a few souls prayed through to victory during the year. Amount paid to pastor, \$61.04; for incidental expenses of the Church, \$56.65. Amount in treasury at present, \$36. Our Sunday School is not so large as at the beginning of the year, our average attendance for the year being 44. Contributions received, \$25.32. H. L. Holden, Pastor and Delegate.

Madison, Ind.—Spiritual condition of the Church fair. Number of members, 40. Have paid out during the year for evangelistic services, \$250.00; for incidental expenses, something over \$370.00, and have given to foreign missions something over \$22.00. Have a good Sunday School of an average attendance of 55. Floyd Honchell, Delegate.

Sparksville, Ind.—The spiritual condition is good. We have held one meeting in which two were saved. We own our Church property, which was dedicated July 4th, 1914, by Rev. M. G. Stanley of Cincinnati, Ohio. At the time of dedication we raised \$43.00 in cash and \$90.00 in pledges towards the indebtedness of the Church. Have taken out three shares in the building and loan, leaving us \$300.00 in debt. Our present membership is 10. Amount paid towards pastor's support, \$17.00. We have a Sunday School in good condition and an average attendance of 39. God has blessed us in our work this year and our pastor has labored faithfully with us. We are trusting God for better things in the future. H. L. Holden, Pastor and Delegate.

On motion the convention was adjourned to meet again Oct. 9th, 9 a. m.

SIXTH BUSINESS SESSION.

Oct. 9th, 9 a. m. Sixth business session opened with praise, prayer and song. A wave of glory swept over the assembly and our hearts were made to rejoice. Thank God for Old Time Salvation, that gets ahead of form and programs once in a while. After roll call and enrollment of those lately arrived, the minutes of the last session were read and accepted. Regular business was then taken up. Chair called for reports of committees. Committee on resolutions reported. Chair reported the following appointments: L. A. Mathers, and W. J. Crider, editing committee.

Moved and carried that State Treasurer be given an order to pay L. A. Mathers \$10.00 for money which he forwarded State Superintendent to meet obligations recommended by the convention held at Orleans, Ind., Oct. 7-12, 1913. The following Church reports were then heard.

Grantsburg, Ind.—Spiritual condition not so good as has been. This has been a year of testing. During the year about eight of our members were either dismissed or withdrew, leaving us a membership of 35, most of which seem to be in good spiritual condition. Had one revival during the year, held by H. W. Cochran. Bro. Cochran done some excellent preaching at this and other times that he was with us, but while there was lots of conviction there were only three that prayed through definitely during the year. Financial condition good. Church out of debt. Amount paid to foreign missions during the year: To Sister Pearl Denbo, China, \$67.00; E. D. Joy, South Africa, \$5.00; James M. Taylor, South America, \$10.00; Bros. Cowman and Kilburn, Japan, \$4.00; total, \$86.00. Expenses on Church, \$6.00, for stove. Sent

This was formerly a P. H. U. as we had and abstract will show

\$1.00 to Sparksville, Ind., towards indebtedness of their Church. Paid out \$110.00 for evangelistic services. Amount in treasury, \$42.77. Also sent \$5.00 for convention expenses. Our Sunday School is not large in attendance, but spiritual. Average attendance of school, 25. Amount in treasury, \$7.93; in missionary treasury, \$7.74. Nannie J. Austin, Delegate.

Mitchell, Ind.—Have been without a pastor a good part of the year and have not made the progress that we possibly would had we had a pastor all the year. Bro. C. S. Driskell served as pastor for a part of the year, during which we had preaching every two weeks. We own our church property, valued at about \$1,000.00, with an indebtedness on it of \$99.69, but have on hands toward indebtedness \$36.55, which will leave \$63.14 debt. Amount paid into the treasury during the year, \$239.67. Disbursed as follows: To Bro. Driskell, \$148.49; to Daniel Taylor, \$3.18; to Sister Katie Robinson, \$3.81; to Bro. Sr. Davis for evangelistic service, \$29.37, and for running expenses of Church \$54.82. We have a Sunday School of an average attendance of 50 to 55. Amount taken in between Dec. 28, 1913, and Sept. 27, 1914, \$14.90. Paid out, \$12.25. Amount in treasury, \$2.65. Henry Clouse, Delegate.

East Enterprise, Ind.—Report of Fair Mt. Church for year ending Sept. 27, 1914: The Church loves the uncompromising truth. Miss Bowman has been our pastor the past year. We hold weekly prayer meetings at the Church, prayer meeting on Saturday night in our camp meeting tabernacle during the summer and cottage prayer meetings during the winter. We own our Church building. Have installed a new light plant this year, at a cost of \$22.00. The Church has raised \$12.51 as missionary money. Have sent \$3.00 to Japan, \$6.00 to Africa and have \$3.00 in the treasury. Paid to pastor, \$115.91. Have received two members into the Church during the year. Held one revival in the Church and a ten days' camp meeting. The Church is satisfied with the pastor. She has been loved by the Church, and God has wonderfully blessed in the services. We are asking God to send the one as a pastor next year that will glorify Him. Report sent in by Mrs. Mary Moreillon, Clerk.

New Castle, Ind.—We would be glad if we could send a delegate to the convention, but it is a hard pull to hold the Church together financially, as some of our best paying members have pulled away and our rent is \$30.00 a month. Our present membership is 24, including children; therefore it makes it hard for us to get started. Report of Church treasury: Total amount of cash received by the treasurer, \$694.47; paid out as follows—for miscellaneous expenditures, \$95.56; for rent, \$240.00; to State Superintendent, \$12.65; to evangelist, \$78.09, and to pastor, \$262.31; balance in treasury, \$5.86. We owe one month's rent of \$30.00, leaving a deficit of \$24.14. Report by Church Clerk, J. W. Blansett.

Middletown, Ind. Mount Zion Church.—This Church was organized Feb. 1, 1914, by Rev. Plen Smith, with a membership of 15. We own our property, valued at about \$600.00, free of debt. Spiritual condition fair. We have had one revival and one tent meeting, in which a number of souls were saved and some sanctified. "And the End is Not Yet." Glory to God, for souls are still praying through and finding God. Expenses of the Church during the year have been near \$175.00. We have a good Sunday School of about 30 as an average attendance. Our school uses the Apostolic literature. This Church has lately set aside a certain offering every month for foreign missions and has appointed Bro. Wm. McPheeters as Missionary Treasurer. We have

preaching every two weeks, prayer meeting at the Church every Wednesday night and cottage prayer meeting every two weeks on Sunday night. Parie Joslyn, Delegate.

Orleans, Ind.—Spiritual condition of the Church fair. Present membership, 48. Have had one revival during the year, conducted by L. W. Stanley and daughters of Cincinnati, Ohio, in which there were several converted and sanctified. Rev. C. S. Driskell has been our pastor. For a part of the year he divided his time between this place and Mitchell, but later devoted his time all to this place. Church treasurer's report: On hands at beginning of the year, \$9.00; received in offerings for pastor, \$345.84; for evangelist, \$119.42; for current expenses, \$113.00; total, \$587.26. Disbursements: To pastor, \$345.84; to evangelist, \$119.42; for current expenses, \$116.70; total, \$581.96. Balance in treasury, \$5.30. Sunday School report: Have a fairly good Sunday School of an average attendance of 38. We use the Apostolic Holiness literature. Have set aside the offerings of the last Sunday of each month for foreign missions. Amount raised for foreign missions during the year, \$33.86; for current expenses, \$21.50. L. A. Mathers, Delegate.

By motion the convention adjourned to meet again at 2:30 p. m.

SEVENTH BUSINESS SESSION.

Seventh business session opened with prayer, followed by roll call. Reading of the minutes of last business session heard and minutes adopted. The committee on examination then recommended the following applicants to the convention for license to preach: Miss Maud Shaw of West Baden, Ind.; Miss Gertrude Robinson of New Philadelphia, Ind.; Harry Nelson, Coalmont, Ind., and Grover Hayhurst, Pimento, Ind. The convention adopted the action of the examining committee and licenses were granted as recommended.

Moved and carried that the convention make the State Superintendent a present of \$15.00.

Moved and carried that the dishes bought by the West Terre Haute Church to be used in entertaining the convention be purchased by the State Convention and kept for use in the State Camp and Convention. On motion made and carried the convention was adjourned to meet, the Lord willing, at Jasonville, Ind., Aug. 20-30, 1915, in connection with the State Camp.

The session was closed by singing "Praise God From Whom All Blessings Flow." The preachers, delegates and visitors had an old fashioned hand shake. Truly we could say, Behold, how they love one another. H. W. Cochran, Secretary Prot.

Report of Committee on Resolutions.

We, your committee on resolutions, in behalf of this convention do hereby express our appreciation and extend our heart-felt thanks to our State Superintendent for his faithfulness and self-sacrificing service in all departments of the office which he has filled, and also to his devoted companion, who has so nobly stood by him in sharing the burdens that have fallen to them in the duties of said office, and since the convention has deemed best to re-elect him to said office for the ensuing year, we, as a convention, pledge to them our hearty co-oper-

ation, praying that the Lord may continue to bless their labors as He has so graciously done during the past year.

Resolved: That this convention extend a vote of thanks to the pastor, members and friends of the A. H. Church of West Terre Haute, who have shown such great kindness and hospitality in the entertainment of the ministers, delegates and visitors who have attended this convention.
