## MINISTERS REPORTS

I have pastored two churches the entire year, Rush and Boltsfork. Rush church is in a good spiritual condition. Boltsfork is not doing as well as we would like to see it, but has a few spiritual members. I have supplied two other churches a part of the year, namely, Willard and Summit. Have built a church building at Summit costing about \$800.00. \$230.00 indebtedness. Organized with eight members. In addition to my pastoral work. I have assisted in nine revivals, viz: Boltsfork, Ky., two times. Summit, Ky., two times. Amhurstdale, W. Va., Hitchins, Trace, Rush and Elkhorn City, Ky. Some of these meetings were good and some were hard battles. All of them had some seekers and some obtained salvation. Preached 161 times. Number saved and sanctified, 125; number taken into the church, 20; baptized, 10; funeral sermons, 6; pastoral calls, 200. Received for my pastoral labor, \$730.00, and special offerings kept no account. Tenth paid in full.

Rev. Wm. Duncan.

I preached eight and nine sermons per month. I have no regular work as my health is bad. I am taking a course of study and God is giving me some souls to reward my labors.

Wm. Wilcox.

We have held twenty-seven revival meetings working in the following states, viz: Ohio, Indiana, Kentucky, West Virginia, Michigan and Pennsylvania. Preached at the following places between revivals: Canton Evangelical church; George St. Mission, Cincinnati, Ohio; God's Bible School, Cincinnati, Ohio; Normal Mission, Normal, Ky. Have held several shop and factory meetings. Have seen two thousand and thirty-six seekers at the altar in these meetings, traveled six thousand and seventy-five miles and preached seven hundred times. Had to cancel some of these meetings on account of influenza quarantine. In some of these meetings the battle was hard, in others the tide ran high, but in each meeting some one sought and claimed to find God. My wife assisted me in all of these meetings except five. We thank God for his goodness and faithfulness to us.

I was pastor of Polk Hill. My work in past year has been mainly at George Street Mission, Cincinnati, O., East End Mission and many other places. The year has been the best year of my life.

Since last convention we have had the privilege of participating in four revivals. Preached some in the historic George Street Mission, Cincinnati, Ohio, at Okley and Mt. Oreb, Ohio. Pike Street Mission, Coving-

ton, Ky.; April 6th, 1918 we accepted the new church in Madrid, Neb., which was organized and built up by Rev. W. Posey. Taken into the church eleven new members. Preached one hundred and eleven times. Saw about seventy-five definite cases of pardon and purity. Received in finances \$606.00.
