# Conference Proceedings

## FIRST SITTING

The first sitting of the Eighth Annual Conference of the East Michigan District convened at 9:00 A.M., July 11, 1963.

The Conference opened with Rev. James Krieder leading in the singing of "Saved To The Uttermost" and " 'Tis Buring In My Soul." After prayer requests were given, Rev. G. V. Skinner led in the opening prayer of the Conference. After conveying his greetings to the Conference, Rev. C. R. Hendrick, District Superintendent, introduced Dr. Melvin H. Snyder, General Superintendent, as the presiding officer of the Conference. After appropriate opening remarks he addressed the Conference using Rev. 3:7-13 as the basis of his address. He spoke of the varying conditions of the churches from year to year.

He gave four things said of the churches in Revelations;

1. Spiritual Perceptability "He that hath an ear to hear let him hear what the Spirit saith unto the Churches". He stressed that this should be our prime objective to hear the voice of the Spirit. On this depends our fruitfulness.
2. Spiritual Conflict "He that overcometh is promised a reward". If we hear the voice of the Spirit it isn't going to run us into easy places, but will lead us into Spiritual Conflict. We are not only appointed to Conflict but we can have victory over the conflict.
3. Spiritual Accountability "I know thy works". God has an accurate appraisal of us and our works.
4. Ministerial responsibility "Message given unto the Angel". The message was given unto the Angel (Pastor) of the church and he can't escape delivering the message.

After the address the business of the day was entered into. It was passed that the Conference Bar constitute the first 12 rows of seats across the front of the tabernacle and the platform.

It was moved and carried that the time of the sittings be from 9:00 A.M. to 12:00, 1:30 to 5:00 and from 7:30 to 9:00.

The Conference Secretary called the roll of ministerial and lay delegates.

Rev. M. C. House read the following Ministerial transfers into our Districts. Rev. G. E. Stace, Rev. Eldon Nelson, Mrs. Eldon Nelson and Rev. Ronald Schmidt from the Michigan District. Rev. Jerald Lavy from the Western Ohio District. These were introduced to the Conference and given seats within the Bar.

The following visitors were introduced to the Conference and given seats within the Conference Bar. Mrs. Melvin H. Snyder, wife of the General Superintendent, Mrs. Beulah Warner, representative from the Steven Moving Van Lines, Mrs. Culpepper, sister of Rev. Purcell, singer and children's worker from the Ohio District.

Mrs. Warner brought words of greeting and testimony to the Conference.

### SECOND SITTING

The second sitting convened at 1:30 p.m. with Rev. D. Wayne Brown leading in the singing of "Glory to His Name". Rev. John Hiatt led in prayer. It was carried that we dispense with the roll call.

The Minutes of the previous sitting were read and approved as corrected.

The following reports were read and accepted:

S. S. Treasurer's report was read by Rev. E. K. Purcell

After the reading of this report, Dr. Snyder called attention to the importance of all churches sending their Rally Day Offering into the General S. S. Department.

The next report was the Missionary Society Treasurer's which was read by Rev. Miss Ruth Alexander.

Pilgrim Loan and Investment Inc. Treasurer's report was read by Rev. H. C. Rickner. The Statistical Report was read by Rev. H. C. Rickner.

A new and interesting item on the Conference Agenda was an Oral Personal Report given by each pastor present. The Chair commented on the favorable and unfavorable contents of said reports.

Rev. L. R. Neff reported for the Examining and Educational Board. This report was accepted.

Rev. John A. Hiatt adjourned the session with prayer.

### THIRD SITTING

The third sitting opened at 7:30 with Rev. Gerald MacDonald leading in the singing of "A Charge to Keep". Rev. A. F. Osborn led in prayer. The congregation joined in the singing of "Rock of Ages." Rev. C. R. Hendrick presented Rev. E. Duane Glasco, candidate for ordination. The following scriptures were read:

I Tim. 3:17 by Rev. G. V. Skinner

II Tim. 4:1-8 by Rev. L. N. Nelsen

Titus 3:1-11 by Rev. A. S. Joppie

General Superintendent, Rev. Melvin Snyder, read for a Scripture lesson II Chronicles 16:7-10. He took as his theme "The Preacher God Wants". He spoke how God is looking for men with perfect hearts. He stated that God wants:

1. A man who will be quiet enough to hear the voice of God and receive the message.
2. A man courageous enough to preach God's message.
3. A man who will be honest enough to live the message.

Dr. Snyder questioned the candidate and Rev. C. R. Hendrick prayed the dedicatory prayer. Dr. Snyder then gave the charge to Rev. Glasco.

After announcements, Dr. Snyder adjourned the session with prayer.

The congregation joined in greeting Rev. Glasco.

#### FOURTH SITTING

The fourth sitting of the Conference was opened at 9:00 A.M. with Rev. Gerald MacDonald leading in the singing "My Jesus I Love Thee." Rev. Arnold Gibson led in prayer. The chair called for scripture verses to be given by the delegates for the devotions of the morning.

The secretary read the Minutes of the 2nd and 3rd sittings, which were approved as read.

Rev. G. E. Stace, now pastor at the Brown Street, was presented to the Conference.

The election was the first order of business. The District Superintendent appointed the following tellers: Arnold Gibson, Ronald Schmidt, Bob Nelson, Ed Smith, Melvin Goodrich, Truman Munsel and Carl Routson.

Dr. Snyder led in prayer before ballots were cast for District Superintendent. Rev. C. R. Hendrick was elected.

Further balloting resulting in the following elections;  
Assistant Superintendent: Rev. H. C. Rickner

Nominations for District Secretary were read by Rev. House,  
Wilbert Walker, Wm. Doe and M. C. House. Ballots were cast.

Rev. H. B. Krieder, Florida District, was introduced to the Conference. It was moved and carried that he be granted an honorary seat within the Conference bar. Ballots were cast for three advisory members to the council. The tellers reported that Rev. M. C. House was re-elected as District Secretary.

Before nominations for Treasurer were read, Rev. A. S. Joppie gave appropriate remarks honoring Rev. A. F. Osborn, retiring District Treasurer, having served 25 years. Three virtues of Rev. Osborn were pointed out: his sincere integrity, his faithfulness, and his brotherly kindness. It was moved and carried that this Conference give Rev. Osborn a love offering for 25 years of unselfish service. The offering was taken immediately.

The Secretary read a resolution from the Council paying tribute to Rev. Osborn for services to both the East Michigan and Michigan Conferences. Flowers were presented to Rev. and Mrs. Osborn and the love offering of \$76.89. Rev. and Mrs. Osborn both gave words of appreciation.

Nominations for District Treasurer were as follows: G. V. Skinner, Raymond Dean, John Hiatt. Rev. Skinner withdrew his name. Ballots were cast and Rev. Dean was elected.

Dr. and Mrs. Elliott, President of Owosso College, were presented to the Conference. It was moved and carried that Dr. and Mrs. Elliott be given honorary seats within the Conference Bar. Conference was recessed for 10 minutes.

Tellers reported that Rev. D. Wayne Brown and Rev. A. S. Joppie were elected to the Council. Ballots were cast for the 3rd member. Rev. Wm. N. Miller was elected.

Nominations for the Examining and Educational Board were A. S. Joppie, L. N. Nelsen. Ballots were cast and Rev. Nelsen was elected.

Nominations for Camp Board were read by the Secretary as follows: Ed Smith, Wm. Doe, Jess Moss and G. E. Stace. Ballots were cast and Wm. Doe and G. E. Stace were elected.

By a recommendation of the council and a unanimous voice vote Rev. D. W. Brown, A. S. Joppie and M. C. House were elected as District Trustees.

It was moved and carried that we accept the recommendation of the council that Rev. C. R. Hendrick, Mason Mills and H. O. House continue to serve on the Pilgrim Loan and Investment Inc. Board in as much as this is a new service to the District.

Nominations for Missionary President were as follows: Mrs. Elsie House and Mrs. Thelma Nelson. Mrs. House was elected.

After announcements, Dr. Elliott dismissed the session with prayer.

## FIFTH SITTING

The fifth sitting of the Conference opened with Rev. H. C. Rickner leading in the singing of "The Lily of the Valley". Rev. G. E. Stace led in prayer. Dr. Paul F. Elliott addressed the Conference in the interest of Owosso College. He called attention to the advancement being made at the college.

The Minutes of the previous sitting were approved as read.

Four Ministers who were absent at the Second Sitting were asked to give their Oral Reports.

Rev. John Hiatt, Treasurer for the Blue-Cross, Blue-Shield reported. It was moved and carried that we accept the report.

Rev. G. V. Skinner reported for the Resolutions Committee. The following resolutions were read and passed.

Resolution I. Regarding - "Conference Committee".

Resolution II Regarding - "Committee Organization".

Resolution III Regarding - "Conference date and location".

Resolution IV Regarding - "Church Extension Committee".

Resolution V Regarding - "System of Communication".

Resolution VI Regarding - "Minutes of Boards and Committees".

Resolution VII Regarding - "Conference Journal Editing".

Here the chair ruled that each editorial change would be voted on separately. Part of resolution regarding Resolutions No. 1 and No. 4 of the 1962 Journal, page 27, being deleted was carried. Part of the Resolution asking that Resolutions 12 through 15 of the 1962 Journal, page 28, be deleted was carried.

Further it was carried to place Annual Resolutions Nos. 2, 6 and 11 in the Standing Rules. Then it was moved and carried that the entire resolution be accepted.

Rev. Skinner read Resolution No. VIII regarding an addition to Standing Rule No. 35, page 35 of the 1962 Journal. It was carried. Session recessed for 10 Minutes.

Rev. Wilbert Walker reported for the Ways and Means committee. The following Resolutions were read and passed:

It was carried that a letter of condolence be sent to Mrs W. H. Joppie.

It was moved and carried that we extend the time until the business of the Conference be finished.

Mrs. D. Wayne Brown reported for the Memoirs Committee. The report was accepted by standing in honor of the Rev. W. H. Joppie deceased this past Conference year. Dr. Snyder led in prayer.

Rev. G. V. Skinner further reported for the Resolutions Committee. Resolution No. IX Regarding - "Appreciations". Rev. W. N. Miller led in prayer.

It was moved and carried that the Council take care of any unfinished business.

It was moved and carried that the Council hear the reading of the last Minutes for ratification.

Dr. Snyder expressed his appreciation to the District for their cooperation during his two-year term as General Superintendent of the District.

The District Superintendent spoke words of commendation for the work of Rev. E. K. Purcell who is transferring to the Rocky Mt. District.

All joined in singing the Doxology. Dr. Snyder dismissed the Conference with prayer.



## Report of the District Superintendent

To the chairman, Dr. Melvin H. Snyder, delegates and friends of the East Michigan District -- Greetings !

With the complete surprise of your call to be District Superintendent last Conference, God providentially brought it about so that I might have time for soul-searching before accepting. After so doing, I came to you dedicated to do my best for the Kingdom, especially that portion known as The East Michigan District of The Pilgrim Holiness Church. This I have Done!

I must say that my assistant, Rev. H. C. Rickner, has been most helpful when called upon and to offer himself in whatever services were needed. Then it would be beyond words to tell you of the assistance and counsel, grounded in wisdom supplied by our District Council. Committees have worked faithfully for understanding and implementation of work assigned them. If therefore there be failures, it cannot be chargeable to these people.

The shoes of the young man whose place I was to fill would be large indeed if I could not have his favor and assistance. These were freely given! Of course, I speak of none other than Rev. Wm. N. Miller, former District Superintendent.

God has added to the blessings that are ordinarily received with the office, by giving exceptional health, both to me and my wife who has entered into the responsibilities with joy. Blessed be His Name!

The "tone" of our year was set early when God gave, perhaps the greatest Camp Meeting since "hill-top" days in Owosso. We must pray that He will repeat that experience this Camp. This wonderful atmosphere carried out into the District, and I think it would be a fair judgment to say that our people are reaching out toward God and spirituality.

Two things seemed to present themselves as emergencies immediately upon coming into office:

**FIRST: A NEED TO STRENGTHEN OUR DISTRICT ORGANIZATION IN ITS PERSONNEL**

In this area **FOUR** things presented themselves.

1st. A need for up-grading our ministry--In loyalty to the Pilgrim Holiness Church and its General and District interests; a greater dedication to the doctrines and cause we have espoused; a determination to improve ourselves educationally to meet the standards of our day.

2nd. A greater demand must be laid upon, and accepted by our churches--In regard to service to their communities; in producing additional membership each year; in a more joyous and, I might add, a more justifiable pride in accepting District obligations.

3rd. We must mold a stronger, healthier and more vigorous District organization that will assure our churches the maximum security in emergencies; better pastor-church relationship, thus bringing about a more satisfactory change of pastors. Our pastors must be elevated above the "hired man" status, to a status of "men sent of God". He in turn must feel that he has been sent to the "Lambs to be fed" and the "Sheep to be led".

4th. Committees, which now number about twenty, are important "human vehicles" loaded with some special cargo, to be assembled and delivered. Unless these committees can and do understand the importance of their particular work, and implement their plans, there will be just one more bulge in the organization.

Starting with these ideas we launched, with the help of Rev. G. V. Skinner as our research specialist, an exhaustive study of all Conference Journals dating back to 1934, along with our 1962 Manual. The purpose here was--

1. To determine the duties and perogatives of each organized body and office that function for one year or more, and show to what it is related.
2. To show what can actually be found in writing that is binding upon each officer and organized body within jurisdiction of the East Michigan District.
3. To provide an easy reference in finding details that are only briefly given, setting forth sections, paragraphs, pages and rules of Conference Journals and Manual.
4. To indicate that some functions within the District have little or nothing at all in writing to show what their responsibility might be, and that in some cases their duties can only be assumed by the name given the officer or committee.
5. To provide a point of beginning where any improvement and re-organization might be desired.
6. To determine whether there are any committees whose work and functions are sufficiently related as to make it feasible for them to be merged, thus streamlining our District organization by cutting down the size of committees, and reducing the expense of operation.

Because of the finding in this detailed research you will recognize legislation coming from the Resolution and Ways and Means committees, seeking changes in these areas. This legislation, along with others from year to year, if passed will go to make up a volume to be known as, "An Index To District Organization and Implementation". This is to be kept in the District office. It is hoped that in each Annual Conference where duties, committees or officers are added, the same will be noted by the proper persons and copies made for the volume, and for the chairmen of committees.

## **Second—Adjusting District Economy**

The idea of "lowering the taxes and spending more money" is still a conundrum to some of us who have the spending and paying to do. We have found that the quickest way to bring an organization to its knee financially, is for some to suppose that District obligations do not apply to them, or that there is other money outside of that provided by the budget, or in our case, the tithe. A Conference that draws up a budget with as thin a margin as ours, leaves no place for emotional spending, neither can it grant "sabbatical years" or "dispensational release" from responsibility. What we, by our self-determination at these Conferences vote through, must fashion our conscience back home. Because we do not have "hidden taxes" nor a "rich uncle" at our federal head, and because there has been a kind of self-exemption by some in the past, we had but one alternative. We must bring

our spending, not in line with the budget set-up, but in line with the budget as paid. To do this we had a great deal of selling and shifting of property to do.

The church Board of Ann Arbor met with us before we had time to partake of our first free meal as District Superintendent. Their problem was uncalculated, unauthorized, unforeseen, yet we were faced with problems there that included \$16,000.00 more than two years past due, with an accumulation of more than \$120.00 per month of interest, and a deteriorating congregation. We did the only thing possible by selling the church.

The church at Ida for several years, has been a liability, with finance from several accounts in District Treasurer's book, in the red. This also was sold.

Watertown, another church which for nine years had failed to draw one individual from the community other than those who went with it when it started, was merged with the Russellville group, another group which had several times crossed over the line of organized and unorganized status. We now have one group who is able to keep a pastor on the field full time and are making gains in every department.

Then there is the Ferndale-Detroit Greely Ave. merger. This was in the process of being merged when I came into office. After we had brought this to completion, selling the building etc. this group now have a lovely location of two and one-half acres, with a lovely brick parsonage consisting of a fine living room with a fireplace, kitchen and dinette, two bedrooms, basement, breeze-way and roomy garage. There is also left to them two land contracts amounting to \$45,000.00 to be paid at the rate of \$255.00 per month at 6% interest. An option was taken on the Detroit Greely Church allowing a year before surrendering ownership.

For years we have tried to operate in Dearborn, a section of a metropolis consisting of over two and one-half million, with a church building which has no modern conveniences in any form, and which was in no way representative of the Pilgrim Holiness Church. This group was merged with the Church Extension Group, Westland Community Chapel, better known to some as Livonia Church. This will increase their strength to where it is hoped that they will be building their new church on a \$20,000.00 piece of property before another conference. A report has just been received that they had seventy-five in Sunday school the first Sunday after merger.

As the year was running out opportunity came along and we were able to close a deal on the Goodrich property for Twelve Thousand Dollars, with Five Thousand-five hundred down, eighty-five dollars per month and a final pay-off date of three years.

In the forgone portion of this report the action seems to be quite drastic. I must agree that this is true. However, I hurry on to say that when you hear the financial and statistical reports you will have to agree that they do not constitute a loss or a retrenchment. On the other hand, though it may seem drastic, it has — 1. Made it possible to detach ourselves, and honorably, from obligations which threatened to hurt us further. 2. It brings us in a position of integrity without creditors. 3. It brings our spending in line with our income. 4. It balanced our district Treasurer's book, and chased away a deficit which has been adding to its ugliness for several years, disturbing the sleep of District Superintendents and council members.

At first sight I would say, here is a "balance by manipulation" that occurs many times when people trade on paper, taking from one department to add to another as long as there are other departments to take from, or until some of these departments demand a pay-off. However in this case that is not true, for there has been a healthy gain in our District finance and General Church finance, in Camp finance and District Administration. We can thank God for a sizable increase in General Stewardship this year crediting us with robust 90.1 percent, placing us at the very top of Districts of any size, and second only to one of the smallest Districts in our entire church, the Atlantic Southeast who is to be congratulated.

Perhaps this would be the time to report that we can keep "old man deficit" away if all churches and pastors will meet the obligations already passed by this conference; namely, church tithe, Sunday School tithe, Young Peoples tithe, 1% for Camp and Conference and pastor's half-tithe. There should be no exemption of anyone of these if we are to have an organization that carries out our plan and remains progressive and solvent.

#### **East Michigan District Loan and Investment:**

You will want to keep alert for anything you may hear concerning this Committee's report on a new plan for helping to finance our District program. Here, for the first time, is an established plan offering you an opportunity of taking something from our church, while at the same time putting something into it. Keep a look-out for one of their representatives and make inquiry about the plan.

#### **Camp Meeting and It's Improvements and Future**

I have accepted with gratitude what God and the humble Christians have handed to us. Nor should I forget or be hesitant in naming the individual who was the human leader of these thoughtful ones for many years, Dr. C. W. Butler. It may be said that we came out from Owosso without a knife or a fork but behold the land which is ours. Yes, and just as they in faith and humility carried out the first phase of history written about this Camp, so do we dedicate ourselves to writing the next phase with just as much appreciative aggressiveness to God's glory.

Many things have been done in connection with the Camp this year.

1. The deeds have been properly transferred to the East Michigan District.
2. A thousand gallon reserve water tank installed.
3. Two hundred fifty new camp meeting song books bought.
4. The tabernacle covered with a new roof.
5. Our lunch stand enlarged and an extended serve offered.
6. A nice two bedroom, living room, kitchen, utility and garage with land enough to extend our tabernacle to seat a third more. It is located immediately behind the tabernacle.
7. A great deal of painting and paper-hanging has been done in an effort to bring our property up to what we feel it should be. Camp development committee has been busy working and will probably come up with suggestions for extended projects for next year.

## **District Meetings and Zone Meetings**

If there is a place where we have a glaring weakness it may be in this area. Interest and attendance has not been all that could be expected among District leaders of all groups, and especially is this true among our younger men who are planning their future in this District. These meetings are designed to acquaint all of us with our relationship to the organization and better prepare us as a team to meet the competition of our adversary. Attendance increased some this year, others had only a token representation.

## **Progress Around The District:**

Forgive me if I fail to include you in the report. We shall only report major accomplishments which cannot be overlooked because of their importance to you.

First of these was the dedication of a fine brick church with a capacity of about 150, built by Rev. Paul DeGrandchamp in a thriving community just at the edge of Pontiac and known as The Waterford Pilgrim Chapel. After building at a cost of approximately \$28,000.00 it is to be turned over to the Pilgrims with a mortgage of approximately \$17,500.00 and a congregation strong enough to take care of the monthly payments. This group has already expressed themselves as ready to become an organized church and will probably be brought into the Conference next year.

The Church at Warren, Michigan had a major addition built this year and I believe is now well-filled making it necessary for Rev. Roy Webster and family to continue their planning into the future there.

Utica with a strong and continuing plan of progress finally took time off to dedicate two of their units which will take care of about 250 people. This is also a fine addition to our community of churches built in brick.

There was a delayed dedication at Clio where Rev. Rickner and family have labored to make it one of the most attractive auditoriums in our District. This church, over a period of a few years, has come from a temporary tabernacle to a beautiful church.

There are other notable accomplishments in the way of beautiful new brick structure that are now in service, but wait some final touches before dedication. Flint, Grace, pastored by the John Dean family is a credit to the community and a great investment in work and money by them and their people. Rev. Bruce White and family have built a beautiful monument in brick at Lennon and will soon be calling for a day of celebration and dedication. If you are traveling East out of Flint on M 21, you will see to your left near the city limits what perhaps is one of the finest stone churches in our connection. Rev. Brown and family along with his people spent many hours in putting into reality their dreams. This is a beautiful display of good taste and practicality.

Plans are in the making for a new church at North Lake Port. Ypsilanti is planning a major remodeling and extension. These are the signs of virility and progress.

There is an air of optimism around the District which is inspiring and causing my work to take on a touch of romance. My judgement is this, opportunity lies all around us; fields are white to harvest; the sickle that is put into the harvest will gather sheaves.

We must prepare ourselves as churches and ministers to bring our Gospel presentation out of the "moth-balls" and up to the present day in which we live. We must offer better and more attractive buildings for our communities. If we do this, if we all dedicate ourselves to God and this organization, nothing withholding, our denomination will take her rightful place among other denominations. **THIS IS OUR DAY! GIVE US THIS MOUNTAIN!** And if Caleb at the age of EIGHTY-FIVE would ask such a thing, do we whose veins pulsate with "young blood" not dare to ask as much.

In the Name of the God of Caleb, we will not accept a status quo.

## **REV. AND MRS. A. F. OSBORN HONORED**

The East Michigan Conference of the Pilgrim Holiness Church, today pays tribute to the faithful services rendered by Rev. A. F. Osborn as Treasurer, both to the East Michigan and the Michigan Conference.

Rev. Osborn was born July 24th in Sanilac County, four miles west of Applegate. He was converted in the fall of 1923 in his home, and approximately one week later was sanctified in the old Detroit First church (then located on Puritan Avenue) under the ministry of the late Rev. E. F. Ewers. Two years later, Brother Osborn began to preach in homes in Dearborn, Michigan. This work developed into a mission and later a church. At the same time, he worked at the Ford Motor Company, and took correspondence work at Bible Holiness Seminary. In May of 1933, Rev. Osborn took his first pastorate-circuit with the Pilgrim Holiness Denomination at Ellsworth and Phelps.

On October 25, 1940, Rev. Osborn lost his first wife (formerly Miss Ruby E. Gordon of Croswell) as a result of a head-on auto accident, which accident also required his hospitalization for eleven weeks.

In 1949 Rev. Miss Sophia Doehring and Rev. Osborn were united in marriage.

Brother Osborn is now completing his twenty-fifth consecutive year as Conference Treasurer. This distinction sets a record of unbroken service to an elected office in our Conference, and with out doubt would be a record for many other Conferences.

During these years as District Treasurer, Brother Osborn has carried on his full duties as a Pastor as well. Unnumbered hours have been spent with the treasurer's books, while fellow pastors were at liberty to use their time for study and other church activities.

A word of thanks and appreciation is also due to Mrs. Osborn for her patience, loyalty, and faithfulness as a minister-treasurer's wife, for 21 years.

Rev. Osborn has requested that the District Council refrain from nominating him as a candidate for the office of District Treasurer.

Brother and Sister Osborn, on behalf of the entire East Michigan Conference we want to say a whole-hearted thank you for a quarter-century of devoted service to God and the Pilgrim Holiness Church. May God's continued blessings and benedictions be poured out richly upon you in the years ahead.

## Sunday School

We wish to thank, first of all, the committee who worked with us this year for the advancement of the Sunday schools of the district. Rev. Goodrich and Rev. Bob Nelson spent long hours helping with the planning of the programs. Rev. Hendrick, the District Superintendent cooperated wonderfully. We thank him. The council also cooperated with the department this year in a fine way.

This has been a good year with the East Michigan Sunday schools. There were five Sunday schools closed: Ferndale, Ida, Ann Arbor, Watertown and Dearborn. One at the close of the year, one mid-year and three at the beginning of the year. Had these schools not closed there would have been an average attendance of some 130 more per week for the district than last year, we had a gain of 6 over last year. We are grateful that we had no loss considering the fact that these schools closed. The two new schools from last year, Gaines and Livonia, have made fine advances, and with the addition of the new school at Waterford, have helped to make up for the loss of the closing schools.

The Sunday school department conducted three major programs this year. Each was a success in its own way. In the fall, there was the contact contest, which started several of the schools off for the winter on a calling program. Then during the fall and winter months, Rev. Ed Smith and I built 42 visitation boards -- one for each school in the district. Also we made up a starting supply of cards to operate them with. Rev. Smith deserves much thanks from the district for the many hours of work he gave to us in helping me with this project. He is a fine carpenter and cabinet maker, and could well have been receiving a good salary doing the same kind of work elsewhere.

These visitation boards have been successful in every instance where they were used as per the sheet of directions which were issued with the boards. Not one who used the visitation board consistently reported failure with it. The third program was the contest with the Michigan district. This did a great deal for some of the Sunday schools. We lost the contest, but several of the schools made very good gains. It was a good contest, and the spirit of the contest was lively - but in our district, not lively enough. The Michigan district really rallied. We lost badly. But some of our schools made such healthy gains, that we were winners too.

We wish to congratulate the churches of the Michigan district for the exceptional gains they made during that contest. Our district had one high Sunday, and this was one of the highest months in the district's history, during this contest. The Fourth church of Flint got the push it had needed, and it has been going over the top ever since. It had no gains for the year, previous to this contest, but it began gaining, and at the close of the year, was ahead by 14 average per week over last year. Last month, Flint Fourth had about a 50 percent gain over June 1962.

We felt the three programs of the district were very helpful, and beneficial to each of the Sunday schools that cooperated in them.

Waterford averaged 23 this year as a new school.

1 - Tape recording (3 lessons) "Personal Evangelism", by F. C. Booth of Fuller Theo. Seminary.

1 - Tape recording of Major Mayor's famous report and university address about modern conditions and modern youth.

1 - Set - Personal Evangelism charts.

We wish to recommend that pastors make use of these helps and aids.

The planned Sunday School program for the coming year calls for extensive expansion of this type of aids in helping each local Sunday School to better prepare its Teachers and workers for the tremendous task that lies before them.

In as much as duty seems to be calling us elsewhere this year, it has been necessary that we relinquish this office to another man who I am sure will be as concerned about each Sunday school as I have been - we wish him the very best, and will be praying for him.

It hasn't been easy to spend over 400 hours this year in the district Sunday School work, but it has been enjoyable.

May God lead the East Michigan District Sunday School Department forward in great strides in our prayers as we go.

Therefore, be it resolved, that the District Council appoint a committee of nine persons, of which three shall serve for three years, three for two years, and three for one year; and that three shall be appointed each year thereafter by the District council to serve for three years. The District Council shall designate one member of the committee to serve as chairman. The District Treasurer shall be an ex-officio member.

This Committee shall be known as the Conference Committee and shall have the following duties.

1. Meet at the call of the chairman at least one month before Conference.
2. Receive all signed resolutions for their study. (Resolutions to be in the hands of the committee by May 1st.)
3. Appoint members of the committee to be responsible to study, prepare, and plan any phase of the Committee's work, and report same to the committee.
4. Provide all delegates with mimeographed copies of resolutions recommended by the committee two weeks before conference.
5. Report the committee's recommendations to the Annual Conference.
6. Provide the District Secretary with typewritten copies of all resolutions approved by the Conference.
7. Do any research work and study any matter requested of them by the Annual Conference or District Council and report on the same as requested.

Be it further resolved that this resolution become a standing rule and replace standing rules 13 and 22, and that the last paragraph of Standing rule 10 be deleted.

## II. Committee Organization

Whereas there is little provided in the way of specific directions for committees such as we have listed on Page 3 of the Conference Journal, and

Whereas the Conference Journals as far back as 1934 do not list any written directives that apply to present existing committees, and

Whereas there is a need to properly define the duties of committees to provide better organization;

Therefore be it resolved that we ask the Conference Committee to make preparations as follows:

1. Make a study of responsibilities and duties of all committees and elected Boards for better organization and implementation of all District interests.
2. Make a report of their findings and final recommendations to the District Council for their approval.
3. Prepare a compilation of this material in such form as the District Superintendent may request for permanent filing in the District Office.
4. Prepare this material in a form so that it can be made available to newly elected committee members, and committee chairman.
5. That any re-editing of this material due to deletions, and additions, or changes from year to year shall become the responsibility of the District Secretary.

Be it further resolved that this resolution become a standing rule.

### **III. Conference Date and Location**

Whereas there has been some interest expressed relative to a change in the date and location of our Annual Conference so it will not be so close to the Camp Meeting time,

Therefore be it resolved that we ask the Conference Committee to explore this matter, and report their recommendations to the District Council.

Therefore be it resolved that we ask the conference Committee to explore this matter, and report their recommendations to the District Council.

### **IV. Church Extension Committee**

Be it resolved that a District Church Extension Committee be appointed by the District Council, to consist of the District Treasurer, one member of the Sunday School Committee, one member of the District Youth Executive Committee, one member of the District Missionary Executive Committee, and two members at large to be chosen with the thought of geographical representation. The chairman of this committee shall be named by the District Council.

The Duties of this committee shall be as follows:

1. To see that its work is carried out in Harmony with Section 27 of the 1962 Manual.
2. To inquire through pastor and church, by request or solicitation of groups, by prayer and persuasion, where there may be possible locations for starting Sunday Schools and Churches.
3. Consider any personal contact by mail or otherwise of any individual who has an interest in starting a Church or Sunday School in some area.
4. Shall seek out and recommend, locations for new churches and Sunday Schools, the amount of finance needed, and the way it is to be used and how it should be raised.
5. Organize a survey from the ministry, laity, and Owosso College for the purpose of determining the possibilities for our Church in any community.

6. Organize "Work groups" from the Ministry and laity and any volunteers for emergency calls.
7. When all data is received and agreed upon by the committee, a report shall be compiled, together with the committee's recommendations, and filed with the District Office for District Council final approval before any projects are started.

Be it further resolved that this resolution become a standing rule.

#### **V. System of Communication**

Whereas in times of emergency there is no organized system of telephone communication between the District Office and the Pastors of the District,

Therefore be it resolved that the District Superintendent appoint a pastor in each zone to do the following:

1. Call a meeting of pastors of the zone before Sept. 1st to select some pastor as the personal contact between the District Superintendent and pastors of the zone, and decide how to make the system effective and what to do about any cost involved.
2. Pastors also are encouraged to organize as thought necessary for planning any pastor's meetings with the District Superintendent, or as may otherwise be needed. Immediately after such meeting, the appointed chairman shall notify the District Superintendent how pastors of the zone are organized.

Be it resolved that last sentence of Standing Rule 35 be deleted. (1962 Journal).

#### **VIII. Pastoral Recall**

Be it resolved that the following be added to standing rule 35, page 35 of the 1962 Conference Journal:

"All ministers receiving calls from churches shall notify the District Superintendent the time he gives his decision to the church."

#### **IX. Appreciation**

Whereas it has always been the disposition of the conference to give a grateful acknowledgment for the manual help on campus and in the dining room and kitchen, and

# **Ways and Means Committee Report**

# Standing Rules

## Camp Meeting

1. **Camp Date** - Be it resolved that the Camp Meeting date be set to begin the second Friday in July.
2. **Camp Board**-Be it resolved that the Camp Board of six members be elected in the following manner; two members to be elected for three years the next two elected to serve two years, and the last two elected for one year. Following this two members shall be elected annually for a three year term. The Board shall secure all workers for Camp and Conference, supervise building and grounds, purchase good and necessary equipment for camp and conference, and have charge of all advertising.

Whereas camp board members are pastors and whereas much of their time must be devoted and their minds occupied with the many duties connected with the manual working of the camp, and therefore are not free to attend and enjoy the camp services;

Therefore be it resolved that after any member of the camp board has served for a period of three years, he shall not be re-elected to the camp board until at least three years have expired. The District Council shall provide nominations from which board members shall be elected.

Be it further resolved that the District Treasurer and one other Council member serve on this board and that the District Superintendent by virtue of his office serve on this board, but shall not be the Chairman. The chairman of the camp board shall be appointed by the District Council.

3. **Camp Labor** - Be it resolved that each church in the conference of less than 20 members give 2 days labor or \$20.00; 20 to 50 members 4 days or \$40.00; above 50 members give 6 days or \$60.00 to employ help to make ready for the annual camp meeting and construction of new buildings and maintenance until a maintenance man be employed.

This call may be issued by the District Council or Camp Board.

4. **Camp Ground Development** - Whereas the Assistant District Superintendent is limited in his service to the District, therefore be it resolved that the Assistant Superintendent shall be chairman of the Camp Ground Development committee which shall consist of the Camp Board Chairman, the District Youth President, a Secretary-Treasurer and two lay members all of whom are appointed by the District Council.
5. **Children's Meetings** -Be it resolved that we have children's meetings during the afternoon and evening services of camp.
6. **Leasing of Lots** - Be it resolved that the District lease lots on the camp grounds to ministers and laymen desiring them as follows:  
The lease fee shall be \$125.00 if paid in cash. Terms: \$145.00 at the rate of \$25.00 down and \$10.00 per month for one year.  
The District shall plant one tree on each lot and shall gravel the street in front of lots.

## Conference

7. **Sunday School Sessions** - Be it resolved that on the two Sundays during camp meeting that there be a Sunday School Session beginning at 9:30 until 10:15 a.m. following the Testimony meeting, and that said session be arranged and supervised by the Sunday School committee.

Be it further resolved that a credit card be given to all in attendance and that each card be signed and returned by the pupil to their local church Sunday School Secretary for the attendance record and reports to the conference.

8. **Youth Activities** - Be it resolved that the Youth department and the camp board be in charge of and provide for all youth activities during the annual camp meeting.
9. **Fiscal Year** - The conference year shall close May 31 and all reports be mailed to the Conference Statistician by June 15.
10. **Examining and Educational Board** - The District Superintendent shall be chairman of the Examining and Educational Board by virtue of his office. He shall have sections 105 and 107 of the Manual read instructing all district licentiates that hereafter they shall appear before the District Examining and Educational Board before their credential shall be granted.
11. **Ordination Service** - Be it resolved that the order of business on the first night of the Conference be the ordination service. Whereas the minister's wife makes a vital contribution to her husband's work, therefore we recommend that the wife of the candidate be given honorary seat with the candidate during the ordination service.

Whereas ordination is an extremely important event in the life of a minister, whereas the family of the candidate may desire to be present and make plans well in advance for the ordination day, therefore be it resolved that the Examining and Educational Board review and examine and then notify candidates 15 days prior to the Conference.

12. **Election of Officers** - Inasmuch as most religious bodies follow the order of having elections immediately following district reports, and inasmuch as many conferences of the Pilgrim Holiness Church follow the same order, therefore be it resolved that election of officers be immediately following district reports.

**21. Lay Visitation** - Whereas the entire program of the General Conference seems to present a forward and aggressive program, and whereas one of the things urged upon each of our Districts was a plan of "lay visitation" and "personal Soul winning;"

Be it resolved that we adopt the following plan, to be known as "Personal Soul and Lay Visitation Plan."

1. That a committee of not more than three be appointed by the District Superintendent whose work shall be:
  - a. To lay out a course of study.
  - b. To appoint committees and instructors in each zone and advise in organizing classes.
  - c. To gather information and give reports on progress and accomplishments.

Be it further resolved:

- a. That there be an intense effort on the part of the pastor to attend all classes, and that he enlist as many of the laity of his church as possible.
  - b. That a certificate of accomplishment be given to all who finish the course.
2. Also be it resolved that at sometime during the period of instruction or immediately after, the pastor of each church will organize in his or her church a group for soul winning and lay visitation and set up files and records recommended by the committee.

**22. Prayer and Fasting League** - Be it resolved that in keeping with the program of our church that we urge each church in our Conference to organize a Prayer and Fasting League. The Objectives of the Prayer and Fasting League shall be:

1. It shall not take the place of the regular church mid-week prayer meeting.
2. The League Membership shall be directed to pray for the general interest of our Church at home and abroad.
3. They shall be encouraged to pray for the local community needs.
4. That where advisable the pastor shall provide a list of definite needs for each member of the League covering such needs as:  
Unsaved families in the community.  
Unsaved families in the Sunday School.  
Unsaved individual church objectives and needs.

Organization:

- a. The pastor shall act as director of the prayer and Fasting League.
- b. The pastor shall recommend one or more names of the official board who shall appoint a secretary to work with the pastor.
- c. The secretary shall form a membership list. Membership in League shall be volunteer membership of the church, Sunday school, youth society, and friends of the church.
- d. The membership shall be kept active by being revised twice each year, September 1, and March 1 of each Conference year.
- e. Whereas this is a new Conference venture, we hereby ask that the next ministerial meeting of this Conference set aside one hour for open discussion of this district project so that better understanding and organization may be perfected at our next District Conference.

## Finance

**23. Finance Committee** - Whereas finance is so important to the on-going of the District and the local church, therefore be it resolved that a finance committee of three members be appointed by the District Council. The duties of this committee shall be as follows:

1. To study all finance in each local church as to their ability to pay district and general united stewardship funds and to recommend ways of paying the same.
2. To recommend to the District Council in regard to amount of indebtedness the local congregation is able to carry.
3. To report all findings to the District Council.
4. To give a yearly report to the District Conference.
5. The Chairman shall be appointed by the District Council.

Be it further resolved that:

- a. Any church unable to pay their united stewardship fund in full shall contact the chairman of this committee at least 90 days before the close of the conference year.
- b. Any church wanting to finance property, either building or buying, shall contact the chairman of this committee.
- c. The local church shall receive the report from the committee and the District Council is not more than 30 days following request.

**24. United Stewardship Fund** - Whereas we are in full accord with the plan of God, namely tithes and offerings for financing the work of the kingdom and advise our people to tithe their income into the local church; therefore be it resolved:

- a. Each local church shall tithe its receipts.
- b. Each Sunday School shall tithe its receipts.
- c. Each local Youth Society shall tithe its receipts.
- d. Each Youth Zone shall tithe its Zone offerings.
- e. Each pastor shall send direct or through the local church treasurer one-half tithe of this church salary to the Direct Treasurer for the Administrative Fund.

These tithes shall be sent each month to the respective Department Treasurers, and forwarded by said treasurer to the District Treasurer. These tithes shall not include loans or money from sale of land or buildings.

Be it further resolved that the District Treasurer send the Equivalent of \$8.00 per member to the General Treasurer for the General United Stewardship fund and that the District Stewardship Fund be divided as follows:

45 percent administration, 7 percent Owosso College, 5 percent Ministerial Benefit, 2 percent General Conference, 7 percent property debt, 21 percent Church Extension, 5½ percent Sunday School, 4½ percent Youth and 3 percent loan fund

**25. Camp and Conference Expense** - Whereas there is a great deal of expense in connection with the annual camp meeting and conference, let each church pay into the District Treasury one (1) percent of their regular offerings to be designated for Camp meeting and Conference expenses.

Inasmuch as it is impossible under the present set-up to any longer give free entertainment to our ministers and their families, therefore be it further resolved that ministers and their families be responsible for their lodging and meals.

Exception shall be all retired ministers, full time pastors and their families whose salary is under \$50.00 per week, and all full time camp workers as determined by the CAMP Board.

Be it further resolved that during the Annual Conference all delegates (Ministerial and Lay) be given their meals free and that the District Superintendent, his wife, and members of his family under 16 years of age shall be given meals and lodging without charge during the Annual Camp and Conference.

Be it further resolved that the District Treasurer pay out of the Administrative fund the Pension Plan, Medical and Hospitalization insurance for the District Superintendent.

**26. Missionary Society 10 percent** - Be it resolved that 10 percent of the local missionary societies regular offerings be sent to the District Missionary Treasurer for yearly projects and district expense.

**27. District and General Fund** - All specified monies raised in the Local Church for District and General work shall be sent to the District Treasurer, who shall forward General funds to the General Treasurer.

**28. Salaries** - The District Superintendent's salary shall be set at \$4800.00 per year plus 7c per mile traveling expense. The District Treasurer shall receive \$500.00 per year; the District Secretary, \$300.00 the District Sunday School Secretary, \$100.00; the Youth Director, \$100.00, the District Statistician \$50.00. All District Officials receive 6c per mile for all miles traveled in the interest of the District.

**29. Camp Funds Report** - The District Treasurer shall submit an itemized report of Camp Meeting Funds as recorded in the 1945 Conference Journal page 13. This report to appear in the Journal.

**30. District Audit** - Be it resolved that all Treasurers books of the District be audited annually by a certified Public Accountant so that a report form the auditor can be given to the Conference when called for.

**31. Pilgrim Loan and Investment Inc.** - Whereas there is a need for a more adequate loan program in our District, therefore be it resolved that the program known as East Michigan Pilgrim Loan and Investment Inc., be adopted and replace our present Church Extension Loan Fund.

**32. Owosso College** - Inasmuch as Owosso College has a successful history in training young people for Christian service, and inasmuch as the General Board has assigned the state of Michigan as the patronizing territory for Owosso College; Therefore be it resolved that the East Michigan Conference go on record in pledging to the College its full cooperation and prayerful support, and open the doors of its churches to a representative of the College at which time the financial needs of the College shall be presented;

Inasmuch as the month of May has been designated by the General Church as Education month, be it further resolved that the Sunday following Mother's Day be designated as Owosso College Day and an offering of \$1.00 or more per member be set as a goal. ## Ministerial

**33. Pastoral Recall** - Be it resolved that the vote on the recall of the pastor shall be taken prior to May 15, this vote shall be taken by secret ballot and shall not be counted in the local church, but shall be placed in an envelope and sealed in the presence of voting body and sent directly to District Superintendent who shall report the results of the vote to the Pastor and the church Secretary.

All ministers receiving calls from churches shall notify the District Superintendent at the time he gives his decision to the church.

**34. Pastors at Camp** - Inasmuch as our pastors are expected to support and attend the annual camp meetings each church shall provide the equivalent of the pastor's offering or salary for the two Sundays of the camp, and the pastors shall be required to attend the entire camp meeting with the exception of Sunday morning.

**35. Insurance** - Whereas the majority of Pilgrim Holiness ministers of the East Michigan Conference have expressed interest for participation in the Blue Cross-Blue Shield protection on a group basis, be it resolved: There shall be a Blue Cross Treasurer, appointed by the Council instructed to act for the ministers and personnel in relations with the representatives of the Michigan Hospital service and Michigan Medical service. The Blue Cross treasurer shall receive all periodic subscriptions from the ministers and make payments of the same to Blue Cross-Blue Shield.

Be it further resolved that we recommend each local church pay their pastor's Medical and Hospitalization insurance.

**36. Parsonage Utilities** - The local church shall provide good, modern heating and cooking facilities for the parsonage, type to be suitable to the locality where the parsonage is located. The District shall provide the same for the District Parsonage.

**37. Pension Plan** - Each local church shall contribute to the Pilgrim Pension Plan fund each month an amount equivalent to 6 percent of the pastor's salary for the year ending March 31, 1964. 7 percent for the year ending March 31, 1965 and 8 percent thereafter. These monies are to be remitted to the District Treasurer, who will forward the same to the Pension Plan Treasurer. If the pastor of a local church is not a member of the Pilgrim Pension Plan, the above percentages paid by the local church of which he is a pastor, shall be placed in a fund to assist aged ministers.

**38. Burial Benefit** - Each local church shall enroll its pastor and wife in the Ministerial Benefit Association, and pay the expense of their membership and each call thereafter from the church treasury.

All general full-time evangelists and their wives receiving their principal support from their meetings shall be enrolled in the M. B. A. and said membership and each call thereafter shall be paid by the church of which he is a member.

The District Superintendent and his wife shall be enrolled in the M.B.A. and the expense be paid from the Administrative fund.

Home Missionary pastors and wives are included in this action, the expense to be paid from the Home Missionary Treasury.

The retired elderly ministers and wives are included in this action the expense to be paid from the Ministerial Relief fund.



39. **Vacations** - It is recommended that our churches grant their pastors a two weeks vacation with pay, and that the District Superintendent shall be given two-weeks vacation with pay.

40. **Pastor's Conference Committee** - Be it resolved that a committee of six be appointed as a Pastor's conference committee by the District Council; that two be appointed for three years, two for two years, and two for one year, and that two shall be appointed each year respectively.

The Pastor's Conference Committee shall arrange the program, set the date, the place, and notify all ministers, of the Pastor's conferences and one-day ministerial retreat.

41. **Pastor's Conference** - Be it resolved that we have two pastors conferences; one in the Spring and one in the Fall each year. Be it further resolved this be placed in Standing Rules.

42. **Retiring Superintendent** - Be it resolved that whenever there shall be elected another District Superintendent, that the Council earnestly endeavor to place said retiring Superintendent in satisfactory position.

43. **Death Notice** - Since in the past on several occasions District Ministers, Widows have deceased without the ministers being notified of their death, therefore be it resolved that in the case of the death of a minister or his widow, the District Secretary notify the ministers of the district.

Be it further resolved that we request the Michigan District to give us this information from their District.

## Conference Proceedings

The Eighth Annual Youth Conference of the East Michigan District, Pilgrim Holiness Church, convened at 9:15 A.M. at the Pilgrim Holiness Church in Pontiac, Michigan, on May 18, 1963. The conference was opened by District Youth President Rev. William Doe.

Richard Wynn, Minister of Music at the local church, led in singing, "I Know Whom I Have Believed". A passage of scripture, Isa. 54:1-3 was read by Rev. J. Kreider after which District Superintendent, Rev. C. R. Hendrick was called upon to lead in prayer.

Rev. W. N. Miller, host pastor, spoke a few words of welcome to the conference.

Rev. Doe introduced Rev. O. D. Emery, General Secretary of Sunday School and Youth, who presided over the conference. Rev. Emery brought a message on the teenage drop-out problem showing that in a recent survey it was found 7 out of 8 teenagers drop out of church between the ages of 12-20. The average church loss is 51/3% per year. It is noted that 84 Pilgrim Churches were contacted in the teenage drop-out survey, which represents 85% of our churches. Danger signals to be watched: Spasmodic Attendance, Chronic Complaints, Changes at Home, changes in the Church. Seven steps we must take in trying to save these drop-outs: 1. Pray without ceasing. 2. Love them--Want them. 3. Win the entire family. 4. Make services vital. 5. Let the Bible speak. 6. Improve leaders--go after absentees. 7. Put teens to work.

Roll was called by the secretary, Rev. H. James Kreider. There were present 19 pastors, 19 youth presidents, 38 delegates, 1 Dist. Supt. and 1 General Officer, making a total of 78 members of the conference.

Motion made and carried that we set first nine rows of the left two sections of seats as the conference bar.

Motion made and carried that the time of sittings be 9:00 to 11:30 A.M., and 1:30 P.M. till the conclusion of the business.

Motion made and carried that we give our guests, Rev. R. K. Story and Dr. Paul F. Elliott an honorary seat within the conference bar.

Report of District Youth President, Rev. William Doe, was read. Words of appreciation were given by Rev. Emery for Rev. Doe's work as Dist. Youth President. A rising vote of appreciation was given by the conference.

Report of District Youth Treasurer was read by Rev. William Lyons. Motion made and carried to receive treasurers report.

### **No. 2. ZONE PRESIDENT'S REPORT**

Be it resolved that the zone presidents give a written report at the Youth Conference.

### **No. 3. CONFERENCE ELECTION**

Inasmuch as the election of our District Youth Officers is important to the other business of the Conference: therefore, be it resolved, that the election of officers be the first order of business following the reports.

### **No. 4. PRINTING PROCEEDINGS**

Inasmuch as it is helpful to have a permanent record of our youth work, therefore, be it resolved, that we request that our journal of proceedings be published in the Conference Journal each year.

### **No. 5. YOUTH CALENDAR**

Be it resolved that the following dates be placed in the Standing Rule. Youth Conference and Convention the third Sat. in May, Youth Leaders Day the second Saturday of September, and District Youth Rally the first Saturday of November.

## **ZONE**

### **No. 6. NOMINATIONS FOR ZONE PRESIDENT**

Whereas the District Council presents two names per zone for the election of Zone Presidents, to the Youth Conference and whereas the District Youth President is in close touch with each Zone; therefore, be it resolved, that we request the District Youth President be allowed to meet with the District Council when making these nominations.

### **No. 7. ZONE PRESIDENTS REPORTS**

Whereas there has been a lack of communication between the zones and the District Youth President, therefore, be it resolved that each Zone President report each zone rally to the District Youth President as soon as possible after each rally.

### **No. 8. ZONE OFFICERS ELECTION**

Inasmuch as the Zone Treasurer should be a qualified person, therefore, be it resolved, that the Zone Treasurer be elected from nominations made by the Zone Executive Committee.

### **No. 9. ZONE COUNCIL**

Inasmuch as there has been a lack of uniformity in the composition of the Zone Councils; therefore, be it resolved, that the Zone Council shall consist of elected zone officers, local youth president or some other local officer in the presidents absence. One pastor to be elected as counsellor if a pastor was not elected to Zone Council.

### **No. 10. ZONE RALLY COUNT**

Whereas there is a need to encourage our youth to attend zone rallies, therefore, be it resolved, that we adopt the following



plan to be used to determine the count in all zones. Under 12 1 point each service. Over 35, 1 point each service. Between 12 and 35, 3 points each service. This includes pastor and youth president regardless of age. Pastor and youth president are to be given a 10 point bonus each if they attend both services. This added to the handicap for total points. In case the rally consist of only one service, the pastor and youth president will still be given the 10 point bonus.

**FIGURING THE HANDICAP** -- Subtract the number of active and associate members of the local society from 100, then multiply by .6.

**EXAMPLE** - Local society has 22 active members and associate members. 100 less 22 equals 78.  $78 \times .6$   
Equals 46.8 or a 47 handicap.

**No. 11. NUMBER OF ZONE RALLIES**

Inasmuch as there is a need of uniformity as to the number of zone rallies held each year, therefore, be it resolved, that the minimum number of rallies per zone be set at four per year.

**No. 12. ZONE FINANCE**

Whereas our zones will receive no finances from local societies, therefore, be it resolved, that zone monies received be retained for the financial operation of the zone, except the 10 per cent tithe which will be sent to the District Youth Treasurer.

### **LOCAL**

**No. 13. FINANCIAL SYSTEM**

Be it resolved that each local society pay 10 percent of society receipts to the District Youth Treasurer. Be it further resolved that the District Youth Department request  $4\frac{1}{2}\%$  for the District Youth operational fund from the District Treasurer.

**No. 14. YOUTH MISSIONARY PROJECT**

Whereas we wish to co-operate with the General Missionary Project, therefore, be it resolved, that each local youth society endeavor to comply with the general youth department's request for finance.

### **CAMP**

**No. 15. YOUTH ACTIVITIES DURING CAMP MEETING**

Be it resolved that the youth department and the camp board be in charge of and provide for all youth activities during the annual District Camp Meeting.

**No. 16. YOUTH CAMPS**

Be it resolved, that the date and number of youth camps be decided upon by the District Youth Council and Camp Board.

**No. 17. YOUTH CAMP SUPPORT**

Whereas there will be no youth camp offerings received in the zones, therefore, be it resolved, that funds for development and improvement of our youth camp be raised through district youth projects.

### **COLLEGE**

**No. 18. YOUTH IN ACTION DAY**

Whereas Owosso College is planning a yearly Youth In Action Day, therefore, be it resolved, that we support this program.

## **Youth President's Report**

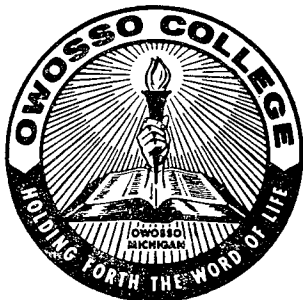
