FLORIDA CONFERENCE
JOURNAL OF PROCEEDINGS

First Sitting

Monday, June 17, 1963, 7:00 P.M.

The first sitting of the Tenth Annual Conference of the Florida District of the Pilgrim Holiness Church convened at 7:00 p.m. June 17, 1963, at the Satellite Beach Pilgrim Church, Satellite Beach, Florida.

The Conference was opened by Rev. M. C. Kittle, District Superintendent.

Rev. Sumwalt led the singing of "Savior, Like A Shepherd Lead Us" and "The Comforter Has Come."

Rev. Ray Richards led the Conference in prayer.

Rev. Kittle introduced Rev. R. C. Hawkins, Church Extension Secretary.

Rev. Hawkins introduced Rev. R. A. Beltz, former Secretary of Church Extension, who is now representing the Pilgrim Pension Plan.

Rev. Beltz gave a talk regarding the beginning of the Florida District under his leadership, which was timely, in order and encouraging.

Rev. Hawkins read scripture from Num. 13:30. Theme of the message was "Progress and Its Pattern".

Rev. Hawkins pointed out there were 10 men with Caleb and Joshua, and they all agreed on many good things, but a part of them agreed the land could not be possessed. Joshua and Caleb **wanted to go forward** but the others said, "IT CAN'T BE DONE"!

Rev. Hawkins stated that all the churches in Florida, **BY THE HELP OF GOD**, could win souls. The Church cannot compete with the world on the World's terms, but we can do all things through Christ which strengthens us.

The idea of getting people to come to Church to build up numbers is ridiculous. When the love of God is in our hearts we are to go out to reap the harvest - not just to get numbers.

If we love God, where is that burden for the lost? How can we love God, live a life of luxury and be unconcerned about a lost world!

It was pointed out that where we live there is a **FIELD OF OPPORTUNITY** and it is up to us who are Pilgrims to reap the harvest. This vision is to show us the way to **GET THE HARVEST IN!** We are to go about it in an orderly and systematical way.

What is our motive? Is it to get position and place in the world, or is it to get the job done for God? The job depends on our prayers and our interest in the harvest. The job depends on how well planned and how good we can relay the truth to the people of our day.

We must relentlessly press on and follow through with our work. If we do not, we will fold up and the harvest will be lost. Let us go up and possess the land.

Rev. Hawkins then led the congregation in singing "TO THE WORK."

The roll was called by the Secretary.

A motion was made and seconded that the Conference Bar consist of the first six pews on both sides of the church.

Rev. R. L. Goodman, from the Kentucky District, Rev. Swanson and Rev. Baynum from the West Virginia District, were received into the Conference pending a letter of transfer. Rev. Strickland from the North Carolina Conference was received by letter of transfer.

Rev. Kittle asked that these men and their wives come forward to be introduced.

A motion was made and seconded for the time of the Conference 7:00 to 9:30 P.M., Monday and re-convene the following day 8:30 - 11:30 A.M. and 1:30 P.M. until finished. This motion carried.

It was moved and seconded to grant honorary seats in the Conference Bar to Rev. Sager, Rev. Stunkel and Rev. Leonard.

Rev. Sumwalt introduced to the Conference, Sister Sally Hankus, Bro. Bond, Bro. Stunkle, Bro. Evans and Bro. Sager. Each one gave a good testimony. It was suggested by Rev. Hawkins that a standing welcome be given these people and the congregation sing "Blest Be The Tie That Binds".

The Chair called for the Report of the District Superintendent Rev. M. C. Kittle, which was read and accepted with a HEARTY AMEN!

The following reports were read and accepted.

Rev. Sumwalt — Auditing

Rev. Emmons — Treasurer, which was accepted with an AMEN.

Rev. Rickner — Statistician

Rev. Gookins — S. S. Promotional Secretary

Due to the expiration of time, it was moved and seconded that the meeting adjourn.

Second Sitting

The second setting convened Tuesday, June 18, 1963, at 8:30 A.M. Rev. Sumwalt opened the service by leading the congregation in singing "He Is Able To Deliver Thee" and "Amazing Grace".

Rev. Hawkins asked that several verses of Scripture be quoted by members of the Conference as the Scripture Lesson.

Rev. J. C. Baynum was called upon to lead in prayer.

Rev. Hawkins spoke to the Conference about the Advanced Level of an unorganized district.

- III When It Should Be Done
1. Minimum - 15 churches and 400 members
 2. Two or three "strong" churches and several more "good" churches. Support pastor and help in district church extension.
- IV Maturity of District
1. Spiritual maturity
 2. Financial strength
 3. Pay budgets and United Stewardship Fund, enough to gradually support district program.
 4. Ecclesiastical maturity (make own decisions)
 5. District cohesiveness
- V When fully Organized
1. Four to six years later
 2. Members 500 to 700
 3. Churches - 20 to 25, Sunday School 1,000 to 1500
 4. Financial strength.

The minutes of the First Sitting were read and approved as read.

Rev. Pevy, The District Youth Secretary, gave his report which was accepted.

The Educational and Examining Board recommended that Gerald Stunkel be granted a first year license. Motion was carried.

Resolution Committee recommended that Resolution No. 4 be changed to 4 cents per mile. Motion was carried.

Resolution Committee recommended that Resolution No. 8 be deleted. Motion was Carried.

Motion was made and seconded that Resolution No. 13 be changed to read as two different resolutions. Motion was carried.

The latter part of Resolution No. 13 was amended.

Resolution No. 11 was amended.

The report of The Ways and Means Committee.

Resolution No. 1, 2, 4, 5, 7 were amended. (See Ways and Means Report)

A ten minute recess was given and Rev. Huff was asked to dismiss in prayer.

The Conference reconvened and Rev. Sumwalt led the congregation in singing "Beneath The Cross of Jesus".

Rev. Goodman led in prayer.

Rev. Hawkins introduced Rev. R. A. Beltz, the Director of the Pilgrim Pension Plan.

Rev. Beltz spoke to the Conference - I Cor. 9:14, "They that preach the Gospel should live of the Gospel".

Meeting adjourned because of the expiration of time.

Rev. Hawkins asked Rev. Cunningham to dismiss in prayer.

Third Sitting

The third sitting convened Tuesday, June 18, 1963 at 1:30 p.m. Rev. Sumwalt led the congregation in singing, "Saved, Saved, Saved".

Rev. Vance was called upon to lead in prayer. Minutes of the previous meeting were read and approved as corrected.

A motion was made and seconded to accept Mrs. Sally Hankus into the conference pending a letter of transfer.

Rev. R. C. Hawkins reported the following appointments had been made by the General Board:

DISTRICT SUPERINTENDENT'S REPORT

To the Tenth Annual Conference of the Florida District of the Pilgrim Holiness Church, Dr. Hawkins, Ministers, Delegates and friends, with profound gratefulness to God we gather to exercise our privileges of Christian fellowship and business relationships in another Annual Conference.

We have completed another year of church history with its eternally recorded records. What has been will now always be, how sober the thought, there is no road back. The **things that should have been accomplished**, but were not, are recorded as our failures. We have written our yearly epitaph. This Conference will inevitably bring forth disclosures of our success or failure. We make these remarks because the future belongs to us; we can do something about tomorrow and every day of this Conference year that is not already history. We can covenant with God and our co-workers that this year shall be a record of successes and not failures. Oh, that God would inspire us with a Pentecostal fervor that would carry us to victories **beyond** our goals and would destroy the complacency of this materially minded generation.

I recently read a definition of optimism and pessimism that impresses me greatly. I quote, "A pessimist is one who sees difficulty in every opportunity; while an optimist is one who sees an opportunity in every difficulty." What do we see? Our attitude to the future will determine our success or failure.

CHURCH IMPROVEMENTS

The following churches have made material improvements as listed:
BEVERLY PARK - Completed church decoration and installed new church sign.

BRADENTON - Two new Sunday School rooms and remodeled parsonage.

TAMPA FOREST HILLS - New church roof, redecorated Sunday School rooms and remodeled parsonage. Purchased 20 new pews.

TAMPA PINECREST - Constructed new church building with a value of \$18,000.

FT. LAUDERDALE - Completed Sunday School rooms, built nursery.

INTERCESSION CITY - Repainted Church building, considerable work on parsonage.

LYNN HAVEN - Installed new bath room.

MIAMI - Sold church and parsonage. Purchased new church, value \$25,000, equity \$25,000. Purchased new 3 bedroom, 2 bath parsonage, value \$15,500, equity \$11,600. Total indebtedness \$3,800.00.

WEST HOLLYWOOD - New ceiling, new lights, new floor, new seats, new hymnals. Have raised half the price of new piano, church newly decorated, new Sunday School equipment.

SATELLITE BEACH - New pews, church painted inside and out, folding doors for class rooms, new heaters, finished nursery and mens rest room.

ST. PETERSBURG FIRST - New pews, new piano, new hymnals, pulpit furniture, parsonage redecorated.

WARRINGTON - New heating system, sidewalks, landscaping, new carpet and platform, interior decorating.

CRESTVIEW - Church interior decorated.

FT. MYERS - Have just completed a new church and Sunday School unit that will be a great credit to the District.

This is a list of human appraisals. Only God knows the prayers, tears, hours, sacrifices, etc., that went into these improvements; and he keeps accurate records, no reward will be lost. Thank you on behalf of the District for these Labors of Love.

NUMERICAL

In membership there were five (5) churches with more than 10% gain. There were eight (8) churches with a gain.

In Sunday School Attendance there were nine (9) churches with a 10% gain.

There were seven (7) churches with more than a 10% gain.

There were ten (10) churches with a gain.

In finance there were eleven (11) churches over the 10% goal.

There were 14 churches with a gain.

A LOOK AT OUR ENEMIES

I Transiency

1. In going over our records it is easy to discover that most of our losses may be laid at this door. What can be done?
 - A. I suggest a neighborhood survey to show who are the transients and who are the permanent residents. We must not neglect anyone, but surely we need to spend much time with those who will become a permanent asset to our Churches.
 - B. Organize these groups into five-year, ten-year and upward groups. Tell them you are going to have a special service for the old-time residents, stress the fact they can qualify. Friendships can be formed that will have lasting results. Let these people know what we really are, not what we may think we are.
 - C. Let our positive approach to Salvation overweigh our negative approach. Time after time we hear the outsiders, "you belong to the againters church. You don't believe in this--you don't believe in that", while those precious truths that really characterize our church are relegated to the back-ground.
May God grant that the joy of our salvation shall be their strength even as it is ours.

II Materialism

1. Satisfaction with material things may become the dominant ruler of our lives.
2. May rob us of the higher ideals of life.
3. May rob us of our spiritual rewards. Quote, "a man's life consisteth not in the abundance of things which he possesseth". These are the words of the Master, "What shall it profit a man tho he gain the whole world and lose his own soul"?

III Recommendation

1. That each church establish goals in keeping with its strength.
2. That these goals be made the subject of earnest prayer, a sacred obligation.
3. That we check weekly as to our attainment of these goals.
4. That more attention be given to the preparation for our services.
5. That every department of the church receive our careful attention.
6. That you conduct a selling program as to the worthwhileness of our church and its efforts.
7. That our prayer meetings be prayer meetings rather than preaching or business meetings. Modern version - where prayer won't be made. Bible version - where prayer was wont to be made.
8. That we take time to be Holy.
9. That we promote revivals as **far** as possible.
10. That the payment of our budgets be a sacred duty on the part of pastor and people.

REPORT OF CONFERENCE YOUTH LEADER

The youth in the Florida District are on the move. There is a marked increase in the interest of Pilgrim Youth Societies.

We have two Zones reporting activities this year:

WESTERN ZONE, under the capable leadership of Mrs. H. M. Lee, has held four youth rallies with an average attendance of eighty-eight present. Offerings were received and dispursed. They have purchased two new banners for the zone as well as published a zone bulletin.

SKYWAY ZONE, under the leadership of Mrs. Frank Salvadore, has held seven rallies with attendance up to 160, with an average of about 125. They also had a Youth Banquet for "highschoolers" in tribute to the seniors of the zone. This zone has a good balance in the treasury again this year.

BROWNSVILLE PILGRIM YOUTH SOCIETY sent \$6.00 to Southern Pilgrim College for the library fund.

WARRINGTON PILGRIM YOUTH SOCIETY sent money to Southern Pilgrim College as well as to Owosso for the libraries. This society also raised \$25.00 for a local project.

RECOMMENDATIONS:

1. That all societies report to the District Youth Leader.
2. That all zones try to establish activities for their youth.

RESOLUTIONS COMMITTEE REPORT

No. 1 Appreciation

We, the Florida District Conference wish to express our appreciation to our General Secretary of Church Extension, Rev. R. C. Hawkins, for his inspiring leadership and efficient services. We also wish to express appreciation to our District Superintendent, Rev. M. C. Kittle, members of the District Council, and the many members and friends of the Church for their labors of love in making this conference a successful one.

No. 2 Committees

Be it resolved that the District Superintendent shall appoint all committees not elected by the Conference or appointed by the District Council. (Standing Rule)

No. 3 Conference

Be it resolved that the Conference Year shall end April 30th and that all reports shall be in the hands of the District Statistician and all funds in the hands of the District Treasurer by May 15. The District records shall close May 31, and the Annual Conference shall be held the third week of June, the place to be determined by the District Council. (Standing Rule.)

No. 4. Conference Delegates

Whereas the conference delegates give their time to attend the conference, and whereas there is additional expense involved, be it resolved that four cents per mile be paid for travel. Cost of meals and lodging shall also be paid for. This cost shall be borne by the local church. Each church shall sponsor one car.

No. 5. Finance

Be it resolved that the local Church Treasurers balance their books at the close of each month and forward all District and General funds to the District Treasurer immediately. (Standing Rule)

No. 6 Ministerial Meeting

Be it resolved that we have an annual Ministerial Meeting, the time and place to be determined by the District Council. Be it further resolved that the District Council appoint a program committee. (Standing Rule)

No. 7 Ministers

Be it resolved that all Ministers accepted as members by the Annual Conference of the Florida District, shall place their membership in some local church in the District within thirty days following the close of the Conference and that they shall make quarterly reports to the District Superintendent and an annual report to the District Statistician. (Standing Rule)

No. 8 Parsonages

Be it resolved that each local Church provide a parsonage with at least a telephone, utilities, refrigerator and cooking stove. (Standing Rule)

No. 9 Pastors

Be it resolved that each Pastor be granted a two weeks vacation with pay annually.

No. 10 Revival

Be it resolved that the Florida Conference set Friday noon meal as a time of prayer and fasting and we urge each local church when possible to observe the same.

No. 11 Sunday Schools

Be it resolved that the District Sunday School Promotional Secretary publish a news sheet each month showing the attendance of each Sunday School and news items. These reports shall be sent to each pastor in sufficient number that they can be passed to each family in the Church. (Standing Rule)

No. 12 District Youth

Be it resolved that there be a District Youth Board consisting of the District Superintendent, Conference Youth Leader and the District Youth Treasurer. Their duties shall be to determine the program, time and place of our District Youth activities. (Standing Rule)

No. 13 Zone Youth

Be it resolved that the Zone President, Secretary, and Treasurer, local Youth Leaders and the Pastor constitute a committee. They shall plan the programs, set the date and choose the place of the zone meeting. They shall raise funds in the youth zone meetings and disburse the same.

WAYS AND MEANS COMMITTEE REPORT

BUDGET

1. Be it resolved that each Church pay (10%) per cent of the regular and Sunday School offerings to be applied on the District Budget. Be it further resolved that the United Stewardship Fund be \$8.00 per member as recommended by the General Conference.

2. Be it resolved that the District Budget be prorated as follows: District Administration, 88%; District Camp and Conference, 5%; General Conference 5%; Southern Pilgrim College, 2%.

DISTRICT MINISTERS

3. Be it resolved that all ordained and licensed ministers of the District pay fifty (50%) per cent of their tithes from ministerial labors, into the District treasury, through the local Church where their membership is held, the same to be applied on the District Budget. (Standing Rule)

SALARIES

4. Be it resolved that the District Superintendent be paid two hundred (\$200.00) dollars on his salary monthly.

5. Be it resolved that the District Treasurer be paid \$50.00 annually and the District Secretary be paid \$25.00 annually, District Statistician be paid \$15.00.

6. Be it resolved that the District officials, other than the District Superintendent be paid 6 cents per mile, by auto, plus lodging and meals when engaged in District business.

DISTRICT EXPENSE

7. Be it resolved that the District Statistician and Sunday School Promotional Secretary shall be paid for all mailing and publishing expense.

8. Be it resolved that there be 250 copies of the District Minutes printed, each Church to be assessed \$5.00 for 10 copies, additional copies 50 cents each.

FLORIDA CONFERENCE
JOURNAL OF PROCEEDINGS
FIRST SITTING

Monday, June 15, 1964, 7:00 P.M.

The first sitting of the Eleventh Annual Conference of the Florida District of the Pilgrim Holiness Church convened at 7:00 P. M., June 15, 1964, at the Forest Hill Church, Tampa, Florida.

The Conference was opened by Rev. M. C. Kittle, District Superintendent.

REPORT OF THE SUNDAY SCHOOL PROMOTIONAL SECRETARY

To the 1964 Annual Conference of the Florida District of the Pilgrim Holiness Church:

Greetings! I come to the close of the Conference year with mixed emotions. Praise to God for each soul saved, each Christian strengthened, and each new scholar enrolled in our Sunday School, but sadness because of inadequate service to both God and man. But, as we start the new year we can say with Paul, "Brethren, I count not myself to have apprehended; but this one thing I do forgetting those things which are behind and reaching forth unto those things which are before, I press toward the mark for the prize of the high calling of God in Christ Jesus." Phillipians 3:13.

This has been a good year in the Florida District Sunday Schools. The reporting has been very good. Even though there were a few who did not get their reports in on time so they could be reported in the Pilgrim's Progress, yet most of the Sunday Schools did send their monthly reports.

Florida Sunday Schools show a gain of 99 per Sunday which is a 12% gain.

Miami has the highest numerical gain which is 24, Satellite Beach second with 19 gain, St. Petersburg third with 18 gain.

Miami and Satellite Beach tie for first place in the percentage gain. They each had 86% gain. Crestview was second with 78 % gain.

We present ribbons to all churches with a 5 per-cent gain or more:

50 per-cent or more: Crestview, Miami, Satellite Beach

25 per-cent or more: Pinecrest

20 per-cent or more: Bradenton, St. Petersburg, West Hollywood

5 per-cent or more: Brownsville

And to our beloved Superintendent for a District Percentage Gain of 12%.

I feel we must pray more, labor more diligently than ever before for the upbuilding of the Kingdom, but where we are insufficient our Christ is still more than sufficient for this world's ills.

REPORT OF CONFERENCE YOUTH LEADER

To the Eleventh Annual Conference of the Florida District of the Pilgrim Holiness Church, Rev. Hawkins, Chairman, Rev. Kittle, my District Supt., Delegates and friends. We feel that the Youth work of our District has made some progress this year, and that the District Youth Society is getting into a position where it is going to make a more tangible contribution to the growth, interest and well-being of the Florida District.

There has been considerable activity on the zone level, in the three zones that I have received reports from. Altho I have not received a report from them, I understand the Zone has also had considerable activity.

Western Zone reports six (6) zone meetings with an average attendance of 95. For one of their projects, they gave an offering of \$50.00 to Southern Pilgrim College. They report excellent cooperation among their churches.

The Goldcoast had six (6) zone meetings with an average attendance of 75. One of their main projects this year was to help our young people get better acquainted with the missionary work of our General Church. They also conducted a Zone watch night service with good attendance. They too, report excellent co-operation.

The Orange Belt Zone report they had three (3) zone meetings with fair attendance.

I was privileged to visit three of the zones, and sensed a good spirit in each of them. I was unable to get the rally dates from the fourth zone, so was unable to visit them. In this, I feel a bit as if I shirked my duty, altho I did not intend to.

The Youth Council, with me, feel that we have taken a big step forward in that we are definitely planning for our first Youth Camp this year. It seems in the Providence of God, that we are planning our first youth camp in co-operation with our Wesleyan Methodist brethren. They have graciously invited us to come and join with their youth this year. We will furnish part of the staff and they part. It will be held on their fine property at Brooksville, August 10 thru 14. I urge you to pray much for this venture. It could mean so much to our youth and to our District.

If the Youth camp this year is a success, then I would recommend that next year, if possible, we try a co-operative venture with our Wesleyan Brethren in the realm of a junior camp that are ages 9 to 12.

I would like to further recommend, that in this conference, we take some steps to provide some finances for the expense and operation of our District Youth work.

I have thoroughly enjoyed my labors in the District Youth Dept. this year, and have appreciated the help, fellowship and co-operation of my brethren on the Youth Council. I have attended two District Y.P.S. council meetings, two combined youth council meetings with our Wesleyan friends. I have been at three zone meetings, and have traveled 3,680 miles in the performance of these duties. I have appreciated the privilege of serving, if even in a small way, the youth of the Pilgrim Holiness Church, the Florida District, and to try to help lift a little of the burden for the District that my beloved District Superintendent, Rev. M. C. Kittle carries.

RESOLUTIONS COMMITTEE REPORT

No. 1 Appreciation

We, the Florida District Conference, wish to express our appreciation to our General Secretary of Church Extension, Rev. R. C. Hawkins, for his efficient services. We also wish to express our appreciation to our District Superintendent, Rev. M. C. Kittle, for his inspiring leadership. Much appreciation is expressed to Rev. Rickner and his church in making this conference a successful one.

No. 2 Committees

Be it resolved that the District Superintendent shall appoint all committees not elected by the Conference or appointed by the District Council. (Standing Rule)

No. 3 Conference

Be it resolved that the Conference Year shall end April 30th and that all reports shall be in the hands of the District Statistician and all funds in the hands of the District Treasurer by May 15. The District records shall close May 31, and the Annual Conference shall be held the third week of June, the place to be determined by the District Council. (Standing Rule)

No. 4 Conference Delegates

Whereas the conference delegates give their time to attend the conference, and whereas there is additional expense involved, be it resolved that four cents per mile be paid for travel. Cost of meals and lodging shall also be paid for. This cost shall be borne by the local church. Each church shall sponsor one car.

No. 5 Finance

Be it resolved that the local Church Treasurers balance their books at the close of each month and forward all District and General funds to the District Treasurer immediately. (Standing Rule)

No. 6 Ministerial Meeting

Be it resolved that we have an annual Ministerial Meeting, the time and place to be determined by the District Council. Be it further resolved that the District Council appoint a program committee. (Standing Rule)

No. 7 Ministers

Be it resolved that all Ministers accepted as members by the Annual Conference of the Florida District, shall place their membership in some local church in the District within thirty days following the close of the Conference and that they shall make quarterly reports to the District Superintendent and an annual report to the District Statistician. (Standing Rule)

No. 8 Parsonages

Be it resolved that each Church provide a parsonage with at least a telephone, utilities, refrigerator and cooking stove. (Standing Rule)

No. 9 Pastors

Be it resolved that each Pastor be granted a two weeks vacation with pay annually.

No. 10 Pastors Recall

Be it resolved that the vote on the pastors recall shall be taken in the first week of April and the results be immediately forwarded to the District Superintendent. Be it further resolved that where the pastor intends to resign or change churches, that he shall notify the District Superintendent not later than April 1st. This shall not apply to those serving under unexpired extended calls.

No. 11 Revival

Be it resolved that the Florida Conference set Friday noon meal as a time of prayer and fasting and we urge each local church when possible to observe the same.

No. 12 Sunday Schools

Be it resolved that the District Sunday School Promotional Secretary publish a news sheet each month showing the attendance of each Sunday School and news items. These reports shall be sent to each pastor in sufficient number that they can be passed to each family in the Church. (Standing Rule)

No. 13 District Youth

Be it resolved that there be a District Youth Board consisting of the District Superintendent, Conference Youth Leader and the District Youth Treasurer. Their duties shall be to determine the program, time and place of our District Youth activities. (Standing Rule)

No. 14 Zone Youth

Be it resolved that the Zone President, Secretary, and Treasurer, Local Youth Leaders and the Pastor constitute a committee. They shall plan the programs, set the date and choose the place of the zone meeting. They shall raise funds in the youth zone meetings and disburse the same.

WAYS AND MEANS COMMITTEE REPORT

BUDGET

1. Be it resolved that each Church pay (10%) per cent of the regular and Sunday School offerings to be applied on the District Budget.
2. Be it resolved that the United Stewardship Fund be \$8.00 per member as recommended by the General Conference.
3. Be it resolved that the District Budget be prorated as follows: District Administration, 88%; District Camp and Conference, 5%; General Conference 5%; Southern Pilgrim College, 2%;

DISTRICT MINISTERS

4. Be it resolved that all ordained and licensed ministers of the District pay fifty (50%) per cent of their tithes from ministerial labors, into the District treasury, through the local Church where their membership is held, the same to be applied on the District Budget. (Standing Rule)

SALARIES

5. Be it resolved that the District Superintendent be paid two hundred (\$200.00) dollars on his salary monthly.
6. Be it resolved that the District Treasurer be paid \$50.00 annually and the District Secretary be paid \$25.00 annually, District Statistician be paid \$15.00 annually, and District Publications be paid \$25.00 annually.
7. Be it resolved that the District officials, other than the District Superintendent be paid 6 cents per mile, by auto, plus lodging and meals when engaged in District business.

DISTRICT EXPENSE

8. Be it resolved that the District Statistician and Sunday School Promotional Secretary shall be paid for all mailing and publishing expense.
9. Be it resolved that there be 250 copies of the District Minutes printed, each Church to be assessed \$5.00 for 10 copies, additional copies 50 cents each.
