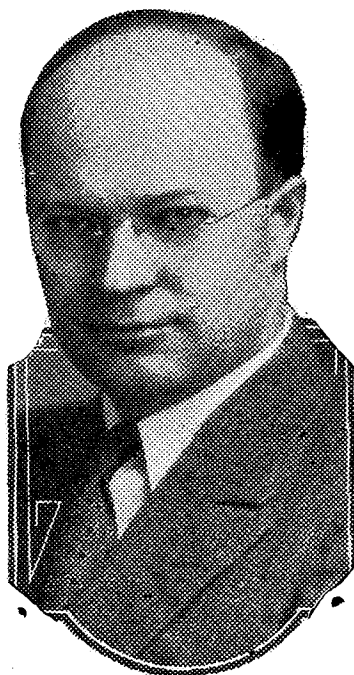

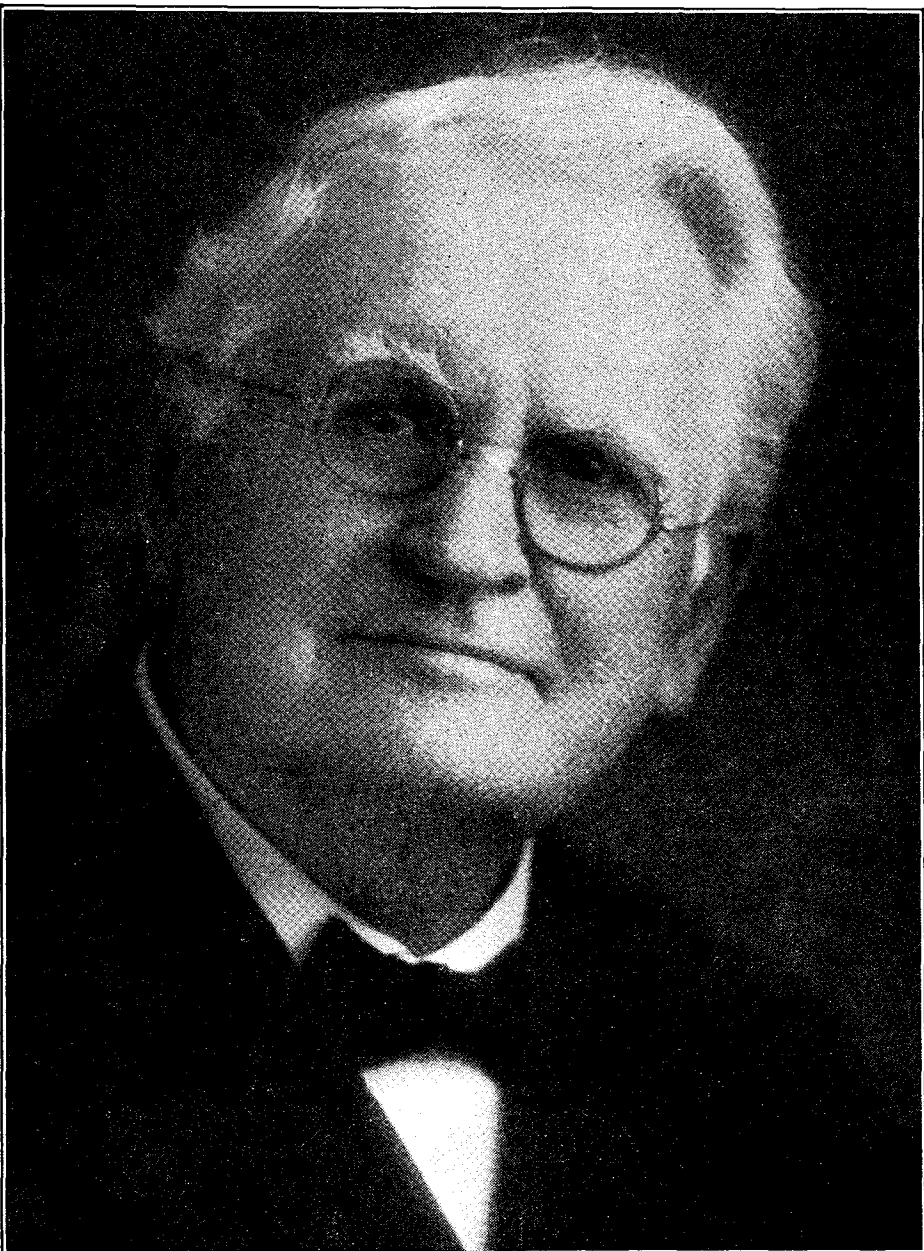

Minutes of Proceeding of the Eleventh Annual District Assembly

The Eleventh Annual Indiana District Assembly convened in the Tabernacle at Frankfort, Indiana, Aug. 14, 1933.

A profitable devotional service consisting of songs and prayer was followed by a fitting scripture lesson by Rev. Jack Donovan.

Rev. W. L. Surbrook, our General Superintendent, presided. After this appropriate resolution, the roll call was taken and each church responded with an estimate of the number of subscriptions to Advocate they would attempt to secure this coming year. The Indiana churches and evangelists promised to secure, if possible, 1,334 subscriptions to our paper.

The Auditing Committee presented a partial report as follows: We found the camp meeting books, Young People's Treasurer, Burial Association Treasurer and Secretary books to be correct. This report was accepted.

He requested us to be prompt with reports and financial obligations. All problems that need consideration, the Superintendent is anxious to assist. More fire, more victory, more prayer is what we need.

SUPERINTENDENT'S REPORT

To the members of the Indiana District:

Another year has passed into history. We have moved another year closer to eternity and I pray many miles nearer to God. Time waits for no one. As we look back, can we say that we have done our best? I pray that the persecutions, the trials, and difficult problems that we have passed through may only be stepping stones to greater success in this coming year.

In the past year, I have made 260 visits, preaching by the help of God 235 times. I bring no sad news. Our brethren and sisters have stood the storm and we are still on the march. Thank God. What is before us, we do not know, but one thing we are assured of, God will be with us. In our call for a donation for Old People's Home, our people have responded wonderfully, making it possible for us to bring to the home 359 1-2 lbs. of flour, 341 lbs. of sugar, 36 lbs. of coffee, 7 lbs. of tea, 50 lbs. of oats, 28 lbs. of rice, 348 lbs. of navy beans, 129 jars of jelly, 693 quarts, 85 half gallons, and 17 gallons of fruit, 58 bars of soap and many other items.

With the consent of the council, we arranged to build a chicken house on the farm. This money was to be raised outside of church obligations. We now have a chicken house built with tile, concrete floor. It is 50 feet long and 20 feet wide. Our churches have given us 150 old hens, 80 young chickens, 3 hive of bees, and the end is not yet. Praise the Lord.

Have enjoyed being associated with brother Montgomery this past year in the work of the district as his assistant. This has been a hard year for our churches and pastors from a financial standpoint and if they had not been in it whole-heartedly, there doubtlessly would have been several cases of desertion, but we have a good lot of self-sacrificing pastors, who have been able to look the wolf in the face and shout him out of countenance.

We have been privileged to visit several of our churches in the drive for our district indebtedness and while we were not able to raise much money, yet we enjoyed meeting with them and noting their spirit of devotion.

We have traveled 3,146 miles, paid out for expenses, \$23.32. Received of District Treasurer for expenses, \$22.32. Received of Winchester church on expense, \$1.00. Total received for expenses \$23.32. Received of Dist. Treas. for salary \$50.00. Collected of churches and turned into Dist. Treas. \$15.35.

We, the Executive Board of the Burial Ass'n. recommend the following amendments and changes in the by-laws of the Burial Ass'n.

1. We recommend that an age limit of 70 years be placed upon applicants for membership in this Ass'n., provided that this shall not apply to applications made prior to the enactment of this amendment.

2. We recommend that the Wesleyan scale of entrance fees be adopted, which are as follows:

Between the ages of 6 months and 10 years	\$.25
Between the ages of 11 years and 20 years50
Between the ages of 21 years and 30 years75
Between the ages of 31 years and 40 years	1.00
Between the ages of 41 years and 50 years	1.25
Between the ages of 51 years and 60 years	3.00
Between the ages of 61 years and 65 years	5.00
Between the ages of 66 years and 70 years	10.00

3. We recommend that where a church is disbanded that members who are members of the Burial Ass'n. shall be required to place their membership in some local P. H. church in order to continue their membership in the Burial Ass'n.

4. We recommend that the funeral benefit for one-half and one-fourth certificates shall be one-half and one-fourth of the whole certificate respectively.

5. We recommend that 30 days of grace be allowed to meet the requirements for reinstatement, also that the words "of fifty cents" be dropped from paragraph 4, article VII.

6. We recommend that the Burial Ass'n. Board be authorized and empowered to act in any emergency that might arise in carrying on the work of the Burial Ass'n. provided that they shall not change the by-laws nor levy extra assessments unless authorized by the District Council.

7. We recommend that the new entrance fees do not apply to reinstatements until August 1, 1934.

REPORT OF THE WAYS AND MEANS COMMITTEE

Recommendation 1

We recommend, that the Camp Meeting workers be appointed by the Camp Meeting Committee; and that no pastor or church assume authority to promise workers tickets.

2.

We recommend, that no delegate to the District Assembly be given free entertainment during Camp Meeting.

3.

We recommend, that the visiting, ordained, licensed and honorary ministers of the Pilgrim Holiness Church, their wives and dependent children be given meals during Camp Meeting; and also ordained ministers of others churches and their wives.

4.

We recommend, that there be a Publishing Committee composed of the District Secretary and two appointive members. It shall be the duty of this committee to publish Assembly Minutes.

5.

We recommend, that the annual business of the local church be closed on July 31, 1933; but that pastors shall continue in service until the Sunday after the District Assembly, the local church to report the extra time in the next year.

6.

We recommend, that the District Secretary be paid \$25.00 for his services.

7.

We recommend, that 500 copies of the 1933 Assembly Minutes be published within 10 days after Assembly adjourns; and that each local church send their order direct to the District Secretary with the money for the number of copies required.

8.

We recommend, that the District Treasurer be paid \$100.00 for his services.

9.

We recommend, that no Board shall obligate the Indiana District financially to exceed \$1500.00, without the sanction of the District Council.

10.

We recommend, that one-half hour each day be devoted to a "School of Prophets" during the 1934 Camp Meeting.

11.

We recommend, that a Ministerial Convention be held, the time, place, and subjects to be arranged by the District Superintendent; also that a period be devoted each day to a "School of Prophets."

12.

We recommend, that each pastor hold a Home Missionary meeting in a new location and report all openings for Home Missionary work to the Home Missionary Board.

13.

We recommend, that each church of the District be requested to send in to the Camp Meeting Treasurer not less than \$3.00 to help defray the table expense of the 1934 Camp.

14.

We recommend, that the five official members of the District Council be elected from the Ministerial Delegation. Recommendation lost.

15.

We recommend, that those pursuing the Study Courses send for their home study questions early in the year, forwarding sufficient postage with their request to cover cost of mailing questions or books.

16.

Inasmuch as the work of the Educational Board is greater than can be handled during the time of the Assembly, we recommend, that all those pursuing the Course of Study, be required to pass their examination prior to the close of the Assembly year. The candidate's manuscript shall be promptly mailed to the member of the Educational Board under whom the Course of Study is being pursued.

17.

We recommend, that the regular Assembly stenographer be paid \$8.00 plus traveling expenses and her entertainment during Assembly.

18.

We recommend, that we have one District Superintendent and two Assistant Superintendents. The two Assistant Superintendents shall be pastors and shall be located, one in the northern part of the District and one in the southern part of the District.

19.

We recommend, that the District Superintendent be paid \$1500.00 for the year plus his traveling expenses.

20.

We recommend, that each Assistant Superintendent be paid \$50.00 per year and his traveling expenses, while in service.

21.

We recommend, that there be a Home Missionary Board of three members composed of the District Superintendent and two elective members.

22.

We recommend, that the Burial Association Treasurer be donated his, his wife's and his minor children's membership in the Burial Ass'n.

23.

We recommend, that where competent persons of different families are available, that no two persons of one family be elected on the Local Church Board.

24.

We recommend, that all Ministers and Deaconesses, who expect to come before either the Educational or Examining Board, be required to be at the Assembly on the first day or forfeit their right to appear before the Boards, unless notification is made to either Board.

25.

We recommend, that where parsonages are not equipped with a heating device, that provision be made for same by the local church.

26.

We recommend, that the District Superintendent and his assistants prepare an itemized account of their traveling expenses, the same to be forwarded the first of each month to District Treasurer.

27.

We recommend, that where possible, that the local church board be composed of lay members.

28.

We recommend, that the Camp Meeting Committee formulate a set of rules governing conduct of campers in dormitories, these rules to be printed and posted in proper places.

29.

We recommend, that the District Budget consist of 10 per cent of all money raised by the local church, Sunday School and Young Peo-

ple's Society, except that raised for Foreign Missions, General Budget, and building funds.

30.

We recommend, that we extend to our General Superintendent a cordial invitation to preside at the 1934 District Assembly.

31.

We recommend, that we have a Nominating Committee of five, appointed by the Superintendent, whose duty shall be to nominate three men in the North and three men in the South to be voted on for the Assistant Superintendents, one to serve in the northern part of the state and one to serve in the southern part of the state.

32.

We recommend, that each church raise the equivalent of 4c for each of its members per month for the Old People's Home and send this money to the District Treasurer the first of each month.

33.

We recommend, that the District Assembly urge upon each church and pastor to make every effort to raise money for Foreign Missions and General Budget and that the District assume responsibility for \$3500.00 for Foreign Missions and \$1700.00 for General Budget.

34.

We recommend, that the District Superintendent give to the Examining Committee the names of Pastors and Churches who have failed to comply with section 107, page 61 of the Manual.

35.

We recommend, that each church give to the Old People's home a donation of groceries, canned fruit and vegetables, the same to be credited as a gift by the church.

36.

We recommend, that our District Camp begin on the second Friday of August each year.

37.

Whereas the budget system of the District must have the support of all our pastors: we recommend, that all pastors and churches not faithful in seeing that the budget is paid be referred to an examining committee of five, appointed by the District Superintendent, before being allowed a voice in District Assembly, according to Manual, page 72, paragraph 2, section 127.

38.

We recommend, that each church furnish the Camp with one pillow, one pillow case and one sheet.

39.

Whereas each year there is a difficulty in securing a correct ministerial list: we recommend, that each pastor bring to the Assembly a list of names of all unstationed ministers that are members of their churches respectively, with correct addresses.

40.

Inasmuch as the General Board has ruled against Y. P. District Organizations, and whereas the Indiana District Y. P. S. originated in this Assembly: We recommend, that this Assembly approve the action of the General Board in disorganizing the Y. P. S.

41.

Inasmuch as the District Council the past year authorized the transfer of the Home Mission and District Deficit funds to meet taxes, interest and other pressing needs and since the District is already heavily indebted: we recommend, that this Assembly grant these transferred funds be made a gift.

42.

Inasmuch as the General Assembly convenes so shortly after our

next District Assembly and our memorials to the General Assembly should come before our District Assembly: we recommend, that our District Superintendent appoint one of the conference committees to draft memorials to General Assembly to be presented to our next District Assembly for ratification and adoption.

43.

Since there is a deficit in the expense account of our District Superintendent of \$160.30: we recommend, that this Assembly authorize our District Treasurer to settle this account satisfactory to the District Superintendent.

44.

We recommend, that the church budget be sent the first of each month to the District Treasurer and be apportioned as follows: State Expense, 85 per cent; State Deficit, 5 per cent; Home Missions, 5 per cent; Mortgage Indebtedness, 5 per cent.

45.

We recommend, that the District furnish the Educational Board such copies of sets of questions as may be needed this year.

46.

We recommend, that the District Superintendent appoint a committee of 5 to arrange for a District Y. P. rally. Time and place to be decided by committee.

47.

We recommend, that we have two Examining Boards of three members each. Each Board is to work independently of the other; the work of these Boards to be equally divided. Matters necessitating council may be brought before a joint session of the Boards.

48.

We recommend, that the Burial Association Secretary be paid \$20.00 for each double call. We further recommend that he, his wife and their minor dependent children be donated free membership in the Burial Association.

49.

Whereas after investigation and deliberation the District Council found it necessary to close the College due to lack of funds, and lack of prospective pay students: we recommend, that this Assembly ratify this action taken by the council in closing the College.

50.

Inasmuch as the General Headquarters have need of 25 arm chairs to use during the next General Board meeting at Indianapolis and they have asked to borrow 25 of the arm chairs belonging to the College: we recommend, that this Assembly grant the loan of these chairs until they are needed.

Whereas God so wonderfully blessed in the messages of truth through His ministering servants, Rev. Albert Wilson and Rev. P. F. Elliott, and

Whereas a great harvest resulted in the ingathering of souls and the awakening of greater interest in Missionary and other fields of service:

Be it resolved that we make our appreciation known to God and before men by rising and singing, "Blessed Be The Name."

III.

Whereas, because of conflicting dates of Assemblies we are especially favored in having Rev. W. L. Surbrook as our Presiding Officer:

Be it resolved that we show our appreciation by a rising vote of thanks.

IV.

Whereas the success of our work, both local and District, depends upon the faithful co-operation of different agencies:

Be it resolved that we show our appreciation to the following by a rising vote: our District officials, pastors, evangelists, Camp committee and workers.

V.

Whereas the Pilgrim Holiness Advocate is spiritual, educational, missionary, co-operative with the General Church, the standard of our Faith and the official organ of our church, and

Whereas our District is recorded as being low in the percentage of subscribers to our church paper:

Be it resolved that we put forth our best efforts to place our District 100 per cent for the Pilgrim Holiness Advocate.

VI.

Whereas the great wave of Anti-Prohibition is sweeping over our fair Land, and

Whereas, multitudes are being swept away by the propaganda of Press and Radio:

Be it resolved that we exhort our ministry to "cry aloud and spare not" against this great evil, and that we as a church place our influence with all who are fighting to keep our Nation clean from the stain of Legalized Liquor and its allied evils.

VII.

Whereas, the Shoemaker Memorial Home is strictly an Indiana District institution, and,

Whereas, this Home houses some who were pioneers in the extension of the Pilgrim Holiness Church in Indiana.

Be it resolved that we respond gladly and promptly to the needs of this Home and fully co-operate with those having charge of this much needed work.

VIII.

Whereas, the Burial Association has proven a great blessing to hundreds of homes when sorrow made financial burdens more difficult to bear, and

Whereas, this worthy organization has suffered because of the present economic crisis:

Be it resolved that we, the ministerial and lay-members of the Indiana District, rally to its support and so help our depression-stricken brethren to give their loved ones a decent Christian burial.

IX.

Whereas, it is poor policy for a trout-fisherman to throw rocks ahead of him into the stream where he hopes to catch fish, and,

Whereas, the term "Holiness" in our denominational name is so identified with the modern Tongues and other fanatical Movements in many parts of the country that the very announcement of our name raises a barrier between us and the people whom we hope to reach:

Be it resolved that we favor the dropping of the term "Holiness" from our name, leaving the name simply, The Pilgrim Church.

X.

Whereas, the General Board is the most important and powerful body in the church next to the General Assembly, and should be composed of the key men of the church, and

Whereas, there is at present no provision made for our District Superintendents to meet in common council, or to be as fully in touch with the workings of the General Church as they should be, therefore
