# Minutes of Proceedings

The Twelfth Annual Indiana District Assembly convened in the Tabernacle at Frankfort, Indiana, August 20, 1934.

The Assembly opened with singing and prayer, after which Rev. Area Montgomery, District Superintendent, sounded the keynote "to do all to the Glory of God," and introduced Rev. W. L. Surbrook, General Superintendent, as the chairman.

In response, Rev. Surbrook read a portion of scripture, Philippians the second chapter. He then spoke of the progress of the church and the plans for the coming General Assembly.

The roll call of ministers and church delegates was taken.

The Assembly bar was fixed the same as last year; namely, the four middle sections extending to the third post of the Tabernacle.

Moved and seconded that the various sittings of the Assembly be adopted as follows: 7:00 to 9:00 a. m., 10:00 a. m. to 4:00 p. m., and 7:00 to 9:00 p. m. Carried.

Moved and second that District Superintendent Montgomery appoint all vacancies on various committees. Carried.

Moved and seconded that Ralph Nibarger be granted a withdrawal from the Statistical Committee. Carried.

By motion, Iona Hall was excused from the Auditing Committee, and Jesse Hayhurst was excused from the Reception and Devotional Committees.

The Ways and Means Committee presented a partial report. Recommendations No. 1 to 7, inclusive, were adopted.

Moved and seconded that the recommendation relative to the Old People's Home assessment be referred to the Ways and Means Committee for redrafting. Carried.

All members of the Examining Board and Educational Board were excused from the Assembly.

Moved and seconded to take a recess until 10:30 a. m. Carried.

Dismissed with prayer by Rev. Montgomery.

The Assembly reconvened, and after a profitable devotional service of songs, scripture quotations and prayer, business was resumed. Rev. Surbrook was in the chair.

The evening devotional service consisted of singing "He Abides" and "Tell It to Jesus." A scripture lesson from 2nd Tim. 2:1-19 was read by Rev. George Huff. After an unusual season of prayer, the presence of the Lord was made manifest by weeping, shouting and testifying of the goodness of the Lord and definite experiences of divine healing.

The roll call of ministers and church delegates was taken. The minutes of the last sitting were read, corrected and approved.

Assembly convened at the regular 10 o'clock session with Rev. W. L. Surbrook in chair. After singing "Revive Us Again" several scriptural quotations were repeated. Rev. Angus Jeffers lead in prayer.

The roll call was taken and each church responded with an estimate of the number of subscriptions to the Advocate they would attempt to secure this coming year. The Indiana churches promised to secure, if possible, 1240 subscriptions to our paper.

On the first ballot, Rev. Edward Schoeff was elected one of the three members of the District Council.

Moved and seconded that the next three highest names be voted upon for the other two members. Carried.

Moved and seconded that the order for the day be postponed until the voting is completed. Carried.

The Ordination Service was conducted by General Superintendent Surbrook, assisted by the Ordination Council. The Assembly sang "Rock of Ages," Bros. Schoeff, Huff and Crider read appropriate portions of scripture bearing upon this service. The General Superintendent impressively mentioned the requisites of a minister as a representative of the Pilgrim Holiness Church. Cleanliness, spirituality, study and good conduct are essential for a successful minister. Moved and second that we accept the report of the Burial Association Treasurer. Carried.

Moved and seconded that we incorporate within the minutes at the close of Educational Board report following the word "Notice," these two states: 1. All ministers that have not been ordained shall appear each year before the Educational Board first, whether notified or not, at each annual Assembly. 2. The Examining Board should be the second board before whom they shall appear, and not the first.

Adjourned by expiration of time. Dismissed with prayer by Rev. Area Montgomery.

### SEVEN O'CLOCK SITTING—WEDNESDAY MORNING

The Assembly joined in singing "I Love to Tell the Story," then Rev. W. L. Surbrook, chairman, read 15 verses of the 50th Psalm. Rev. Edward Schoeff led in prayer.

Minutes of the last sitting were read, corrected and approved.

The report of the Statistical Committee was read and accepted.

A resolution relative to the death of Marion French was read and accepted.

Moved and seconded that we accept Recommendations No. 29 by the Ways and Means Committee. Carried.

The committee on drafting memorials presented their report, and Memorials 5, 7, 8 and 9 were accepted. Memorial 6 was lost.

The name of Adam Schwing was nominated for Camp Meeting Committee, and the Assembly ratified this nomination.

Brother Strader and Sister Eva Riggs sang by request.

Moved and seconded that the Editing Committee have charge of printing the 500 copies of Memorials to the General Assembly.

Moved and seconded that 100 extra copies of minutes be printed for the district. Carried.

Moved and seconded that this sentence be added to the notice of the Educational Board in the minutes: "All preachers appearing before the Educational Board bring their local church recommendation with them." Carried.

Moved and seconded that the Assembly take a recess until 10:30 a. m. Dismissed with prayer by Rev. E. W. Wright.

The Assembly reconvened. Singing, scripture quotations and prayer were profitable to us. Rev. Surbrook in chair.

Recommendation No. 30, relative to addition of two members to District Council was read and adopted. By ballot these additional council members were elected as follows: Rev. W. A. Frye and Rev. C. G. Taylor.

Recommendation No. 31 was read and adopted.

A memorial relative to tenure of office of members of District Educational Board was read and accepted.

Invitations were received for the Ministerial Convention in 1935 from the following churches: Marion, French Lick, Muncie, Elwood, Indianapolis (First), Terre Haute Hulman Street Church.

The list of alternate delegates for ministers and lay members to the General Assembly were read and the appointment ratified.

Moved and seconded that the District Council be authorized to fill all vacancies among delegates or alternates to the General Assembly. Carried.

Recommendation No. 32 relative to a fund for ministers of small churches who desire to attend the Ministerial Convention was read and accepted.

Moved and seconded that the District Superintendent appoint a committee of three to investigate who is entitled to receive financial aid to attend the Ministerial Convention. This money need not be budgeted. Carried.

This appointment was Edward Schoeff, Joseph Jackson and Ernest Crowder.

Since there was an error, the Council made a few additions in the lay delegate list with their alternates, which corrected this list. All appointments were ratified by the Assembly.

The District Superintendent's report was read and accepted.

Moved and seconded that we take a ten-minute recess. Carried.

The Assembly reconvened and business proceeded.

Moved and seconded that the matter of securing rooms for General Assembly be left with the Camp Meeting Board. Carried.

The report of the Stationing Committee was read and accepted.

The District Council elected Area Montgomery, Edward Schoeff, Donald Snow, E. V. Halt and George Huff as trustees of the District. The Assembly ratified this appointment.

Moved and seconded that the District Council be authorized to take care of any unfinished business. Carried.

Minutes of this sitting were read and approved.

Moved and seconded that we adjourn.

Dismissed with prayer by General Superintendent Surbrook.

### SUPERINTENDENT'S REPORT

In the close of this, another conference year, with all its responsibilities, obligations and problems, it has been a pleasure to serve you. The associations with you, ministers and people, have been pleasing indeed, and I want to thank you for your faithful co-operation.

In the past year we have preached 215 times, made 30 visits, besides the many trips to the Old People's Home and farm. The churches have made it possible to bring to the home some splendid donations. Vincennes sent the largest donation, namely 40 gallons of peaches. It has been necessary to drive a well on the Old People's Home farm at the cost of \$110.00. The churches responded freely, and this debt is paid. Also we had to buy a team of horses at the cost of \$160.00. Part of this has been paid by our churches. One hundred and thirty-five dollars worth of hog wire has been placed around the Old People's Home farm. The barn has been painted and a 38 ft. bridge has been placed across the dredge ditch on the farm. For all that has been accomplished, let us give God the Glory.

We have traveled 30 000 miles, dedicated one church in Richmond and one in Morgantown, preached one funeral. We have in our district at this time 104 churches and 14 preaching points, where we hope in the future to organize churches. My expenses for the year were \$485.00 and my salary is paid in full.

## REPORT OF THE WAYS AND MEANS COMMITTEE

### Recommendation 1

We recommend that the following recommendations of the 1933 Assembly minutes be dropped: 9, 12, 14, 21, 28, 30, 31, 33, 34, 37, 40, 41, 42, 43, 49 and 50.

2

We recommend that one-half hour be devoted to a "School of Prophets" during camp.

3

We recommend that we have one District Superintendent and that he be paid \$1,500.00 plus his traveling expenses.

4

We recommend that we have one Assistant District Superintendent, and that he be paid his traveling expenses while in service.

5

We recommend that the District Superintendent and his assistant prepare an itemized account of their traveling expenses, the same to be forwarded the first of each month to the District Treasurer.

6

We recommend that on the second day, afternoon session, of the Ministerial Convention, a period be devoted to a business session to consider the following matters:

1. Location of next annual convention.
2. Hearing reports of committees on arrangements.
3. Election or appointment of such official committees as said convention may see fit to create.

7

We recommend that the home missionary work of the District be placed in the hands of the District Council.

8

Inasmuch as the present Camp Meeting Board does not contain a sufficient number of men, we recommend that two more members be added to the board.

9

Inasmuch as we have done but little toward Home Missionary work, we recommend that the District Council lay immediate plans for such work by dividing the District into zones and appoint a leader for each zone, each zone to hold group meetings to lay plans and raise funds for the support of a work in a new field and do its best to organize a strong new church.

10 (tabled)

11

Inasmuch as our District Superintendent has been burdened down with the care of the Old People's Home, we recommend that the governing of the home and farm be placed in the hands of the District Council, and that they shall appoint a Superintendent of the home and farm, and also a manager of the home and a manager for the farm.

12

We recommend that the burden of the raising of funds for the bonded indebtedness of the District property rest on the District Council, and not on the District Superintendent.

13 (referred)

14

We recommend that the District Council nominate the Ministerial and lay delegates and alternates to the General Assembly, and bring same before this Assembly for ratification.

15

We recommend that each church furnish the camp with the following articles: One sheet, one pillow and case, three glasses, three desert dishes, three cereal dishes, two plates and two dish towels.



Since all the churches did not respond to the special pledge offering which was taken during camp for the lifting of a \$500.00 bond by October 1, we recommend that each church send in an offering as follows:

- \$ 3.00 from each church with membership of 25 or less
- 5.00 from each church with membership of 26 to 40
- 7.00 from each church with membership of 41 to 60
- 9.00 from each church with membership of 61 to 80
- 11.00 from each church with membership of 81 to 100
- 15.00 from each church with membership of over 100

In order to take care of another bond with interest by April 1, we recommend each church send in an offering as follows by March 31:

- \$ 5.00 from each church with membership of 25 or less
- 8.00 from each church with membership of 26 to 40
- 11.00 from each church with membership of 41 to 60
- 14.00 from each church with membership of 61 to 80
- 17.00 from each church with membership of 81 to 100
- 20.00 from each church with membership of 101 to 125
- 23.00 from each church with membership of 126 to 150
- 25.00 from each church with membership above 150

We recommend that only ministers, their wives and unmarried dependent children and lay delegates be given entertainment during Assembly. All entitled to this entertainment shall be duly registered and given cards of recognition. For all other entertainment the same rate shall prevail as during camp.

We recommend that each church send its District budget the first of each month to the District Treasurer, and that it be apportioned as follows: District expense, 80%; District deficit, 5%; Home Missions, 5%; mortgage indebtedness, 10%.

We recommend that the Camp Meeting Committee formulate a set of rules governing the conduct and attire of people who occupy the platform, and also a set of rules for conduct around Tabernacle and grounds.

We recommend that where churches are unable to pay at least \$5.00 a week for pastor's support, the District Council be given the privilege of forming these churches into circuits.

We recommend that the Assistant District Superintendent be paid \$50.00 for his services.

23 (referred back to committee)

We recommend that each church furnish this portion of camp meeting supplies in time for the General Assembly, 1934, as follows: Three cereal dishes, three desert dishes, three heavy glasses and also three teaspoons.

We recommend that any person who cannot remain during the entire District Assembly not be sent as delegate, and all delegates sent be required to remain for the entire Assembly, except for the cause of sickness or death.

Whereas the General Board has voted recommending the General Assembly take over the Burial Association, and whereas, it is very probable that the coming General Assembly will assume control of the Burial Association, we recommend that the time limit for the reinstatement

ment fee of 50c be extended until such time as the General Church shall assume control of the Burial Association.

27

We recommend that the District Council formulate a new concise report blank for annual report of pastor to the Assembly.

28 (Lost)

29

Where there are sufficient competent members, we recommend no one person hold more than one office on the local church board.

30

Inasmuch as the work of the District Council has been increased and inasmuch as the Council has asked for a larger representation, we recommend that this Assembly elect two additional members to the District Council.

31

We, the Board of the former Anderson Chapel Pilgrim Holiness Church, recommend that our Assembly change the name to "Twin Oaks" Pilgrim Holiness Church, because we have abandoned the Anderson Chapel Church, and are building a new church and the law will require a new name.

32

Inasmuch as some of our pastors cannot attend the Ministerial Convention because of a lack of funds, we recommend that pastors receiving \$10.00 to \$15.00 a week salary shall donate \$1.00; pastors receiving \$15.00 to \$20.00 donate \$2.00; pastors receiving above \$20.00 donate \$3.00; this money to provide a fund for traveling expenses to the Ministerial Convention, same to be pro-rated to pastors receiving \$5.00 or less per week.

33

We recommend that the Camp Meeting workers be appointed by the Camp Meeting Committee; and that no pastor or church assume authority to promise workers tickets.

34

We recommend that no delegate to the District Assembly be given free entertainment during Camp Meeting.

35

We recommend that the visiting, ordained, licensed and honorary ministers of the Pilgrim Holiness Church, their wives and dependent children be given meals during Camp Meeting; and also ordained ministers of other churches and their wives.

36

We recommend that there be a Publishing Committee composed of the District Secretary and two appointive members. It shall be the duty of this committee to publish Assembly Minutes.

37

We recommend that the annual business of the local church be closed on July 31st, 1933; but that pastors shall continue in service until the Sunday after the District Assembly, the local church to report the extra time in the next year.

38

We recommend that the District Secretary be paid \$25.00 for his services.

39

We recommend that 600 copies of the 1934 Assembly Minutes be published within 10 days after Assembly adjourns; and that each local church send their order direct to the District Secretary with the money for the number of copies required.

40

We recommend that the District Treasurer be paid \$100.00 for his services.

41

We recommend that a Ministerial Convention be held, the time, place and subjects to be arranged by the District Superintendent; also that a period be devoted each day to a "School of Prophets."

42

We recommend that each church of the District be requested to send in to the Camp Meeting Treasurer not less than \$3.00 to help defray the table expense of the 1935 camp.

43

We recommend that those pursuing the Study Courses send for their home study questions early in the year, forwarding sufficient postage with their request to cover cost of mailing questions or books.

44

Inasmuch as the work of the Educational Board is greater than can be handled during the time of the Assembly, we recommend that all those pursuing the Course of Study be required to pass their examination prior to the close of the Assembly year. The candidate's manuscript shall be properly mailed to the member of the Educational Board under whom the Course of Study is being pursued.

45

We recommend that the regular Assembly stenographer be paid \$8.00 plus traveling expenses and her entertainment during Assembly.

46

We recommend that the District Superintendent be paid \$1500.00 for the year plus his traveling expenses.

47

We recommend that the Burial Association Treasurer be donated his wife's and his minor children's membership in the Burial Association.

48

We recommend that where competent persons of different families are available, that no two persons of one family be elected on the local Church Board.

49

We recommend that all Ministers and Deaconesses, who expect to come before either the Educational or Examining Board, be required to be at the Assembly on the first day, or forfeit their right to appear before the Boards, unless notification is made to either Board.

50

We recommend that where parsonages are not equipped with a heating devise, that provision be made for same by the local church.

51

We recommend that where possible, that the local Church Board be composed of lay members.

52

We recommend that the District Budget consist of 10% of all money raised by the local church, Sunday School and Young People's Society, except that raised for Foreign Missions, General Budget, and building fund.

53

We recommend that each church raise the equivalent of 4c for each of its members per month for the Old People's Home, and send this money to the District Treasurer the first of each month.

54

We recommend that each church give to the Old People's Home a donation of groceries, canned fruit and vegetables, the same to be credited as a gift by the church.

55

We recommend that our District Camp begin on the second Friday of August each year.

56

Whereas each year there is a difficulty in securing a correct ministerial list, we recommend that each pastor bring to the Assembly a list of names of all unstationed ministers that are members of their churches respectively, with correct addresses.

57

We recommend that the District furnish the Educational Board such copies of sets of questions as may be needed this year.

58

We recommend that the District Superintendent appoint a committee of five to arrange for a District Young People's rally. Time and place to be decided by committee.

59

We recommend that we have two Examining Boards of three members each. Each Board is to work independently of the other; the work of these Boards to be equally divided. Matters necessitating council may be brought before a joint session of the Boards.

60

We recommend that the Burial Association Secretary be paid \$20.00 for each double call. We further recommend that he, his wife and their minor independent children be donated free membership in the Burial Association.

## REPORT OF THE COMMITTEE ON RESOLUTIONS

1

Whereas God has marvelously blessed our Camp Meeting in the preaching of the Word, the unction of the Holy Spirit and in supplying the financial needs of the Camp in this critical economic period, also in the large number of persons who were privileged to enjoy the blessings of the Camp, therefore be it resolved that we express our thankfulness to God by standing and singing, "All Hail the Power of Jesus Name."

2

Whereas it is our very good fortune to have our General Superintendent, Rev. W. L. Surbrook, as our presiding officer in this our twelfth annual District Assembly of Indiana, therefore, be it resolved that we express this appreciation by a rising vote.

3

Whereas the repeal of the Volstead Act and the legalization of the distribution of liquor has resulted in a condition that, socially and morally, is no better than the so-called Prohibition Days, in that instead of segregated saloon districts governed by certain laws, served by men bar-tenders, we now have girls dispensing liquor in almost every restaurant and barbecue stand in the country, therefore, be it resolved that our District go on record as favoring any plan that would remedy these present day evils.

4

Whereas, death has removed from our roll, during the past year, Rev. J. F. Morris, who made his home for the last few years at the Shoemaker Memorial Home, therefore be it resolved that we stand and sing "In the Sweet Bye and Bye" as a memorial to our departed brother in the ministry.

5

Whereas the health of our Assistant Superintendent, Rev. W. J. Crider, is becoming impaired in this climate, and whereas, because of this condition he is removing to another District, and whereas his services, his council and his fellowship will be greatly missed in our District, therefore be it resolved that we express this feeling to our brother by rising and singing "Blest Be the Tie That Binds."

## MEMORIALS TO GENERAL ASSEMBLY

1

Whereas there has been difficulty in requiring ministers to surrender our pulpits and vacate our parsonages after they have been disqualified to hold credentials in our church, we therefore recommend that whenever the credentials of a minister have been revoked by proper authority on stated manual grounds, this minister's salary shall thereupon cease, and he shall vacate our pulpits immediately, and our parsonages within 30 days. We further recommend that he shall forever be disqualified to preach in any of our pulpits until his credentials have been restored by the Assembly of the District in which he resided.

2

We recommend that where competent persons of different families are available, that no two persons of one family be elected on the local Church Board.

3

Whereas our Manual, Section 174, provides that unless any lay member who receives a church letter, places it in another church within 60 days, it becomes void, but makes no provision as to how long a minister may keep his credentials after ceasing to be a member of our church, therefore we recommend that when any minister in our church fails to deposit his letter with another of our churches, or with some other organization within 60 days, his credentials shall become void, and are to be taken up by the District Council with which he was last registered.

4

Whereas the unlimited tenure of the office of the District Superintendents is not always conducive to the best interests of our District Organization, we recommend that no person shall hold this office for more than four consecutive years.

5

Whereas the expense of the General Assembly rests heavily on the Districts at the close of the quadrennium, we recommend that each District take steps to distribute this expense equally over the four years.

6 (Lost)

7

Whereas our churches do not seem to follow out the Manual as to divisions of classes, as stated in the Manual, Section 83, and this portion of the Manual is superfluous, therefore be it resolved this portion of the Manual be dropped.

8

Whereas the Pilgrim Holiness Advocate is second to none in its field, and whereas it alone contains information regarding our own church activities, therefore be it resolved that we favor any action in the direction of placing the subscription to the Advocate as a part of our church covenant.

9

We recommend that the following paragraph be added to Section 120, page 69 in the Manual: "The regulation dress and bonnet of an ordained deaconess shall be navy blue or white. This uniform shall be worn while engaged or employed in the duties of this office."
