# Minutes of Proceedings

The Thirteenth Annual Indiana District Assembly convened in the Tabernacle at Frankfort, Indiana, August 19th, 1935.

The Assembly opened with a devotional service in charge of Rev. C. D. Jester. Rev. Floyd Goins read a scripture lesson and lead the Assembly in prayer.

After the devotional service, with General Superintendent Surbrook presiding, the roll of ministers was called.

Motion carried that the Assembly bar consist of the four middle sections extending to the third post.

A motion prevailed that the various sittings of the Assembly be adopted as follows: 7:00 to 9:00 A. M.; 10:00 A. M. to 4:00 P. M.; and 7:00 to 9:00 P. M.

It was voted that District Superintendent Montgomery be authorized to make all appointments for the vacancies on the Ways and Means Committee and the Educational Board.

A motion prevailed that General Superintendent Surbrook address the Assembly Tuesday morning at 10:00 A. M.

The Assembly voted to accept Resolutions 1, 2, 3, 4, 5 and 6 of the

The Ways and Means Committee then reported; Carl Reed, Secre-  
 tary, reading and Recommendations 1, 2, 3, 4 and 5 were adopted.

### THIRD SITTING—August 19, 1935

The Third Sitting came to order at 7:00 P. M. After singing and  
 prayer the Ministerial roll was called. Each pastor responded to this  
 roll call with the number of subscriptions to the Pilgrim Holiness  
 Advocate he would attempt to secure this year. The roll of church  
 delegates was called and completed.

Recommendations 6, 7 and 8 were adopted. (Printed in the appendix).

A motion prevailed to refer Recommendation No. 9 to the Ways and Means Committee for redrafting.

The Assembly voted to accept Recommendations No. 10 and 11 presented by the Ways and Means Committee. (Printed in the appendix).

The following visiting Pilgrims were introduced and welcomed to the Assembly: Rev. R. T. Mills, president of Owosso Holiness Seminary, and wife; Rev. May from Kentucky; Rev. Ray Miller, returned missionary from Africa; and Brothers Skinner and Phipps, students from Owosso Seminary.

These visitors were granted an honorary seat within the Assembly bar.

By request of the Assembly, Brothers Skinner and Phipps impressively sang "Jesus Took My Burden."

A motion carried to change the hour of sitting Tuesday morning to 8:00 A. M.

By motion, the Assembly rescinded the action relative to meeting at 8:00 Tuesday morning, and it was voted to adjourn until 10:30 A. M. Tuesday morning.

At 9:15 o'clock, the Assembly adjourned and was dismissed with prayer by the District Secretary.

#### FOURTH SITTING—August 20, 1935

The Fourth Sitting opened with the song "Since Jesus Came into My Heart," then Rev. C. P. Pridgin read a scripture lesson, and addressed the Assembly with a stirring message relative to the necessity of unity among us. A blessed season of prayer followed this appropriate address.

A motion prevailed to dispense with the roll call the remainder of the Assembly.

General Superintendent Surbrook preached from the text "Give no offense in anything that the Ministry be not blamed." Pastors, workers and laity were stirred and received a new vision of the responsibility that is placed upon the Ministry, in preaching, practical living, and the loyalty that must be given to Christ and the Church. He admonished the Brethren to be an example of Christian character, avoiding all absurdities and antagonistic remarks, and slovenly appearance that hinders a worker's influence.

A motion carried to take a recess until 1:15 P. M. and Superintendent Montgomery dismissed the Assembly with prayer.

At 1:15 P. M., Assembly reconvened. The singing was led by Bro. Phipps from Owosso, Mich., and the scripture lesson was read by Rev. O. L. King, returned missionary from West Indies.

Moved and seconded that the report of the Auditing Committee relative to the District Treasurer's books be received. Carried.

The report of the District Treasurer was received by the Assembly. (Printed in the appendix).

A motion prevailed that all churches be instructed to follow the Manual according to Section 73, Page 48, which states that all money raised by representatives for institutions in our churches be sent to the District Treasurer.

After hearing the report of the District Treasurer, Recommendation 9, relative to the distribution of state funds, was reread and accepted by the Assembly.

Moved and seconded to accept Recommendation 12, relative to Home Missionary Work, presented by the Ways and Means Committee.

A motion prevailed to amend Recommendation 12 with this additional sentence, "All home missionary funds are exempted from Dis-

trict Budget." Recommendation 12 with its amendment was adopted. (Printed in the appendix).

It was voted to accept Recommendations 13 and 14 presented by the Ways and Means Committee. (Printed in the appendix).

Moved and seconded to rescind the action which accepted Recommendation 5, relative to a Statistical Committee. Carried.

Recommendations 15, 16 and 17 were adopted by the Assembly. (Printed in the appendix).

At the request of the Assembly, Rev. R. T. Mills gave an interesting and encouraging report of the progress of Owosso Seminary.

The Committee on Resolutions presented Resolution 7 and it was accepted. (Printed in the appendix).

A motion prevailed that the election of officers be the order of the day at 6:00 P. M.

#### FIFTH SITTING—August 20, 1935

The Assembly joined in singing "What a Friend We Have in Jesus," and Rev. Donald Snow led in prayer.

Minutes of the Fourth Sitting were read and approved.

A motion prevailed that the order of the day be postponed until a partial report of the Examining Board be received.

The partial report of the Examining Board was read and accepted. (Printed in the appendix).

It was voted that the following serve in the place of absent delegates and be granted a seat within the Assembly bar: Beulah Rogers, Scott City; Sister Thomas, Marble Corner; Mrs. John Williams, Brown's Chapel; Sister Rogers, Dupont; Sister Riggs, New Castle and Mrs. Bob White, Morgantown.

Moved and seconded that District Superintendent Montgomery appoint eight tellers. Carried. Tellers were appointed as follows: Ray Smith, Wilbert McCrory, Rollie Shell, Lester Mayhew, Carl Reed, Floyd Goins, Walter Speck and Ralph Nibarger.

Ballots were cast for the five advisory members of the Council, and tellers were excused to count the votes.

Rev. Moreland Yundt drew an impressive picture on the Second Coming while the song "He's Coming Soon" was sung.

Four additional tellers were appointed as follows: C. D. Jester, E. W. Wright, Leonard Guyer, and Mark Storey.

Ballots were cast for District Statistician and Rev. Mark Storey was elected.

A motion prevailed that District Superintendent Montgomery appoint a Nominating Committee of not less than five members to nominate a group of not less than ten names from which six are to be elected by the Assembly to constitute the Examining Board.

It was voted that the Nominating Committee be empowered to make nominations for all Committees.

Time for adjournment arrived but an extension of one hour was granted.

A motion carried that the Nominating Committee present a group of ten names from which six are to be elected by the Assembly to constitute the Educational Board.

The following were appointed by District Superintendent Montgomery to constitute the Nominating Committee: George Huff, Donald Snow, Edward Schoeff, C. G. Taylor, and Ray Smith.

It was voted that the Assembly set aside the election of officers, which was the order of the day, in order to receive the report of the Statistical Committee. The report of the Statistical Committee was read and accepted. (Printed in the appendix).

Moved and seconded that the report of the Camp Meeting Treasurer, Rev. Angus Jeffers, be accepted. Carried. (Printed in the appendix).

The report of the Auditing Committee, relative to the books of the Camp Meeting Treasurer, was read and accepted.

The following ten names were presented to the Assembly by the Nominating Committee, from which ballots were to be cast for six to constitute the Examining Board: E. W. Hall, Fred Johnson, W. S. Dean, O. W. Barnes, Walter Speck, Aaron Hayhurst, W. A. Frye, Ray Smith, Lawrence Williams, E. E. Crowder.

A motion prevailed that the two names receiving the highest number of votes serve for three years on the Examining Board; the two receiving the next highest serve for two years; and the two receiving the next highest serve for one year.

Tellers were excused from the Assembly to count the ballots.

Results of the ballot cast for the five Advisory members of the Council were announced and the following were all elected on the first ballot: Donald Snow, Edward Schoeff, C. G. Taylor, W. A. Frye, and E. W. Hall.

A trio composed of guitar, mandolin and accordion favored the Assembly with good music.

The following ten names were submitted to the Assembly by the Nominating Committee, from which ballots were to be cast for six to constitute the Educational Board: E. W. Wright, C. G. Taylor, Ruth Storey, Alice Hart, H. Shepard, Floyd B. Dunn, Clyde Titus, Pearl Dean, Carrie Gick and Mary Toombs.

Time for adjournment came but it was voted to continue thirty minutes with the matter in hand.

The tellers were excused from the Assembly to determine the results of this ballot.

A motion prevailed that the Assembly rescind the action relative to all committees being nominated by the Nominating Committee.

It was voted that all unelected committees be appointed by the District Council.

Moved and seconded that the District Trustees be appointed by the District Council. Carried.

The Memorial Service for Rev. Elmer Klopfenstein, Rev. E. C.



Rhoads and Rev. Joseph Akers was voted to be conducted during the Devotional hour Wednesday morning.

A motion prevailed to have breakfast at 8:30 A. M., Wednesday morning.

The sitting adjourned by motion until 10:00, Wednesday morning, and Rev. E. W. Hall dismissed with prayer.

### SIXTH SITTING—August 21, 1935

The Memorial Service for Rev. Elmer Klopfenstein, Rev. E. C. Rhoads and Rev. Joseph Akers, who have left us since our last Assembly, was opened by singing, "I Will Meet You in the Morning." Rev. C. G. Taylor offered prayer and a scripture lesson was read by Rev. George Huff. Rev. Edward Schoeff talked briefly on the life of each of the deceased, and admonished us to so live that when we are gone, we will be missed among those with whom we have laboured. The congregation stood and impressively sang "Amazing Grace."

Minutes of the last sitting were read and approved.

The results of the ballot cast for the Examining Board was as follows: Rev. W. S. Dean and Rev. E. W. Hall, each to serve three years; Rev. Aaron Hayhurst and Rev. Fred Johnson, each to serve two years; Rev. Walter Speck and Rev. William Frye, each to serve one year.

The result of the ballot cast for the Educational Board was read as follows: Rev. C. G. Taylor and Rev. Alice Hart, each to serve three years; Rev. F. B. Dunn and Rev. Harry Shepard, each to serve two years; Rev. Carrie Gick and Rev. E. W. Wright, each to serve one year.

A motion prevailed to accept Rev. E. W. Wright's resignation from the Educational Board. The next highest in the election was Mrs. Ruth Storey, who automatically became a member of the Educational Board.

Recommendation 18, presented by the Ways and Means Committee, was accepted by the Assembly, and Recommendation 19 was lost. (Printed in the appendix).

It was voted to accept Resolution 8, which expressed our pleasure of having Rev. W. C. Stone, Editor Emeritus of the Pilgrim Holiness Advocate, with us in our District Assembly. (Printed in the appendix).

A motion carried that the Assembly instruct the Ways and Means Committee to present a recommendation relative to securing funds for the State indebtedness; same to be apportioned according to the income of the pastors, unstationed ministers, ordained and licensed deaconesses.

A motion prevailed that pastors and their wives serving a church as one pastor, receiving one salary, pay on the state indebtedness as one pastor.

By legislation enacted in a preceding sitting, a list of rules was to be prepared by the Camp Meeting Committee and ratified by the Assembly, but due to lack of time for preparation of the same, the Assembly authorized the District Council to ratify these rules when formulated.

A motion carried to adjourn until 3:30 P. M., and Assembly was dismissed with prayer.

#### SEVENTH SITTING—August 21, 1935

The Seventh Sitting opened at 3:30 P. M., with the song "Near the Cross," and Rev. Carl Reed led in prayer.

Minutes of the Sixth Sitting were read, corrected and approved.

A motion prevailed to accept the report of the Zoning Committee relative to the rezoning of the District. (Printed in the appendix).

The District Council presented a report relative to the Assessment of the Churches according to membership to secure funds for the State Indebtedness, as follows:

This Ordination service opened with a song service led by Rev. C. D. Jester. The Assembly sang "A Charge to Keep I Have." Appropriate portions of Scripture were read by Edward Schoeff, C. G. Taylor and Donald Snow. General Superintendent Surbrook delivered the charge to the candidates for ordination. He admonished each one to be blameless in duty, demeanor and doctrine. After this unusual and impressive charge, the following nine candidates were duly ordained: Flo Andrews, Lindley Arnett, Floyd B. Dunn, Cleo Jones, Lester Henry, Ruth Klopfenstein, Ralph McCrory, George Phares, J. B. Zeits.

Report of the Stationing Committee was read. (Printed in the appendix).

A motion carried to authorize the District Council to approve the minutes of the Seventh Sitting.

The Assembly was adjourned and dismissed with prayer by General Superintendent Surbrook.

Indiana District Assembly.

Dear Fellow Ministers, brothers and sisters in Christ:

We are closing at this time another conference year. How quickly the years are passing by and yet there have been multiplied opportunities and responsibilities, the results of which will reach into eternity.

Each year has its burdens and its problems. This has been no exception. One thing reassures us as we push on from year to year. God is on our side and He is faithful.

I have preached 250 times this year by the help of the Lord, made 25 visits to churches where I did not preach, visited ten Zone meetings, organized two churches; namely, Norway and Beech Grove, traveled 30,000 miles. My expenses were \$396.44.

Some mighty problems have faced us as a District, one of which is the financial condition. God has greatly helped us. You will receive this report from our Treasurer.

As a church I believe we have made some progress. Our Zone meetings have been a blessing and I believe should be pushed until each Zone shall be a center for the organization of new churches, building up of the weaker ones and creating continually a greater spirit of unity and loyalty to our Church.

## REPORT OF THE WAYS AND MEANS COMMITTEE

### Recommendation 1

Inasmuch as the following recommendations of the 1934 Assembly have served the purpose for which they were made, we recommend that they be dropped: Recommendations 2, 6, 7, 8, 14, 15, 16, 17, 24, 26, 27, 30, 31, 41, 47, 48 and 60.

2

We recommend that the Camp Meeting Committee formulate a set of rules governing the conduct and attire of people who occupy the platform, and also a set of rules for conduct around the Tabernacle and grounds, and that these sets of rules be presented to this Assembly for ratification.

3

Inasmuch as the campus is congested during the Camp Meeting with cars so that there is very little suitable space available for visitors to spread out lunches, and little space available for resting between services, we recommend that a strip of ground 100 feet wide, west of the camp meeting grounds, be set aside for a parking ground, and immediate steps be taken to prepare same for 1936 Camp.

We further recommend that no tents be pitched, nor trucks parked along the east side of the campus.

4

Inasmuch as the Zone meetings have been beneficial in advancing the interests of the District, we recommend that they be continued as last year, and that the District Superintendent appoint a committee to rezone the District, and this committee report to this Assembly.

5

Inasmuch as the Statistical Committee has always been unable to give a report until the close of the Assembly, we recommend that all reports must be in the hands of the chairman of said committee not later than ten days after the close of the fiscal year.

(Carried and later rescinded).

6

Inasmuch as some pastors are unable to attend the Ministerial Convention because of a lack of funds, we recommend that all pastors receiving a salary of \$10.00 or more a week donate \$1.00 toward a fund for traveling expenses to the Convention, same fund to be prorated to pastors receiving a salary of \$5.00 per week or less.

7

We recommend that we have one District Superintendent and that he be paid \$1600.00 plus his traveling expenses.

8

We recommend that we have one Assistant District Superintendent and that he be paid \$50.00 plus his traveling expenses while in service.

9

We recommend that each Church send its District Budget the first of each month to the District Treasurer, and that it be apportioned as follows: District Funds, 80%; Mortgage indebtedness, 10%; Home Missions, 5%; General Assembly Expense, 5%.

10

Inasmuch as the District Superintendent has been heavily burdened with the Old People's Home and Farm, we recommend that the governing of the same be placed in the hands of the District Council in order that he may be relieved of all responsibility of same and devote all his time to the interests of the churches of the District.

11

We recommend that 700 copies of the Assembly Minutes be pub-

lished within ten days after the Assembly adjourns; and that all orders for same be sent directly to the District Secretary.

12

Inasmuch as in the past years we have done but little toward Home Missionary work, we recommend that the District Council form the churches of the District into two groups for the raising of funds; each group shall be responsible for raising \$15.00 per week. This amount shall be apportioned to the individual churches of the group according to the financial strength of the Church. Money accumulated shall be held as a trust fund by the District Treasurer until such time as the District Council shall see fit to put on campaigns in suitable fields.

It shall be the duty of the District Council to engage a competent evangelist and a corps of workers and place them in a good location and keep them there until a good church is organized.

All offerings raised in these meetings shall be turned in to the Home Missionary fund. All Home Missionary funds are exempted from District Budget.

13

We recommend the District Secretary be paid \$30.00 for his services.

14

We recommend the District Treasurer be paid \$110.00 for his services.

15

We recommend that the Assembly elect a District Statistician, and that all reports be in his hands not later than ten days after the close of the fiscal year.

We further recommend that he be paid \$10.00 for his services.

16

We recommend that each church furnish the Camp with the following articles: 1 pillow and case; 1 sheet; 1 straw tick; 3 plates; 3 heavy glasses; 3 cups.

17

We recommend that those pursuing the Study Courses send for their home study questions early in the year, forwarding a large stamped envelope with each request, to cover cost of mailing questions, etc.

18

We recommend that all campers bring their own pillows and sheets.

19

We recommend that each ordained and licensed Minister and Deaconess pay \$1.00 per month into the District Treasury on the bonded indebtedness. Lost.

20

We recommend the following recommendations from the 1934 Minutes be retained in the 1935 Minutes: Recommendations 5, 12, 18, 21, 25, 29, 33, 34, 35, 36, 37, 42, 44, 45, 49, 50, 51, 52, 53, 54, 55, 56, 57, 58 and 59. (Printed and renumbered beginning with Recommendation 22 in 1935 Minutes and ending with Recommendation 46 in 1935 Minutes).

21

In order to retire the bonded indebtedness, we recommend that all pastors pay an amount into the District Treasury each month as follows:

Those whose weekly income is \$5.00 or less .....	\$0.25
Those whose weekly income is \$5.00 to \$10.00 .....	.50
Those whose weekly income is \$10.00 to \$15.00 .....	.75
Those whose weekly income is \$15.00 to \$20.00 .....	1.00
Those whose weekly income is \$20.00 to \$25.00 .....	1.25
Those whose weekly income is over \$25.00 .....	1.50

We further recommend that all unstationed preachers and all deaconesses whose gross income is less than \$500.00 per year pay 50c per month and those whose gross income is \$500.00 and over, pay \$1.00 per month.

It is understood that those preachers who have pledged will be permitted to apply same on assessment.

We further recommend that the District Council formulate plans to put on a campaign among the members of the churches to raise funds on the bonded indebtedness.

22

We recommend that the District Superintendent and his assistant prepare an itemized account of their traveling expenses, the same to be forwarded the first of each month to the District Treasurer.

23

We recommend that the burden of the raising of funds for the bonded indebtedness of the District property rest on the District Council, and not on the District Superintendent.

24

We recommend that only ministers, their wives and unmarried dependent children and lay delegates be given entertainment during Assembly. All entitled to this entertainment shall be duly registered and given cards of recognition. For all other entertainment the same rate shall prevail as during camp.

25

We recommend that where churches are unable to pay at least \$5.00 a week for pastor's support, the District Council be given the privilege of forming these churches into circuits.

26

We recommend that any person who cannot remain during the entire District Assembly not be sent as delegate, and all delegates sent be required to remain for the entire Assembly, except for the cause of sickness or death.

27

Where there are sufficient competent members, we recommend no one person hold more than one office on the local church board.

28

We recommend that the Camp Meeting workers be appointed by the Camp Meeting Committee; and that no pastor or church assume authority to promise workers tickets.

29

We recommend that no delegate to the District Assembly be given free entertainment during Camp Meeting.

30

We recommend that the visiting, ordained, licensed and honorary ministers of the Pilgrim Holiness Church, their wives and dependent children be given meals during Camp Meeting; and also ordained ministers of other churches and their wives.

31

We recommend that there be a Publishing Committee composed of the District Secretary and two appointive members. It shall be the duty of this committee to publish the Assembly Minutes.

32

We recommend that the annual business of the local church be closed on July 31st, 1936; but that pastors shall continue in service until the Sunday after the District Assembly, the local church to report the extra time in the next year.

33

We recommend that each church of the District be requested to send in to the Camp Meeting Treasurer not less than \$3.00 to help defray the table expense of the 1936 Camp.



34

Inasmuch as the work of the Educational Board is greater than can be handled during the time of the Assembly, we recommend that all those pursuing the Course of Study be required to pass their examination prior to the close of the Assembly year. The candidates' manuscript shall be properly mailed to the member of the Educational Board under whom the Course of Study is being pursued.

35

We recommend that the regular Assembly stenographer be paid \$8.00 plus traveling expenses and her entertainment during Assembly.

36

We recommend that all Ministers and Deaconesses, who expect to come before either the Educational or Examining Board, be required to be at the Assembly on the first day, or forfeit their right to appear before the Boards, unless notification is made to either Board.

37

We recommend that where parsonages are not equipped with a heating device, that provision be made for same by the local Church.

38

We recommend that where possible, that the local Church Board be composed of lay members.

39

We recommend that the District Budget consist of 10% of all money raised by the local Church, Sunday School and Young People's Society, except that raised for Foreign Missions, General Budget, and Building Fund.

40

We recommend that each church raise the equivalent of 4c for each of its members per month for the Old People's Home, and send this money to the District Treasurer the first of each month.

41

We recommend that each church give to the Old People's Home a donation of groceries, canned fruit and vegetables, the same to be credited as a gift by the Church.

42

We recommend that our District Camp begin on the second Friday of August each year.

43

Whereas each year there is a difficulty in securing a correct ministerial list, we recommend that each pastor bring to the Assembly a list of names of all unstationed ministers that are members of their churches respectively, with correct addresses.

44

We recommend that the District furnish the Educational Board such copies of sets of questions as may be needed this year.

45

We recommend that the District Superintendent appoint a Committee of five to arrange for a District Young People's rally. Time and place to be decided by Committee.

46

We recommend that we have two Examining Boards of three members each. Each Board is to work independently of the other; the work of these Boards to be equally divided. Matters necessitating council may be brought before a joint session of the Boards.

4

Rhoads of Tipton, therefore be it resolved that we honor their memory by rising and singing that old hymn, "Eastern Gate."

5

Whereas our food and dining hall service has been exceptionally good, and whereas very little sickness has occurred during our Camp, therefore be it resolved that we express our appreciation to our cooks, to those who planned the meals and to those who served the dining hall in any capacity, by a rising vote.

6

Whereas our lunch stand was closed during the preaching services of our Camp, and whereas many times during the day the services at the lunch stand were halted in order that some one might offer prayer and ask God's blessing upon the food and service, therefore be it resolved that we heartily commend those in charge of the stand and express our appreciation by a rising vote.

7

Whereas prevailing conditions necessitated the closing of the Frankfort School, and whereas the Indiana District does not, at this time, maintain a school, therefore be it resolved that we lend our moral support to the School in our sister District in Owosso, Michigan, and that we encourage our young people to attend that school.

8

Whereas, God has marvelously answered prayer in granting us the pleasure of having our Editor Emeritus of the Advocate, Rev. W. C. Stone, with us in our District Assembly, therefore be it resolved that we manifest our thankfulness to God and express our Christian love and fellowship to Brother Stone by a rising vote.
