# Minutes of Proceedings

## FIRST SITTING—AUGUST 22, 1938

The Thirty-fifth Annual Indiana District Assembly convened in the Tabernacle at Frankfort, Indiana, August 22, 1938.

Assembly was opened with a devotional service in charge of Rev. Loyd Montgomery. The songs entitled "What a Friend" and "Amazing Grace" were sung. Rev. George Huff read the scripture and Rev. E. V. Halt led in prayer.

General Superintendent Surbrook was introduced to the Assembly and took the chair.

The Secretary called the roll.

A motion prevailed that the hours of the sessions be as follows: 7:00 a. m. to 9:00 a. m., 10:00 a. m. to 4:00 p. m., and 7:00 p. m. to 9:00 p. m.

A motion passed that District Superintendent Montgomery appoint people to fill the vacancies on the Committee on Memorials and the Ways and Means Committee.

A motion was passed that all local ministers who are pastoring churches be given a seat in the conference bar.

A motion prevailed to refer the matter of entertainment to the Ways and Means Committee.

The following visitors were introduced to the Assembly: Rev. and Mrs. Swanson, Rev. Mills, Rev. Hertel, Rev. and Mrs. King, Mr. and Mrs. Driscoll and Mrs. Hall.

It was voted to grant these brethren an honorary seat within the conference bar.

The District Superintendent appointed Rev. Ralph McCrory to fill the vacancy on the Ways and Means Committee, and Rev. Gilbert Noel to fill the vacancy on the Committee on Memorials to the General Assembly.

The following churches were presented and received into the Assembly: Monon, Ogdon, Wheatland, Brookside (Indianapolis), Greenbrier, Summersville, and Anderson Second.

Rev. Area Montgomery's report was read and accepted by the Assembly. (All reports of District Officers are printed in Reports of Officers, Boards and Committees.)

Assistant Superintendent George Huff gave a verbal report which was accepted.

A motion was lost that the reports from the local churches be read while nothing else is before the Assembly.

The Committee on Memorials to the General Assembly gave a partial report. (All memorials are printed in Reports of Officers, Boards and Committees.)

The motion prevailed that we recess for one hour.

Assembly reconvened by singing "What a Friend." Rev. Mills led in prayer. The Assembly sang "Amazing Grace," and Rev. and Mrs. Wade favored us with a song.

A partial report was made by the Resolution Committee. (All resolutions are printed in Reports of Officers, Boards and Committees.)

The Ways and Means Committee gave a partial report. (All recommendations are printed in Reports of Officers, Boards and Committees.)

Assembly adjourned by the expiration of time. Rev. George Huff dismissed with prayer.

## SECOND SITTING—AUGUST 23, 1938

The second sitting of the Assembly was opened with the song "Glory to His Name," with Rev. Rollie Shell leading. Rev. Newton led in prayer. The Assembly then sang a verse of the song entitled "Near the Cross."

It was voted that we dispense with the roll call.

The minutes of the first sitting were read and accepted.

The Auditing Committee's report was read and accepted. (This report is printed in Reports of Officers, Boards and Committees.)

The District Treasurer's report was read and accepted.

The Camp Meeting Treasurer's report was read and accepted.

A march offering was taken for table expense.

The report of the treasurer in charge of money for state indebtedness was read and accepted. (Printed in Reports of Officers, Boards and Committees.)

Rev. Sturk was introduced to the Assembly.

A motion that we elect officers was lost.

Mrs. Hankins, Mrs. Grazelle and Mr. and Mrs. Jackson were introduced to the Assembly.

The Ways and Means Committee reported.

The Resolutions Committee reported.

The motion was lost that the time for the election of officers be set for Tuesday morning at 10 o'clock.

A motion prevailed that we hear a message by Rev. Sturk on the Second Coming at 7 o'clock Tuesday morning.

The Secretary called the roll of the churches and each church responded with the number of subscriptions to the Advocate it would endeavor to get in the coming year. There were 1,057 subscriptions promised.

A motion prevailed that everyone eligible be given a card to get into the dining room.

The motion prevailed that Rev. Area Montgomery appoint someone to take care of the distribution of these cards. He appointed Rev. Wilbert McCrory.

Mrs. Grazelle of Pasadena, Calif., favored the Assembly with a musical number.

Assembly adjourned by the expiration of time. We were dismissed by Rev. Mills.

---

### THIRD SITTING—AUGUST 23, 1938

Session convened at 7 a. m. with Rev. Hall in charge of devotions. Rev. A. Montgomery led in prayer. Rev. Sturk gave a timely and interesting sermon on the Second Coming, stressing five points, namely: (1) The Mystery of Iniquity, (2) The Hinderer, (3) The Removal of the Hinderer, (4) The Revelation of the Man of Sin, and (5) The Destruction of the Man of Sin. The Assembly then sang the song entitled "When We All Get to Heaven."

The minutes of the last session were read and accepted.

The Ways and Means Committee reported.

The District Statistician's report was read and accepted.

The Assembly sang "The Doxology."

Rev. Montgomery appointed Rev. Floyd E. Dunn, Rev. Lester Mayhew and Rev. Walter Daugherty to act on a committee for rezoning the district.

The Assembly adjourned by the expiration of time. Rev. Sturk dismissed with prayer.

---

### FOURTH SITTING—AUGUST 23, 1938

The fourth sitting convened at 10 a. m. with Rev. Clem in charge of devotions. Rev. Preusz led in prayer. The Assembly was favored with a song by Junior Driscoll.

Brother D. W. Zook, Brother J. M. Zook, Brother Rosentrader and Brother Reese, all from Tabor, Ia., were introduced to the Assembly.

The motion prevailed that they be given an honorary seat within the conference bar.

The minutes of the third sitting were read and accepted.

Rev. Walter Surbrook addressed the Assembly with a stirring mes-

sage. His subject was "The Laborer Is Worthy of His Hire." In this timely discourse, among other things, he suggested: that the pastor's salary be paid during camp, that there be a stipulated salary for the pastor, that the pastor be furnished a telephone, and that he be given substantial donations. He also brought out the fact that evangelists have heavy expenses and should be better paid for their labors.

Rev. Storey read the report of the unstationed ministers and evangelists and it was accepted.

The report of the Educational Board was read and accepted.

The motion prevailed that the order of the day be the election of officers at 2 p. m.

The report of the Committee on Memorials to the General Assembly was read. Some memorials were carried.

The Ways and Means Committee reported. Recommendation was referred to the committee.

The report of the Home Missionary Committee was read and accepted.

Rev. Croy and Rev. Hall were introduced to the Assembly.

The motion prevailed to adjourn until the call of the chairman. The Assembly was dismissed with prayer by Rev. Floyd B. Dunn.

The Assembly reconvened and the election of officers was the order of the day. Rev. A. Montgomery was re-elected District Superintendent on the first ballot. Rev. George Huff was re-elected Assistant District Superintendent. Rev. F. B. Dunn was re-elected District Secretary. Rev. E. V. Halt was re-elected District Treasurer.

Rev. Mark Storey, District Statistician, was re-elected by acclamation.

The present trustees of the Indiana District were re-elected by acclamation.

The motion was passed that the District Superintendent appoint a committee of five to bring in nominations for the various committees to be ratified by the Assembly.

Brother Dean and Brother Frye were re-elected on the Examining Board by acclamation.

Rev. Taylor and Sister Hart were re-elected for three years to the Educational Committee by acclamation.

Rev. Area Montgomery appointed Rev. Carl Reed, Rev. Edward Schoeff, Rev. George Huff, Rev. Ralph Nibarger and Rev. Jesse Hayhurst to act on the Nomination Committee to nominate members to serve on the various committees.

A motion prevailed that the District Superintendent, Assistant District Superintendent, District Treasurer and District Secretary act as a committee to bring in the names of the delegates to General Assembly to be ratified by the Assembly.

The Ways and Means Committee reported. Some recommendations were adopted.

A motion was passed that the District Superintendent be given a two weeks vacation with pay.

The Ways and Means Committee reported. Some recommendations were adopted.

A motion was passed that the time be extended one hour.

As a token of the Assembly's appreciation of the leadership of the General Superintendent, Rev. Surbrook, an offering was taken for the purpose of buying him a new suit of clothes.

The report of the Committee on Delegates to the General Assembly was read and ratified by the Assembly.

The report of the tellers who counted the ballots for the election of five members for the District Council was read. Rev. Schoeff, Rev. Frye, Rev. Taylor and Rev. Floyd Goins were elected. Rev. Waddell was re-elected by acclamation to serve on the District Council.

The report of the committee appointed by Rev. Montgomery to nominate members to serve on the various committees was read and ratified by the Assembly.



The report of the Rezoning Committee was read and ratified by the Assembly.

The Committee on Memorials to the General Assembly reported.

The Ways and Means Committee reported and a recommendation was passed.

Rev. Surbrook introduced the following District Evangelists to the Assembly: Rev. Ralph Benjamin, Rev. Lawrence Williams, Rev. Frazee, Rev. Newton, Rev. Sanders, Rev. Hattie Dunkleberger and Rev. De Veir.

General Superintendent Surbrook recommended that the District Superintendent's vacation start at the end of this Assembly and continue until General Assembly.

A motion prevailed that Rev. Montgomery appoint the Zone Chairmen.

Rev. F. B. Dunn presented the offering taken to buy the General Superintendent a suit of clothes to the General Superintendent.

The session was adjourned by the expiration of time. Rev. Surbrook dismissed with prayer.

---

#### FIFTH SITTING—AUGUST 24, 1938

A short memorial service was held in the tabernacle with Rev. L. L. Scantland in charge of singing "Some Bright Morning." Rev. Loyd Montgomery read the 90th Psalm and Rev. Aaron Hayhurst prayed. The Assembly sang "The Eastern Gate." Rev. Area Montgomery made a few touching remarks in remembrance of those who have died since last Assembly. Those who have gone to be with God this last year are: Mrs. Emma Frye, the beloved wife of Rev. W. A. Frye; Rev. Loyd Lewis, formerly a pastor in this district; Brother William Hobson and Sister Frances Crowl, both members of the Old People's Home. The Assembly sang "Blest Be the Tie."

The minutes of the fourth sitting were read and accepted.

The Ways and Means Committee reported. Some recommendations were passed.

The Examining Board completed its report and it was accepted.

The motion was passed that the Logansport church be restored to its former zone.

Rev. Area Montgomery appointed the Zone Chairmen.

A motion prevailed that the word "Street" be attached to the name of the Terre Haute-Greenwood Church, making the name read "Greenwood Street Pilgrim Holiness Church" in the Minutes.

A motion prevailed that the District Council prepare some program to be presented to the Assembly next year with reference to the accommodation of the increasing crowds. The District Council is authorized to do whatever it feels best to temporarily relieve this situation.

A motion prevailed that the District Council be authorized to investigate and grant credentials to Rev. Hill, Violet Hill and Paul McNeely.

A motion was passed that the lunch stand be closed during the three main preaching services of the Camp.

A motion prevailed that the District Superintendent make the arrangements for the time and place for the Ministerial Convention to be placed on the back or in the Minutes.

A motion was carried that the Assembly recess until 10 o'clock. Rev. E. W. Hall dismissed with prayer.

The Assembly reconvened with Rev. Riggs in charge of singing "He's a Wonderful Saviour to Me." Rev. Clem led in prayer. We were favored with a song by a quartette.

The motion was passed by common consent that the name of A. O. Shipley be inserted in Resolution 5 of the Resolution Committee.

An impressive ordination service was held with seventeen candidates for ordination. "Amazing Grace" was sung and Rev. A. Montgomery led in prayer. "A Charge to Keep I Have" was sung with great feeling. It was moved and passed that a picture be taken of the group of ministers ordained in this service. Rev. Huff, Rev. Schoeff and Rev. Taylor read scriptures bearing on the duties of an ordained minister. Rev. Surbrook

gave a short talk outlining the characteristics that the Holy Spirit emphasises: (1) The candidate must be straight in his marriage relations—having but one living wife, (2) Vigilance, (3) Be sober, (4) Good behavior, (5) Given to hospitality, (6) Apt to teach. After this stirring message seventeen ministers were duly ordained.

Rev. Montgomery read the report of the Stationing Committee.

The motion prevailed that the Assembly give the District Council authority, in case they deem it advisable, to bring in a tenth Memorial to the General Assembly.

A motion prevailed that the Ordination Council be in the picture taken of the seventeen ministers ordained.

A motion was passed that the District Council read and approve the Minutes of the last session of this Assembly.

A motion prevailed that the District Council complete any unfinished business that might have been overlooked by this Assembly and that the record of the same be incorporated in the Minutes.

A motion prevailed that we adjourn and General Superintendent Surbrook dismissed the Assembly with prayer.

### DISTRICT SUPERINTENDENT'S REPORT

To the Indiana District Assembly,  
Convening at Frankfort, Indiana.

August 22, 1938

Dear Fellow Laborers:

I am happy to report to you the events of another conference year. This has been, to the Indiana District, a splendid year. I pray this is true with the entire church. God has been good to us and has seen fit to bless us exceedingly in our labors. Many have been saved and a number added to our church.

**CHURCHES ORGANIZED:** We have organized six churches this year: Wheatland, 12 members; Monon, 28 members; Ogdon, 23 members; Brookside (Indianapolis), 21 members; Greenbrier, 27 members, and Summersville, 23 members.

We owe the organization of Wheatland, under God, to Brother Gribble, Brother Wilson and Brother Kelley.

Monon was begun the latter part of last conference year. Rev. Hascue Carter wrote to us, asking us to help pitch a tent in Monon. Rev. J. B. Zeits had the tent and we advanced them forty dollars of Home Missionary money. Rev. Carter stayed there and is in charge.

Ogdon is a product of our present Home Missionary efforts. Rollie Shell is there and doing well.

For the Brookside Church (Indianapolis) we are indebted to Rev. Chester Newland and some others who stood faithfully by him. This church is located in a residential district. It is a nice church and has our first pipe organ.

Rev. Elmer Duncan has been instrumental in the organizing of the Greenbrier Church, which is located about seven miles from Paoli, Ind.

Rev. Will Gerbig was instrumental in the organizing of the Summersville Church.

We have a building in Terre Haute which has been called the Pilgrim Holiness Mission. Five hundred dollars is paid on this building, leaving a balance of only four hundred dollars. This has a mission hall and five-room parsonage all in one building. This should soon be organized into a church. The Prospect Street Mission (Indianapolis) is going well and should also be organized soon.

**PARSONAGES:** We have added ten parsonages to our number this year. They are: English, Evansville Second, Fulton, Beech Grove, Muncie, North Vernon, Spearsville, Twin Oaks, French Lick and Marion.

The church at English has built a splendid title parsonage with six rooms and a full basement. We had the pleasure of dedicating this parsonage to the Lord's work.

Twenty-eight churches have already had parsonages: Anderson First,

Bicknell, Burns City, College Corner, East Enterprise, Elwood, Evansville First, Epson and Elnora, Greensburg, Greenwood, Hartsville, Huntington, Indianapolis First, Kokomo, Lawrenceburg Lebanon, Linton, Logansport, Loogoootie, Michigantown, Morgantown, Orleans, Shoals, Sullivan, Hulman Street (Terre Haute), Tyner, Wabash and Westport.

Five churches: Muncie, Bicknell, Evansville First, Kokomo and Tipton have excavated, putting in full basements.

**LOCAL INDEBTEDNESS:** Our local churches are getting out of debt. Aurora burned their mortgage this year, and others are doing fine along this line.

**STATE DEBT:** We have liquidated \$2,000 on our bonded indebtedness, leaving a balance of only \$2,500 on bonded indebtedness. We have paid \$100 on another note, cutting this note to \$200. We have paid \$75 to one of the faculty, paying him in full. We have paid all interest and all obligations due. Thank God for His wonderful help.

**CAMP GROUNDS:** Some improvements have been made on our camp grounds, such as fencing, painting the hallways in the dormitories and Administration building, putting water and sinks in five of the cottages and the Sherman Hotel, putting new sliding doors on the Tabernacle, painting the dining hall, Sherman Hotel, seven cottages and the lunch stand, putting a new roof on the Administration building, and making several new benches.

**OLD PEOPLE'S HOME:** We repapered the major part of the Old People's Home this year and enlarged the washroom. We installed a new iron fireman that is to be paid for this November.

**OLD PEOPLE'S FARM:** We have brick veneered the farm house and have put a full basement under it. We have built a 24x40 feet addition to the barn with a hay loft, and have purchased a 1935 Chevrolet truck with dual wheels and overload springs.

This has been an exceptionally busy year. I have made 295 visits, preached 270 times, attended eight zone meetings, four District Council meetings, the Ministerial Convention, the State Young People's Convention, two Zone Young People's meetings, two General Board meetings, have dedicated one parsonage and two churches—Clarksburg and Chesterfield. I have traveled 37,000 miles.

I thank God for His protection and care through this year.

My salary has been paid in full and I have received \$500 on expenses.

## REPORT OF COMMITTEE ON HOME MISSIONS AND CHURCH EXTENSION

It is with praise to God for answered prayer that we, the Home Missionary Committee, submit the following report of our progress as a district in the field of Home Missions and Church Extension.

### New Churches

Seven new churches have been organized during the past year, six of which are to be presented to the district. They are: Ogdon, 23 members; Monon, 28 members; Wheatland, 12 members; Green Brier, 27 members; Sumerville, 23 members. Making a total of 137 members added to the district through these new churches.

### Churches Reorganized or Helped

For several years the Anderson Second Church has been in need of help. It was deemed wise by the committee, in consultation with the District Superintendent, to reorganize this church. This was done, and it now has a membership of 35. It has taken into its treasury over a thousand dollars in six months.

The Indianapolis Third Church, which has been on the point of collapse for a number of years, was helped by the committee, and now has a membership of 14. We have a beautiful church building at this place.



### **Missions**

A number of missions are now in operation in the district. These, along with a majority of the churches listed above, have been started by energetic pastors and their congregations who have dared to push out into the whitened harvest field for God and for souls. Among those that have come to the attention of the committee are: Prospect Street Mission, Indianapolis; Parr, a preaching point near Monon, Ind.; a Mission located in the center of Fort Wayne on a main street and in a good building; a Mission in Marion operating under the direction of the parent Pilgrim Holiness Church; Mission in Anderson; a mission in a good building near Andersonville. Many of these prospects are very bright, and no doubt will be organized into churches during the coming conference year.

### **Our Losses**

Along with the successes of this department of our work there have been some losses. An effort was made to conserve the efforts put forth last year in Gary, Ind., but after an attempt of one month it was deemed wise to discontinue our efforts there as the results were not such as would merit the spending of more funds in this place.

While the work at Hagerstown was organized with eleven members, at the present we do not have enough members to present this church to the district. Until recently this church has been carried as a preaching point. The future of it is somewhat uncertain at the present.

The committee has received from the Treasurer for incidentals, such as traveling expenses, telephone calls, etc., \$157.99.

All ministers who have not been ordained shall appear first each year before the Educational Board, bringing recommendations from local church, whether notified or not, at each Annual Assembly.

The Examining Board is the second board before whom all licensed ministers must appear, and not the first.

All ministers appearing before the Educational Board shall bring their recommendations with them.

**REPORT OF THE WAYS AND MEANS COMMITTEE**

1

We recommend that each church raise two cents per member each month for District Home Missionary work and church extension, money to be paid to the District Treasurer.

2

Inasmuch as it is sometimes impossible for the local church to send district funds to the District Treasurer by July 31, we recommend that the District Treasurer hold his books open until August 10.

3

We recommend that the Camp Meeting Board formulate a set of rules, governing the use and rates of electrical appliances, to be posted in the rooms and other conspicuous places.

4

Inasmuch as the District Superintendent has been heavily burdened, we recommend that the present farmer in charge of the Old People's Home farm be placed in charge of all farm interests and Old People's Home. This position to be known as the Superintendent of Old People's Home and Farms, with a salary of \$50.00 per month, and that he give a report quarterly to District Council. We also recommend that all applicants be accepted by the District Council.

5

Inasmuch as some adjustments are needed in zone boundaries, we recommend that the District Superintendent appoint a committee of three to re-zone the district. Anyone interested in the re-zoning of district confer with the Zoning Committee.

6

We recommend that the Ways and Means Committee meet at the call of the chairman prior to the next District Assembly at the Pilgrim Holiness headquarters. Their traveling expenses and entertainment to be paid by the District Treasurer.

7

We recommend that we have one Assistant District Superintendent who shall be paid \$4.00 per day or fraction of a day while he is actively engaged in service to the district, plus the traveling expenses incurred in such service.

8

We recommend that 1,000 copies of the Assembly Minutes be published within thirty days after the Assembly adjourns, and that all orders for same be sent directly to the District Secretary.

9

Whereas our farmer has worked faithfully for four years with no time for rest and recreation, we recommend that he be allowed a two weeks vacation with pay at a time when he can best be spared from his work. He shall provide a competent man to take care of the farm during his absence, this man to be paid from the revenues of the farm.

10

We recommend that the ordained, licensed and honorary ministers of the Pilgrim Holiness Church, their wives and dependent children, and also ordained ministers and their wives of other churches be given meals during Camp Meeting.

11

We recommend that all pastors, evangelists and unstationed ministers failing to send in their reports to the District Statistician by the tenth of the month following the end of the conference year be denied a seat within the conference bar for that year.

12

We recommend that the District Budget be pro-rated as follows: District funds, 65%; District Home Missions, 10%; General Assembly, 5%; Old People's Home, 15%; Camp Meeting equipment and table expense, 5%.

13

We recommend that the District Budget consist of 10% of all money raised by the local church, Sunday school and Young People's societies, except that raised for Foreign Missions, General Budget, building funds, and all funds raised for specified district interests.

Building funds purposes shall be interpreted to include rent on parsonages and churches and money paid on contracts of the same.

14

Inasmuch as Sunday School work is greatly neglected in many places, we recommend that each zone have a Sunday School Convention every six months. We further recommend that a Sunday School leader be appointed for each zone by the District Superintendent and respective zone presidents.

15

We recommend that each church grant its pastor a two weeks vacation with salary.

16

We recommend that the District Superintendent appoint a committee of five to arrange for a District Young People's Rally. We further recommend that the time be the second Friday, Saturday and Sunday of June; place to be decided by the committee.

17

We recommend that those desiring entertainment as workers during the Camp Meeting, other than those specified by Recommendation 10, shall pay a registration fee of \$1.00 when accepted as workers.

18

We recommend that the Young People's Zone boundaries conform to the zoning of the District Zoning Committee.

19

We recommend that we delete from our Minutes, Recommendations 4, 8, 14, 16, 18, 26, 28 and 38 from the 1938 Minutes.

20

Inasmuch as some of the churches were not represented when pledges were taken for District Indebtedness, we recommend that the District Superintendent be authorized to contact said churches relative to pledges and offerings for District Indebtedness.

21

We recommend that our District Superintendent be authorized to complete arrangements for the Ministerial Convention; we further recommend that ministers submit subjects for the Ministerial Convention to our District Superintendent.

22

Inasmuch as the zone meetings have been beneficial in advancing the spiritual, educational and doctrinal interest of the district, we recommend they be continued.

23

We recommend that each church provide a parsonage with telephone.

24

We recommend that the annual business of the local church be closed on July 31 of each year, but that pastors shall continue in service until and including the Sunday after the District Assembly, the local church to report the extra time in the next year.

25

We recommend that the regular Assembly stenographer be paid \$15.00, plus traveling expenses and her entertainment during Assembly.

26

We recommend that the District Council be given the privilege of forming small churches into circuits.

27

We recommend that our District Superintendent be paid a salary of \$2,100.00 plus \$500.00 for expenses.

28

We recommend that the District Council purchase insurance for the camp ground cottages and contents. The cost of said insurance to be paid by the Camp Treasurer.

We further recommend that said insurance shall be made payable to the Trustees and Camp Treasurer of the camp grounds.

We further recommend that where individuals wish to have a loss paid to them, that a contract of insurance be entered into between them and the Camp Treasurer; such contract to provide that they shall pay a pro-rata of the insurance. As long as they shall keep their pro-rata paid, they shall be entitled to recompense for such loss as shall be paid to the Camp Treasurer for loss sustained to the cottage or contents.

29

We recommend that for a period of one year the following plan for the Old People's Home farm be adopted. On the first of our Assembly year \$100.00 be placed in the hands of our farmer as a working capital.

The farmer shall give to the District Treasurer an itemized account at the close of each month of money expended and balance on hand. The District Treasurer shall then reimburse the farmer for the amount expended.

30

We recommend that all persons taking the preacher's study course shall have their examinations in the hands of their instructors by July 16 of each conference year.

We recommend that at each annual Camp Meeting, on the last Thursday, Friday and Saturday, there shall be one daily session of the Educational and Examining Boards for the purpose of the examination of ministers. All ministers knowing themselves due to appear before these boards are urged to be present.

We further recommend that the time of such sessions shall be announced from the platform.

31

We recommend that needed repair be made to our Tabernacle and buildings, and that no new buildings or changes be made upon our State Camp Grounds unless authorized by this Assembly or two-thirds majority vote of the District Council.

32

We recommend that our District Council be instructed to investigate all county records and procure all needed legal assistance to bring all records up-to-date of all district property. Expenses shall be paid by District Treasurer.

33

We recommend that the District Secretary be paid \$50.00 for his services for the year of 1938-39.

34

We recommend that the District Statistician be paid \$30.00 for his services.

35

We recommend that the Camp Meeting Committee formulate a set of rules governing the conduct and attire of people who occupy the platform, and also a set of rules for conduct around the tabernacle and grounds, and that these rules be presented to the Assembly for ratification.

36

We recommend that the District Treasurer be paid \$110.00 for his services.

37

We recommend that those pursuing the study courses send for their home study questions early in the year, forwarding a large stamped envelope with each request, to cover cost of mailing questions, etc.

38

We recommend that only ministers, their wives and unmarried dependent children and lay delegates be given entertainment during Assembly. All entitled to this entertainment shall be duly registered and given cards of recognition. For all other entertainment the same rate shall prevail as during Camp.

39

We recommend that any person who cannot remain during the entire District Assembly shall not be sent as delegate, and all delegates sent be required to remain for the entire Assembly, except for the cause of sickness or death.

40

Where there are sufficient competent members, we recommend no one person hold more than one office on the local Church Board.

41

We recommend that the Camp Meeting workers be appointed by the Camp Meeting Committee, and that no pastor or church assume authority to promise worker's tickets.

42

We recommend that no delegate to the District Assembly be given free entertainment during Camp Meeting.

43

We recommend that there be a Publishing Committee composed of the District Secretary and two appointive members. It shall be the duty of this committee to publish the Assembly Minutes.

44

We recommend that where parsonages are not equipped with heating device, that provisions be made for same by the local church.

45

We recommend that where possible the local Church Board be composed of lay members.

46

We recommend that each church raise the equivalent of four cents for each of its members per month for the Old People's Home, and send this money to the District Treasurer the first of each month.

47

We recommend that each church give to the Old People's Home, a donation of groceries, canned fruit and vegetables, the same to be credited as a gift by the church.

48

We recommend that our District Camp begin on the second Friday of August each year.

49

Whereas, each year there is a difficulty in securing a correct ministerial list, we recommend that each pastor bring to the Assembly a list of names of all unstationed ministers that are members of his church, respectively, with correct addresses.

50

We recommend that the district furnish the Educational Board such copies of sets of questions as may be needed this year.

51

We recommend that we have two Examining Boards of three members each. Each board is to work independently of the other; the work of these boards to be equally divided. Matters necessitating council may be brought before a joint session of the boards.

(Carried.)

3

Whereas, our General Superintendent has arranged his dates to be with us to preside at our Thirty-fifth Annual Assembly, therefore

Be it resolved that we, as an Assembly, vote our appreciation of thanks by standing and singing "Blest Be the Tie That Binds." (Carried.)

4

Be it resolved that we, the Pilgrim Holiness Church of Indiana, condemn the liquor traffic as an outlaw to God and justice, and urge upon our membership that they refrain from patronizing, where at all possible, stores, restaurants and filling stations which sell intoxicants in any form. (Carried.)

5

Whereas, God in His wisdom has seen fit to call to their eternal home one of our Indiana ministers, Rev. Lloyd Lewis; one licensed deaconess, Margaret Francis; Mrs. Emma Frye, faithful wife of one of our pastors; two members from the Shoemaker Memorial Old People's Home, name-

ly, Sister Frances Crowl and Brother William Hodson, and O. A. Shipley, therefore

Be it resolved that we express our sympathy by standing with bowed heads for one minute, followed with prayer by our State Superintendent. (Carried.)

## MEMORIALS TO GENERAL ASSEMBLY

### INDIANA DISTRICT

#### Memorial No. 1

"WHEREAS: Our Manual makes no provision for the non-assessment of juvenile members, and

"WHEREAS: This may have a tendency to discourage such membership, therefore

"BE IT RESOLVED: That all members under voting age be listed as non-assessable members.

#### Memorial No. 2

"WHEREAS: The Manual provides that each church vote on the recall of the pastor at least thirty days before the District Assembly, but makes no provision for the answer of the pastor to the church and District Superintendent, and

"WHEREAS: The failure to answer gives occasion for confusion to both the church and District Superintendent, therefore

"BE IT RESOLVED: That where the local church votes to recall a pastor, he shall notify the church of his acceptance or refusal within fifteen days after such recall is made. The District Superintendent shall also be notified of his decision.

#### Memorial No. 3

"WHEREAS: The Manual states that each church shall provide a parsonage for its pastor, and

"WHEREAS: No provision is made for the District Superintendent, therefore

"BE IT RESOLVED: That each district shall provide a parsonage and telephone for its Superintendent.

#### Memorial No. 4

"WHEREAS, Our Manual makes no provision for the disorganization of local churches, and

"WHEREAS: This provision is sometimes needed, therefore

"BE IT RESOLVED: That the following be adopted:

"When such action seems advisable, a local church may be disorganized by two-thirds vote of the District Council. Appeal from this action may be made to the General Board. When a local church disbands or is disorganized, all property belonging to the local church shall become the property of the District Assembly with which the said local church has been affiliated, and the local trustees shall make proper transfer of all such property to the District Trustees, unless the District Council shall, in any given instance, for reasons which seem sufficient to them, refuse to permit such transfer of property."

#### Memorial No. 5

"WHEREAS: The annual signing of ordained minister's annual credentials has not proven satisfactory, and

"WHEREAS: There should be some such annual credentials issued certifying the minister's standing, and

"WHEREAS: These credentials should be of such size and form as to be conveniently carried by those whose work necessitates traveling, therefore

"BE IT RESOLVED: That the form in Section 204, Page 128 of the Manual be reproduced on a small card, suitable for carrying in billfold, and that these credentials be issued annually to each ordained minister in good standing.

#### Memorial No. 6

"INASMUCH: As our evangelists receive an evangelistic commission in the form of a certificate, and

"INASMUCH: As our licensed and ordained preachers, as well as our licensed and ordained deaconesses, receive a certificate of license, and

"INASMUCH: As many of our song evangelists travel extensively and are actively engaged in song evangelism, but have no credentials, therefore

"BE IT RESOLVED: That all song evangelists who are regularly and actively engaged in song evangelism be given a certificate of license as such.

"WE FURTHER RECOMMEND: That all candidates for such credentials be recommended by the local church of which he or she is a member, also that such person be required to appear before the Examining Board and receive recommendation from same.

#### **Memorial No. 7**

"WHEREAS: Under the present formation of the General Board, some districts have no representative on the board, and

"WHEREAS: The District Superintendents are the key men of the districts, therefore

"BE IT RESOLVED: That the General Board consist of the general officers of the church, the superintendents of the organized districts, and one other member from each district for each two thousand members, plus two school representatives, one to be selected from the section west of the Mississippi and one from the section east of the Mississippi.

The traveling expenses of the District Superintendents and elective members are to be met by their respective districts upon an equalization of carfare basis.

The district elective members are to be first elected by the district delegations at the General Assembly, and afterwards by the District Assemblies.

#### **Memorial No. 8**

"INASMUCH: As our publishing interests have been making a steady growth, and

"WHEREAS: There is now no provision made for the future interests of this department, and

"WHEREAS: Our present buildings are inadequate to properly house printing equipment, therefore

"BE IT RESOLVED: That each year the net profits of the publishing department be put into a fund to be held in trust by the treasurer of the publishing department for the purpose of erecting and equipping our own publishing house.

#### **Memorial No. 9**

"INASMUCH: As Section 142, Page 85 in our Manual has worked a hardship upon certain licensed ministers, due to their inability for various reasons to meet the requirements of this section, and

"WHEREAS: It is somewhat inconvenient for the State Council to act upon the same, therefore

"BE IT RESOLVED: That this section be amended to read as follows:

"All licensed ministers failing to complete and report on at least two subjects a year in their required course of study, for two consecutive years will automatically forfeit their license, unless in the judgment of the Educational Board an exception shall be made.

The District Council shall have power to review and pass upon such action when it deems it advisable.

When an applicant cannot be present at an annual Assembly, due to unusual circumstances, the Educational Board and other boards may pass on such cases provided such absentee has sent in a satisfactory report and also has a recommendation from his local Church Board and District Superintendent.
