# Minutes of Proceedings

### FIRST SITTING

The Thirty-sixth Annual Assembly of the Indiana District convened in the Tabernacle at Frankfort, Indiana, August 21, 1939, at 7:30 a.m.

The Assembly was opened with a devotional service in charge of Rev. Gilbert Noel.

General Superintendent, Rev. W. L. Surbrook, was introduced to the Assembly and took the chair.

Rev. Surbrook gave a timely message to the Assembly.

The Secretary called the roll.

A motion was passed that the conference bar be set to include the three main sections of the tabernacle back to the third post, exclusive of the wings, and to include the platform.

A motion prevailed that the hours of session be as follows: 7:00 a. m. to 9:00 a. m., 10:00 a. m. to 4:00 p. m., and 7:00 p. m. to 9:00 p. m.

The motion prevailed that the District Superintendent make the appointments to fill vacancies on the various committees.

The report of the District Superintendent was read and accepted. (Printed in Reports of Officers, Boards, and Committees.)

Rev. Reed, chairman of the Home Missionary Committee, gave a verbal report of the Home Missionary work for this year, and the following churches were received into the Conference: Alexandria, Twelve Points (Terre Haute), Merom, Edinburg, and Fort Wayne. (Printed in Reports of Officers, Boards, and Committees.)

The statistical report was read by the District Statistician, Rev. Mark Storey, and was accepted. (Printed in Reports of Officers, Boards, and Committees.)

Assembly adjourned by the expiration of time. Rev. Area Montgomery dismissed with prayer.

### SECOND SITTING

The second sitting of the Assembly was opened by singing "What a Friend." Rev. E. W. Hall led in prayer.

A motion prevailed to dispense with roll call.

The minutes of the last sitting were read and accepted.

Rev. Area Montgomery appointed Rev. Thurman Pruesz to serve on the Examining Board, and Rev. Imogene Snyder to serve on the Educational Board.

The Ways and Means Committee gave a partial report. (Printed in Reports of Officers, Boards, and Committees.)

The District Superintendent appointed Mrs. E. W. Hall and Rev. and Mrs. Ermal Wilson to serve on the Auditing Committee.

The motion prevailed that the Assembly adjourn until 2:00 o'clock. Rev. George Huff dismissed the Assembly with prayer.

Session reconvened by singing "Near the Cross." The Assembly was led in prayer by Rev. Floyd B. Dunn.

Report of the Resolutions Committee was read and accepted. (Printed in Reports of Officers, Boards, and Committees.)

A motion prevailed that the Tipton church be put back in Zone 2.

A motion prevailed that the Tuesday morning devotional service be devoted to a memorial service.

A motion prevailed that the order of the day be the election of officers.

A motion was passed that Rev. Area Montgomery appoint six tellers.

Rev. W. L. Surbrook led in prayer.

A motion prevailed that the order of the day be postponed until the report of ministers could be had and voted into the Conference. This report was read and accepted.

A motion prevailed that all local licensed ministers who are pastors be granted a seat within the Conference bar with privileges of the bar.

Rev. Area Montgomery was re-elected District Superintendent. Rev. George Huff was re-elected Assistant District Superintendent. Rev. Floyd Dunn was re-elected as District Secretary. Ballots were cast for District Treasurer and Rev. E. V. Halt was re-elected as District Treasurer. Ballots were cast for the District Council.

A motion prevailed to adjourn. Rev. Taylor dismissed with prayer.

### THIRD SITTING

The third sitting opened by singing "There Is a Fountain Filled With Blood." Rev. George Huff led in prayer.

The Secretary called the roll of the churches and each church responded with the number of Advocate subscriptions it would endeavor to get in the coming year. There were 1,151 subscriptions promised.

The Secretary then called the roll of the delegates.

The minutes of the last sitting were read and accepted.

The report of the tellers who counted the ballots for the election of five members for the District Council was read. Rev. W. A. Frye, Rev. Edward Schoeff, Rev. C. G. Taylor, Rev. Floyd Goins, and Rev. L. L. Waddell were elected.

Rev. Mark Storey was re-elected as District Statistician by acclamation. The Trustees of the Indiana District were re-elected by acclamation. They are: Rev. George Huff, Rev. Area Montgomery, Rev. E. V. Halt, Rev. Edward Schoeff, and Rev. C. G. Taylor.

A motion prevailed that members be elected by acclamation to fill the vacancies on the Examining Board. Rev. Thurman Pruesz. Rev. Edward Schoeff, and Rev. Jesse Hayhurst were elected.

A motion prevailed that Rev. Imogene Snyder and Mrs. Mark Storey be elected by acclamation to serve on the Educational Board.

A motion prevailed that the District Superintendent appoint a nominating committee of five to bring in nominations for all the committees, said nominations to be ratified by the Assembly.

Rev. and Mrs. Mills and Rev. Garnet Jewell were introduced to the Assembly.

Rev. Area Montgomery appointed Rev. Melvin Snyder, Rev. Carl Reed, Rev. E. W. Hall, Rev. Clarence Morrison, and Rev. Mark Storey to serve on the Nominating Committee.

The report of the Auditors was read and accepted. (Printed in Reports of Officers, Boards, and Committees,)

Rev. Montgomery introduced the district evangelists and singers.

The Camp Meeting Treasurer's report was read and accepted. (Printed in Reports of Officers, Boards, and Committees.)

The report of the Examining Board was read and accepted. (Printed in Reports of Officers, Boards, and Committees.)

A motion prevailed that we extend the time until 10:00 o'clock.

The ordination service was opened by singing "A Charge to Keep I Have." Rev. George Huff led in prayer. Scriptures having reference to the duties of an ordained minister were read by Rev. Schoeff, Rev. Taylor, and Rev. Montgomery. After a very impressive talk by Rev. W. L. Surbrook, nineteen candidates were ordained. "Rock of Ages" was sung by the Assembly.

A motion was passed that Rev. George Huff, Rev. E. W. Wright, and Rev. Area Montgomery be in charge of the Memorial Service.

A motion prevailed that the time of the next session be set at 8:00 o'clock Tuesday morning.

Rev. Carl Reed, chairman of the Home Missionary Board, introduced to the Assembly the delegations from the churches organized this year. Rev. E. V. Halt dismissed with prayer.

### FOURTH SITTING

A short memorial service was held in the tabernacle. The service was opened by singing "What a Friend," after which Rev. George Huff

prayed. Rev. E. W. Wright, Rev. George Huff, and Rev. Area Montgomery spoke briefly in remembrance of those who have died since last Assembly. Those who have gone to be with God this last year are: Rev. Melvin Pratt, Rev. John Anderson, Rev. Earl King, Rev. Ellis Mendenhall, Brother John Wharton, Brother Inman, Sister Hodson, Sister Alice Brady, and Sister Mattie Shepherd. Rev. C. D. Jester sang "Jesus Saviour Pilot Me." The service was dismissed with prayer.

Session reconvened at 10:00 o'clock by singing "What a Friend." Rev.

Parker Husselton led in prayer.

A motion prevailed to dispense permanently with roll call.

The minutes of the last sitting were read and accepted.

The report of the Nominating Committee appointed to bring in names of members to fill the vacancies on the various committees was read and ratified by the Assembly.

A motion prevailed that we refer the matter of the Home Missionary set-up back to the Ways and Means Committee, and that they work out a plan and bring it in to the Assembly.

The Assistant District Superintendent's report was read and accepted.

(Printed in Reports of Officers, Boards, and Committees.)

The Ways and Means Committee reported. (Printed in Reports of Officers, Boards, and Committees.)

A motion prevailed that we recess until 12:00 o'clock.

Session reconvened by singing "Near the Cross." Rev. Area Montgomery led in prayer,

A motion prevailed that all discussion be stopped and that a vote by secret ballot be taken on whether or not to start the school this fall. The Assembly voted the school be started in the fall—217 votes cast, 172 for the opening of the school in the fall, and 45 against.

The Assembly was favored with a song by the Munn quartette.

A motion prevailed to lift Recommendation 43 of the Ways and Means Committee from the table.

A motion to put Muncie church back in Zone 3 was tabled.

A motion prevailed that a picture be taken of the ministers ordained this year, and that it be inserted in the minutes.

Session was adjourned by the expiration of time. Rev. L. L. Waddell dismissed with prayer.

### FIFTH SITTING

Session opened by singing "In the Sweet Bye and Bye." Rev. Morrison led in prayer.

The minutes of the last session were read and accepted.

The Examining Board read the names of candidates recommended for ordination. This report was accepted.

Three ministers were ordained, after which the Assembly sang "Blest Be the Tie That Binds."

The Ways and Means Committee read their report. (Printed in Reports of Officers, Boards, and Committees.)

The Examining Board's report was read and accepted. (Printed in Reports of Officers, Boards, and Committees.)

The Nominating Committee read the nominations for members to serve on the Frankfort Bible School Board.

The report of song evangelists was read and accepted. (Printed in Re-

ports of Officers, Boards, and Committees.)

A motion prevailed that the Assembly vote on the names as presented by the Nominating Committee.

A motion prevailed that 400 copies of the booklet of papers read at the 1939 Ministerial Convention be printed.

A motion prevailed that the time be extended 15 minutes.

The tellers reported on the vote for the School Board. The following were elected: Rev. Mark Storey, Rev. Waddell, Rev. Floyd Goins, Rev. Area Montgomery, and Rev. Aaron Hayhurst.

Rev. L. L. Waddell resigned, and Rev. Dean filled this vacancy.

Assembly adjourned by the expiration of time. Rev. Area Montgomery dismissed with prayer.

### SIXTH SITTING

The sixth session was opened by singing "He Is So Precious to Me."

Rev. George Huff led in prayer.

The motion prevailed that the District Superintendent make appointments of Zone Chairmen where they have not been elected as provided by Assembly ruling.

The minutes of the last session were read and accepted.

Rev. W. A. Frye led in prayer.

The Educational Board's report was read and accepted. (Printed in Reports of Officers, Boards and Committees.)

The Ways and Means Committee reported further. (Printed in Reports of Officers, Boards and Committees.)

Rev. Pursley dismissed the sixth sitting with prayer.

### SEVENTH SITTING

Session was opened by singing, "Whiter than Snow." Rev. Riggs led in prayer after which the Assembly sang, "Amazing Grace."

The minutes of the last sitting were read and accepted.

Rev. Mrs. Gibson was ordained.

Rev. Miss Shutts, formerly of the West Virginia District, was intro-

duced to the Assembly.

The motion prevailed that the recommendation with reference to the District Superintendent's salary and traveling expenses be changed from "\$2,100.00 plus \$500.00 for expenses" to "\$2,100.00 and expenses."

The motion prevailed that the future Zone Meetings be held jointly—Young People and Adults—and that the time of meeting be left to the discretion of the Zone.

The motion prevailed that the District Superintendent be granted two

weeks' vacation with pay.

A motion prevailed that the Assembly recess until the call of the bell to give the Stationing Committee time to finish its report. Brother Hall dismissed with prayer.

Session reconvened by singing a few verses. Rev. Huff led in prayer. A motion prevailed to accept the name of Lillian Hobbs as a licensed minister.

The report of the Stationing Committee was read and accepted. The Assembly was dismissed with prayer by Rev. Aaron Hayhurst.

# REPORTS OF OFFICERS, BOARDS AND COMMITTEES

### DISTRICT SUPERINTENDENT'S REPORT

To the Thirty-Sixth Annual Assembly of the Indiana District of the Pilgrim Holiness Church convening at Frankfort, Indiana, Aug. 21, 1939, I beg to submit this report:

When we look back through the past in the years of our church's history in Indiana considering the trials, tests, and battles we have confronted, we are fully convinced that God has been with us and He that

careth for those that love Him has surely cared for us.

As we come to you with the report for this year, we are made to say that the same God lives. He has not forsaken us but has watched over us through another year. To say that we are fully satisfied with the results of this year would be false. We feel there is much to be done and so much left undone, that it is hardly possible that we will ever reach a place in this life where we are entirely satisfied. We do appreciate all that God does for us. He has blessed our ministry and churches and advances have been made along many lines.

CHURCHES ORGANIZED: We have organized five churches this year, namely: Alexandria, Twelve Points (Terre Haute), Merom, Edenburg, and Fort Wayne. We have purchased a tabernacle in Boonville on two nice lots. It is in good repair and a splendid building with a good con-

gregation. The properties cost us \$1,000. This work should soon be organized. We have five other preaching points some of which are making good progress toward organization and one that has asked to be organized immediately after Conference. The Home Missionary Chairman will give you a full report of this part of the work.

PARSONAGES: We have added four parsonages to our number this year. They are at Brookside church of Indianapolis, at Tipton and at Indianapolis Second Church. Muncie has sold their parsonage and

erected a beautiful nine-room parsonage close to their church.

LOCAL IMPROVEMENTS: Evansville First Church has remodeled to such an extent that they have practically a new building. A number of churches have painted, improving their appearance greatly.

LOCAL INDEBTEDNESS: I officiated at the burning in effigy of the last mortgage note on our church at Greenwood Street, Terre Haute.

OLD PEOPLE'S HOME. Our home has suffered the loss of four of our inmates this conference year. God has been good to us at the Home and the response of our churches for the support of the Home is encouraging.

OLD PEOPLE'S HOME FARM: The farm is progressing nicely and

everything looks good for a bumper crop.

CAMP GROUNDS: We have erected a new dormitory on the Camp Grounds, consisting of 39 rooms, ladies' and men's rest rooms, and four shower baths. We have placed a sewage system across the grounds and made it available if desired to all the cottages on the south side of the tabenrnacle.

DISTRICT INDEBTEDNESS:: I am happy to tell you that God has enabled us as a church to liquidate \$2,000 on our bonded indebtedness.

To Him be all the glory.

I have made 225 visits this year, preached 209 times, attended General Assembly, General Board Meeting, our Ministerial Convention, Young People's Convention, and eight zone meetings. I officiated at nine funerals and assisted at three. I have traveled 35,000 miles and received my salary in full and \$500 on my traveling expenses.

### REPORT OF THE HOME MISSIONARY COMMITTEE

Gratefully acknowledging the help of God the Home Missionary Committee submits the following report of Home Missionary work in the District:

Five new churches have been organized: Alexandria with 22 members; Twelve Points (Terre Haute) with 16 members; Ft. Wayne with 13 members; Edenburg with 21 members, and Merom with 19 members, a total of 81 members.

In addition there are two places ready for organization within a short time—Booneville and Ohio Ridge.

A mission is in operation at New Point under the direction of Rev. Elza Ruble. They have a nice hall and a Sunday school of around 30. The committee helps with the rent here.

Rev. E. J. Clem using the Home Missionary tent held a meeting at Middletown which resulted in a mission which will open soon and be ready for organization. The work is moving forward under Rev. Charles Kelley. Outside of furnishing the tent the committee spent no money here.

Rev. Lawrence Wade opened a mission in Bedford this year which is showing a strong growth. Their Sunday School has an average attendance of 40. Prospects are bright for an organization here.

The Prospect Street Mission at Indianapolis reports good progress.

All ministers who have not been ordained shall appear first each year before the Educational Board, bringing recommendations from local church, whether notified or not, at each Annual Assembly.

The Examining Board is the second board before whom all licensed ministers must appear, and not the first.

All ministers appearing before the Educational Board shall bring their recommendations with them.

### REPORT OF THE WAYS AND MEANS COMMITTEE

ı

We recommend that each church raise three cents per member each month for District Home Missionary work and church extension, money to be paid to the District Treasurer.

2

Inasmuch as it is sometimes impossible for the local church to send district funds to the District Treasurer by July 31, we recommend that the District Treasurer hold his books open until August 10.

3

We recommend that the Camp Meeting Board formulate a set of rules, governing the use and rates of electrical appliances, to be posted in the rooms and other conspicuous places.

4

We recommend that a committee of three be appointed by the District Superintendent to revise the by-laws of the Old People's Home.

5

We recommend that all money raised by representatives of General Home and Foreign Missionary interests be applied according to the Manual as provided in paragraph number 12, Section 127.

6

We recommend that our present farmer in charge of the Old People's Home Farm be placed in charge of all farm interests and Old People's Home, this position to be known as the superintendent of Old People's Home and Farms, with a salary of \$50.00 per month. Said superintendent shall be amenable to District Council to which he shall give quarterly reports. We also recommend that all applicants be passed on by the District Council.

7

We recommend that the Ways and Means Committee meet at the call of the chairman prior to the next District Assembly. Their expenses and entertainment to be paid by the District Treasurer.

Ω

We recommend that 1,000 copies of the Assembly Minutes be published within thirty days after the Assembly adjourns, and that all orders for same be sent directly to the District Secretary.

9

We recommend that the ordained, licensed and honorary ministers of the Pilgrim Holiness Church, their wives and dependent children, and also ordained ministers and their wives of other churches be given meals during Camp Meeting.

10

We recommend that all pastors, evangelists and unstationed ministers failing to send in their reports to the District Statistician by the tenth of the month following the end of the conference year be denied a seat within the conference bar for that year.

11

We recommend that the District Budget be pro-rated as follows: District funds, 60%; District Home Missions, 10%; General Assembly, 5%; Old People's Home, 15%; on note held by Burial Association, 10%.

12

We recommend that the District Budget consist of 10% of all money

raised by the local church, Sunday School and Young People's societies, except that raised for Missions, General Budget, building funds, and all funds raised for specified district interests. Building fund purposes shall be interpreted to include rent on parsonages and churches and money paid on contracts of the same.

12

We recommend that each grant its pastor a two weeks' vacation with salary.

14

We recommend that those desiring entertainment as workers during the Camp Meeting, other than those specified by Recommendation 9, shall pay a registration fee of \$1.00 when accepted as workers.

15

Inasmuch as the zone meetings have been beneficial in advancing the spiritual, educational and doctrinal interest of the district, we recommend they be continued. We further recommend that the conference ministers of each respective zone meet as soon as possible and elect their President. This election shall be subject to the approval of the district Superintendent.

16

We recommend that each church provide a parsonage with telephone.

17

We recommend that the annual business of the local church be closed on July 31 of each year, but that pastors shall continue in service until and including the Sunday after the District Assembly, the local church to report the extra time in the next year.

18

We recommend that the regular Assembly stenographer be paid \$15.00, and her entertainment during the Assembly.

19

We recommend that our District Superintendent be paid a salary of \$2,100,00 and expenses.

20

We recommend that for a period of one year the following plan for the Old People's Home farm be adopted: On the first of our Assembly year \$100.00 be placed in the hands of our farmer as a working capital.

The farmer shall give to the District Treasurer an itemized account at the close of each month of money expended and balance on hand. The District Treasurer shall then reimburse the farmer for the amount paid.

21

We recommend that all persons taking the preacher's study course shall have their examinations in the hands of their instructors by July 16 of each conference year.

We recommend that at each annual Camp Meeting, on the last Thursday, Friday and Saturday, there shall be one daily session of the Educational and Examining Boards for the purpose of the examination of ministers. All ministers knowing themselves due to appear before these boards are urged to be present.

We further recommend that the time of such sessions shall be announced from the platform.

22

We recommend that needed repair be made to our Tabernacle and buildings, and that no new buildings or changes be made upon our State Camp Grounds unless authorized by this Assembly or two-thirds majority vote of the District Council and the Camp Meeting Board.

We recommend that the District Secretary be paid \$50.00 for his services for the year of 1939-1940.

24

We recommend that the District Statistician be paid \$30.00 for his services.

25

We recommend that the Camp Meeting Committee formulate a set of rules governing the conduct and attire of people who occupy the platform, and also a set of rules for conduct around the tabernacle and grounds.

26

We recommend that those pursuing the study courses send for their home study questions early in the year, forwarding a large stamped envelope with each request, to cover cost of mailing questions, etc.

27

We recommend that only ministers, their wives and unmarried dependent children and lay delegates be given entertainment during Assembly. All entitled to this entertainment shall be duly registered and given cards of recognition. For all other entertainment the same rate shall prevail as during Camp.

28

We recommend that any person who cannot remain during the entire District Assembly shall not be sent as a delegate, and all delegates sent be required to remain for the entire Assembly, except for the cause of sickness or death.

29

Where there are sufficient competent members, we recommend no one person hold more than one office on the local Church Board.

30

We recommend that the Camp Meeting workers be appointed by the Camp Meeting Committee, and that no pastor nor church assume authority to promise workers tickets.

31

We recommend that no delegate to the District Assembly be given free entertainment during Camp Meeting.

32

We recommend that there be a Publishing Committee composed of the District Secretary and two appointive members. It shall be the duty of this committee to publish the Assembly Minutes.

33

We recommend that where parsonages are not equipped with heating device, that provisions be made for same by local church.

34

We recommend that each church raise the equivalent of four cents for each of its members per month for the Old People's Home and send this money to the District Treasurer the first of each month.

35

We recommend that our District Camp begin on the second Friday of August each year.

Whereas, each year there is a difficulty in securing a correct ministerial list, we recommend that each pastor bring to the Assembly a list of names of all unstationed ministers that are members of his church, respectively, with correct addresses.

37

We recommend that we have two Examining Boards of three members each. Each board is to work independently of the other; the work of these boards to be equally divided. Matters necessitating council may be brought before a joint session of the boards.

38

Whereas this has been the first year that recommendation No. 11 in the 1938 minutes has been in our minutes and whereas for that reason leniency and mercy has been extended to those who failed to meet its demands; therefore, be it resolved that this rule be ridgedly enforced in the 1940 Assembly.

Be it further resolved that our Statistician presents the names of those who fail to meet the requirements of said recommendation to the District Secretary, who shall read the names.

39

We recommend that where churches are located in cities that the location of the church appear in our minutes.

40

We recommend that no pastor call an Evangelist outside of our church without the approval of the District Superintendent.

41

We recommend that the deacons or deaconess arrange for a monthly donation for pastor, such donation to be announced publicly.

42

We recommend that our District Superintendent appoint a committee of five to make arrangements for the Ministerial Convention. Subjects and programs to be arranged for by this committee.

We also recommend that the subjects be in the hands of the writer at

least three months before Convention.

The time and place to be fixed by this Assembly. We further recommend that the church entertaining said Convention he required to furnish sleeping accommodations only.

43

We recommend that the heads of departments of the Camp Meeting Board and Stand Manager be authorized to make purchases for their respective departments. We further recommend that all bills for said purchases be placed in the Camp Meeting Treasurer's hands before the close of the Camp.

44

We recommend that the Indiana District reopen the Frankfort School with the following departments: Junior High School, High School, Bible and Missionary Training, and Music. We further recommend that said school be under the direction of a Board of Directors consisting of five members.

45

We recommend that the District Superintendent appoint a committee of five to arrange for a District Young People's Rally. We further recommend that the time be the second Friday, Saturday and Sunday of June. Place to be decided by the committee.

We also recommend that each Young People's Society be requested to send in an offering for the Convention. Also churches without societies are invited to send in an offering for the Convention, inasmuch as the Convention is a blessing to every church.

46

We recommend that each church of the district be requested to send into the District Treasurer not less than \$3.00 for the expense and entertainment of the pastors for the 1940 Camp. We further recommend that each church send in at least one cotton blanket.

47

We recommend that the nominating committee present seven names to this Assembly from which five shall be elected as Board of Directors for Frankfort Bible School.

48

We recommend that no pastor or local church board shall sell any real estate belonging to local church without the consent of the District Superintendent.

49

We recommend that the District Council set a standard rate of mileage for all officials and workers in the Indiana District for traveling expenses.

50

We recommend that we have one Assistant Superintendent who shall be paid \$4.00 per day or fraction of a day while he is actively engaged in service to the district, plus the traveling expenses incurred in such service.

51

We recommend that the District Treasurer be paid \$110.00 for his service.

52

We recommend that we delete from our 1939 minutes the following recommendations, 5, 9, 18, 28, and 32.

53

We recommend that the District Council be given the privilege of forming small churches into circuits.

54

We recommend that each church give to the Old People's Home a donation of groceries, canned fruit and vegetables, the same to be credited as a gift by the church.

55

We recommend that the district furnish the Educational Board such copies of sets of questions as may be needed this year.

56

Inasmuch as Sunday School work is greatly neglected in many places, we recommend that each zone have a Sunday School Convention every six months. We further recommend that a Sunday School leader be appointed for each zone by the District Superintendent and respective zone presidents.
