Minutes

The First Session

The Fourth Annual Conference of the International Holiness Churches of the Carolina District convened at Randleman, N. C., at 10 A. M. Nov. 24, 1914.

The First Session was opened by singing No. 28 in "Praise and Invitation," after which Rev. C. A. Ludwick led in prayer. The prayer was followed by singing, "On the Way."

The Opening Address was given by the State Superintendent, Rev. M. A. Baldwin.

The minutes of the Third Annual Conference of the Apostolic Holiness Union and Churches were read in a condensed form and adopted.

The first three rows of seats were set apart for the exclusive use of the preachers and delegates.

The duties and privileges of the members of the Conference were set forth by the State Superintendent.

It was moved and carried that the ministers and delegates be enrolled on the Conference roll at once.

It was moved and carried that Rev. W. R. Cox assist the secretary in making the enrollment.

The reading of the enrollment showed

eighteen ministers and twenty Church and Sunday-school delegates had enrolled.

The State Superintendent next called the Conference to the reading of the Church reports and Sunday-school reports. Twenty churches were called and ten were reported.

It was moved and carried to adjourn the Conference until 2 P. M.

Second Session

The Second Session convened at 2 P. M., Nov. 24, 1914, by singing No. 48, in "Praise and Invitation," after which Rev. Geo. B. Kulp led the opening prayer. The minutes of the last session were read and approved and the roll was called and nineteen ministers and twenty-three delegates answered to their names.

The Conference next turned to the business of church reports and thirty-five churches were called and twenty-three made a report.

The chairman appointed the following Committees:

Examining Committee: Rev. W. R. Cox, Rev. Geo. B. Kulp, and Rev. M. A. Baldwin.

Nominating Committee: Rev. C. A. Ludwick, Rev. S. S. Nelson and Rev. S. M. Stikeleather.

Committee on Resolutions: Rev. O. L. Ruth, Rev. P. R. Thompson, Rev. S. M. Stikeleather, Rev. W. R. Cox and Rev. S. S. Nelson.

The State Superintendent next called for

ministerial reports and eight reports were given.

It was moved and carried that the Conference adjourn until 9 A. M. on Nov. 25.

Third Session

The Third Session was called to order by the State Superintendent at 10 A. M., Nov. 25, 1914. No. 24 in "Praise and Invitation" was used as an opening hymn, after which Rev. G. H. Butner led the opening prayer. The minutes of the last session were read and approved and the roll was called and twenty-three ministers and nineteen delegates were present. The question of election of officers was taken up and a motion made that the election of officers follow immediately after the Conference disposed of the resolutions which the Resolution Committee held which were ready for presentation. After discussion the motion was carried.

The Conference next turned to the reports of the ministers. Three reports were read.

It was moved and carried that the Conference turn to the report of the Committee on Resolutions and consider the resolutions.

The State Superintendent appointed Rev. P. R. Thompson to take the place of the Secretary on the Nominating Committee.

The chairman of the Resolution Committee read the following report:

First. Resolved, That each pastor shall

preach on the subject of tithing one or more times during the year and urge all his people to give the tenth and that he shall see that a public offering be taken each Sunday when there is preaching, which offering shall be used for the incidental expenses of the church, also that a business meeting shall be held each month.

Second. Resolved, That one day of the next Conference be set apart in the interest of the Sunday-school work among the International Holiness Churches in the Carolina District for the stimulation and promotion of Sunday-school work along straight holiness lines.

Third. Resolved, That each pastor sees that each of his churches adopts some plan of raising missionary money for the home and foreign fields and for arousing interest among his members on the subject of missions, that a correct record be kept of the same by the church secretary and the money be sent either direct, or to the State Missionary Board, that the said church and Missionary Board may be able to report correctly.

Fourth. Resolved, That the next Conference shall not be held in connection with a revival meeting.

Fifth. Resolved, That ten per cent. of each pastor's offering and also of our evangelists working in the Carolina District be applied to the State Superintendent.

Second part of Fifth. Resolved, That the State Superintendent also be allowed to

receive free will offerings, reporting the same in his quarterly financial reports.

Moved and seconded that the first resolution be adopted. After discussion the question was called for and adopted.

Moved and carried unanimously without discussion that the second resolution be adopted.

Moved and carried that the fourth resolution be adopted.

Moved and carried that the fifth resolution be adopted.

Moved and carried that the Conference turn to the election of officers.

Moved and carried that the Secretary cast a ballot for J. L. Crouse for Treasurer for the ensuing Conference year. The ballot was cast by the Secretary.

For Councilmen the vote was as follows: Rev. C. A. Ludwick 13, Rev. O. L. Ruth 22, Rev. P. R. Thompson 10, Rev. W. R. Cox 28, Rev. W. A. Way 27, Rev. M. A. Baldwin 19.

Moved and carried that the Secretary cast a ballot for the Missionary Board. The former Board was elected by the Secretary's ballot.

The following were declared elected by the Conference: For State Supt., Rev. S. S. Nelson, Ass't Supt., Rev. S. M. Stikeleather, Sec't Mrs. W. R. Cox, Treas., Mr. J. L. Crouse,

Councilmen, Rev. O. L. Ruth, Rev. W. R. Cox and Rev. W. A. Way. For State Missionary Board, Rev. W. R. Cox, Rev. S. S. Nelson and Rev. M. A. Baldwin.

Moved and carried to return to ministerial reports. Forty-six reports were called for and twenty-three were reported.

Moved and carried to adjourn until 2 P. M.

Fourth Session

The Fourth Session was opened by singing No. 29 in "Praise and Invitation," after which Rev. O. L. Ruth led in prayer. The minutes of the last session were read and approved. The roll was called and twenty ministers and twenty-three delegates were present. Church reports were again called for and four churches and two Sunday-schools not included in these church reports were given. Mrs. W. C. Kirkman made her report at this time.

The report of the Treasurer of the State Missionary Board was read and accepted.

The report of the State Treasurer for this district was read by the Secretary and accepted if found correct by an Auditing Committee.

Rev. W. R. Cox, M. A. Baldwin and J. L. Crouse were appointed to act as Auditing Committee for the ensuing Conference year.

The State Superintendent next read his annual report and gave some words of ex-

hortation and also words of encouragement and praise.

Rev. W. C. Cruse entering the Conference at this time was called upon to give his report.

Moved and carried to have the minutes of this Conference published.

Moved and carried that each pastor pledge himself as to the number of copies of minutes which he would take. 540 copies were subscribed for.

The place of the next Conference was taken up. Proximity and Troy were nominated. Troy received a majority of votes.

Moved and carried to hold next Conference one week earlier than it convened this year.

Moved and carried that Sister Cornie Caudle be re-elected Home Missionary for the coming year.

Moved and carried that the State Superintendent be placed on the examining Committee for the coming year.

Moved and carried that Rev. W. R. Cox be placed on the same Committee.

Moved and carried that Rev. S. M. Stikeleather be placed on the same Committee.

Moved and carried that the chairman appoint a committee to formulate resolutions regarding a permanent Conference Extension Loan Fund.

The chairman appointed on this Committee, Revs. S. M. Stikeleather, P. R. Thompson and S. S. Nelson.

Moved and carried that an offering be taken at the present time for helping in the completion of the Albemarle Church. While the offering was taken No. 36 in "Praise and Invitation" was sung. A prayer of thanks was given by the State Superintendent. The offering amounted to \$7.60.

Moved and carried that Rev. Geo. B. Kulp, Supt. of the International Apostolic Holiness Churches be given an hour to-morrow, beginning at 9:30 A. M., in which to address the Conference.

Moved and carried that an hour be set apart at 9 A. M. Friday for a preacher's meeting. Rev. Geo. B. Kulp, to be in charge.

Rev. Geo. B. Kulp gave a talk on our missionaries in the West Indies.

The support of our home missionary was taken up and considered.

Moved and carried to adjourn until 9 A. M. to-morrow.

The Fifth Session

The Fifth Session was called to order by the State Superintendent at 9 A. M., Nov. 25, 1914, and opened by singing No. 48 in "Praise and Invitation," after which Rev. J. F. Nance lead in prayer. The minutes of the last meeting were read and approved. The roll was called and eighteen ministers and nineteen delegates were present. The Conference then sang Nos. 29 and 86 in "Praise and Invitation." Rev. Geo. B. Kulp

took charge of the service at the close of the singing and gave an interesting and profitable talk to the preachers and delegates.

After the address No. 49 was sung and a free-will offering taken for Bro. Kulp, which amounted to \$24.62 in cash and 50 cents in pledges. A prayer of thanks was given by the State Superintendent.

Moved and carried that a free-will offering be taken up by the pastors in each of their churches in the near future for helping in the completion of the Albemarle Church.

The resolutions of the Committee on the Church Extension Loan Fund was read as follows:

Your Committee to whom you have referred the subject of a Church Extension, hereby make the following report. We hereby do recommend:

First. That we have a Church Extension Fund:

Second. That this fund shall consist of moneys contributed by each church on the first Sunday in March of each year.

Third. It shall be the duty of each pastor to present this before his people in a sermon pertinent to the subject preceding the offering and he shall report the amount received at the next Annual Conference.

Fourth. All moneys thus raised shall be forwarded to the State Treasurer, who shall keep it in a separate fund to be known as The Church Extension Fund.

Fifth. This money shall be loaned to Churches making application, at the direction of a Church Extension Committee, elected by the Annual Conference each year.

Moved and carried that the resolutions be adopted.

The Church reports were finished with the reading of the report from Beulah, Va.

The ministerial reports were finished by reading reports from Rev. W. P. Ware, Rev. C. A. Lain and Sister W. C. Cruse.

The following churches were without a report: Meadow Creek, Union Chapel, Christ's, Reidsville, Haw River and St. Paul.

Moved and carried that Conference adjourn until 2.30 P. M.

The minutes of the last session were read and approved. The roll was called and twenty ministers and fifteen delegates were present.

Miss Ida Conway of Edgemont, N. C. being approved for license, it was moved and carried that she be given license.

Moved and carried that board be elected to loan the Church Extension Fund and also that the said board see that all loans are secured.

Moved and carried that the State Superintendent be chairman of said board.

Moved and carried that State Secretary be a member of the same board.

Moved and carried that Rev. M. A. Baldwin be a member of the same.

Moved and carried that the Conference give a vote of thanks to the people of Randleman, also, to the pastor and his wife for their courteous entertainment extended to the Conference.

Some remarks were made by the prospective Superintendent and also by Rev. Geo. B. Kulp on the subject of the work of pastors.

Moved and carried that the Conference adjourn until 9 A. M. to-morrow morning.

Five rescue services were held in response to the resolutions of last Conference. These were held at High Point, Gold Hill, St. Paul, Beulah and Zion, Davidson Co., N. C. and Sawyersville.

The president of the Apostolic Holiness University states in answer to a preceding question that the property of the Apostolic Holiness University is deeded to trustees who are the same as those of the property of

the Apostolic Holiness Church of Greensboro, N. C.

Rev. Geo. B. Kulp gave an address to the ministers of the Conference.

Moved and carried that the Conference express their appreciation of the work done by the out-going State Superintendent and a welcome to the new State Superintendent.

Moved and carried to adjourn the Annual Conference of 1914 by singing No. 28 in "Praise and Invitation."

ANNUAL REPORT OF THE STATE SUPERINTENDENT

I have devoted my entire time to the work to which I have been called as Superintendent of the Carolina District of the Apostolic Holiness Church. I have visited all the churches of the District except two. I have visited a number of them three to four times during the year. Held thirteen quarterly meetings (three quarterly meetings not held because of the very rainy and snowy weather). I held four revival meetings. Preached 226 times. About 121 persons professed either justification or sanctification under my ministry during the year. I organized four churches, one at Mt. Zion in Moore Co., N. C., with eight charter members. One at Bagley Swamp near Hertford, N. C., with fifteen charter members. Also two in Floyd County, Va.—Union Chapel near Copper Hill, Va., with twenty-one members and

Christ's Church, with nineteen charter members. A total of sixty-three members. I also received into membership at other places fifteen persons, making a grand total of seventy members that I have received into membership this year. I conducted twenty-two prayer-meetings; made 321 religious calls; preached three funerals; traveled over 7000 miles by rail and quite a number by private conveyance. I have received for my service to the churches, \$556.77. Received for revival work, \$46.50. Received in personal offerings, \$2.00. Making a total of \$605.27. I have given to God's cause this year \$62.00.

I am very much encouraged with the Holiness work in the Carolina District. I believe that it is in the best condition and making the greatest progress toward real success that it ever has since it has been organized. I notice that the churches have made quite a gain in offerings each year. In 1913 there was a gain of \$1,286.20 over the year 1912, and I am sure that the reports this year will show a decided improvement over 1913. It is very important that we as a Church should push every line of Holiness work, such as Home and Foreign Missions, Sunday-schools and see that our pulpits are supplied with pastors and evangelists who are filled with the Holy Ghost and wisdom, and that the Official Boards be made up of sanctified people, not to make new laws but to faithfully carry out those laid down in our Church manual.
