# MINUTES

## OF THE TWENTY-SECOND ANNUAL ASSEMBLY OF THE KANSAS DISTRICT OF THE PILGRIM HOLINESS CHURCH



FIRST SITTING MONDAY A. M., JULY 22, 1935

The first sitting of the twenty-second annual Assembly convened at Winfield, Kansas, July 22, at 9:00 a. m., with Gen. Supt. W. L. Surbrook in the chair. An inspirational address was delivered by Brother Surbrook. The roll call was read. Moved and seconded that the front six seats in the three south sections inside the arches constitute the Assembly bar. Carried.

The new churches of Brewster, Natoma, Toronto and Pleasant Ridge were presented by the District Superintendent to the Assembly and accepted. Moved and supported that the time for regular sessions be from 9:00 a. m. to 12 noon, and from 1:30 to 5:00 p. m. Carried.

Moved and supported that the District Superintendent appoint committees. Said committees to hold over for 1936 Assembly. Carried. Reading of committees as follows:

Foreign Missionary—Mrs. H. J. Beecher, Velma Berggren and Mary Dice.

Auditing—Mrs. R. C. Stalcup, Bertha Orr Busby and Bessie Plummer.

Moved and supported to accept the resignation of M. M. Con-



rad from Examining Board. Carried. Moved and seconded that the District Superintendent fill said vacancy until election of officers. Carried. Carl Hahn and Joel Kelly were appointed to fill vacancies on Examining Board.

Moved and seconded that all district reports be given to the Statistical Committee. Carried.

Report of District Superintendent read and accepted.

Moved and supported to recess until 1:30 p. m. Carried.

#### SECOND SITTING MONDAY P. M., JULY 22, 1935

The second sitting opened at 1:30 p. m., with Gen. Supt. Surbrook in the chair. A special song was sung by Vera Carter and Vera Howerton, after which a stirring, instructive and warning message from 2 Cor. 6: 1-12 was delivered by Bro. Surbrook. His text was 2 Cor. 6: 3, and his subject was "Helps and Hindrances to the Ministry."

The roll call was read. Minutes of last sitting read and accepted. Partial report of Resolution Committee read and acted upon. Rev. Edwards, partor of the Church of the Nazarene at Arkansas City, was introduced to the Assembly and granted an honorary seat in the Assembly bar. Moved and supported that the District Superintendent appoint a Publicity Committee to advertise present Camp. Carried.

Partial report of Ways and Means Committee read and carried. Rev. Durham, pastor of the Church of the Nazarene at Grenola, was introduced to the Assembly and granted an honorary seat in the Assembly bar. Partial report of Examining Board read and accepted. Report of Foreign Missionary Committee read and acted upon.

Moved and supported that the election of officers be the order of the day immediately following the devotional exercises Tuesday morning. Carried. Motion to adjourn.

#### THIRD SITTING TUESDAY A. M., JULY 23, 1935

The third sitting opened at 9:00 a. m., July 23, 1935, with Gen. Supt. Surbrook in the chair. A special song was sung by Brother Steelhead, after which a very helpful message was delivered from Rom. 12th chapter by Bro. Surbrook.

The roll call was read. Sisters Dice and Deardorf were accepted on their credentials into the Assembly. Minutes of last sitting were read and accepted. Brother Thomas was welcomed to the

Assembly and gave his testimony. Moved and supported that the election of officers be deferred until the report of the Examining Board is read and acted upon. Carried.

Partial report of Examining Board read and accepted.

Brothers Carl Dael and L. L. Miller were introduced to the Assembly and granted honorary seats in the Assembly bar. Bro. Steelhead of California District, and Bro. C. Harold Ripper, pastor of the Church of the Nazarene at Winfield, were introduced to the Assembly and granted honorary seats in the Assembly bar.

Election of officers was next in order: Rev. L. L. Waddell was elected District Superintendent on first ballot.

Moved and supported to reconsider recommendation 6 of Ways and Means Committee. Carried. Moved and seconded to amend recommendation 6 to grant Bro. Waddell two months off the district in evangelistic work. Carried.

Rev. Bartlett, pastor of M. E. Church at Byers, was introduced to the Assembly and granted an honorary seat in the Assembly bar. J. H. Philpot was elected Assistant Superintendent.

Motion to adjourn.

#### FOURTH SITTING TUESDAY P. M., JULY 23, 1935

The fourth sitting of the Assembly opened with Gen. Supt. Surbrook in the chair. Bro. Steelhead sang a special song, after which Bro. Thomas read the Scripture lesson from Acts 20: 17-35. Moved and seconded to dispense with reading of roll call. Carried. Minutes read and approved.

J. H. Fortner was elected District Secretary on first ballot.

Jack Campbell was elected District Treasurer on first ballot.

H. K. Busby, E. A. Gafford and H. J. Beecher were elected as the other members of the Council.

H. J. Beecher was elected on Examining Board to serve until 1938.

Moved and supported that the District have both an Examining Board and an Educational Board. Carried.

Moved and supported that the District Council appoint the Educational Board. Carried. Motion to adjourn.

#### FIFTH SITTING WEDNESDAY, JULY 24, 1935

The fifth sitting of the Assembly opened at 9:00 a. m., with Dist. Supt. Waddell in the chair. The second chapter of Titus was read by Bro. Waddell as a Scripture lesson. Moved and seconded to dispense with the roll call. Carried.

Minutes of last session read and approved. Final report of Ways and Means Committee read and acted upon. Report of

Resolution Committee read and acted upon.

Moved and seconded that the District Secretary write Brother Jonas Nickell a letter of appreciation for his donation of a beef to the Camp. Carried.

Moved and seconded that the District Superintendent let the contract for the printing of Minutes. Carried.

Report of Auditing Committee read and approved. Moved and seconded to give the District Treasurer a vote of thanks for his efficient service. Carried.

Moved and seconded that the District pay the District Treasurer \$20 and the District Secretary \$15 for their services for last year. This is to be paid from the District Fund. Carried.

Hutchinson, Brewster and Fowler gave invitations for the Ministerial Convention. Hutchinson was chosen as place of Convention.

Report of Statistical Committee read and accepted with corrections. Report of Bro. Philpot's Home Missionary and Church Extension Work read and approved.

Moved and seconded that time of Ordination Service be set for 10 a. m., Friday. Carried. Moved and seconded that each Church give a donation to the Ministerial Convention. Carried.

Moved and seconded that in appreciation of Bro. and Sister Solters' sacrifice and labors, and due to Bro. Solter's recent bereavement, we now humbly bow to offer prayer in their behalf. Carried. Moved and seconded we adjourn until 9 a. m. Thursday. Carried.

#### SIXTH SITTING THURSDAY, JULY 25, 1935

The sixth sitting of the Assembly opened at 9 a. m., with Dist. Supt. Waddell in the chair, Devotional exercises were conducted by Evangelist Keller. Reading of roll call was dispensed with.

Minutes of last sitting read and approved.

Recommendation of District Council in regard to camp evangelist approved. Rev. A. H. Wilson of New York, will be called as evangelist.

Moved and seconded that the Ministerial Convention be held February 4, 5 and 6, 1936.

Appointment of Publicity Committee approved as follows: Lee Rathbun, Ernest Burton and M. M. Conrad. Moved and seconded that the Publicity Committee advertise 1936 Camp using cuts of camp ground and tabernacle. Carried.

Moved and seconded that 425 copies of the Minutes be printed

for the coming year. Carried. Moved and seconded to pay for the Minutes from the District Fund. Carried.

A special song was sung by Bro. Philpot.

Moved and seconded that the report of the Stationing Committee be read at the Saturday afternoon service. Carried.

Moved and seconded to adjourn until 9 a. m., Friday. Carried.

#### SEVENTH SITTING FRIDAY, JULY 26, 1935

The seventh sitting of the Assembly opened at 9 a. m., July 26 with Dist. Supt. Waddell in the chair. Moved and seconded to dispense with the roll call. Carried.

Moved and seconded that the chair appoint a Nominating Committee of three to bring names of candidates for Young People's and Children's Workers for 1936 Camp. Carried. E. B. Overholt, Mrs. Mabel Rathbun and H. K. Busby were appointed.

Report of the Examining Board read and accepted.

Motion to adjourn.

#### EIGHTH SITTING SATURDAY, JULY 27, 1935

The eighth sitting of the Assembly opened at 9 a. m., July 27, with Dist. Supt. Waddell in the chair. Roll call and reading of minutes of last session were dispensed with.

Moved and seconded that the Assembly ratify the appointment of the Educational Board as follows: J. H. Fortner for 3 years, Wayne Plummer for 2 years and Carl Hahn for 1 year. Carried.

Mrs. H. K. Busby, Vera Carter and Vera Howerton were chosen as Children's Workers, and Roy Nible was elected as Young People's Leader for 1936 Camp. Moved and seconded to have Assembly following Camp Meeting of 1936. Lost.

Moved and seconded that a Young People's District organization be perfected according to Sec. 10, page 62 and paragraph 7, and Sec. 61, page 51 of Manual. Carried.

Moved and seconded to recess until 11:15. Carried.

At 11:15 Bro. Waddell delivered an address to the Assembly on the Hope of His Calling; using Eph. 1: 15 as the text. Moved and seconded that we give Bro. Waddell a vote of thanks for his services as District Superintendent during the past year. Carried.

Moved and seconded that any business which has not been taken care of by the Assembly be left to the District Council. Carried. All reports are to be mailed to Statistical Committee at least one week previous to District Assembly. Motion to adjourn.

## DISTRICT SUPERINTENDENT'S REPORT

### TO THE 22ND ANNUAL ASSEMBLY OF THE KANSAS DISTRICT OF THE PILGRIM HOLINESS CHURCH

Greeting:

The past year has been one of climatical extremes. Drouth, dust, heat and floods have in turn broken all previous records, since last Assembly. However, the Lord has given courage and faith to press on. If men remain under these conditions to buy and sell, sow and reap, in order to gather in barns—our Churches and Ministers must remain to preach to them the Gospel of saving and sanctifying grace.

The Lord has given us four Church organizations this year. Brother M. M. Conrad conducted a revival in Brewster, and struck a real spiritual gusher, which resulted in a splendid organization. Brother Philpot conducted a meeting at

Keystone, where Brother Ralph Smith was laboring faithfully as pastor. We owned a Church and parsonage there, but had no Church constituency. However, at the close of the revival, Brother Philpot was enabled to re-organize the Church.

The third new Church was the product of Brother and Sister Lee Rathbun's labors near Natoma. They conducted a very successful revival, resulting in a Pilgrim Holiness Church, then remained to pastor the new Church. The fourth Church is only a few days old, and is the result of Brother Philpot's efforts in two revival meetings in Toronto.

### IMPROVEMENTS

This year has seen much development along the line of property improvements.

The Fredonia Church, under the leadership of Brother and Sister H. J. Beecher, has completed a beautiful brick Church building with full basement.

Our new Church at Gove, with the tireless efforts of Brother and Sister Cork as pastors, has completed, free from debt, a nice frame Church.

The very recently organized Church at Brewster, where Brother and Sister Duncan labor as pastors, has completed the nicest basement Church we have seen.

Fowler, where Brother and Sister Isgrigg are pastoring, is building a new parsonage.

Sabetha, assisted by Brother Engle, pastor, recently completed a general overhauling of their building and placed a very substantial addition to the same, with basement and modern equipment.

The recently organized Church at Hartford, where Rev. Lois Fairchild pastors, has purchased a nice frame Church building, centrally located, and are doing splendid work.

The parsonage at Hutchinson, where Brother Campbell is pastor, has been reconditioned and beautified. There have also been improvements at a number of other places on the District for which we rejoice, because He has told us to occupy until He comes.

Personally, God has enabled me to visit the entire District twice and some Churches more. Altogether, have traveled for the District, including trips to District Council Meetings, General Assembly, General Board Meeting, and Bible School Board Meeting, 12,974 miles at a total expense, including travel, telephone calls, telegrams, stamps, etc., of \$292.83. Received for such expense, \$292.83; also received \$600.00 salary. Preached 62 times with 40 seekers, conducted about 40 business meetings, made 84 calls, conducted 4 funerals.
