

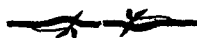

MEMORIALS TO THE GENERAL ASSEMBLY. KENTUCKY DISTRICT

1. We recommend that all District Superintendents become members of the General Board, by virtue of their office, plus one other member from each zone.

2. We recommend that the General Board draft a financial plan to be used in each District, excepting where variations are necessary to comply with local conditions.

3. We recommend that all District Superintendents be elected for a two-year term.

4. In order to reduce expense of issuing license, we recommend that license be issued with present face of form with space for renewing for three consecutive years.

5. We recommend that the Young People's Society of our church be organized as Local, District and General.

6. Be it resolved that each District elect at its Annual Assembly a Stationing Committee of three members, the District Superintendent to be the chairman; this Committee to have control of all pulpits, making any and all changes in pastors, allowing each church to have a first, second and third choice.

7. Whereas there has been some difficulty in requiring ministers to surrender our pulpits and vacate our parsonages after they have been disqualified to hold credentials in our church; therefore be it resolved that whenever the credentials of a minister have been revoked by proper authority on stated Manual grounds, this minister's salary shall cease and he shall vacate our pulpit immediately and our parsonage within thirty days. Be it further resolved that he shall forever be disqualified to preach in any of our pulpits until his credentials have been restored by the District Assembly in which he resides.

REPORT OF THE DISTRICT SUPERINTENDENT

To the 25th Annual Assembly of the Kentucky District of the Pilgrim Holiness Church, convened at Elizabethtown, August 7-11, 1934.

Greetings to you in the precious Name of Jesus!

About seven months ago Bro. Wolfe called a Council meeting, and at this meeting Tennessee was severed from Kentucky. Rev. R. W. Wolfe, our Superintendent, was transferred to Tennessee, and your servant was placed on the Kentucky District, due to the fact that he had worked with Rev. Wolfe in the capacity of District Treasurer for about three years and knew many

problems of the District. I was well aware of the fact that it was no easy task; however, we knew that the God who led the children of Israel out of Egyptian bondage, through the Red sea, and who led Caleb and Joshua into the promised land, and who caused the sun dial to go back ten degrees, was able also to lead the Pilgrim Holiness Church in the Kentucky District on to victory.

I immediately made a tour of the District in spite of the extremely cold weather, and was given a hearty welcome by the pastors and churches. I had never realized the great need and the prospects of the Pilgrim Holiness Church in Kentucky until I made my first trip through the District.

After my first trip over the District, the brethren assembled at Elizabethtown for a Ministerial Convention. This meeting was owned and blessed of the Lord and His presence was with us throughout. Steps were taken by the District Council and sanctioned by the Ministerial body, which proved to be a great blessing to our District financially.

While we have labored strenuously with the churches that are already organized, at the same time we have labored to blast out some new churches. By the help of the Lord we have been able to open up five new prospective Pilgrim Holiness Churches at the following places: Paintsville, Louisville, Glancy Fork, Sample and Stringtown, the last named coming to us from the West Virginia District. The Paintsville pastor reports that he is now able to organize with ten members, and our new work at Louisville is very encouraging. The churches at Covington, Carrollton and Wheelwright have been painted throughout, leaving no indebtedness. The Elizabethtown church has completed the basement of their new church. Mrs. M. A. Evans has deeded us a lot at Poplar Plains with an old building on said lot, with practically enough lumber in it to frame a new church. I have made investigation and found that the Camp Meeting property at Louisa, Ky., including two acres of land with timber on same, also a tabernacle and one other building, is the property of the Pilgrim Holiness Church.

I have traveled 13,000 miles at an expense of about \$400.00; have preached 101 sermons, and seen from one to thirty at the altar; have assisted in three revivals, held one camp meeting, conducted 75 business meetings and secured 156 "Advocate" subscriptions through the pastors. Salary received, \$729.19; for traveling expenses, \$104.14.

Elizabethtown, Ky., August 7, 1934

The 25th Annual Assembly of the Kentucky District of the Pilgrim Holiness Church convened at 9:00 A. M., with Dist. Supt. E. E. Leadingham in the chair. Opened by singing "When We All Get to Heaven." Rev. George Beirnes led in prayer, followed by singing "I Will Make the Darkness Light before Thee."

Scripture Lesson was read from Hebrews, first chapter, by Bro. Leadingham.

Special Song, "Riding on a First-class Car," by Leonard Bowling.

Minutes of the last Assembly reviewed and approved.

Roll call of Ministers and Deaconesses.

Moved and supported that the first six seats shall constitute the Conference Bar. Carried.

Moved and carried that Rev. Geo. Beirnes be given a seat on the platform and the privilege of the floor.

The following Committees were appointed by the Dist. Supt.—Memorials, Ways and Means, Resolution, and Reception; also appointments were made to fill vacancies on the Examining and Educational Boards.

Moved and carried that we receive into our District Bro. and Sister Brannon, Bro. A. E. Smith, Bro. O. C. Keller. These and some others were introduced to the Assembly.

Reports from Ashland Heights Church were heard and accepted.

Moved and supported that the time of the business sessions be from 9:00 A. M. to 11:45 A. M. Carried.

Aspen Grove Church reports read and accepted.

The Statistical Committee was appointed.

Normal Church reported and their reports were accepted.

Moved and supported that the reading of reports be eliminated. Motion lost.

Special song, "A String of Empties," by Bro. L. Steele.

Cloverport reports read and accepted.

Bro. Neil Horton gave a good testimony. He was granted a seat in the Conference Bar.

Reports of the Pike Street Church, Covington, were heard and accepted.

The Committee on Memoirs was appointed.

Bro. John Headley was introduced to the Assembly.

Reports of Third St. Mission, Covington, were read and accepted.

Quartet sang, "I Wonder What Heaven Must Be."

Reports of Elizabethtown Church read and accepted.

Reports of Fairview Church read and accepted.

Reports of Hitchins Church read and accepted.

Report of Mrs. Gertie Vincent, Deaconess, was read and accepted.

Motion made and carried that Sister Stewart be the Delegate from the Hitchins church.

Report was made of "Advocate" subscriptions taken. Bro. W. E. Honeycutt secured the highest number and was given a rising vote of thanks.

Announcements.

Adjourned by singing "Praise God From Whom All Blessings Flow," and shaking hands. Benediction by Bro. Gross.

Second Session

August 8, 1934

Opened by singing "He Rolled the Sea Away" and "Launch Out into the Deep". Prayer was led by Bro. Frank May, followed by the song, "Wonderful."

Duet, "In the City Which the Bible Calls Foursquare," by the Bowling Brothers.

Scripture Reading and comments from Psalm 103, by Bro. Paul Stewart.

Minutes of the former sitting read and approved.

Bros. Hendricks, Murphy, Stowers, Duncan, Rowan, Barber, Robinson, and Sorrell were introduced and welcomed into the Assembly.

Roll call, and changes of address noted.

Bro. Stapleton from Huntington, W. Va., was introduced and sang.

Carrollton reports read and accepted.

Report of S. R. Maddox read and accepted.

The Ways and Means Committee presented a Recommendation which was adopted with an amendment. (See Recommendations of Ways and Means).

Moved and supported that Resolution No. 4 be revoked. Motion lost.

Moved and carried that the Ways and Means Committee and the Resolution Committee revise the Resolutions and separate all those pertaining to finance, for the Ways and Means Committee to handle, the other resolutions to be taken care of by the Resolution Committee.

Duet, "It Took Hold of Me," by Bro. and Sister Shields.

Reports of Erlanger Church were read and accepted.

The names of the Auditing Committee were read.

Report of the Falmouth Church read and accepted.

Pastor's and Statistical reports from Kingswood were read and accepted with a correction in the Statistical report.

Report of W. E. Honeycutt read and accepted with the understanding that he make an estimate of his services, etc.

Latonia Church reports read and accepted.

Motion to adjourn was carried.

Announcements.

Benediction.

Third Session
August 9, 1934

Opened by singing "Rock of Ages" and "He Is My Pilot." Prayer led by Bro. Bolender, followed by singing "Blessed Assurance."

Romans, 12th chapter, was read and expounded by Rev. J. F. Woods, Superintendent of the West Virginia District.

Minutes were read and approved.

Roll call.

Moved and carried that Bros. Smith and Headley be given a voice in the Assembly.

Motion made and carried to hold the election of officers at this time.

Bro. Woods led in prayer.

Motion made to have the report of the District Superintendent read. This report was read and accepted by a rising vote.

Tellers appointed were Bros. Houston, Posey and Benner.

Moved and supported to give Bro. Leadingham a rising vote of appreciation for his services this year. This was done.

The election resulted as follows—E. E. Leadingham, elected District Superintendent on the first ballot; Denver Musser, Assistant Superintendent on the first ballot; Jenny V. Vincent, District Secretary on the first ballot; M. M. Benner, District Treasurer on the first ballot, C. E. Posey elected to the District Council on the first ballot.

Moved and carried to vote on the four next highest for the second member of the District Council. H. H. Bolender was elected on this ballot. Motion made and carried to vote on the two next highest for the third councilman. L. S. Houston was elected on this ballot.

Bro. G. L. Wellman was introduced to the Assembly, and testified.

On motion the time of adjournment was extended one hour.

Moved and carried to have all the Committees appointed by the Dist. Supt. Ballots were prepared for the election of the Stationing Committee. There was no election on the first ballot. Motion made and carried to vote on the three highest. Bros. Musser and Posey were elected.

Special singing by Bro. Steele, Bro. and Sister Shields, and Bro. and Sister Sorrell was enjoyed at intervals during the election of officers.

Moved and supported to have an afternoon session at 2:30 today. Carried.

Moved and carried to have the District Council make the appointment of delegates to the General Assembly.

Bro. Robinson was appointed to serve on the Resolution Committee in the absence of Bro. Adams.

Ballots prepared to elect two members on the Educational Board.

Camp Meeting Committee was appointed—Bros. Honeycutt, Durham, Perry, Johnson and Rowan.

Adjourned.

Benediction by Bro. Woods.

Afternoon Session
August 9, 1934

Dist. Supt. in the chair. After the singing of "Rock of Ages," Bro. McCord led in prayer.

Bro. Musser read from Philippians, 2nd chapter.

Minutes of the morning session were read and accepted.

The roll call was omitted.

Report of elections on the Educational Board. R. D. Perry was elected. Bros. Carpenter and Durham were next highest, both receiving the same number of votes. Bro. Carpenter moved to suspend the rules and elect Bro. Durham by acclamation. Bro. Durham was elected.

Ballots prepared for the election of District Trustees.

Moved and supported to retain the two now on this board and elect only one. Carried. No election on the first ballot. Moved and carried to vote on the two highest and Bro. Carpenter was elected on that ballot.

Moved and seconded to have the Dist. Supt. appoint the Examining Board. Carried.

Resolution Committee reported. Seven resolutions were adopted. (See resolutions). Moved and carried to revoke Resolution number 32.

Moved to refer the matter of the Young People's Convention to the District Council. Carried.

Ways and Means Committee reported. Six Recommendations were passed upon.

Recommendations for License and Ordination were read by Bro. Perry, chairman of the Educational Board, and passed upon.

Report of J. M. Walton was read and accepted.

Motion made and carried to have the Ordination service tonight.

Discussion as to paying what we are behind on our Minutes. About \$43.00 was raised in cash and pledges.

Benediction by Bro. Hendricks.

Morning Session

August 10, 1934

Opened by singing "When I See the Blood." Bro. Rowan led in prayer. General Superintendent, Rev. W. L. Surbrook, in the chair. He read from the 50th Psalm, then brought to us a good, encouraging report of the work in general.

Roll call of Ministers, Deaconesses and Delegates.

Minutes of last sitting read and approved.

Report of Ways and Means Committee. The first Recommendation was accepted.

The list of Delegates to the General Assembly was read.

Motion made and carried to take pledges for General Assembly expense, the remainder to be collected from the churches.

Moved and carried that each delegate to the General Assembly pay at least \$10.00, and the rest of the expense be collected from the churches. \$190.00 was thus pledged.

Moved and carried that the apportionment per member for General Assembly expense be twenty cents. Also that all churches not having delegates send their apportionment to the Treasurer by the 30th inst.; and those having delegates going to the Assembly send their part by the delegate, he to report to the Treasurer.

Committee on Memorials to the General Assembly reported. The first Memorial was referred to the Committee. The second, third and fourth were passed upon. Moved and supported to refer the fifth to the Committee. Moved and supported that the form of organization for District Young People's Societies be sent as a Memorial to the General Assembly and that a Memorial be drafted asking the General Assembly to draft a Constitution and by-laws for District Young People's Organization. Carried. The form of Organization was read.

The Resolution Committee presented a Resolution which was adopted.

Motion made and carried to have a business session this afternoon at 3:00 o'clock.

Adjourned.

Afternoon Session

August 10, 1934

Opened by singing "He Abides." Bro. Neil Horton led in prayer.

The roll call was dispensed with.

Minutes of the morning session read and accepted.

Committee on Memorials presented a Memorial which was accepted.

Ways and Means Committee reported and three more Recommendations were accepted.

Resolution Committee reported and two Resolutions were adopted.

Committee on Memorials presented another Memorial which was accepted.

Moved and carried that Resolution number 26 be revoked and that the Stationing Committee report this evening at six o'clock.

The Auditing Committee reported that they had found the books correct.

Report of the District Treasurer was read and adopted.

Motion made that any delegate who is not going to the General Assembly

let it be known before he leaves the Assembly, and the alternate be notified so he can raise the \$10.00. Carried.

Moved that the delegates not present be notified of their appointment and of the \$10.00 to be paid on expenses, and if they cannot go that they write the Secretary by the 20th inst.; also that the churches whose pastors are not present be notified of the amount equal to 20 cents per member to be raised. This motion carried.

The Auditing Committee reported that the books of E. E. Leadingham, Treasurer for the first five months of the year, were also correct.

Orval C. Keller, Esther Close, and Mrs. H. K. Brannon were appointed on the Statistical Committee for next year.

Moved and supported to have the Camp and Assembly next year to begin the first week in August. Carried.

Moved and carried that we have one Ministerial Meeting this year.

Moved and supported to have 400 copies of the Minutes printed; amendment was made that we have 500 printed. The motion carried as amended.

Moved and carried that the 500 copies of our Memorials be made at once on the lettergraph.

Moved and supported to rescind Resolutions number 1, 5, 6, 12, 13, 14, 15, 16, 17, 18, 19, 22, 23, 27, 29, 30, 31, 33, 34, 36, 37, 39, 41, 42, 44. This motion carried.

Moved and supported that a Resolution be drawn up stating that the Home Missionary Board be eliminated and the work placed in the hands of the District Superintendent; amendment made that it be placed in the hands of the District Superintendent and the District Council. The motion carried as amended.

Motion made and carried that the Treasurer continue to send out the report sheets.

The Resolution Committee presented a resolution which was adopted.

The roll of ministers was called, and pledges of "Advocate" subscriptions were taken amounting to 280.

Moved and carried that a rising vote of thanks be extended to our General Superintendent. This was carried, and the vote given unanimously.

Moved and carried that the time and place of our Ministerial Meeting be left in the hands of the District Superintendent.

The District Council is authorized to fill any vacancy that may occur in our delegation to the General Assembly.

Moved and supported that the District Council select the evangelist for our next District Camp Meeting. Amendment made that this matter be taken care of within sixty days. The amendment carried, and the original motion also.

Bro. Neil Horton from Tennessee expressed his pleasure in being with us and gave us a hearty invitation to visit their Assembly and Camp.

The Resolution Committee reported, and the Resolution concerning an offering for the District Camp was adopted. (The last two Resolutions are to be found in the Recommendations of the Ways and Means Committee).

Some closing remarks were made by Gen. Supt. Surbrook.

Benediction by Bro. Surbrook.

RESOLUTIONS

1. Resolved: that we adhere strictly to Manual in giving credentials. Sec. 95, 96, 102-104.

2. Resolved: that each pastor read all resolutions of this Assembly to his congregation at the earliest possible convenience.

3. Be it resolved: that the District Superintendent make at least three trips over the district each year.

4. Be it Resolved: that each church send one set of reports, corrected and balanced by the pastor, to the Assembly.

5. Be it Resolved: that this Assembly authorize a Committee of three, with our District Superintendent as chairman, to take control of all pulpits until the next General Assembly. Thereafter we shall abide by the action of the General Assembly.

6. Resolved: that each church supply the Camp with two each of the following: knives, forks, spoons, cups, saucers, plates and glasses.

7. Resolved: that each pastor of our District make a special effort to place a new Manual in the home of each member of our church as soon as they are available.

8. Resolved: that no pastor hold revivals off his charge without making satisfactory arrangements with his local church board, and then not more than two revivals during the Conference year, provided said church is supporting him.

9. Resolved: that no person be granted license to preach, or renewal of credentials, who does not believe in and practice the Bible doctrine of tithing.

10. Resolved: that all Resolutions be retained from year to year, unless revoked or revised by special act of the Assembly.

11. Be it Resolved: that the books of the local churches be closed at the end of the month prior to the month in which the Assembly convenes.

12. Be it Resolved: that we as a District set for our goal at least one church in every county in the State of Kentucky, and that we never stop until this is done or Jesus comes. This would give us at least 121 churches.

13. Since it is a matter of importance for the pastors of the District to attend the Assembly and Camp, be it therefore resolved that the pastor's support at the church where he is serving as pastor shall continue over the two Sundays he is attending said Assembly and Camp.

14. Resolved: that no church elect a delegate to our District Assembly who will not agree to stay through the entire Assembly.

15. We recommend that those pursuing the Study Course send for their home study questions early in the year, forwarding sufficient postage with their request to cover cost of correspondence.

16. We recommend that the District Assembly furnish the Educational Board with a complete set of books of the Preachers' Study Course.

17. Whereas, many of our pastors have not received sufficient financial support, be it Resolved, therefore, that each local church appoint one prayer meeting night each month as "Donation Night", at which time foodstuffs and provisions shall be brought together for the pastor.

18. Whereas we, as ministerial brethren, as a majority, do not believe in the practice of foot-washing in our churches; and whereas a few of our ministers preach it as a necessity, and this causes a confusion in some of our churches and has led to serious conditions; and inasmuch as the Manual does not give it as an ordinance, be it resolved that we refuse to license ministers who preach it as a necessity; and that those who now preach it as such will cease to preach same.

19. Be it Resolved: that our District Superintendent appoint a Statistical Committee for next year.

20. Be it Resolved: that all reports be handed to the Statistical Committee not later than the second session of the Assembly, and any church or minister who fails to do so shall be fined \$1.00 and be announced to the Assembly.

21. Be it Resolved: that the Camp Meeting Committee formulate a set of rules governing the conduct of campers in dormitories. These rules to be printed and posted in proper places.

22. Whereas the need of the following Resolutions ceases to exist, be it resolved that we strike them from our minutes. Numbers 1, 5, 6, 12, 13, 14, 15, 16, 17, 18, 19, 20, 22, 23, 27, 29, 30, 31, 33, 34, 36, 37, 39, 41, 42, 44.

23. We recommend that the matter of the printing of the Minutes be referred to the District Council.

RECOMMENDATIONS OF THE WAYS AND MEANS COMMITTEE

1. We recommend that we adopt the system of raising Foreign Missionary money requested by the General Church Board as follows: that each church have a weekly Prayer Service and that a Missionary Rally be held monthly on the Lord's day, and at the service an offering be taken for Foreign Missions, same to be forwarded to the District Treasurer.

2. In order to raise our District and General Budget, we recommend that each member (except probationary members and children under fourteen years of age) be assessed \$3.00 per year to be paid monthly.

3. We recommend that the Secretary and Treasurer be paid a minimum salary of \$50.00 each year, same to be paid in equal monthly payments.

4. We recommend the adoption of the suggestions of our General Superintendent relative to the Sunday Schools of our District giving ten cents per week for a Tent Fund, and that each church pay \$1.00 per month for Home Missionary work. We further recommend that each Sunday School throughout the District adopt the Birthday Offering plan, said offering to go toward the Tent and Home Missionary fund.

5. We recommend that all active pastors and evangelists tithe all their income monthly to the District Superintendent, all other licensed and ordained ministers to be assessed \$12.00 per year, same to be paid monthly. Failure to do so each month will call for the action of the District Council.

6. We recommend that the District Superintendent's salary be reduced to \$1,200.00 and that we grant him \$300.00 for traveling expenses.

7. We recommend that we pay 25 per cent of the assessment of the Laity to the General Budget and that the remaining 75 per cent be left in the District as a sinking fund and in the event that sufficient funds are not received from the Ministerial tithes and assessments to meet the District Superintendent's salary that the same be paid from the sinking fund.

8. We recommend that the balance on our Minutes be raised in cash and pledges on the Assembly floor at once. Same to be paid within sixty days.

9. We recommend that each church in the District be requested to send to the Assembly not less than \$2.00 to help defray the table expenses, 1935.

10. We recommend that each church of the Kentucky District pay a sum equal to 20 cents per member to be applied on the transportation and entertainment expenses of the General Assembly, this amount to be forwarded to the District Treasurer not later than August 30th.

11. We recommend that each member of the Pilgrim Holiness Church of the Kentucky District pay 10 cents per year into the District Treasury, same to be held in trust as a General Assembly Expense Fund.

12. We recommend that each church take a free-will offering for the Dist. Supt. on his regular visits, the same to be deducted from the \$300.00 he is allowed on his traveling expenses.

13. We recommend that each church set apart one prayer meeting night each month for special prayer for the District Camp Meeting, at which time an offering shall be taken to defray the expense of the Camp Meeting, and be forwarded to the District Treasurer each month.
