GENERAL PROCEEDINGS

First Sitting of the Kentucky District Assembly at Aspen Grove, Ky.

August 9, 1938—7:30 A.M.

The Twenty-Ninth Annual Assembly of the Kentucky District of the Pilgrim Holiness Church opened with the blessing of God upon it by singing "Oh the Unsearchable Riches of Christ." Then Brother E. E. Watts led in prayer, followed by some burning testimonies.

Brother Danny Woodward of Ohio sang "Did Jesus Ever Say No?"

Brother Leadingham then introduced Brother A. H. Wilson, Assistant General Superintendent, who took the chair. He spoke briefly and read the 133rd Psalm. The roll was called.

On motion the first six rows of seats and the platform was designated as the conference bar.

One member of the reception committee being absent, motion was carried that the District Superintendent appoint one to fill the vacancy, and Brother Robt. Weedman was appointed.

The following persons were then presented to the Assembly: Sister Spatz, Brothers Lowery, Driskell, Woodward, Lipps, Kettle, Horton, Miller, Watts, Ward, Sister Adams, Brothers Humphrey, Williams, Carter, Kelly, Brother and Sister Visenguard, and they gave good testimonies. By vote of the Assembly they were granted honorary seats within the Conference Bar.

Moved and supported that the District Superintendent appoint the vacancies on the Educational and Examining Boards. Carried.

Moved, seconded and carried that the Editing Committee for last year be continued.

It was carried that the Superintendent appoint the Auditing Committee.

Moved and seconded that the same order of sessions used last year be continued with a change in the time of the afternoon service to 2 o'clock instead of 2:30. Carried.

Motion made and carried that the District Superintendent appoint the Committee on Condolence.

Session adjourned by expiration of time.

Benediction by Brother Houston.

Second Sitting—Aug. 8—10:30 A.M.

We sang "His Way With Thee" and were led in prayer by Brother Ward of Ohio.

The District Superintendent presented three new churches, Fullerton accepted with 25 members, Louisa accepted with 8 members, and Cottageville Mission was organized into a church with 12 members and accepted. He also reported that the Stewart's Chapel Church desires to deed their property to the Pilgrim Holiness Church. It was moved, seconded and carried to accept this property.

Brother Frank May was appointed on the Educational Committee and

Brother Jack Tackett was appointed on the Examining Committee by the District Superintendent.

The Resolution Committee reported.

Moved and carried to adopt the first resolution presented.

It was moved and seconded to table the second resolution presented.

Moved and seconded that Resolution No. 26 be deleted. Carried.

It was carried that Resolution No. 35 be revised.

Moved and carried that Resolutions No. 36 and No. 37 be deleted.

It was carried to adopt the Resolution that the District Council appoint all pastors for new missions or churches for the first five years of their existence or until said council deem it proper to do otherwise.

Report of Ways and Means Committee.

The first Recommendation was adopted.

Moved and carried that the Second Recommendation presented be adopted, funds for General work subject to the approval of the General Assembly, the first month of this year to be on the old plan for the general funds.

Brother Steele sang "I Am Glad I Am On the Inside Looking Out."

Motion carried that the order of business in the morning be the election of officers.

The chair appointed a Condolence Committee of Sisters Bolender, Magdalene Bradford, Alexander and Whittinghill.

Sisters Thelma Powell, Weedman and Brother Fred Crum were appointed by the District Superintendent on the Auditing Committee.

Motion to adjourn carried. Benediction by Brother Bolender.

August 10—Third Sitting—7:30 A.M.

The session opened by singing "I Love to Tell the Story." Brother E. P. Qualls led in prayer, and read from I Kings, 18th chapter, giving a splendid message from the 21st verse.

Roll was called.

The minutes of former session were read and approved.

Moved and seconded that the former action concerning election of officers be rescinded. Carried.

Sr. Spatz, Home Missionary from Pikeville, read a report of the work there and also gave a verbal report, which was gladly accepted.

The transfers of Sister Emma Garmen from Pa.-N.J. Dist. and of Brother J. C. Williams from the Ohio Dist. were read and both were accepted into the District.

Announcements were made and recessed for breakfast at 9 o'clock.

Benediction by Brother Lucas.

August 10—Fourth Sitting—10:30 A.M.

Session reopened by singing. Prayer was led by Brother Bolender. The District Superintendent's report was read and accepted.

Brothers Scott, Shelton and Biggs were presented to the Assembly.

Report of the Assistant Superintendent was read and accepted.

District Treasurer's report was read and accepted.

The District Superintendent appointed as tellers: Brothers Johnson, Singleton, Bolender, Robinson and Houston, for election of officers.

Brother Leadingham was elected District Superintendent; Brother Houston, Assistant Superintendent; Sr. Vincent, Secretary, and Brother Singleton as Treasurer on the first ballot.

Two hundred and fifty cans of fruit were promised to Brother and Sister Leadingham this fall; also \$50 was raised in pledges on Sister Leadingham's hospital bill.

By request Brother Steele sang "A String of Empties."

Ballots were prepared for the election of the three additional members of the Council. Brothers Shields, Bolender and Crider were elected on the first ballot. While the votes were being counted special song was sung by Brothers Williams and Carter, also by Sister Hadden.

By vote of the Assembly Brother J. C. Williams was excused to go home.

Motion carried to adjourn. Benediction by Brother Crider.

August 11—Fifth Sitting—7:30 A.M.

Session opened by singing "Sweeter As the Years Go By."

Led in prayer by Sister Keaton.

Brother Crider read from 15th chapter of John, bringing many rich thoughts from the Word.

The roll was then called.

Minutes were read and accepted.

Sister Miller was introduced to the Assembly.

The Committee on Memorials presented seven recommendations which were all accepted.

Resolution was adopted requiring all delegates to the General Assembly to read the Manual and Minutes of the former General Assembly.

Report of the Committee on Condolence was read and accepted and it is to be spread on our minutes.

Report of the Auditing Committee read and accepted.

Motion carried to recess until after breakfast.

Dismissed by Brother Leadingham.

August 11—Sixth Sitting—10:30 A.M.

Opened by singing "Blessed Assurance."

Brother Steele led in prayer.

Brother Wilson then presented Brother Surbrook, General Superintendent, who took the chair and brought a brief, encouraging message of greeting.

Motion made to amend resolution accepted Tuesday by striking out the word "churches."

Moved and seconded that the recommendation presented by the memorial committee be referred back to the committee. Motion carried.

Motion carried to delete recommendation numbers 5, 9, 10 of the Ways and Means Committee in our minutes.

Moved, seconded and carried to revise No. 7 recommendation.

The three new recommendations presented were accepted. (See Recommendations of Ways and Means Committee.)

Moved and supported that the district treasurer be paid \$125 per year instead of \$100. Carried.

Subject of the General Assembly expense was considered.

Moved, seconded and carried that pledges from churches and individuals be received on this amount.

Moved and seconded that each delegate going to the General Assembly pay \$5.00. Carried.

Motion made and seconded that each minister not attending the District Assembly be asked to give \$1.00 or more on the General Assembly expense. Carried. Said amount to be sent to Treasurer on or before the 29th of August.

Moved and seconded to extend the time of adjournment one-half hour.

Ballots were cast to elect three ministerial delegates to the General Assembly. Brothers Shields, Bolender and Crider were elected on the first ballot.

Brothers Lucas, Tackett and Senter were elected as alternates.

Moved and seconded that we have another business session at 2 o'clock. Carried.

Moved and seconded that each pastor submit the name of a lay member as a candidate for delegate to General Assembly. Carried.

Recessed until 2 o'clock. Dismissed by Brother Houston.

August 11—Seventh Sitting—2 P.M.

Assembly convened again at 2 o'clock and we sang "What a Friend We Have in Jesus." Brother Johnson led in prayer.

Brother Surbrook spoke to the delegation on the Scripture, "The laborer is worthy of his hire."

Ballots were prepared for the election of lay delegates to the General Assembly. Two tellers being absent Brothers Shields and May were appointed in their place. On the first ballot Sister Powell, Sister Holmes were elected, and Sister Burbaugh on the second ballot. Sisters Burkholder, Esther Ratliff and Ruth Yelton were elected as alternates.

Moved and seconded to retain the present Board of District Trustees. Carried.

Moved and seconded that Brother Houston be elected on the Examining Board. Carried.

Moved and seconded that Brother Johnson be elected on the Educational Board by acclamation; also Brother Senter. Carried.

Moved and seconded that the District Superintendent appoint all other committees. Carried.

By vote of Assembly Brother Bolender was elected Chairman of the Camp Meeting Committee.

A partial list of the Advocate subscriptions secured was taken.

Adjourned. Benediction by Brother Wilson.

8th Sitting—August 12, 1938

Session opened by singing "Must Jesus Bear the Cross Alone?" 2Bro. Weedman led the prayer. The scripture was read by Bro. Shields from I Timothy.

The roll was called.

The minutes of the previous session were read and approved.

A part of the church reports were read by the Statistician.

Moved and seconded that the time of adjournment be extended fifteen minutes in order that the totals of the Statistical Report might be heard. Motion carried. The totals were read and the report accepted.

Moved and seconded to have all the church reports read. Carried.

Adjourned by expiration of time.

Benediction by Bro. Johnson.

9th Sitting—August 12, 1938

Reassembled at 10:30 by singing "Amazing Grace." Bro. Bowling led in prayer.

Memorial No. 8 was read and accepted as revised.

The Resolution Committee reported. Two resolutions were accepted. One was referred for redrafting.

Bro. L. W. Sturk, First Assistant General Superintendent, was introduced, also Sister Sturk, Sister Braam, Sister Lee. At Bro. Wilson's request, Bro. Sturk took the chair.

Resolution Committee continued. Three resolutions were accepted.

Moved and seconded that Resolution No. 21 be changed, setting the date for our camp, permanently, to begin on the first Friday in August. Carried.

A recommendation from the Ways and Means Committee, concerning pastors' salaries, was accepted.

Report was made of the drive for Advocate subscribers. Bro. Shields secured sixty, was awarded the first prize, a set of Commentaries. Bro. Bolender had received twenty, and was given a nice Bible. Bro. Tackett had gained twelve, and was presented a beautiful New Testament.

Invitations were received from Kingswood and Ashland Second for the Ministerial Meeting. Kingswood received the largest number of votes, was selected as first choice; Ashland Second Church, second choice.

The names of ordained ministers, licensed ministers, licensed deaconesses were read and passed upon. Two names were passed upon for ordination to the ministry.

The time of the ordination service was set for the close of the afternoon sitting.

Adjourned by expiration of time to reconvene at 2 o'clock for afternoon session.

Benediction by Bro. Sturk.

10th Sitting—August 12, 1938.

Opened at 2 o'clock by singing "When I See the Blood." Bro. Senter led in prayer. "Amazing Grace" was sung by the congregation.

The Resolution Committee presented a resolution which was rejected.

Motion carried to accept a resolution to take the place of Resolution No. 13 in our minutes.

Moved, seconded and carried to rescind Resolution No. 13.

Ways and Means Committee reported. Moved and seconded to receive the recommendation that the expenses of the Assistant Suprintendent be paid while he is doing district work. Carried.

The reading of the church reports was continued until completed. Motion

carried to accept this report and that it be spread upon our minutes when the proper corrections have been made.

Bro. and Sister Oden were introduced to the Assembly, their transfers having already been received from the Ohio District. They were accepted into our district.

A memorial to the General Assembly was read and accepted as amended.

The following appointments to committees was made by the District Superintendent: Campmeeting—Bro. Bolender, Bro. Crum, Bro. Tackett, Bro. Praither and Bro. May. The Resolution and Ways and Means Committees remain the same as last year; Bro. Senter, Statistician.

Motion carried to extend the time of adjournment.

By vote of the Assembly the Council is granted power to pass on some ministers who have not yet been fully considered.

Moved and seconded that Sister Leonard Fleming be granted minister's license. Carried.

The following were selected as the places for the next Group Meetings: Fullerton, Salem, Kingswood, Soldier, and Prestonsburg.

A vote of thanks was given to various individuals and committees for their faithful service.

The minutes of today's sessions were read and approved as read.

The ordination service was announced from 6 to 7 o'clock.

Recessed until after supper. Dismissed with prayer.

The ordination service was conducted by Bro. Sturk. Bros. Robert Weedman and M. L. Brown were the candidates. This service was attended with great blessing from the Lord, and at the close the Assembly adjourned with God's benediction resting upon us.

RESOLUTIONS

1. Resolved: that all resolutions be retained from year to year, unless revoked or revised by special act of the Assembly.

2. Resolved: that we adhere strictly to Manual in giving credentials, in compliance with Sec. 141-147-149.

3. Resolved: that no person be granted license to preach, or renewal of credentials, who does not believe in and practice the Bible doctrine of tithing, and tithes into the Pilgrim Holiness Church.

4. Resolved: that all persons applying for license appear in person to the Examining Board, unless applicant is sick or otherwise unable to appear, and in such cases some member of the Assembly certify as to their character and location.

5. Resolved: that the District furnish the Educational Board with a complete set of books of the Preachers' Study Course.

6. Resolved: that those pursuing the Study Course send for their home study questions early in the year, forwarding with their request 25c to cover the cost of questions and postage for each subject.

7. Resolved: that each pastor read all Resolutions of this Assembly to his congregation at the earliest possible convenience.

8. Resolved: that each pastor of our District make a special effort to place a 1938 Manual in the home of each member of our church.

9. Resolved: that all preachers come, send someone, or pay the equivalent of three days' labor for the preparation of the District Camp and Assembly, when called upon by the District Superintendent.

10. Resolved: that all preachers give three days' labor or pay the equivalent, providing a building program is launched, same to work under the supervision of the Building Committee.

11. Whereas, many of our pastors have not received sufficient financial support, be it resolved: that each local church appoint one prayer meeting night each month as "Donation Night," at which time foodstuffs and provisions shall be brought together for the pastor.

12. Since it is a matter of importance for the pastors of the District to attend the Assembly and Camp, be it therefore resolved: that the pastor's support at the church where he is assisted as pastor, shall continue over the two Sundays he is attending said Assembly and Camp.

13. Resolved: that each local church board or pastor calling an evangelist

outside the District or from another church, consult the District Superintendent.

14. Resolved: that each pastor list, in a book, the name and address of each Advocate subscriber with the date of expiration, said book to be transferred to the following pastor.

15. Resolved: that we as an Assembly ask each pastor after resigning a church, to seek a location in which to live beyond the circle of the church's territory.

16. Resolved: that the action of the 1935 Assembly, in regard to our Camp Ground, be revoked.

17. Resolved: that the District Council be authorized to take any step it deems necessary in securing a permanent location for our District Camp and Assembly.

18. Resolved: that no one leave the Assembly without its permission.

19. Resolved: that in the event we move from Aspen Grove, an annual Camp Meeting be planned and sponsored by the District Council and the Aspen Grove local church.

20. Resolved: that the date of the beginning of our Camp be permanently set for the first Friday in August.

21. Resolved: that we register all who come to Camp, assigning work to each one, as equally as possible. A meal ticket will be given all who register, and is to be presented at the dining room door.

22. Resolved: that all who disregard the following rules be answerable to the District Council:

a. All pastors shall instruct their church and young people that all who come to the Camp shall abide by its rules.

b. Everyone shall retire, or be quiet after 10:30 P.M.

c. A dean shall be appointed over each dormitory.

d. No single young people shall be allowed to be off the grounds after 7:00 P.M.

e. No article shall be taken from the dining room or kitchen without permission from the one in charge, and shall be returned in good condition.

f. No food shall be taken from the kitchen without permission.

g. Parents shall supervise the conduct of their children, while on the Camp Grounds.

h. A supervisor shall be appointed to care for the kitchen and dining room workers; for the parking of cars; caring for the tent, and tabernacle; and for the cleaning of the Camp Grounds; these to be appointed by the Camp Meeting Committee.

23. Resolved: that no church elect a delegate to our District Assembly, who will not agree to stay through the entire Assembly.

24. Resolved: that each church supply the Camp with two each of the following: cups, plates, glasses, tea towels, and one straw tick.

25. Resolved: that the District Council be vested with full power to construct buildings for the District when necessary, appointing and directing a committee to carry out its plans.

26. Resolved: that the District Council set the date for the Ministerial Convention and said date to be recorded in the Minutes.

27. Resolved: that the District set for its goal at least one church in every county in the State.

28. Resolved: that the District Superintendent make at least three trips over the District during the year.

29. Resolved: that the District Superintendent be consulted and present if possible when drawing up all deeds in the District.

30. Resolved: that the District Groups be recorded in our Minutes.

31. Resolved: that each Group of the District have at least three Quarterly Meetings a year.

32. Resolved: that each of our Sunday Schools correctly enroll each class, said enrollment to be revised quarterly.

33. Resolved: that each church close their books on the last day of each month and that the reports be sent to the Dist. Treasurer, immediately.

34. Resolved: that our Dist. Supt. appoint a Statistician for next year.

35. Resolved: that each church, preacher, and deaconess send a copy of their reports to the Statistician on Monday after the Assembly year closes, which is to be the last Sunday of July. Be it also resolved: that the District Treasurer's books be closed at noon on the following Thursday.

36. Be it resolved: that we have 500 copies of our district minutes printed, said minutes to be sold for 25c per copy; 10 copies or more 10c per copy.

37. Be it resolved: that each local church send ten quarts of sweets to the Camp.

38. Resolved: that the names and addresses of all Sunday School Superintendents, Presidents of the Young People's Societies and the Chairmen of the Missionary Committees be placed in our District Minutes.

39. Resolved: that no pastors hold revivals off his charge without making satisfactory arrangements with his church board and the district superintendent and that no pastor hold a revival away from his church within thirty days after a revival in his own church, then not more than two revivals during the conference year, provided said church is supporting him.

40. Resolved: that we shall have a District Young People's Convention beginning on Thursday before the Camp at 7:30 P.M. The day services on Friday and Saturday to be devoted to Young People's work. Be it further resolved: that the District Council shall appoint a president in each zone who shall create interest among our young people, conduct zone rallies and who shall work directly under the supervision of the District Young People's Director and the District Superintendent.

41. Resolved: that each delegate to the General Assembly be required to read the entire Manual, also the 1934 General Assembly Minutes, before said Assembly convenes.

42. Whereas our Manual states that the pastor shall receive first consideration, section 67, therefore be it resolved: that at our Group Meetings we have a chairman that urges, insists and checks on our pastors being amply paid.

43. Resolved: that each zone have a Sunday School Attendance Banner to be given quarterly to the Sunday School having the largest attendance; also an Offering Banner to be given to the Sunday School having the largest offerings.

44. Resolved: that the District Council appoint all pastors for new missions for the first five years of their existence or until said Council shall decide to do otherwise.

45. Resolved: that a rising vote of thanks be given to Bro. Surbrook, Bro. Wilson and Bro. Sturk for their presence and assistance in the Assembly.

46. Resolved: that we give our District Superintendent a rising vote of thanks for his untiring service.

47. Resolved: that we give our District Treasurer and District Secretary a rising vote of thanks.

48. Resolved: that we give our Missionaries a rising vote of thanks.

49. Resolved: that we give a rising vote of thanks to the Camp Meeting Committee for their services during our Camp and Assembly.

50. Resolved: that we give a rising vote of thanks to our cooks, kitchen and dining room workers, for the good meals prepared and for their service.

51. Resolved: that we give a rising vote of thanks to the Editing Committee.

52. Resolved: that we give a rising vote of thanks to each of our churches and friends for so liberally donating produce to our Camp and Assembly.

53. Resolved: that we give a rising vote of thanks to the Aspen Grove Church and community for their co-operation.

54. Resolved: that we give a rising vote of thanks to our Statistician for his satisfactory service.

RECOMMENDATIONS OF THE WAYS AND MEANS COMMITTEE

1. We recommend: that each Sunday School of our District pay 10c per week for a Tent Fund. We further recommend that each Sunday School adopt the Birthday Offering plan, said offering to go toward the Tent and Home Missionary Fund.

2. We recommend: that each church pay as much as \$5.00 on the expenses of the pastor and delegate to the District Assembly. We further recommend:

that the amount raised be equally divided, providing the pastor and delegate do not go to the Assembly together.

3. We recommend: that our District pay \$100.00 per year on General Assembly Expense Fund.

4. We recommend: that each church take a free-will offering for the District Superintendent on his regular visits, same to be credited to said church's District budget, when reported by the Superintendent to the Treasurer.

5. We recommend: that in as much as this State is included in the Owosso, Michigan, Bible School Zone, we therefore strongly recommend that our people patronize our own Bible School; we further recommend: that we raise \$100.00 per year for this school.

6. Whereas there is a pressing need for funds to erect buildings to house our people, we recommend that we as an Assembly, make strenuous efforts this year to raise such funds. The same to be used at the discretion of the District Council.

7. We recommend: that each church raise a sum equivalent to \$2.00 per member, per year, for Foreign Missions. We further recommend: that we as a District co-operate fully with all the financial requirements of the General Church.

8. We recommend: that we adopt the system of raising Foreign Missionary money requested by the General Church Board as follows: that each church have a Weekly Prayer Service and that a Missionary Rally be held monthly on the Lord's Day, and at this service an offering be taken for Foreign Missions, same to be forwarded to the District Treasurer.

9. We recommend: that all active pastors and evangelists pay $\frac{3}{4}$ of their ministerial tithes and $\frac{1}{2}$ of their tithes from secular labor, to the District Superintendent. All other licensed and ordained ministers to be assessed \$12.00 per year, same to be paid monthly. Failure to do so will call for the action of the District Council.

10. We recommend: that the Superintendent and the Treasurer be vested with power to purchase bond, or insurance, as required to securely cover the Treasurer and all District monies.

11. We recommend: that the District Treasurer shall send out to each local church, quarterly statements showing amounts due in each department. We further recommend: that a quarterly statement be sent to each minister showing amount due on assessment.

12. We recommend: that the District Treasurer be paid \$125.00 per year and the District Secretary be paid \$50.00, same to be paid in equal monthly payments.

13. We recommend: that the District Superintendent's salary be raised to \$1,500.00 per year, and that he be granted two weeks of vacation with pay; also, that he be paid 3c per mile for traveling expenses.

14. We recommend: that the District Superintendent send out quarterly a bulletin, stating the standing of the churches on their general and district budgets, the same to be reported as follows:

Honor roll church paid in full.....	100%
Silver star church paid up.....	75%
White star church paid up.....	50%
Red star church paid up.....	less than 50%

15. We further recommend: that the District Treasurer prepare a chart for the District Assembly giving the standing of the churches for the year by the above mentioned percentage with the honor roll churches receiving a gold star.

16. We recommend: that the Assistant Superintendent be allowed 25c per meal for meals bought while working in the district work.

17. We recommend: that where it is possible, every church with twenty members of voting age pay their pastor \$10.00 or more, and that every church with thirty members of voting age pay \$15.00 as a minimum. Churches having forty members of voting age pay \$20.00 per week minimum. Churches with fifty members of voting age pay what church and pastor agree up in harmony with this scale.

18. We, the Ways and Means Committee, recommend that all of our budgets for district and general interest be set according to our financial ability.

19. We recommend: that our budgets for district and general interests be as follows:

REPORT OF THE DISTRICT SUPERINTENDENT

To the Twenty-Ninth Annual District Assembly now in session, Aug. 10,
Greetings:

Through the goodness and mercy of God we have been privileged to labor another year in His great vineyard. We are indeed grateful to our Heavenly Father for His guidance, protection and many blessings bestowed upon us this past year. There have been many battles to fight and burdens to carry, but we are rejoicing over the victory the Lord has been pleased to give us.

Many of our churches have been blessed with an old-time revival, which has resulted in many new additions to our church membership. Some of our Sunday Schools have taken on new life and have broken all previous records in attendance. Much interest has been created among our young people.

The Second Church at Covington has completed its five-room parsonage. Due to financial conditions the church building program at Erlanger has been retarded a little. Nevertheless the folk are worshipping in the building and expecting to have it entirely completed soon. Falmouth raised the ceiling in their church building, install new indirect lighting fixtures, papered, installed good opera chairs, which increased their seating capacity, and have done other improvements, such as building a coal shed, underpinning of the church, concretizing in front of the church, obtained a life-size picture of Jesus speaking to Nicodemus, and a rubber runner for the aisle. A lot has been purchased at Frankfort on which to erect a new church building; same was paid for in full the day we took the deed. Some splendid improvements have been made on the church building at Garvin Hill, such as ceiling the church and installing electric lights. A very beautiful church building has been erected at Kingswood, and it is one of the best buildings in the district, having less than \$100 indebtedness on it. Our efficient pastor at this place surely has labored faithfully in order to complete and pay for this building. However, I wish to say that due credit should be given to our General Church Secretary, Rev. S. M. Stikeleather, also, for this nice commodious church, as he donated the lot and gave heavily himself and did a great deal of soliciting. A modern nine-room brick parsonage with full-size basement has been purchased at Louisville, valued at \$5,000; and they have also built two rooms in their church basement for Sunday School work. A nice parsonage has been obtained at Maysville, a frame building, valued at \$1,000. The First Church at Ashland has painted its church building, including the roof and the parsonage, sodded the yard and planted shrubbery, which greatly added to the appearance of the place and also increased the value of the property; and have paid an old street assessment of about \$60 that had been past due several years. Ashland Second Church put a very excellent full-size basement under their building, which made four beautiful Sunday School rooms. The church building at Tram has been ceiled on the inside. Soldier put pews in their church, which, though not new, are good. They installed a furnace also. Elizabethtown installed a \$580 furnace in their church free of indebtedness. Salem painted their church on the inside and out and have put new seats in their building. We have pushed every department of our work, and have stressed the need of deep spirituality and Bible standards.

I have tried to preach 127 times, conducted 81 business meetings, 15 Quarterly Group Meetings, 3 revivals, 1 Ministerial Meeting, 1 District Assembly, organized 3 churches, i. e., Louisa, Fullerton and Cottageville, and have several other good prospective churches, performed 1 marriage ceremony, ordained 3 to the ministry, attended 2 General Board Meetings at Indianapolis, Ind., 2 School Board Meetings at Owosso, Mich., have traveled 18,864 miles, including the 2 trips each to the General Board Meetings and the School Board Meetings, have received \$511.42 for travelling expenses, and my salary in full.

I wish to thank our Assistant Superintendent, District Council, every pastor, evangelist and worker for their splendid co-operation throughout the year.
