Adjourned by expiration of time. Benediction by Bro. Surbrook,

FRIDAY-8 A.M.

The Assembly met with Bro. Flexon in the chair. Opened by singing "Higher Ground." Led in prayer by Bro. Steele. Bro. Bolender read Scripture lesson from Eph. 4:1-13.

The roll was called.

The minutes were read and approved.

The combined report of the Examining and Educational Boards was heard and accepted. (The names appear in the directory.)

The Resolution Committee presented two resolutions which were adopted. The Ways and Means Committee reported. Motion carried to delete numbers 3, 7, 14, 18, 19, the last clause of No. 5 and to revise 13. The recommendation concerning the Camp Budget and percentages of same was adopted.

A resolution of the Council regarding Aspen Grove was read and adopted. Motion carried to refer the resolution as to cottage specifications to the Council.

Motion carried that Louisville be the place for the Ministerial Meeting. Motion prevailed that each church bring or send in an offering of \$1.00 or more on the expenses of the Ministerial Meeting.

The places for the Zone Meetings were set as follows: Louisville Zone, Louisville; Covington Zone, Erlanger; Big Sandy Zone, Toler; Ashland Zone, Fullerton; Olive Hill Zone, Soldier.

Bro. Steele was excused by the Assembly.

Adjourned. Dismissed by Bro. Flexon.

FRIDAY-10 A.M.

After singing and prayer, Sr. Marie Holmes sang a solo.

The Council presented a resolution regulating the building of cabins. Motion carried to adopt same.

Motion carried to accept the recommendation of the Council governing the sale of lots.

Motion carried that an addition be made to recommendation No. 15 of the Ways and Means.

The report of the Committee on Condolence was read by Sister Shields and accepted.

Motion carried to leave the time of the Zone Meetings to the Dist. Supt.

The Examining and Educational Boards presented a few more names which were passed upon.

Bro. Flexon advises that we hold to the Manual in regard to licensed ministers.

List of Committees was read by the Dist. Supt. (See directory.) Motion carried to adopt resolution No. 48 with a rising vote.

Adjourned. Benediction by Bro. Leadingham.

RESOLUTIONS

DISTRICT SUPERINTENDENT

- 1. Resolved: that the District Superintendent make at least three trips over the District, during the year.
- 2. Resolved: that the District Superintendent be consulted and present if possible when drawing up all deeds in the District.
- 3. Resolved: that the District Superintendent appoint a Statistician for next year.
- 4. Resolved: that the District Superintendent be a member of our Zone Bible School Board.
- 5. Whereas, our District Camp is permanently located near Maysville, Ky., therefore be it resolved: that the Aspen Grove property be deeded back to their Board of Trustees and that the District Superintendent be a member of their Campmeeting Board. Be it further resolved: that this resolution be inserted in the deed.

COUNCIL

6. Resolved: that the date of our Camp and Assembly be left in the hands of the District Council.

7. Resolved: that the District Council be vested with full power to construct buildings for the District when necessary, appointing and directing a committee to carry out its plans.

8. Resolved: that the District Council set the date for the Ministerial

Convention and said date to be recorded in the Minutes.

9. Resolved: that the District Council appoint all pastors for new missions for the first five years of their existence, or until said Council shall decide to do otherwise.

10. Resolved: that we, as an Assembly, delegate to the Council, power to make the rules and by-laws regulating the sale of lots and building of cottages and to govern the Campground, same to be printed in the Minutes.

CHURCH

1. Resolved: that each church supply the Camp with two each of the following: cups, plates, glasses, tea tofels, and one straw tick.

12. Resolved: that each church close their books on the last day of each

month and that the reports be sent to the Treasurer immediately.

13. Resolved: that each church, preacher and deaconess send a copy of their reports to the Statistician on Monday after the Assembly year closes, which is to be the fifteenth of July. Be it also resolved: that the District Treasurer's books be closed at noon on the following Thursday.

LOCAL

14. Be it resolved: that each church send ten quarts of sweets to the

Camp.

15. Whereas, many of our pastors have not received sufficient financial support, be it resolved: that each local church appoint one prayer meeting night each month as "Donation Night," at which time foodstuffs and provisions shall be brought together for the pastor.

16. Since it is a matter of importance for the pastors of the District to attend the Assembly and Camp, be it therefore resolved: that the pastor's support at the church where he is assigned as pastor, shall continue over the

two Sundays he is attending said Assembly and Camp.

17. Resolved: that each church provide a cottage on the Campground for their pastor, and that other members of the District be urged to build

for their personal need.

18. Whereas, the times in which we are living are perilous and the needs of the District, both financially and spiritually, are so great, therefore be it resolved: that we set aside the first day in each month for fasting and prayer.

SUNDAY SCHOOL

19. Resolved: that each of our Sunday Schools correctly enroll each

class, said enrollment to be revised quarterly.

20. Resolved: that each Zone have a Sunday School Attendance Banner to be given quarterly to the Sunday School having the largest attendance; also an Offering Banner to be given to the Sunday School having the largest offerings.

21. Resolved: that we obtain the service of a Sunday School Booster to visit each church once a year, to enthuse, lay plans and help to perfect the organization of each Sunday School. This person is to be appointed by the District Council and is to be given free-will offerings to cover their traveling expenses.

YOUNG PEOPLE

22. Resolved: that we shall have a District Young People's Convention beginning on Thursday before the Camp at 7:30 P.M. The day services on Friday and Saturday to be devoted to Young People's work. Be it further resolved: that the District Council shall appoint a president in each zone who shall create interest among our young people, conduct zone rallies and who shall work directly under the supervision of the District Superintendent and the Young People's Executive Secretary.

ZONES

23. Whereas, our Manual states that the pastor shall receive first consideration, section 67, therefore be it resolved: that at our Zone Meetings we have a chairman that urges, insists and checks on our pastors being amply paid.

24. Resolved: that the District Zones be recorded in our Minutes.

25. Resolved: that each Zone of the District have at least three quarterly meetings a year.

CREDENTIALS

26. Resolved: that we adhere strictly to Manual in giving credentials, in compliance with Sec. 141-147-149.

27. Resolved: that no person be granted license to preach, or renewal of credentials, who does not believe in and practice the Bible doctrine of tithing, and tithe into the Pilgrim Holiness Church.

28. Resolved: that all persons applying for license appear in person to the Examining Board, unless applicant is sick or otherwise unable to appear, and in such cases some member of the Assembly certify as to their character and location.

29. Resolved: that the District furnish the Educational Board with a

complete set of books of the Preachers' Study Course.

30. Resolved: that those pursuing the Study Course send for their home study questions early in the year, forwarding with their request 25c to cover the cost of questions and postage for each subject.

PASTORS

31. Resolved: that each pastor read all Resolutions of this Assembly to his congregation at the earliest possible convenience.

32. Resolved: that each pastor of our District make a special effort to place a 1938 Manual in the home of each member of our church.

33. Resolved: that each local church board or pastor calling an evangelist outside the district or from another church, consult the Dist. Supt.

34. Resolved: that each pastor list in a book, the name and address of each Advocate subscriber with the date of expiration, said book to be transferred to the following pastor.

35. Resolved: that all pastors, when changing charges, must adhere to

our Manual, section 53, paragraph 14.

36. Resolved: that each minister of our district closely observe the requirements of the Manual, section 153, in regard to recognizing the local pastor.

37. Resolved: that no pastor hold revivals off his charge without making satisfactory arrangements with his church board and the District Superintendent and that no pastor hold a revival away from his church within thirty days after a revival in his own church, then not more than two revivals during the conference year, provided said church is supporting him.

38. Resolved: that all pastors bring the obituary of deceased members,

38. Resolved: that all pastors bring the obituary of deceased members, which have been prominent in the District, to the Assembly for the benefit

of the Condolence Committee.

ASSEMBLY

39. Resolved: that no one leave the Assembly without its permission.

40. Resolved: that no church elect a delegate to our District Assembly who will not agree to stay through the entire Assembly. (Manual, sec. 82, par. 2.)

CAMP

41. Resolved: that we register all who come to Camp, assigning work to each one, as equally as possible. A meal ticket will be given all who register, and is to be presented at the dining room door.

42. Resolved: that all who disregard the following rules be answerable

to the District Council:

a. All pastors shall instruct their church and young people that all who come to the Camp shall abide by its rules.

b. Everyone shall retire, or be quiet after 10:30 P.M.

- c. A dean shall be appointed over each dormitory, when necessary.
- d. No single young people shall be allowed off the grounds after 7 P.M. e. No article shall be taken from the dining room or kitchen without permission from the one in charge, and shall be returned in good condition.

f. No food shall be taken from the kitchen without permission.

g. Parents shall supervise the conduct of their children, while on the Campground.

h. A supervisor shall be appointed to care for the kitchen and dining room workers; for the parking of cars; caring for the tent, and tabernacle; and for the cleaning of the Campground; these to be appointed by the Camp Meeting Committee.

43. Resolved: that all preachers give three days' labor, or pay the equivalent, in developing our Campground when called upon by the Dist. Supt.

44. Resolved: that all preachers come, send someone or pay the equivalent, of three days' labor for the preparation of the District Camp and Assembly when called upon by the Dist. Supt.

MINUTES

45. Resolved: that all resolutions be retained from year to year unless revoked or revised by special act of the Assembly.

46. Resolved: that we have five hundred copies of our District Minutes

printed, said Minutes to sell for 25c per copy.

47. Resolved: that the names and addresses of all S. S. Superintendents, Presidents of the Y. P. Societies and Chairmen of the Missionary Com-

mittees be placed in our District Minutes.

48. Resolved: that this Assembly give a rising vote of thanks to our General Superintendent, Rev. W. L. Surbrook, and his assistant, Rev. R. G. Flexon, also Rev. E. E. Leadingham, our District Superintendent, and District officials, our laboring help and donators and to all who have served so faithfully to make this Camp and Assembly a blessing.

RECOMMENDATIONS OF THE WAYS AND MEANS COMMITTEE

1. We recommend: that each Sunday School of our District pay 10c per week for a Tent Fund. We further recommend that each Sunday School adopt the Birthday Offering plan, said offering to go toward the Tent and Home Missionary Fund.

2. We recommend: that each church pay not less than \$5.00 on the expenses of the pastor and delegate to the District Assembly. We further recommend: that the amount raised be equally divided, provided the pastor

and delegate do not go to the Assembly together.

3. We recommend: that each church take a free-will offering for the District Superintendent on his regular visits, same to be credited to said church's District budget, when reported by the Superintendent to the Treasurer.

4. We recommend: that in as much as this State is included in the Owosso, Michigan, Bible School Zone, we therefore strongly recommend that

our people patronize our own Bible School.

- 5. Whereas there is a pressing need for funds to erect buildings to house our people, we recommend that we as an Assembly, make strenuous efforts this year to raise such funds. The same to be used at the discretion of the District Council.
- 6. We recommend: that we adopt the system of raising Foreign Missionary money requested by the General Church Board as follows: that each church have a Weekly Prayer Service and that a Missionary Raily be held monthly on the Lord's Day, and at this service an offering be taken for Foreign Missions, same to be forwarded to the District Treasurer.

7. We recommend: that all active pastors and evange ists pay ¾ of their ministerial tithes and ½ of their tithes from secular labor, to the District Superintendent. All other licensed and ordained ministers to be assessed \$12.00 per year, same to be paid monthly. Failure to do so will call

for the action of the District Council,

8. We recommend: that the Superintendent and the Treasurer be vested with power to purchase bond, or insurance, as required to securely cover the Treasurer and all District monies.

9. We recommend: that the District Treasurer shall send out to each local church, quarterly statements showing amounts due in each department. We further recommend: that a quarterly statement be sent to each minister showing amount due on assessment.

10. We recommend: that the District Treasurer be paid \$125.00 per year and the District Secretary be paid \$50.00, same to be paid in equal monthly payments.

11. We recommend: that the District Superintendent's salary be \$1,-500.00 per year, and that he be granted two weeks of vacation with pay; also, that he be paid \$300.00 for traveling expenses.

12. We recommend: that the Assistant Superintendent be allowed 25c

per meal for meals bought while working in the district work.

13. We recommend: that where it is possible, every church with twenty members of voting age pay their pastor \$10.00 or more, and that every church with thirty members of voting age pay \$15.00 as a minimum. Churches having forty members of voting age pay \$20.00 per week minimum. Churches with fifty members of voting age pay what church and pastor agree upon in harmony with this scale.

14. We recommend that the District Treasurer prepare a chart for the District Assembly giving a gold star to the churches paid up in full to District and General interests, and a silver star to the churches paid up seventy-five per cent, a white star to the churches paid up fifty per cent, and a red

star to the churches paying less than fifty per cent.

- 15. We recommend that we strictly adhere to the ruling of the Manual, section 127, paragraph 121, in regard to General Funds. "To set a yearly budget of expense of not more than \$3.00 per member for the General church both at home and abroad, namely: Foreign Missions, Home Missions and Administrative Expense. The General Assembly of 1938 instructed the General Board to make the division of such General church funds as follows: (a) For 1938-39, \$2.00 for Foreign Missions, 50c for Home Missions and 50c for General Administrative Expense; (b) for the fiscal years 1939-42, \$1.90 for Foreign Missions, 60c for Home Missions, 50c for General Administrative Expense." The Action of the General Board: "Be it resolved: that when a local church raises its general budget allotments monthly, such church shall be granted the privilege of specifying surplus funds. In the event the local church treasurer does not allot General Budget Funds according to the Manual, section 127, paragraph 12, that the General Board authorize the District Treasurer to make the proper allotment."
- 16. We recommend that District Budget, Home Missions, Bible School and General Assembly Expense be combined under the head of District Budget (said budget is named below). We also recommend that 65% of the District Budget go to the sinking fund, which shall be a preferred claim, 25% to Home Missions; 5% to Zone Bible School; 5% to General Assembly Expense.

17. We recommend that the Camp Budget of each local church be as listed below. We further recommend that 75% of same be applied on payment of Camp property, this to be a preferred claim, and 25% go to the general operating expense of the Camp.

DISTRICT SUPERINTENDENT'S REPORT

The Thirtieth Annual Assembly of the Pilgrim Holiness Church, Kentucky District, now in session, Greetings:

Through the providence of God we have been privileged to meet again this side of the Judgment in another Annual Assembly, and I want to thank our Heavenly Father for divine protection and keeping power. I have never loved the Lord better and had more victory than today. This past year has been a very busy year indeed, and there have been many battles, however the Lord has fought all of them for us.

Some splendid repairs have been done on the Carrollton church, such as painting, papering, repairing the roof, etc. Covington II church has gone forward in a gracious way, after a mighty revival last fall which resulted in many souls finding God. The folk purchased a church building with a large seating capacity and several Sunday School rooms, in an excellent location. Through the untiring efforts of our faithful pastor and folk at Erlanger, the church building there has been completed. At Frankfort they are putting the stone on the ground for their new church building. The beautiful church at Kingswood has been entirely completed and it was my privilege to dedicate it free of debt without taking an offering. Louisville has a new church building and several nice rooms for Sunday School work. They used brick siding on the outside, and to say the least, we now have a church building and parsonage there that is a credit to any church. For a quarter of a century the church building in Maysville has been in a very undesirable location, but after a good tent meeting there early in this assembly year, a lot was purchased in a good location and on New Year's Day our folk moved in a very commodious building and I sincerely believe that Maysville has a much brighter future. Rush church is having repairs that have been needed for some time. A splendid church was organized by our Assistant Superintendent at Bolt's Fork with twelve members, and we have other calls to places where there are prospects of getting new churches.

The new Campground has been purchased and by the help of our Lo.d and the cooperation of our precious people we have been able to erect a tabernacle size 45x80, a dining room which easily seats 150 people at one time, kitchen, size 16x20, and a ladies' dormitory, size 28x40, an office building with tour rooms, and six cottages and about 1,000 leet of sidewalk on the Camp-

ground

The Lord has especially blessed in giving some gracious revivals in the district, and a beautiful spirit of fellowship has prevailed throughout the

year among the brethren.

I have tried to preach 117 times, conducted two revivals, 88 business meetings, 14 quarterly group meetings, one ministerial meeting, supplied the Covington First Church as pastor for two months and the Falmouth Church for five weeks, dedicated two churches and one child, attended the General Assembly, one General Board meeting, one special Committee Meeting at Columbus, Ind., in the interest of the Burial Association, was on the Campground about 45 different days, traveled 19,362 miles, including my trip to the General Assembly, General Board and Committee Meeting. I received \$524.46 for traveling expenses and my salary in full.

Due to the fact that it was necessary for me to spend a considerable amount of time on the Campground, I was unable to give the churches the

service that I wanted to.

I wish to sincerely thank our Assistant District Superintendent and the entire District Council, every pastor, evangelist, worker, and all of the laity for their loyal support and splendid cooperation throughout the years that I have served you as District Superintendent. However, I will ask that you do not vote for me as Superintendent this year.

I pray God's richest blessings upon all of you, from the least to the

greatest, and I wish my successor great success whoever it may be. Humbly submitted,

RULES GOVERNING SALE OF LOTS AND BUILDING OF COTTAGES

Price of lots \$10.00 each. Terms, \$1.00 down payment when purchased, balance to be paid in monthly payments of \$3.00 each. 6% on unpaid balance at maturity. All lots are to be paid for within six months or contract be void.

All outside lots shall be in dimension 20-foot front and 30 feet in length. Inside lots size 20 by 20. All cottages are to be uniform in size and placement on lots in accordance with the row or street on which they may be placed. The dimensions of the cottages are to be 10 by 12 ft. with an 8 ft. eave. Six concrete piers, one door and two or more windows, a screen door and metal roof. This made of dressed lumber and to have two coats of white paint. An extra room may be made at the back with a shed style roof, on the outside lots. A porch may be built on thefront of any and all cottages.

The Campmeeting oard has the right to paint or repair in any way necessary and the owner is to pay the expenses of the same. Aluminum paint only is to be used on the roofs.

The Campmeeting Board is to keep all buildings insured and the owner of each cottage is to pay his part of the premium.


