STANDING RULES

1. Assembly Year

The Assembly year shall close June 30 and complete reports must be in the hands of the District Statistician by July 20 following. All reports must be reviewed by the local board before being forwarded to the District Statistician. All reports received after July 20 shall be omitted from the yearly report.

2. Funds

Each church shall raise for the general budget the equivalent of \$.50 per member per year for general administration expenses: \$.60 for general home missions, plus \$1.90 per member for foreign missions. They shall also raise for district budget the equivalent of \$2.15 per member.

3. Bible School Fund

Each church shall raise for the Bible School Fund the equivalent of \$1.50 per member per year, pastor included at same rate. All monies raised for the Bible School Fund plus other Bible School offerings shall be sent to the Bible School Treasurer, Rev. H. T. Mills, 1020 S. Washington Street, Owosso, Michigan.

4. Ministerial Tithes

One half of all ministerial tithes shall be turned to the support of the District Superintendent.

5. District and General Funds

All monies raised in the local church for district and general funds shall be sent to the District Treasurer, who shall forward general funds to the General Treasurer.

6. District Official's Salaries

The District Superintendent's salary is fixed at a minimum of \$2,000 per year, plus 3 cents per mile for traveling expenses. District Treasurer shall receive \$60 per year and the District Secretary shall receive \$60 per year.

7. Pastor's Camp Meeting Offering

Inasmuch as our pastors are expected to support and attend the annual camp meeting, each church shall provide the regular pastor's offering for the two Sundays of the camp, and that the pastors be privileged to attend the entire camp meeting.

8. Examining Board

The District Superintendent shall be chairman of the Examining Board by virtue of his office.

9. Camp Meeting Expense

Churches are to be rated according to their financial strength and part of the camp-meeting expense is to be raised among the churches of the district. The District Council shall pro-rate the expenses among the churches. All money raised for this purpose shall be in the hands of the District Treasurer not later than thirty days prior to camp meeting.

10. Resolutions

Inasmuch as many resolutions are presented to this committee without signatures:

Be it, therefore, resolved that no resolution be presented to this assembly except it be signed.

! Be it further resolved that this resolution be made a standing rule of this assembly.

JOURNAL OF PROCEEDINGS

FIRST SITTING

The first sitting of the Forty-First Annual Assembly of the Michigan District of the Pilgrim Holiness Church was opened at 8:30 A. M., August 11th, 1941. Congregational singing was led by Rev. Gaylord Skinner with Rev. Miss Ila Bruce at the piano.

Prayer was offered by Rev. H. B. Kreider.

The scripture lesson, John 17, was read by Rev. B. O. Shattuck.

Following the reading of the scripture lesson a communion table was set and all Christians present, including ministers, delegates, and visitors, received the sacrament of the Lord's Supper. This proved to be a sacred and blessed hour in our Assembly.

Rev. and Mrs. Russell Mohl favored us with a special song, "God shall Wipe away all Tears".

Rev. M. L. Goodman, District Secretary, read a letter of greeting from the General Superintendent, Rev. W. L. Surbrook.

The Assembly roll was called by the Secretary, Rev. M. L. Goodman.

It was moved and seconded that the letter of greeting from Rev. Surbrook be included in the minutes. The motion was carried.

July 29, 1941.

To the District Assembly of the Pilgrim Holiness Church, convening at Owosso, Michigan.

My dear brethren:

Greetings in the fellowship and service of Jesus our coming King.

Since there are other assemblies convening on this date thus making it impossible to be with you, I have asked your district superintendent, Rev. J. R. Thompson, to preside in your assembly for me. The Assembly called for the report of the Auditing Committee. The report was read by Rev. G. E. Stace.

Moved and seconded that we adopt the report of the Auditing Committee. The motion was carried.

The Auditing Committee reported that they had audited the books of the Treasurers of the Bible Holiness Seminary, the Michigan District Treasurer, and the Michigan District Young People's Treasurer and found them to be correct.

The report of the Statistical Committee was called for by the Assembly.

Rev. A. C. Doehring read the report.

Moved and seconded that the report of the Statistical Committee be accepted. The motion was carried.

Moved and seconded that we hear the District Superintendent's Annual Report. The motion was carried.

Moved and seconded that the report of the District Superintendent be received and included in the minutes. Th motion was carried.

DISTRICT SUPERINTENDENT'S REPORT

To the Forty-First Annual Assembly of the Pilgrim Holiness Church of the Michigan District: Greetings:

Through the mercy and unmerited favor of God through another year we have gathered this morning for this annual assembly. As we come we can well afford to come with heads bowed in holy reverence and our hearts lifted in holy communion to God who holds us by the right hand of his power. While the world is saddened by wars and strife, and its future looks very dark and unpredictable, the Christian church has every reason to look up with deepened faith and renewed hope. Through the storms and battles of the past year we have come as a district—claiming victory through the grace of God. The three "Celestial Anchors" of which Paul spoke in the last verse of the thirteenth chapter of First Corinthians, namely, "Faith, Hope and Divine Love" have helped us to ride the crest of the storm, and win.

God has visited our churches in a very definite way this past year with some excellent revivals. The work of the Spirit has been clearly evidenced by some outstanding cases of Salvation, also some remarkable cases of Divine healing for which we are all very thankful. The unfortunate accident which cost the life of our beloved and Godly sister, Mrs. A. F. Osborn, was at the same time a gracious manifestation of the power of God in raising up Brother Osborn, who was injured, they believed, fatally. The entire district was shocked and grieved by the loss of a faithful Pilgrim and Christian, but in turn rejoiced when Brother Osborn was restored to health and to us.

Our older and better-established churches have demonstrated every evidence of keen, and enthusiastic interest in the work of the district, and have graciously and willingly shouldered the load. Not only have the churches kept up a fiery interest in foreign missionary work, but a similar interest has been shown in home missionary work and all local interests. A number of churches of the district have had special mortgage-burning services, thus clearing God's property of all debt. Our North Branch church caught the vision of a new church, and as a result we have in North Branch a beautiful, little church standing as a monument of the help of God and the tireless labors of Rev. William M. Thorp and his faithful people. The future looks bright for the North Branch work, and what has been said of North Branch can be said of Ecorse. The bank building which they were using was closed to them and they started a building project. Today, they have a spacious new building, just off Southfield Road, declaring the faithfulness of God and the will-to-work of Rev. LeRoy Bruce and his people. They have worked and sacrificed to push the building to the present point, and prospects for them are exceptionally good. A number of our churches have remodeled their buildings, adding to both appearance and room. Rev. G. Emmer Stace and the Eaton Rapids saints have just completed a remodeling project on their church, for which they are to be commended. The work there is steadily growing and prospects are bright and promising.

Rev. Lester R. Nelson and the hard-working Bellaire saints have remodeled their church and have provided for a beautiful Sunday school department in the basement, with fine rooms. They have now a fine church in this beautiful little Northern City. Reverend Nelson by careful living has gained the confidence of the business men of the city. Rev. Calvin Hendricks and his splendid people are going

forward in a very certain manner, they, too, have started a building program, and as a result have a beautiful seven-room parsonage, all modern, standing on the same lot as the church. This results from their labors and desire to see the work go forward.

Rev. Ellsworth S. Swanson, of Ellsworth; Rev. A. C. Doehring, of Owosso; Rev. Russell Mohl, of Lapeer Road, Flint; Rev. H. B. Kreider, of Alma, have done excellent jobs of remodeling and re-decorating their churches this year. Rev. C. V. Holstein and his fine Grand Rapids folk, after a long battle to find a place of worship, have been favored with definite help from God in getting established in a beautiful church near the heart of the city. The prospects for Grand Rapids are of the best. Rev. J. F. Meulman at Jackson with the aid of his good people have greatly improved the looks of their church by redecorating the interior. Rev. Fred Stalker of Arcadia and his people recently purchased a building and they too have made this building a very comfortable place to worship.

Home Missionary Work

Michigan is a great state, with its multiplicity of lakes, sparkling streams, towering hills and wooded acres, set off by a network of highways and super-highways second to none in the United States. Because of this splendid highway system every city and hamlet in the state can be reached by automobile, with ease. We have great industrial centers, mining sections, agriculture districts and lumbering areas. Since we have such a wide variety of industry, we have all classes of people and many of them are hungry for salvation.

In this great commonwealth there are hundreds of towns and small cities without any kind of Holiness work. God is, however, helping the Pilgrim Holiness church to advance on the home missionary front. We have recently launched a new project at Munising in the Upper Peninsula, and the outlook is good. Rev. Carl Messer is holding the fort there and from all appearance the church can have a growing work there. The plans are already laid to open a new field for our church in Marquette, through the kindness and interest of the First church of Flint in the home missionary work of the district. The First church of Flint has assumed the obligation of establishing a work in that city.

Our faithful Pilgrims at Battle Creek have contributed in a most cheerful and remarkable manner to the Home Missionary work in the Michigan district as well as other interest. They are now contributing toward the support of four Home Missionaries in the district in addition to the district budget. It is apparent they have the vision of the need and are with their faithful pastor forging ahead in the work of Home Missions.

They were organized in May this year, and they have a new church building well under way, too.

Our Dryden work, which is under the supervision of Rev. Harold Rickner, is moving along very nicely and while it, as yet, has not been organized into a church, it will be in the near future. We have a new work organized at Whigville, south of Flint. They own two lots there, all paid for, and already plans are being formulated for a building. A fine group of clean, spiritual folks, under the leadership of Rev. Orville Smith, of St. Clair Shores, felt led of the Lord

to come with the Pilgrims. They, too, have been organized into a Pilgrim Holiness church.

REPORT OF THE WAYS AND MEANS COMMITTEE

Rule No. 1

The assembly year shall close June 30 and complete reports must be in the hands of the District Statistician by July 20 following. All reports must be reviewed by the local board before being forwarded to the District Statistician. All reports received after July 20 shall be omitted from the yearly report.

Rule No. 2

Each church shall raise for the general budget the equivalent of 50 cents per member per year for general administration expenses; 60 cents for general home missions, plus \$1.90 cents per member for foreign missions. They shall also raise for district budget the equivalent of \$2.15 cents per member.

Rule No. 3

Each church shall raise for the Bible School the equivalent of \$1.50 per member per year, pastor included at same rate. All monies raised for the Bible School Fund plus other Bible School offerings shall be sent to the Bible School Treasurer, Rev. H. T. Mills, 1020 S. Washington St., Owosso, Michigan.

Rule No. 6

The District Superintendent's salary is fixed at a minimum of \$2,000.00 per year, plus 3 cents per mile for traveling expenses. District Treasurer shall receive \$60 per year and the District Secretary shall receive \$60 per year.

Rule No. 9

Churches are to be rated according to their financial strength and part of the camp-meeting expense is to be raised among the churches of the district. The District Council shall pro-rate the expenses among the churches. All money raised for this purpose shall be in the hands of the District Treasurer not later than thirty days prior to camp-meeting.
