JOURNAL OF PRECEEDINGS

With the singing of "Glory To His Name," the Forty-Seventh Conference of the North Carolina District of the Pilgrim Holiness Church, joyfully joined in praise to Him who has graciously brought us together again.

District Superintendent Page called the conference to order at 10:00 a.m. August 14, 1957. He welcomed all ministers and delegates, then expressed our joy at having our beloved General Superintendnt, Dr. Wm. H. Neff, with us. Mr. Neff will preside at the conference.

We were led in prayer by our reverend and greatly loved former General Church Secretary, Rev. S. M. Stikeleather.

General Superintendent Neff brought greetings from the general church, and also from his own heart. He mentioned how this conference should be a time of genuine blessedness and spiritual refreshing as we share our mutual victories of the past year, and plan for greater things in the year to come. The thrill that we experience in being able to speak of the Pilgrim church as "My Church" is not to be overlooked.

He further mentioned how that there are and should be, discussion and debates on various business matters in order that the best may be secured. Such differences are to be carried on in the spirit of Christian love and courtesy.

He further stated that his prayer is that God's Spirit will vouchsafe unto us His directing and welding of us together in Christian love, and His will, will be done in all the deliberations of the conference.

As to the conference bar, a motion carried that it include the first fifteen rows of seats in the tabernacle, excepting the section at the right which shall be reserved for visitors. The time of the sittings shall be 9:00 a.m. - 11:45 a.m., 2:00 p.m. - 4:45 p.m., and 7:00 p.m. - 9:30 p.m.

The secretary called the roll of ministers and lay delegates to the conference. Honorary seats within the bar were granted to Rev. and Mrs. S. M. Stikeleather, and Rev. Mrs. Wm. H. Neff.

A motion carried that we only recess the sessions rather than adjourning.

A motion carried that we accept the transfer of Rev. Edward Houston as an ordained minister from the Pennsylvania - New Jersey Conference.

A motion carried that Prof. Gordon E. Miller be declared a member of the conference, due to his position as President of Southern Pilgrim College.

It was the joyful privilege of the session to receive into our conference a new church from Archdale, N. C. Rev. James Denny is the pastor, and Mrs. Allen Farlow the delegate.

The District Superintendent appointed Rev. Clyde Parker to take the place of Rev. Fred Sumwalt who has left this conference.

The District Superintendent, Rev. Page, read his report of his work in the district and the general condition of our work. Said report was accepted.

The Assistant District Superintendent, Rev. Wray J. Smith, read his report of work done for the district and was accepted.

President Gordon E. Miller gave a splendid report of Southern Pilgrim College and of its outlook; said report was accepted.

The Statistician gave the report of the work of our District numerically and financially, and was accepted.

The session was dismissed with prayer by Rev. J. W. Covington.

THE SECOND SITTING

The second sitting opened at 2:00 p.m. with the singing of "Leaning On The Everlasting Arms." Prayer was offered by Rev. Edward Houston.

General Superintendent Neff urged that the goal of our churches should above all be that of the deepening of the spiritual life of our churches.

The Auditors report was given by Rev. F. W. Henry, and was accepted.

The Treasurer, Mr. L. B. Gallimore, read his well prepared and printed report of the financial work, and was received with thanksgiving.

The District Secretary of Missions, Mrs. W. F. Page, read the fine report of the work accomplished and the money raised through the societies, and was accepted.

The Sunday School Promotional Secretary, Rev. Charles Apple, read the report of the fine gain made and work accomplished, and was accepted.

The Secretary-Treasurer of the Camp Meeting, Rev. U. N. Freeman, reported on the 1956 camp and was accepted.

The Young People's Executive Secretary, Rev. McCray Holmes, read the report of the State and Youth Rallies conducted during the year, and was accepted.

The Forward Movement Committee's report was given orally by Rev. R. J. Hobbs and was accepted.

After announcements, the session was dismissed by Rev. C. W. Hartman.

THIRD SITTING

The first order of this sitting was a very sacred hour in which four men were ordained to the ministry. They were Rev. J. B. Stutts, Rev. H. M. Carroll, Rev. William Walker, and Rev. Floyd Miller

The General Superintendent Neff delivered the ordination charge, basing his remarks from Col. 1:23, I Tim. 6:11, I Cor. 9:19, and I Cor. 9:27.

Paul said, "I am to be a man of God." As a man of God he is a holy man. Outwardly he is righteous and inwardly is holy. Such must ever be your aim as a minister.

Again he said Paul said "I am to be a minister unto all." A minister is not to live unto himself, but unto the Christ who died for him. The proof of Paul's Apostleship was his being a servant of all. As one gives himself in servanthood to others, God will care for his every need. As a minister you are called to be a servant. Any concept of the ministry to exalt itself to lordship over the flock is entirely out of the will of God.

Paul further said "I must keep my body under." One must keep the drives of his body, soul and spirit under strict discipline and hold them in line.

In concluding his remarks, he charged the ministers to be true to the God who has called you; to the church who is ordaining you; to the people whom you serve. You are to be the best possible representative of the Gospel of Grace that God can make you.

Following the ordination, the precious presence of the Holy Spirit settled over the entire conference in waves of spiritual refreshing. Many glowing testimonies of praise to God and appreciation for the church and one another were given.

The Resolutions committee presented four resolutions. Number one carried. Number two was referred to the council. Number three was referred back to the resolutions committee. Number four was tabled.

The sitting adjourned by expiration of time. The session was dismissed with prayer by Rev. W. L. Cockman.

FOURTH SITTING

With grateful hearts for the refreshing showers that our remembering God was sending upon the earth, the Pilgrims gathered in the tabernacle for the fourth sitting of the conference.

The session opened with the singing of "Showers of Blessings." Our hearts were led to the throne in prayer by Rev. U. N. Freeman; special prayer was made for those ministers now in the hospital, and the shut-ins at home.

The secretary read the minutes of the first three sittings and were approved.

The resolution committee presented several resolutions. Number 3 which had been tabled in an earlier sitting was brought before us and lost. Number five was lost. Number six was lost. Number seven carried.

The reception committee presented as visitors, Rev. and Mrs. S. M. Stikeleather, of Kingswood, Ky., Rev. and Mrs. H. J. Olson of Kernersville, N. C., Rev. Mrs. Wm. H. Neff of Indianapolis, Indiana, and Miss Gene Carr of Pittsburgh, Pa. These were granted honorary seats within the conference bar.

A motion carried that the first order of business after dinner be the election of District officers.

The Ways and Means Committee presented one resolution which carried.

A motion carried that we admit to first year conference license standing, Kenneth Taylor and Larry Jarvis.

The committee of Memoirs presented a lovely tribute in honor of our departed loved ones who were called to the more excellent glory.

A motion carried that the secretary send a letter of greeting to Rev. and Mrs. M. H. Russell, Rev. H. F. Donelly, and Rev. G. C. Craven who are absent from the conference due to sickness.

The committee on Memorials to the General Conference presented five memorials. Numbers 1, 2, 4, and 5 carried. Number three was lost.

A motion carried that we reconvene at 1:30 p.m.

The sitting was dismissed with prayer by Rev. Wray J. Smith.

FIFTH SITTING

The fifth and last sitting of the conference convened at 1:30 p.m., and opened with the singing of "The Solid Rock". Prayer was offered by Rev. H. B. Barger.

Last year's enrollment opened with 66 full time students. The total enrollment for the first semester was 88 counting 14 in night classes and 8 specials. Our prospects for this coming year are looking better. We are hoping to see an increase in our enrollment.

Improvements

During the year several of the churches and individuals contributed money for the remodeling of rooms in our girls' and boys' dormitories. The exterior of the president's home and the teacherage have been painted. New screens have been installed at the teacherage through gifts of our faculty members, also new screens have been installed on the girls' dormitory through the efforts of our North Carolina Missionary societies. This is one project that has certainly improved the appearance of our campus. The music department was able to purchase a grand piano through contributions given by interested friends. The graduating class of 1956 gave a water cooler that has been installed in the girls' dormitory.

Recommendations

1. That we continue to pray and plan for a new administration building.

2. That every family of our Pilgrim Church become a member of our Living Endowment Club.

3. If possible some group sponsor the renovation of the hallway in the girls' dormitory, another group raise funds for a grand piano for our chapel, this is a great need as our music department is growing.

4. A continued cooperation between District and College. Southern Pilgrim College must ever go forward. Its program in the future depends upon what is done today. That puts a tremendous responsibility on every one of us. I trust that the Spirit of Christ will control our hearts and our thinking. I also trust that we will seek the will of God in every detail of our lives as we endeavor to do business for His great kingdom.

REPORT OF DISTRICT YOUTH EXECUTIVE SECRETARY

To the forty-seventh annual Conference of the North Carolina Pilgrim Holiness Church:

Following is the report of the district youth work for the past year.

We are thankful for the way God has blessed our efforts in the different fields of endeavor encompassed by the youth department. However, we are conscious of the need of more interest and greater participation in youth activities over the district. The youth work in this district is divided into four different phases of activity: (1) Zone Rallies, (2) Youth Camp, (3) District Convention, and (4) District Youth Project.

1. Zone Rallies. Our goal for the past several years has been set at four youth rallies in each zone. These rallies are supposed to serve for inspiration and instruction and challenge to the youth of our churches. We feel that a good rally can do a great deal to promote the interest of our youth work in particular, and the interest of the Pilgrim Holiness Church in general. I regret that we did not reach our goal as a district this year. The Asheboro Zone was the only zone to have four rallies. The other zones for various reasons did not reach their goals. The zone chairmen reported ten rallies conducted in the district this year. I attended eight of these.

2. Youth Camp. The Youth Camp this year did not have as large enrollment as that of last year, but in many respects, we feel that it was one of the best camps to date. We enrolled approximately 150 campers. The time spent in class and on the recreation field, as well as that spent in the services, was very profitable. The evangelistic services found more than eighty-five (85) campers weeping through to victory around the altar. A number of young people prayed through in their rooms and in dormitory prayer meetings. Our Youth Camp is certainly worth all the effort put forth. The teachers and camp workers discharged their duties faithfully, and I wish to express my appreciation to them for their cooperation and help.

3). District Convention. Our Annual District Youth Convention last year was well-attended. Each year the district youth department has been sponsoring this convention by furnishing free room and board for the first two days of the camp meeting for all young people age 10-25 who register and pay a fee of \$1.00 before the first Friday night service. We are happy with the response we have had thus far. Each year the interest in the business session of the convention has increased, and some good legistlative work has been done.

4. District Youth Project. For the past year the District Youth Project was the sponsoring of the new church in Archdale. The Youth Board worked with Rev. James Denny, and were in the process of getting a loan with which to purchase the property in Archdale when the High Point Church came through with their gift of \$2,500 for the property. Our portable chapel was placed on the property, and the department sent regular support of \$50.00 per month to the pastor of the church. We are happy, and not vainly so, that we were the first to pledge support to this fine new church. We are also happy for the help of the High Point Church, for they certainly made our load much lighter than it would have been had we been forced to secure the loan as first intended.

I have traveled over 900 miles in the interest of the district youth work. I made a trip to Indianapolis to the Youth Leaders' Conference, and it was my privilege to travel to the British West Indies as a member of an "OPERATION MISSIO" gospel team sent out by the Pilgrim Youth of America during National Youth Week. It has been a privilege to work with the wonderful Pilgrim Youth of North Carolina another year, and I only regret that my service has not been better. My sincere appreciation to the men who worked with me on the Youth Board, and to the pastors and young people over the district who have supported us with their prayers and regular offerings to the Youth treasury.

RESOLUTIONS

1. Whereas the method of calling pastors, adopted last year, has proved very unsatisfactory in several cases, therefore be it resolved that this conference rescind the former resolution of 1956, page 30, paragraph 7.

2. Resolved that the district council appoint a Campus Planning Committee, and that they, with the help of a competent engineer, be empowered to supervise future landscaping; allocate lots for camp meeting cottages; form a building code for such cottages; locate future buildings, and relocate present buildings at such time as the district council deems advisable.

WAYS AND MEANS

1. Whereas we have \$156.00 in our delegate fund, and whereas it takes approximately \$1,500.00 to cover our proportion, therefore be it resolved that our District Superintendent insist that all churches raise their assessment during the early part of this conference year.

MEMORIALS TO GENERAL CONFERENCE

1. In order that we may achieve a more equitable pastoral relationship, and to secure a greater degree of satisfaction relative to the installation of pastors, Be it therefore resolved that a stationing committee be created; and be it further resolved that the District Council, with it's chairman, the District Superintendent, be the stationing committee.

The Stationing Committee shall meet not later than one month before the Annual Conference. The problems and needs of each church shall be carefully studied and analyzed. The minister deemed most capable and fit for each situation shall thereupon be assigned as pastor.

To aid the Stationing Committee in reaching its decision, the pulse of the local church shall be determined by a secret ballot. All the members of the local church of voting age shall be instructed to write the name of the minister preferred. This ballot shall be immediately impounded and sent to the Stationing Committee. The results of this ballot shall not be divulged to the local congregation. This ballot shall be reviewed by the Stationing Committee.

Each local church shall have also the privilege of sending a duly elected pulpit committee to confer with and advise the Stationing Committee.

Be it further resolved, that the Stationing Committee shall be empowered to remove a pastor when it is deemed best for the interests of the local church.

2. As singing and music plays an important part in our regular services and revival meetings, and since there are approved song evangelists in the Pilgrim Holiness church, therefore be is resolved, that all licensed song evangelists be declared a member of their conference with voting privileges.

3. Whereas many of our people are continually moving into new areas, and many times lose contact with the church; Be it resolved, that the General Conference compile a church directory giving names and addresses of churches and ministers; said directory to be published annually and made available to all pastors for the purpose of aiding people in church transfers.

4. Whereas our present manual forbids the using of divorced individuals in any official capacity, and whereas we believe there are innocent parties involved and that they do have scriptural grounds for divorce, and whereas our present system creates a double standard because we allow such person to be members of our church, believing they are members of the body of Christ, therefore be it resolved that we rescind that part of our manual which forbids use of such individuals, and permit such individuals to hold offices in our church, and that divorced and remarried ministers be allowed to hold their credentials.

CONFERENCE STANDING RULES

1. Churches are asked to give pastors a two week vacation with pay. (1941)

2. Churches should see that their delegates to conference conform to standards of the manual. (1945)

3. Local church officers assume their duties the first of July. (1946)

4. Local ministers licenses to be renewed are to be sent to the district superintendent at conference with a recommendation of the local church. (1957)

5. Our District Budget shall be 15%, with the breakdown as follows: District Budget 7%, Bible School 5%, Loan fund 1%, and Home Missions 2%. (1948).

6. The Youth Convention shall convene on the first Friday night of the Camp meeting and continue all day Saturday, running in conjunction with the Camp Board. (1951)

7. District officials shall receive 6c per mile for traveling in district business. (1955)

8. To help support the District Sunday school work, churches with fifty members

and over shall pay five dollars a year, and churches with less than fifty members shall pay three dollars into the Sunday school Boards treasury. (1952)

9. Whereas, the Conference has established the \$3.00 per member budget for Southern Pilgrim College to be broken down as follows: \$1.50 for indebtedness, \$1.00 for maintenance, \$.50 for inurance; and whereas, there is need for additional revenue for operation of said school; therefore, be is resolved: that this Conference take action that each church put the Bible School in the Budget; and be it further resolved that the churches allow the school representatives to conduct one service in the interest of the school, and that they be allowed to raise a cash offering. (1952)

10. Pastors changing to a new field shall terminate their labors the last Sunday in July and move to their new field and take up their work the first Sunday in August. (1952)

11. The Assistant District Superintendent shall receive 10.00 for each business meeting held in churches. (1952)

12. All Youth and Sunday school attendance banners be awarded on percentage basis. (1952)

13. Delegate fund for General Conference be set at 15c per member. (1953)

14. Every church of the District is requested to pay the pastor's utilities. (1953)

15. The first night session of conference shall be designated for the ordination service of ministers, and that the certification of ordination be formally presented at said service. (1954)

16. Churches changing pastors have the privilege of contacting any minister in the District. (1954)

17. Ministers' children under 18, and unemployed, be entertained free at the district conference. (1954) Also licensed song evangelists and Bible School teachers. (1956)

18. Resolved that a temporary District Parsonage Fund be established by a special 1% assessment on all regular church and Sunday school offerings. (1955)

19. District minutes shall be given at the rate of one per church-member family; said number must be in secretary's hand not later than two weeks after Camp if minutes are to be received. (1955)

20. All conference licensed ministers shall meet the Educational and Examining Boards the day previous to conference. (1955)

21. All church public servants who tender a resignation shall vacate said office within 60 days. (1955)

22. The District Treasurer shall mail a monthly financial report to each pastor and church treasurer which is to be posted in the church. (1956)

23. If tabernacle is used during winter, and furniture disarranged, the benches must be numbered and replaced in proper places before conference. (1956)

24. Each church desiring to nominate a lay-delegate for General conference, should do so at their annual meeting proceeding the last District conference before the General conference. (1956)

25. Our Bible school shall be called Southern Pilgrim College. (1956)

26. The salary of the District Treasurer shall be \$500.00 a year, and the secretary shall receive \$250.00 a year.

STANDING RLUES – DISTRICT SUPERINTENDENT

1. Our District Superintendent shall have a two weeks vacation with pay. (1941)

2. The District Superintendent is Chairman of the Camp Meeting Board. (1943)

3. The District Superintendent has the privilege of conducting four revivals a year, and retaining all offerings from same. (1950)

STANDING RULES – COLLEGE

1. Members of the Board of Directors shall be elected for two-year terms. (1946)

2. There shall be two laymen on the Board of Directors. (1953)

STANDING RULES - CAMP MEETING

1. The Conference shall annually elect the Secretary-Treasurer of the Camp. (1941)

2. There shall be 8 members on the Camp Meeting Board; they shall be elected for a term of 4 years. (1941)

3. The Camp secretary-treasurer shall read his report at each conference.

STANDING RULES – SUNDAY SCHOOL BOARD

1. The District Council shall elect the Sunday School Board of four.

2. They shall be amendable to the District Council.

STANDING RULES – HOME MISSIONS

1. The Home Missionary Board shall give a copy of the Manual and a one year's subscription to the Advocate to each Charter-member family of new churches.

2. The source of the Boards finances shall be: 1. District Home Missionary fund. 2. Public offerings in the services held on the field. 3. Personal donations. 4. An appeal to the established church once a year. 5. The Board shall have access to the Missionary Funds of the district. 6. The expenses of the Board may be collected from the Home Missionary fund. (1955)

STANDING RULES – YOUNG PEOPLE

1. A \$1.00 registration fee will be charged those receiving entertainment at convention. (1952)

2. The district shall be divided into five zones for youth work. (1953)

3. A District Youth Camp shall be an annual meeting. (1953)

4. Offerings received for the Youth Home Missionary Project shall be sent directly to the District Youth Treasurer. (1954)

- 5. The Executive Youth Secretary shall receive \$100.00 a year. (1957)
- 6. Banners at Youth Rallies shall be given as follows:
 - 1. For the largest percentage on the enrollment of society present.
 - 2. For the society having the largest number present.
 - 3. No society may receive both banners.

Resolved that the District Youth Program shall be supported financially by:
 (1) Each church with fifty or more members send a special offering of at least \$10.00.
 (2) Churches with less than fifty members send a special offering of at least \$5.00.
 Furthermore; each Zone chairman shall receive an offering in each rally, and send to the district youth treasurer all not used for the Zone rally expenses. An offering shall also be taken at the annual convention.

Further: each society is requested to send a liberal monthly offering to the youth treasurer to support the District Youth Project.

MINUTES OF THE ANNUAL YOUTH CONVENTION

The business session of the eleventh Annual Youth Convention was held at 2:30 p.m., August 17, 1957 at the tabernacle on the District grounds.

The convention opened with the Executive Secretary, Rev. McCray Holmes, leading the group in singing "Pilgrim Youth Keep Marching On."

Our District Superintendent, Rev. W. F. Page, gave an enlightening exhortation on "Things Necessary To Be A Successful Christian."

Rev. Charles Apple, Executive Sunday School Secretary, led in prayer.

Rev. Holmes gave a very interesting report for the past year.

Youth Treasurer, Rev. James Smith, also gave an enlightening financial report consisting of reports from individual churches. These reports were well accepted.

Rev. James Denny gave a summary of the progress of the District Youth Project at Archdale, N. C.

The Resolutions Committee presented four resolutions.

1. Whereas we need to strengthen our Youth Organization on the local level, be it resolved that the Youth Board plan a district youth leader's conference. This conference shall serve to train and help the leaders of our societies to do a better and more efficient job in their respective duties. Such conference will feature workshops along the lines of program planning and youth promotion in the local churches. Be it further resolved, that the local church society pay the mileage expenses of the society president, vice-president, secretary-treasurer, and pastor to this conference.

2. Whereas district youth project for the past year has been the supporting of the new Archdale church, and whereas, they are ready to start a church building, Be it resolved, that we take as our project this year the buying of the windows and doors for the basement church soon to be constructed: said contribution not to exceed \$650.00.

3. Since there is a feeling that the convention held during the first two days of the camp meeting does not meet all the needs of a good annual youth convention, be is resolved, that this convention instruct the Youth Board to plan another time for the annual convention when the emphasis and all activities could be beamed directly and exclusively to the interests and needs of our youth. Furthermore, the board should consider the last week end of our Youth Camp.

The Ways and Means Committee submitted the following:

1. Be it resolved that the District Youth Program be supported financially in the following manner:

a. District Youth Convention and General expenses: We request that each church send a special offering for the support of this work. Churches with fifty or more members, at least \$10.00; churches with less than fifty members, at least \$5.00. Furthermore, each Zone Chairman shall receive an offering in each rally and send to the district youth treasurer all that is not used for the Zone rally expenses. An offering shall also be taken at the Annual Convention.

b. We request that each society send a liberal monthly offering to the Youth Treasurer to support the district youth project.

2. Motion carried to raise the Executive Secretary's salary from \$75.00 to \$100.00 per year.
