P R O C E E D I N G S

The Ministers and delegates of the Pilgrim Holiness Churches of Oklahoma and Texas met in business session at Hopeton, Okla., at 2:30 P. M., Friday July 19, 1935. We were privileged to have with us our General Superintendent, Rev. W. L. Surbrook who brought us a splendid address on the subject, "Our Talent, Trouble and Time."

The roll was called of ministers and delegates.

Moved and supported that Sister Bleakley and Brother Van Winkle be granted the privilege to vote. Carried.

The report of R. A. Beltz, former District Superintendent was read and accepted.

The report of John J. Doll, Home Missionary was read and accepted.

The auditing committee's report as follows was read and accepted: "We the undersigned auditing committee have examined the books of the Treasurer of the Okla. and Texas District of the Pilgrim Holiness Church and find same to be correct." Signed, MRS. W. P. HALTOM, PAUL W. FINCH.

The report of R. A. Beltz, Treasurer was read and accepted.

The following minister's reports were read and accepted: R. A. Beltz, Nellie Mix, W. O. Bottenberg, S. H. Umbarger, Sister Harless, Maggie Hull, Flossie Doll, Grace Nelson, Waldo Van Winkle.

Sister Hull also gave her testimony of how God had so wonderfully answered her prayers the past year and it proved a great blessing to the Assembly.

Sister Dauel and Sister Mix gave their testimony and it was followed by a song by Brother Slate, "Just a Little While." These proved to be indeed times of refreshing from the presence of the Lord.

A report of the Advisory Council containing ten resolutions was read and after consideration of each one they were adopted. (See resolutions Adopted.)

Motion to adjourn to meet at 2:30 P. M. tomorrow. Carried. Benediction by Brother Surbrook.

Brother Surbrook made some remarks concerning our Burial Association and the Ministerial Benefit Association and urged our people to join same.

The following church reports were read and accepted: Cordell, Higgins, Hillsboro, Hopeton, Newkirk, Payson, Pleasant View and Shamrock.

Sister Bleakley read her report and gave her testimony which proved a great blessing.

Mrs. R. K. Williams' minister's report was read and accepted.

Mrs. S. H. Umbarger ordained deaconess gave a verbal report.

Motion made that the council have charge of printing the Minutes. Carried.

The Minutes of the former session were read and approved.

Moved and supported that the District Superintendent appoint a committee to draft resolutions of thanks and appreciation to be read the last day of the Camp. Carried. R. A. Beltz, W. O. Bottenberg and Nellie Mix were appointed.

The Minutes were read and approved. A motion to adjourn carried. Dismissed by prayer.

RESOLUTIONS ADOPTED BY THE ASSEMBLY

1. Whereas we are to raise \$30.00 per month for the support of our Superintendent, Be it resolved that each Church raise the following amounts:

Hopeton	50.00
Shamrock	12.00
Newkirk	12.00
Hillsboro	12.00
Mayfield	12.00
Higgins	12.00
Cordell	6.00
Payson	6.00
Total	<u>182.00</u>

These amounts shall be divided into monthly payments and sent to the District Treasurer.

2. Inasmuch as the above amounts will not be sufficient to take care of the Superintendent, Be it resolved that our pastors and evangelists pay their tithe from ministerial income into the District Treasury for the Superintendents support and that it be mailed in the first of each month.

3. We recommend that the District Superintendent tithe into the District Treasury for the support of Home Missions.

4. Since there has been no provision made for the travelling expense of the Superintendent, other than free-will offerings and since the District is so large that it will necessarily mean a lot of travelling, Be it resolved that a liberal love offering be given him at each quarterly visit to our churches, same to be over and above the amounts apportioned each church and the minister's tithe. Be it also further resolved that he

be paid the minimum of two and a half cents a mile, and that the above offerings be applied on same and the balance be paid from the Home Mission fund.

5. Inasmuch as prayer is so important in carrying out the Great Commission, Be it resolved that each church have a Missionary prayer meeting each month, and that the pastors urge their people to pray especially for our Home and Foreign Missionary work.

6. Since the Bible teaches us that faith without works is dead, Be it resolved that in addition to our Missionary prayer meetings that each Church or Sunday School take an offering each month for Home Missions and also an offering for the General Budget and Foreign Missions and that the amounts specified by our General Board, namely \$1.00 per member for General Budget and \$2.00 per member for Foreign Missions be our goal.

7. Inasmuch as there is a need of a miscellaneous fund in the District to take care of the cost of report blanks, printing, postage, etc., Be it resolved that each Church raise the following amounts during the year for that fund.

8. Whereas it is so expensive to buy new tents and we must conserve the good tent that we have, Be it resolved that each time the tent is pitched for a meeting that the sum of not less than \$5.00 be raised and placed in the Treasury to be used in repairing the tent when needed.

9. In order that we may conserve the Lord's money and give our churches the advantages of evangelistic meetings, Be it resolved that we as pastors and churches consult our Superintendent in slating evangelists and where it is possible and practical they be slated for two or more consecutive meetings which would keep down travelling expense.

10. Inasmuch as there are such great blessings derived from a Ministerial and Christain Worker's Convention, Be it resolved that during the year we have a three day

convention on the District. The Council shall be the committee to set the time and place and prepare a program.

DISTRICT SUPERINTENDENT'S REPORT

Dearly Beloved:

It is again thru the Providence of Almighty God that we are permitted to meet in our Annual Camp Meeting and for this Convention. The all seeing Eye has not failed to watch over us during the past year and we have ample proof on every side that God still cares for His own.

This has been a year of advancement in many ways. The glorious spirit of progress and pushing ahead that was so manifest in last years Camp and especially in the great Home Missionary Service the last Sunday morning has continued to be felt throughout the year. Through the gifts and sacrifices of our people and the help given us by the General Board we have been able to keep a Home Missionary, Rev. John Doll in the field all during the year. While it was necessary at different times for him to give some time to revival work in our smaller churches yet a number of meetings were held in new fields.

Four churches were organized during the year at Cordell, Payson, Newkirk and near Higgins, Texas. We urge that steps be taken as soon as possible to strengthen these places.

Besides this there has been progress made in the churches we had last year. Last summer the Mayfield church had a good revival and a number of members were taken into the church. This is a very needy field and plans should be made for a tent meeting to be held there soon.

The Hillsboro and Shamrock churches have paid off all the indebtedness on their properties during the year. To we who know how dark the future looked for our Hillsboro work a few years ago when a mortgage threatened to take all our property this is indeed a worth accomplishment. Shamrock has had a battle because they have been without a pastor most of the year. We should get a pastor on that field at once.

The Hopeton Church has enjoyed an unusually good year. They have built a new basement and made other

improvements on their property besides having nearly doubled their Sunday School and added to their membership.

The Pleasant View Church has remodeled their building and added a splendid basement at the expenses of nearly \$1000, practically all of which has been paid or covered by pledges. The yearly report also shows a substantial gain in the Sunday School.

A year ago we had five churches with 131 members. Today we have 9 churches with 214 members. This shows a gain of 4 churches and 83 members, an 80% gain in churches and 63% gain in members.

Some of us had hoped last year to be able to organize the District this year. But after a careful survey we felt best to keep under the wing of the General Board a while longer. When a boy I use to take a great interest in the raising of the chickens in the spring. I noticed that the chicks were not anxious to be weaned from the mother hen but would seek her sheltering wing when quite large, and it was usually not until the mother hen would fly on the roost and leave them that they would entirely shift for themselves. If you will pardon this homely illustration, I feel very much like the chick that since we are so small and needy here in Oklahoma and Texas that as long as the General Board will aid and protect us as they have during the past year, I am not anxious to pass out from under the sheltering wing. However, I do trust that we shall enjoy such a healthy growth that ere long they will see that we are strong enough to be organized into a District and this will be done. While there are many churches of various denominations in these two great states after having studied the field for nearly five years I am persuaded that there is plenty of room for a people with the standards that we profess. Even scores of church people are dis-satisfied with the low standards that are held out in many places and are hoping and praying for something better. I feel like the Church at Philadelphia, that God has set before the Pilgrim Holiness Church an open door in Oklahoma and Texas. What a challenge! Will we go up and possess the land?

I wish to give a bried word of explanation as to why I resigned as Superintendent at the General Board meeting in May. I had felt for some time that I was not giving and could not give the time to the churches that they needed. Calls kept coming to help in revivals. The churches needed the visits of a Superintendent often

and being a busy pastor I could not do this only between Sundays which was not satisfactory. After careful consideration I felt it best for me to resign and accordingly gave my resignation to the General Superintendent in May. Upon the recommendation of the Executive Council Rev. C. H. Dauel was appointed Superintendent by the General Board and provisions made whereby he will be able to devote the major portion of his time to this work.

Brother Dauel has already proven himself a great blessing to our work and I want to now pledge my wholehearted support and allegiance to his leadership. May I also urge every minister and layman to hold up his hands and put their shoulder to the wheel. Our load pulls so heavy that we have no need of brakemen but we do need men to push and shovel coal.

I am told that when George Washington was on his way to take command of the armies of the colonies he asked how the Yankees behaved under fire. When told that they were very brave and would fight to the finish and not retreat he said that the war could be won. And it was. With ministers and laymen who can behave like that in the battle of the Lord and will stay put we can have victory. We might learn a lesson from the postage stamp, "Stick until we get to our destination."

I have preached 16 times, held 9 business meetings and organized one church. I travelled in my car over the District 3,716 miles for which I received for expenses \$93.20. I also attended the General Board meeting at Indianapolis in May, travelling 1,700 miles for which the churches gave me \$24.75. This makes a total of 5,416 miles travelled and \$117.95 received for expenses.
