## C O N F E R E N C E   P R O C E E D I N G S F I R S T       S I T T I N G

The third annual conference of the Pacific Northwest District convened in the Camp Meeting Tabernacle at Bend, Oregon, August 4, 1942 at 9:30 A.M. The Conference was opened by singing "Faith of our Fathers," then led in prayer by Dr. E.P. Dixon. R.W. Wolfe, Sec'y of Home Missions, was introduced by the Dist. Supt., O. C. Keller. Bro. Wolfe read from the Scriptures and exhorted the Conference to strive for higher things. This was followed by the roll call.

Names of new ministers were read and approved; Mrs. Alice Norris transferring from the Idaho-Washington Dist, John Strom transferring from the California Dist., and Milton Harrington transferring from the Rocky Mountain Dist. Abel H. West and George Doll were received into the District as ordained ministers.

A motion was carried that the first four rows of seats serve as the Conference Bar.

The District Supt. then appointed the following committees:

Resolutions Committee: Sherman Moore, Gerald Beckwith, Ellen Sanders.

Ways and Means Committee: The Dist. Supt. and all pastors.

Auditing Committee: E.R. Quick, Milton Harrington, C. E. Cox.

Statistical Committee: Mrs. O.C. Keller, Milton Harrington, Mrs. Alice Norris.

Editing Committee: O.C. Keller, C.E. Cox, Opal Suiter.

Committee on Memoirs: Mrs. Ted Munger, Mrs. O. D. Weaver, Mrs. Cynthia Schmidt.

The report of the Dist. Supt. was then read and accepted. Bro. Wolfe brought greetings from the General Board and its appointment of Orval G. Keller as Supt. of the Pacific Northwest Dist. The Dist. Treasurer's report was also received and accepted. Adjournment followed until 1943.

2nd. The conference convened again with a devotional period. "In the Great Triumphant Morning" was sung and Sr. Schmidt prayed. A motion was carried to have the reading of the minutes and the roll call dispensed with until the close of the Conference.

The pastors of the various churches then gave their reports and these all were approved.

Adjournment was made necessary by expiration of time. Bro. Moore dismissed in prayer.

THIRD SITTING--WEDNESDAY, AUG. 5, 9:30 A.M.

Conference opened by singing, "Rock of Ages," followed with prayer led by Sr. Sanders. Bro. Wolfe read from Col. 2:6-10 speaking of the spiritual temple which can be built in Him.

A motion was carried to receive Bro. Wesley Wilson and Bro. Ezra Cobb into the fellowship of the Conference Bar.

Bro. Wolfe gave his instructions to the Conference on the duty of the council, the pastor and the laymen in cooperating with the work of the Conference Superintendent.

The report of Sr. Norris was approved and accepted. Sr. Schmidt gave a deaconess' report from the Medford church which was approved and accepted.

Bro. Strom was appointed Secretary of the District Young Peoples' work, and Bro. Moore was appointed District Secretary of Sunday School work.

The Committee on Memoirs reported.

A statistical report was accepted subject to correction and completion by the Dist. Council. A motion was carried that the Auditing Committee report to the Dist. Council. Motions were further carried that the Dist. Sec'y be instructed to write a letter of thanks and appreciation to the owner of the camp grounds, and that a rising vote of thanks be given to the Bend Church for their kind entertainment and faithful labor during the Camp and Conference. Rising votes of thanks were extended to the Gen. Sec'y for his wise and godly help and leadership, his encouragement and his instruc-

tions ; to Sister Snider and the kitchen help for their labor of love during the Camp , and to our District Supt. for his labors .

The District Conference closed with a sense of deep gratitude to God for His blessings on this great home missionary district during this past year .

The reading of the minutes of the sessions were accepted and approved at the close of the session.

Our General Secretary, Rev. R. W. Wolfe, offered the closing prayer .

#### REPORT OF THE RESOLUTION COMMITTEE -AS ACCEPTED BY THE DISTRICT CONFERENCE.

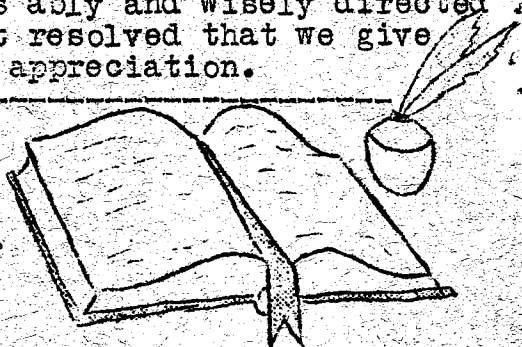
1. That the District Council serve as our Home Missionary Committee.
2. That each church devote one service each month to missionary interests. (General Budget)
3. That we set aside a weekend period once a quarter for District holiness conventions, as directed by the District Superintendent .
4. Be it resolved that no minister, evangelist, or Christian worker in any realm be permitted to hold special services on the District without the consent of the District Superintendent.
5. That the District Supt. appoint a Sunday School Sec'y for the District, to stimulate and carry on the work .
6. Inasmuch as we are living in times of extreme lusts and worldliness and that such a spirit is manifest even in holiness churches, be it resolved that we request every parent member to see to it that their children dress and conduct themselves as becometh holiness and according to our church Manual .
7. That each church appoint an individual to see that there is a food offering for the pastor at least once each month.
8. All monies are to be in to the District Treasurer by the 10th of each month .
9. That all churches take an offering , both of food and cash for the Camp Meeting .

10. That the fiscal year shall close June 30, with pastors taking their new charges a week after Camp Meeting .
11. That we have a three days' Christian worker and preachers' convention during the fiscal year, the time and place designated by the District Conference as being Roseburg, November 17- 19, 1942 .
12. That once each month in a public service that each pastor shall make a special effort to secure subscriptions for the Pilgrim Holiness Advocate, our church weekly paper.
13. That we give a rising vote of thanks to Brother Quick and the Bend church for their cooperation and kindness in securing the Camp Grounds and for their labors in helping to make the Camp a success .
14. Be it resolved that we give a hearty vote of thanks to Sister Snider and her helpers for their labors in the dining room and kitchen .
15. Whereas Brother Wolfe , our General Sec'y of Home Missions, has ably and wisely directed our Conference, be it resolved that we give him a rising vote of appreciation.

## Report of the District Superintendent.

To the Third Annual Conference of the Pacific Northwest District of the Pilgrim Holiness Church, greetings in Jesus' name!

First of all, I want to testify to the fact that just now the blood of Jesus covers every sin and that the Holy Ghost abides in all His fullness!

This past year has been a year of many changes much unrest, turmoil, and confusion. War has come to our land and has visited other lands with bloodshed, famine, death, desolation, and all the horrors of modern carnage. Because of these conditions and the consequent shifting of populace our churches have been hindered in most sections.

But in spite of the times, the Lord has blessed this vine of His planting, and enabled us to go forward. This past year we have been able to organize churches at Portland, at Bend, and at Salem. At the present time the total membership of these three new churches aggregate a sum of some fifty four fine members with others planning to come in soon. Our district membership has nearly doubled and our new people are splendid Christians who desire the old paths. We have bought a fine church and parsonage at Portland and have also purchased a parsonage in Medford. Our work in Jacksonville has been blessed and encouraged under the ministry of Brother Harrington. We can say with Morrison of old, "The future is as bright as the promises of God."

God has wonderfully helped the churches in sending in funds for the district expenses. From an empty treasury God has helped us to meet all our obligations, pay rents in new places, and send in money to the General Office for both Home and Foreign Missions. We have a small balance on hand at the present hour.

Personally, our labors have been abundant. I have served as pastor of both the Roseburg and Salem churches, have held all the quarterly meetings for the churches and have visited some

of the churches many times, in one case fourteen times this year! I have traveled about 7,000 miles on the district at a cost of about 1¢ per mile, and in attending the General Conference and other conventions about 4,000 miles. I have tried to be prompt in my correspondence and have written many cards and letters, also published a monthly bulletin. God has given us about 150 individual seekers at our altars, many of them new people who have not been connected with any church before.

At the appointment of the General Board I have accepted this position for the coming year, and plan to work harder, pray more, and to keep humble at the Master's feet, to occupy until He comes.
