## CONFERENCE PROCEEDINGS

The Sixth Annual Conference of the Pacific Northwest District convened in the Camp Meeting Tabernacle at Quinaby Park, Salem, Oregon, August 13, 1945 at 9:30 a. m. The Conference was opened by the singing of the old hymns, "All Hail the Power of Jesus Name," and "The Solid Rock." Rev. Roy Morgan led in a season of prayer. Rev. W. Wolfe, General Secretary of Home Missions and Church Extension then delivered the opening address and presided during the Conference.

A motion prevailed that the first five seats in the center section of the Tabernacle constitute the Bar.

A motion prevailed that the Conference stand in a rising vote of thanks in recognition of the great sacrifice and untiring service of Rev. and Mrs. Floyd Morgan during the past Camp Meeting.

Rev. R. W. Wolfe announced the appointment of Rev. Roy Morgan as District Superintendent. Announcement of additional members of the District Council was made to include Rev. Floyd Morgan and Rev. I. G. Canary.

The incoming District Superintendent, Rev. Roy Morgan, delivered a short message of inspiration to all the Conference.

The District Superintendent's Report was submitted by Rev. Floyd Morgan. A motion prevailed to accept this report and the Conference rose in an expression of thanks to Brother Morgan for his services.

By motion which prevailed, the Conference recessed until call by the chair.

#### Afternoon Sitting

The Conference reconvened at 1:30 p. m. with prayer which was led by Rev. Wm. McGlasson.

Rev. I. G. Canary submitted the report of the Resolutions Committee. A motion prevailed to adopt Resolution No. 1.

A motion prevailed to adopt Resolution No. 5.

A motion prevailed to adopt Resolution No. 7.

A motion prevailed to adopt Resolution No. 8.

A motion prevailed to adopt Resolution No. 9.

A motion prevailed to amend Resolution No. 6 to include the time and place, and that details be referred to a committee appointed by the District Superintendent. The District Superintendent then designated the District Council to handle details of plan outlined in Resolution No. 6.

The Report of the Ways and Means Committee was submitted. A motion prevailed to adopt Resolution No. 1.

A motion prevailed to adopt Resolution No. 2.

A motion prevailed to adopt Resolution No. 3.



The Report of the Educational Committee was read. Motions prevailed to adopt all recommendations made.

The Report of the Auditing Committee was read, after which a motion prevailed to adopt the same.

Reports were read and accepted from the following churches: Portland (Montavilla), Roseburg, Seattle, Vancouver, Medford, Raymond, Clatskanie, Salem, Bend, Klamath Falls, Silverton, and Marysville.

Reports of unstationed ministers and evangelists were read and accepted as follows: Mrs. Alice Norris, William McGlasson, Myrtle McGlasson, Abel H. West, Harry W. Heck, May S. Heck, Sheridan Hughes and S. G. Tighe.

Appointment of the Camp Meeting Board was made, as follows; Floyd Morgan, Dept. of Kitchen and Dining Room; E. P. Dixon, Treasurer; I. G. Canary, Secretary; Harry W. Heck, Dept. of Grounds and Sanitation; George Banka, Dept. of Entertainment; William McGlasson, Dept. of Purchasing.

A motion prevailed that the District Council nominate four ministers and two lay members of the Conference as delegates to the General Conference.

A motion prevailed that the District Council nominate the District Young People's President and District Young People's Secretary-Treasurer.

The Report of the council on nominations was read, as follows: Imogene Canary, President of District Young People. By acclamation, the Conference elected this nomination. Miss Berniece Kellis, nominated as Secretary-Treasurer of the District Young People's Organization. By acclamation, the conference elected this nominee.

Rev. Floyd Morgan, Rev. John Conner, Rev. James Dole and Rev. I. G. Canary were nominated as delegates to the General Conference. Rev. Floyd Morgan and Rev. John Connor were elected as ministerial delegates by the Conference, and Rev. James Dole and Rev. I. G. Canary elected as alternates respectively. Nominations for lay delegates to the General Conference were as follows: Mr. C. W. Callar and Mr. Don Johnson. Mr. C. W. Callar was elected as lay delegate to the General Conference with Mr. Don Johnson as alternate.

A motion prevailed that the fiscal year close June 30th.

A motion prevailed that the last session of the Conference Minutes and such unfinished business as may be left by the Conference, be confirmed in advance by the Conference.

(The following minutes regarding resolutions are the completion of Conference proceedings enacted by the District Council.)

A motion prevailed that Resolutions of appreciation for the Camp Meeting Workers be placed in the minutes.

A motion prevailed that trustees will be elected for the Pacific Northwest District. The following persons were nominated and elected: Dr. E. P. Dixon, Chairman, Rev. Paul C. Nering, and Rev. John Connor.

A motion prevailed that the Conference print 200 copies of the District Minutes, the same to sell for twenty-five cents each.

A motion prevailed that the Conference stenographer be paid the sum of ten dollars.

A motion prevailed that conference licensees wishing to contact the Educational Board shall do so, as follows:

The District Superintendent appointed the District Trustees as a committee to zone the District.

A motion prevailed that Resolution No. 14 be adopted.

## REPORTS OF OFFICERS, BOARDS, COMMITTEES

### District Superintendent's Report

To the sixth Annual Conference of the Pacific Northwest District of the Pilgrim Holiness Church, Greetings:

Another church year has become history. During this time our nation has been engaged in the greatest war that the world has ever known. Because of this conflict, many homes have been broken and many hearts saddened. We can praise God that the end seems near at hand.

God's people are engaged in a great battle against sin and unrighteousness, but we are assured of certain victories if we are good soldiers of Jesus Christ.

The past year, although one of troubles and burdens, has been lightened by the prayers and co-operation of the Christian people.

We have much to be thankful for. We praise God for the advancements that have been made. Our churches have had good revivals, and

have grown spiritually, numerically, and financially. Evangelists Murl Henry and J. W. Stuart, who have labored in the revivals, have seen their efforts blessed.

The interest of Brother and Sister Heck in revivals and Sunday School work, too, had the blessings of the Lord.

Many improvements have been made in the Vancouver Church including refinishing and beautifying the auditorium, remodeling the lighting system, and plastering the living quarters.

The people at Medford have been engaged in a building program throughout the year. The exterior of the building has been completed at a cost of seventeen hundred dollars. They are finishing the interior now; and the church will be very attractive when it is done.

The property at Bend has been freed of debt.

At the Montavilla church in Portland, the mortgage has been burned and improvements have been made. Cement walks, new roofing and re-decorating are included in them.

The original debt on the Seattle property has been reduced to \$640.00 and other improvements have been made.

Two of the cabins and the kitchen at the camp ground have new roofs.

A blessed and profitable mid-year preacher's convention was held at the Portland Montavilla Church with the Rev. W. H. Neff as guest speaker.

I have traveled some 16,000 miles, preached 93 times, made 47 visits to the churches, held two short revivals, conducted five annual meetings, received eight members into the church, anointed and prayed with 13 persons for healing, and dedicated 20 children. I have received \$1800.00 for district work; \$580.00 was used in traveling and other expenses. \$860.00 was paid for a car and about \$250.00 was contributed to various phases of the work in tithes, offerings and gifts.

A wonderful camp meeting has just closed. Our people, loyal and spiritual, have a vision for the work. Some definite plans are under way for the advancement of the cause here in the Northwest.

Rev. Roy Morgan has been appointed in my stead for the superintendency since I have resigned because of ill health. With the vision and the cooperation that there is among our people, I predict a great future under the leadership of Brother Roy Morgan.

## REPORT OF THE RESOLUTIONS COMMITTEE

1. Be it resolved that each minister shall read his own annual report.

2. Be it resolved that each church shall furnish camp meeting equipment such as beds, bedding, furniture, dishes, utensils, etc., such that they might give away and that might be acceptable by the Camp Meeting Committee.

3. Be it resolved that each church be responsible for the salary or offering for the pastor during the Camp Meeting, and conference, and that this resolution shall be read to the church by the Church Secretary at the annual church meeting or sixty days before the Conference.

4. Be it resolved that we have a district young people's organization consisting of Young People's President, and Secretary-Treasurer, and that a nominating committee be appointed by the District Superintendent that shall present names to this Conference.

5. Be it resolved that a Young People's Rally be conducted in different zones of our district and that a zoning committee be appointed by the chair to effect this zoning.

6. Be it resolved that we have a Ministerial Seminar of two weeks during, February 4-16, inclusive at the Portland Montavilla Church.

7. Be it resolved that we have a master plan for our Camp Meeting Grounds and that this plan be drawn by a responsible draftsman to be approved by the District Council. Be it further resolved that all improvements and buildings be in harmony with the master plan.

8. Be it resolved that we have a Camp Meeting Committee composed of six men appointed by the District Superintendent and that these shall include the following departments: Camp Meeting Treasurer, Camp Meeting Secretary, Department of Purchasing, Department of Entertainment, Department of Grounds and Sanitation, Department of Kitchen and Dining Room.

10. Whereas Rev. R. W. Wolfe, our General Church Secretary of Home Missions and Church Extension has been permitted to be present at our Camp Meeting and Conference, and has given such wise and godly assistance, be it Resolved that we give him a rising vote of appreciation and a hearty "Amen."

11. Whereas Rev. Floyd Morgan has so sacrificially devoted himself to the cause of righteousness and the responsibility of the District during the past fourteen months, be it resolved that we extend to him our utmost appreciation by standing to our feet.

12. Whereas, Sister R. S. Snyder has so efficiently and untiringly performed as our Camp Meeting Cook, be it resolved that we give her and her helpers a rising vote of thanks.

13. Whereas Rev. Roy Morgan, Rev. J. W. Stuart, Imogene Canary and May S. Heck have labored as our Camp Meeting Workers with unity and spirituality, be it resolved that we extend our appreciation with a rising vote of thanks.
