CONFERENCE PROCEEDINGS

The Seventh Annual Conference of the Pacific Northwest District of the Pilgrim Holiness Church convened in the Camp Meeting Tabernacle at Pilgrim Park, Salem, Oregon, August 12, 1946, at 9 o'clock A.M. The Conference was opened by the singing of the old hymns, "A Glorious Church"

and "Leaning On The Everlasting Arms," after which a good season of prayer was led by Brother George Doll. Then the Conference group sang, "When I Survey the Wondrous Cross." Rev. R. A. Beltz, General Secretary of Home Missions, then delivered the opening address and presided during the Conference. Everyone then joined in singing the chorus, "I'll Go Where You Want Me To Go."

A motion prevailed that the first five seats in the section of the tabernacle, and the platform constitute the Conference Bar.

A motion prevailed to give honorary seats within the Conference Bar to the following ministers: C. Edwin Cox, Vern G. Storey, Mrs. Vern Storey, Vale Johnson, Lloyd Johnson, Carl Mansfield, and Milton Harrington.

A motion prevailed to receive Rev. and Mrs. Vern G. Storey into the Conference, transferring from the California District as ordained ministers.

A motion prevailed to receive Rev. Sherman Moore back into the Conference from the California district, as an ordained minister.

A motion prevailed to receive Rev. C. Edwin Cox back into the Conference from the California District, as an ordained minister.

A motion prevailed that the Conference seat Mrs. C. E. Cox as lay delegate from the Central Point Church.

A motion prevailed that the Conference receive Rev. Carl Mansfield as a minister from the Indiana District.

A motion prevailed that our Camp Meeting Evangelist, Brother Walter Drown, from the Rocky Mountain District, be given an honorary seat within the Conference Bar.

Replacements and substitutions on Standing District Committees were made as follows:

The District Superintendent, Roy E. Morgan, read and submitted his report for the Conference. A motion to accept this report prevailed.

The District Superintendent then exhorted the district pastors concerning the necessity of careful preparation and completion of the annual report.

A motion prevailed to excuse the Resolutions Committee from the Conference session.

A motion prevailed dispensing with the reading of the Church Reports by each pastor.

The Report of the District Statistician was then read. A motion prevailed that this report be accepted and that the Statistician be given the privilege of completing this report as statistics are made available before the publication of the minutes of this Conference.

The chairman then commended the Conference on the gains that had been made, and delivered words of admonition relative to work to be done in the Sunday School.

Mrs. Minnie Morgan, the District Sunday School Secretary, gave a verbal report, which was accepted by motion which prevailed.

The Report of the Resolutions Committee was submitted and read by Brother Lee Williams:

A motion prevailed to adopt Resolution No. 1.

A motion prevailed to amend Resolution No. 2, that a suitable person be appointed to prepare and paint uniform highway signs and that each church be responsible for the costs of its own signs. A motion then prevailed to adopt Resolution No. 2 as amended.

A motion prevailed to adjourn and reconvene the Conference session at 2 P.M. Brother Walter Drown dismissed the session with prayer.

AFTERNOON SITTING

The Conference reconvened at 2 p.m. as the group sang the hymns, "Stand Up, Stand Up For Jesus," and "My Sheep Knew My Voice." This

was followed by a season of prayer which was led by Brother W. W. Ponder. Brother Beltz then exhorted the Conference on the Subject, "Cowards in Battle" using as his text, Psalms 78:5-11.

The reading of the minutes of the previous session were read and approved.

A motion prevailed to seat Ben Evans as the lay delegate from the Seattle Church.

Action upon the Report of the Resolutions Committee was resumed. A motion prevailed that Resolution No. 3 be withdrawn and that another be submitted in its place. The new Resolution No. 3 was submitted and adopted by motion which prevailed.

Resolution No. 4 was read and adopted by motion which prevailed.

Resolution No. 5 was read and adopted by motion which prevailed.

Resolution No. 6 was read and adopted by motion which prevailed.

Resolution No. 7 was read and adopted by motion which prevailed.

Resolution No. 8 was read and adopted by motion which prevailed.

Resolution No. 9 was read and by motion which prevailed, was amended to include Brother Beltz as co-worker at the 1947 District Ministerial Convention with Brother P. W. Thomas. The amended Resolution was adopted by motion which prevailed.

Resolution No. 10 was read and adopted by motion which prevailed.

Resolution No. 11 was read and adopted by motion which prevailed.

Resolution No. 12 was read and adopted by motion which prevailed.

Resolution No. 13 was read and adopted by motion which prevailed.

The District Young People's Report submitted by Imogene Canary and read by the Secretary was approved by motion which prevailed.

The Report of the Auditing Committee was read by Mrs. John Connor, and accepted by motion which prevailed.

The Report of the District Treasurer was read and accepted by motion which prevailed.

A motion prevailed to grant Rev. Thos. Lee, one of the Camp Meeting evangelists, an honorary seat within the Conference Bar.

The Report of the Ways and Means Committee was read by Rev. Floyd Morgan, chairman.

Resolution No. 1 was read and adopted by motion which prevailed.

Resolution No. 2 was read and adopted by motion which prevailed.

Resolution No. 3 was read and adopted by motion which prevailed.

Resolution No. 4 was read.

Resolution No. 5 was read and adopted by motion which prevailed.

Resolution No. 6 was read and adopted by motion which prevailed.

Resolution No. 4 was re-read and adopted by motion which prevailed.

The Conference then recessed after a season of prayer led by Brother Thomas Lee.

After the Recess, the Conference joined in singing, "There Is Sunshine In My Soul." This was followed by prayer led by Brother John Connor.

Brother Beltz gave a report of his work in the present field, and exhorted the pastors and workers with the reading of the 121st Psalm.

A Joint Report of the Educational and Examining Committees was read by James Dole, chairman of the Examining Committee.

A motion prevailed to accept the Committee's recommendation that June Risinger be granted Conference Singer's License.

A motion prevailed to accept the Committee's recommendation that Carl Mansfield be granted 1st year Conference Minister's License.

A motion prevailed to accept the Committee's recommendation that Lloyd Johnson be granted 1st Year Conference License.

A motion prevailed to accept the Committee's recommendation that the 2nd Year Conference Minister's License for Harry Heck be continued. By virtue of the amalgamation of the Holiness Church with the Pilgrim Holiness church, the following ministers were accepted into the district. as follows:

Harvey L. Williams. Ordained Minister; Clark Sutter, 2nd Year Conf. License; Louisa White 1st year. A motion prevailed to accept the Committee's Recommendation that the 3rd year Conference Minister's License for S. G. Tighe, be continued.

A motion prevailed to accept the Committee's recommendation that the 2nd year Conference Minister's license for William McGlasson be continued.

A motion prevailed to accept the Committee's recommendation that the 2nd Year Conference Minister's license for Myrtle McGlasson be continued.

A motion prevailed to accept the Committee's recommendation that Vale Johnson be granted 2nd year Conference Minister's License.

A motion prevailed to accept the Committee's recommendation that the 2nd Year Conference License for A. T. Williams be continued.

A motion prevailed to accept the Committee's recommendation that the 3rd year Conference Minister's License for Mrs. Ida May Morgan be continued.

A motion prevailed to accept Mrs. May S. Heck and Mrs. Alice Norris as candidates for ordination. It was announced that the ordination service would be conducted during the next District Ministerial Convention.

A motion prevailed that Dr. E. P. Dixon, John Connor and Donald Johnson be nominated as Trustees of the District and that the District Secretary be instructed to cast the Ballot in accordance with the State Law. The Ballot was cast by the Secretary in the presence of the Conference, and Dr. E. P. Dixon, John Connor and Donald Johnson were declared to be elected.

The Conference proceeded to elect officers of the Camp Meeting Board.

A motion prevailed that the District Secretary and District Treasurer be elected Camp Meeting Secretary and Camp Meeting Treasurer, respectively, by virtue of their office.

By motion which prevailed, the office of Camp Meeting Registrar be added to the Camp Meeting Board.

Mrs. Alice Norris was elected by acclamation as chairman of the Entertainment Department.

William McGlasson was elected as Camp Meeting Purchasing Agent.

Rev. Vern Storey was elected by acclamation as chairman of the Buildings and Grounds Department.

A motion prevailed that the Dining Room Department of the Camp Meeting Committee, be divided into the Department of Kitchen and the Department of Dining Room, for the reason that the work scope is too large for one person.

C. E. Cox was elected by acclamation to head the Department of Kitchen.

James Dole and Floyd Morgan were nominated on the ballot for Head of the Department of Dining Room. Inasmuch as the count of ballots indicated a tie, a motion prevailed that both James Dole and Floyd Morgan be elected to fill this position.

Carl Mansfield was elected as Camp Meeting Registrar.

This was followed by the reading of the minutes of this session by the secretary. By motion which prevailed the minutes were approved.

A motion prevailed that the unfinished business that may be left by the Conference, and the minutes thereof, be confirmed in advance by the Conference.

A motion prevailed that Resolutions of appreciation for the Camp Meeting and Conference Workers, be placed in the minutes of this Conference.

A motion prevailed that the Conference print 200 copies of the District Minutes, the same to sell for 25 cents each.

A motion prevailed that the department to which James Dole was elected shall be designated the Department of Labor.

The last sitting of the Seventh Annual Conference was closed with prayer, and inasmuch as God has given us such a gracious Camp Meeting and Conference a motion prevailed that the Conference stand and sing "Praise God From Whom All Blessings Flow."

REPORTS OF OFFICERS, BOARDS AND COMMITTEES

DISTRICT SUPERINTENDENT'S REPORT

To the Ministers and Delegates of the Seventh Annual Conference of the Pacific Northwest District of the Pilgrim Holiness Church, greeting:

Grace and peace from God our Father and the Lord Jesus Christ and the blessed Holy Ghost be multiplied unto you.

At the close of another Conference year, we, by the providence of God are assembled to make our reports and shape our plans for the coming year as the Lord may lead.

First of all, we praise the Lord for glorious victory, full and complete through Jesus the Captain of our salvation. His precious blood now cleanses from all sin. Praise be to Him forever. God has given us a wonderful Camp which just closed. We thank God for such preachers as Brother Drown, Brother Lee and Brother Olson. We can never be the same again.

We appreciate the privilege of laboring with such a loyal and spiritual band of saints as God has given us on this district. We love every one of you and thank God for you and your faithfulness.

The past year has been a blessed and fruitful year in spite of problems and battles. God has given blessed victory. We thank Him and give unto Him who alone is worthy, all the glory.

The past year we have traveled over 35,000 miles in district work and our trip to General Conference.

We have preached 158 times, have made 46 visits to individual Churches on the District, visiting each church from 4 to 11 times; we held four regular District Council Meetings and three specially called meetings. We held eleven Church Board meetings, organized one Church with a charter membership of 23 members, held one Ministerial Meeting on the District. We had 75 individual seekers in our meetings, and received thirteen subscriptions to the *Advocate*. We have sent out over 1200 pieces of mail during the year.

God has been good to us in every way; the people of God have loved and helped and been kind to us. Our salary has been paid in full and we have everything to be thankful for.

There has been an unusually large building program on the District the past year.

Medford finished their new auditorium and they have a place of worship which is an asset to our entire denomination and is all paid for.

Clatskanie has purchased a new location and has built a splendid and well-arranged building for all departments of the Church, and for living quarters for the Pastor. This church has only a small indebtedness on it.

The church at Seattle has paid the entire debt on their splendid parsonage and the church property.

Raymond has made some very good improvements on their building.

Bend has built a new Church building which is paid for.

Portland has made many noticeable improvements on the living quarters. quarters.

Vancouver has painted the building and it looks very nice.

Silverton purchased a good location with a parsonage on it and has built a very splendid Chapel. The indebtedness is small in comparison to the property value.

We have been blessed with the addition of two Church properties with one organized Church and the other a Sunday School. This came about as the result of the Church merger between the Holiness Church and the Pilgrim Holiness Church.

We have as fine a group of pastors as can be found anywhere who have upheld us in prayer and their cooperation. We appreciate them and their loyal people.

We go forward with faith in God and Divine Love in our hearts for the work of God, the souls of men and an increasing adoration for Him who hath loved and redeemed us. Jesus is real and precious to us.

We appreciate our faithful and hardworking companion who has stood by and helped make our work possible.

SPECIAL SECTIONS FROM THE MANUAL

Section 198, paragraph 1, 2 and 3:

Those entering a ministerial office shall immediately enter upon the prescribed course of study and pursue same until completed. To this end they shall place themselves under the direction of the District Educational Board which has charge of this work unless the same course or its equivalent is taken in school.

Examinations required by the District Educational Board shall be submitted in writing and shall be conducted at the time and place of the District Conference or during the year upon completion of a book or subject, either personally or through the mails.

The passing grade of any subject or study shall not be less than an average of 70 per cent.

Section 154:

No person shall be eligible for ordination until first having served at least two years in active ministry.

Section 155:

The licentiate who has held his license at least three years and has successfully completed the required course of study shall be eligible for ordination as a minister of the Gospel, unless the District Council will have deemed it wise to have ordained before the expiration of the three-year period.

Section 149, Paragraph 1:

All licensed ministers failing to complete and report on at least two subjects a year in their required Course of Study, for two consecutive years, will automatically forfeit their license, unless in the judgment of the Educational Board an exception shall be made.

Each minister pursuing our course of study shall mail 25 cents with each request for questions on each subject. Those failing to comply with this recommendation will not receive their questions.

1. Resolved that all ministerial tithe be sent to the District Treasurer to be applied on the support of the District Superintendent.

2. Resolved that all Birthday Offerings be used for Home Missions.

3. Resolved that each church take a special Missionary Offering each month to be equally divided between Home and Foreign Missions.

4. Resolved that each church take an offering for the District Superintendent at each of his regular visits, the same to be applied on his salary.

5. Resolved that each church be placed on a budget to be apportioned as follows per month:

STANDING RESOLUTIONS

1. Be It resolved that the District Council serve as our Missionary Committee.

2. Be it resolved that each church devote one service each month to missionary interests.

3. Be it resolved that no minister, evangelist or Christian worker in any realm be permitted to hold special services on the District who is not in sympathy and harmony with the doctrine and teaching of the Pilgrim Holiness Church, nor without the advice and consent of the District Superintendent.

4. Be it resolved that each church appoint an individual to see that there is a food offering for the pastor at least once each month, which will be investigated by the District Superintendent during his visit to each church.

5. Be it resolved that all money is to be sent to the District Treasurer by the 10th of each month.

6. Be it resolved that all churches take an offering, both of food and cash for the Camp Meeting.

7. Be it resolved that each pastor conduct a class of catechism on the doctrine of holiness each month for the education of the members and their children.

8. Inasmuch as we are living in times of extreme lusts and worldliness and that such a spirit is manifest even in Holiness churches, be it resolved that we request every parent member to see to it that their children dress and conduct themselves as becometh holiness and according to our Church Manual.

9. Be it resolved that each church shall conduct a special Pilgrim Holiness Advocate subscription campaign and that a gold star recognition shall be given to each church that attains a hundred percent family membership subscription.

10. Be it resolved that our young people be given a prominent part in our District Ministerial Convention.

11. Be it resolved that each church shall furnish camp meeting equipment such as beds, bedding, furniture, dishes, utensils, etc. such that they might give away and that might be acceptable by the Camp Meeting Committee.

12. Be it resolved that each church be responsible for the salary or offering for the pastor during the Camp Meeting, and conference, and that this resolution shall be read to the church by the Church Secretary at the annual church meeting or sixty days before the Conference.

13. Be it resolved that we have a district young people's organization consisting of a Young People's Executive Secretary-Treasurer, and that a nominating committee be appointed by the District Superintendent that shall present names to this conference.

14. Be it resolved that a Young People's Rally be conducted in different zones of our district.

15. Be it resolved that we have a master plan for our Camp Meeting Grounds, and that this plan be drawn by a responsible draftsman to be approved by the District Council. Be it further resolved that all improvements and buildings be in harmony with the master plan.

16. Be it resolved that we have a Camp Meeting Board composed of nine men and that these shall include the following departments: Camp Meeting Treasurer, Camp Meeting Secretary, Department of Purchasing, Department of Entertainment, Department of Buildings and Grounds, Registrar, Department of Kitchen, Department of Labor, and Department of Dining Room.

17. Be it resolved that we have a Call Card plan for the District which shall be for the purpose of united help of \$1.00 per call, not more than four calls per year, for the Church Extension work of the District.

18. Be it resolved that there be quarterly meetings held in the Pacific Northwest district—and be it further resolved that the quarterly meeting shall be a union meeting of the churches of each zone, namely, the Northern, Central and Southern Zones.

19. Be it resolved that there shall be suitable advertising signs of the local church on the highway or highways approach and on the nearest through street to the church building, and on the church building.

20. Be it resolved that the District elect the members of the Camp Meeting Board.

21. We recommend that the course of study be purchased by ministerial candidates.

22. Be it resolved that the District School Committee be empowered by the Conference to Contact the School Committees of the California District and the Idaho-Washington District for the purpose of establishing a Northwest School for all three districts.

23. Be it resolved that each church make plans for an active Missionary Society. This society shall function for Home and Foreign Missions and both men and women shall participate.

26. Be it resolved that those who regularly use the lights and water from the Camp Ground, except the caretaker or district officials shall pay the prevailing scale.

27. Be it resolved that immediate steps be taken to have a phone installed at Pilgrim Park.

28. Be it resolved that there be an annual ministerial convention. Be it further resolved that the 1946-47 Ministerial Convention shall be at Medford, Oregon on a Tuesday, Wednesday and Thursday, in February, and that we secure Rev. Paul Thomas as the worker.

29. We recommend that the local Sunday School shall count as present those from the local Sunday School who are attending the Annual District Camp Meeting—the attendance to be counted only when a card is signed by the proper camp meeting authority.

30. Be it resolved that the retiring pastor of the local church shall make available to his successor an up-to-date record of the names and addresses of the members and friends of the local church.

31. Be it resolved that immediate steps be taken to minimize the fire hazard to Pilgrim Park and buildings. Be it further resolved that a committee shall be appointed and empowered by the District Council to do this.

32. Inasmuch as the Brotherhood Insurance Company of Fort Wayne, Indiana, is state accredited and a Mennonite sponsored, non-profit Insurance Company for churches, and inasmuch as this Insurance Company has made available to the Pilgrim Holiness Church its fire, wind, etc. insurance at one-half State listed cost, be it resolved that the Pacific Northwest District take advantage of this insurance in the local and district properties.

Olson, be it resolved that we express our deepest appreciation for the many spirit filled messages we enjoyed.

36. Whereas Mrs. Arnold, Milton Harrington, Lloyd Johnson, Myrtle McGlasson and May Heck rendered special services to the general upbuilding of the Camp Meeting, be it resolved that we express our appreciation to them by a rising vote of thanks.

37. Whereas, Brother Rader, and his assistants, Brother and Sister Norris, Brother Evans, and Sister Woodruff worked so faithfully and untiringly in the kitchen department, be it resolved that we give Brother Rader and his helpers a rising vote of thanks.

38. Whereas, members of the various Conference Committees have ably and efficiently served to expedite the business of this Conference Session, be it resolved that we express our thanks to each one who have so willingly given of his time to the business affairs of this District.
