CONFERENCE PROCEEDINGS

The Twenty-third Annual Conference of the Pacific Northwest District of the Pilgrim Holiness Church opened at Pilgrim Park, Salem, Oregon, July 30, 1962 at 9:00 a.m.

The conference sang "Majestic Sweetness" with Roy Dworschak as song leader and Miss Anna Hooker as pianist.

Rev. Clarence Jackson led in prayer.

Our hearts were stirred by an address from our General Superintendent Melvin H. Snyder. He read from Matt. 8:5 and Hebrews ll:1,2. Our attention was drawn to the marvelous faith of the Centurion. He had a greater faith than Mary, Peter, John the Beloved, and possibly all Israelites that were born. Faith that:

- 1. Exercised with profound humility. (I am unworthy).
- 2. Exercised in a profound love. (My servant is grievously tormented).
- 3. Recognized constituted authority. (Speak the Word only).
- 4. Exercised authority. (Speak the word only and my servant shall be healed).

Dr. Snyder concluded his address by leading the conference in a verse of "'Tis So Sweet To Trust In Jesus".

The roll call was read.

The platform and the first five seats on each side of the church auditorium were designated as the conference bar.

The sessions of the conference were set at 9-12 a.m. and 2-5 p.m.

The Reception Committee was appointed. It is composed of Bro. Briggs and Bro. Jackson.

Rev. John Connor read the District Superintendent's report which was received by a standing vote of thanks.

Rev. Walter Cole read the Assistant Superintendent's report which was received with a hearty "Amen".

The Auditor's report was read by Rev. Verlie Arnett. It was received by vote of the conference.

Rev. V. G. Story read the District Treasurer's report. It was moved and seconded we receive this report with deep appreciation. It was passed by a standing vote of thanks.

The Statistical report was presented by Rev. Donald Mack. Dr. Snyder noted some discrepancies in the reporting of the local churches. He recommended to the pastors the way to correct this. Bro. Mack's report was received by saying "Amen".

Rev. Harley Briggs gave the Sunday School Promotional Secretary's report. It was voted we receive the Secretary's report.

Mrs. Edna Connor, the District Missionary President, reported District World Mission Activity progress. It was moved and seconded that we receive the report. Carried.

Rev. John Larson, District Youth Secretary, read his report. It was received by vote of the conference.

The Reception Committee brought Rev. Gregory, supply pastor at Svensen; Rev. and Mrs. George Moran, pastor at Medford; Rev. and Mrs. Charles Stewart, pastor of Portland Alberta; Rev. Henry Miller, California and recently of Grants Pass; and Rev. Sherman Moore, pastor at Klamath Falls. They were granted an honorary

seat in the conference bar.

The Resolutions Committee report was heard and accepted.

The Ways and Means Committee report was submitted by Rev. Clarence Jackson, the chairman. It was moved and seconded that we receive this report. Passed.

We were adjourned at 11:45 due to lack of time to elect officers before noon.

Rev. Verlie Arnett prayed the dismissal prayer.

Second Sitting

The chairman declared a special session of the conference at 1:00 p.m.

The Educational Board presented its report to the conference. The Examining Board reported.

The reports of the Examining and Educational Boards were received by vote of the conference.

The Ordination Service of Rev. John Larson followed.

The Conference was privileged to hear a tape recorded greeting from the John Price's in Africa.

The Reception Committee introduced Rev. O. A. Wells of the Idaho-Washington District to the conference. He was granted an honorary seat in the conference bar.

The Resolutions Committee brought a group insurance proposal before the conference. This insurance was to be made available to pastors and their families and was to be investigated and set up by a committee. It was moved and seconded we accept the proposal. Carried.

The Ways and Means Committee brought a proposal authorizing council members transportation to council meetings. The motion was amended to include the sum of " 5ϕ per mile". The main motion, as amended, was received by vote of the conference.

The Memoir Committee reported no ministers and only one layman had passed away, Mrs. George Mitch of Aurora. The conference stood in silent prayer to God in thanks for giving her the Crown.

The election of officers followed.

Dr. Snyder prayed a prayer for guidance in the elections. The following officers were elected:

The conference voted to authorize the council to take care of

any unfinished business.

It was moved and seconded the council hear and approve the conference minutes: It was carried.

Dr. Snyder reported that we had a very successful General Conference which indicates the denomination is maturing in judgment. Various important General Conference matters were reviewed and explained to the conference.

It was voted we adjourn.

We were dismissed by singing the Doxology and by the benediction by Dr. Snyder.

DISTRICT SUPERINTENDENT'S REPORT

To our General Superintendent Dr. Melvin Snyder, Pastors, Delegates and Friends. Greetings in Jesus' Name! To this Twenty Third Annual Conference of the Pacific Northwest District of the Pilgrim Holiness Church now in session at Salem, Oregon.

We, for another year, have found that the promises of God are a source of unfailing strength. God has enabled most of our workers to continue in the battle for another year. I have found in our churches an atmosphere of Spiritual progress. There have been heart rendering burdens because of certain conditions but we are pressing forward nevertheless. Who can rightly judge his accomplishments here and now as to eternal values, but I trust that each of us can truthfully say that I have done my best. The forces of sin are still waging a heated conflict, but the Army of God is moving on to blessing and God gives victory through the triumphant power of Jesus' Blood. A number of our churches have had real good revivals during the past year.

Our young people had a wonderful conference the last of December with many praying through to definite victory. Rev. H. H. Barton was used of the Lord in these services.

We have just closed one of the best camp meetings that the District has ever had in attendance, financially and spiritually. The Lord gave us some of the best of His workers in the Chatfields as singers, Brother Philpot evangelist with Brother Drown helping with our day meetings. Our folks also enjoyed our two General men who were with us, Dr. Hawkins and our General Superintendent, Dr. Snyder. But most of all we were honored with the presence of the Lord in every service. To Him be all the Praise and Glory - Amen and Amen.

Church Improvements

Church improvement is progress. Without progress or vision, the people and our work perish.

Aurora - new addition with three classrooms, a study, and two rest rooms. A new gas furnace with ducts to be placed later.

Silverton - painted the church on the outside, new steps at the back of the parsonage and finished the interior of some of

their classrooms.

Klamath Falls - installed an inter-com in their nursery, bought new song books and purchased some furniture and shades for the parsonage.

Eugene - redecorated the interior of the parsonage, and refinished the hardwood floors, and have done work on shrubs, lawn, etc.

Grants Pass - the new auditorium is nearing completion. The windows are in, wainscoating on the interior and the two buildings are joined together.

Hazen Chapel (View) - added four new classrooms, installed a new furnace, painted the outside of the church, purchased 75 new song books, and placed a large sign outside.

Marysville - new windows in the church.

Medford - grand piano, and organ. New altar, sidewalk at front entrance, parking lot graded and covered with granite. A new outside bulletin board.

Portland Alberta - painting the exterior of their parsonage and have a paint fund well on its way toward painting the exterior of the church. Fifty new song books and fireplace repaired.

Portland First - repaired the front porch of the parsonage and put in cement steps, painted the outside of the parsonage and made other improvements.

Raymond, Washington - repaired, puttied and painted the entire outside of the church. Added needed wiring such as outlets, lights and switches. The roof given a coat of asphalt. Planted shrubbery and flowers to beautify the grounds.

Salem - church exterior repaired and painted, a new brick planter and church sign, a cedar fence, trees and shrubs planted on the property, a new pulpit, a memorial to Winona Caves.

Seattle - fixed fire door and painted some in the basement of the church.

Central Point - work has been done on the walls of the parsonage because of the dry rot, the garage has been made into a nice room with other improvements being made to keep the property in good repair.

Corvallis - put on a new cedar shingle roof on church, added more fill dirt to their parking space and have their furnace in operation.

Svensen - put some furniture in their parsonage and made other minor repairs.

Vancouver, Washington - they have continued with their building program by finishing more classrooms, a missionary ladies work room in the basement, roof over the back entrance to the church and parsonage, with other improvements on grounds and buildings.

Roseburg - this church has undergone a complete change in church and parsonage. Redecorating in the church, of furniture and room. The parsonage finished inside, redecorated, floors refinished, sealed, new wiring put in with the parsonage off the meter with the church. Composition brick siding on all the exterior of the parsonage part of the building, also roof repaired on this part of building, yard and driveway greatly improved.

Personal Report

I have preached 80 times, supplied at the Portland Alberta church until they got a pastor, preached at Holiness Association meetings, directed the State Holiness Association Meeting, being president.

I have held no revivals, had one funeral, helped with one wedding, three communion services, dedicated three babies, held a number of prayer meetings, taught Sunday School classes, prayed for the healing of eight.

I have attended three zone rallies, held sixteen annual meetings, twenty board meetings, visited every church and Sunday School on Sunday morning - then visiting them more than the manual requires. I have written many letters seeking pastors for our churches. I have travelled 20,000 miles on and for the District. I have attended school board meetings, leader's meeting at Indianapolis and General Conference, travelling 34,000 miles in the interest of the Kingdom.

My ministry has been to encourage our people to continue in the faith and do their best to see others saved rather than to have seekers at my altar. However, there have been ten seeking to be saved or sanctified under my ministry, and there have been some real refreshing times around the altar when the saints have met to pray and God has come to bless. Numbers have held up their hand for prayer.

I have worked 560 hours on the District which includes Raymond, Grants Pass, Aurora, Corvallis and on the camp grounds, excluding getting ready for youth conference or camp meeting.

The kitchen in the district parsonage has been painted and, through the help of willing workers, cement walks have been laid in front of children's chapel, dining room and the stand.

The dormitory rest rooms have been nearly completed with windows, doors and stalls. The wash room a new floor. There has been built a new septic tank with drain to care for the needs of the dormitory. More of the ground leveled and seeded, a duplex with stools and showers nearly completed for our camp workers.

I have enjoyed this year of labor for Him though it has been a strenuous year, taxing body, soul and spirit, but to Him be all the glory for giving strength and blessing.

Our goal for the coming year is to strengthen our lines with prayer and fasting and charge the enemy on every line, helping as many to safety through Jesus as we can.

STANDING RESOLUTIONS

- Conference -

- Be it resolved that no minister, evangelist or christian worker be engaged without approval of the District Superintendent.
- 2. Be it resolved that all District and General funds be sent to the District Treasurer by the tenth of each month.
- 3. Be it resolved that the pastor's salary or offerings be paid during camp and conference.
- 4. We recommend where possible that suitable signs of the local church be placed along the highway or highways approaching the city and at the nearest through street.
- 5. Be it resolved that the retiring pastor shall give to his successor an up-to-date record of the names and addresses of members and friends of the local church.
- 6. Be it resolved that the quarterly bulletin, "The Northwest Pilgrim", be edited by the District Superintendent. The Bulletin shall comprise new items from each department head. Be it further resolved that means for the publishing of the bulletin be by subscription, the price to be set by the District Council.
- 7. Whereas the constitution of the United States provides for freedom of worship, be it resolved that this conference go on record as being opposed to any school system which violates the conscience of our children by any anti-christian requirements which are contrary to the teaching of the Pilgrim Holiness Church.
- 8. Whereas some of our churches pay their pastors by the free will offering method and as this often is a handicap in raising finances; therefore we recommend that each church pay their pastor a salary.
- 9. Be it resolved that in the event of the death of a district minister or his wife, the District Secretary be notified at once and he shall notify the pastor of each church.
- 10. We recommend that the editing committee date all standing resolutions in their respective years -- from 1952.
- 11. Begit resolved that no one be elected or appointed to more than one major board or committee, where possible. 1955
- 12. Whereas, the General Board of the Pilgrim Holiness Church has authorized the Pilgrim Pension Plan, Inc., to make loans of Pension Funds to local Pilgrim Holiness Churches under such conditions as require active participation on the Pilgrim Holiness Districts.

THEREFORE, BE IT RESOLVED by the Annual Conference of this district that the District Council, District Trustees, and all District officials be and they are hereby authorized, to do and perform any and all acts required of them in the consummation of authorized loans to local Pilgrim Holiness Churches of this district, subject however, to the limitations and conditions set out in said Resolution of the General Board of the Pilgrim Holiness Church authorizing said loans. We further recommend that foresaid limitations and conditions be on file with the District Superintendent. 1955

- 13. We recommend that each church grant their pastor a two week vacation, with salary paid. 1956
- 14. Be it resolved that each pastor send the annual reports to the District Statistician by July 10. 1956
- 15. We recommend that all district committees and boards, ministerial delegates, and all those needing to meet the district committees, be at the camp ground Friday night, July 27. 1959
- 16. Be it resolved that the pastoral recall be conducted the first two weeks in April, and the reports of the vote to be reported immediately to the District Superintendent. 1959
- 17. Be it resolved that all new resolutions or proposed resolution changes be written out and delivered to a member of the Resolutions Committee by the day before conference. 1960
- 18. Whereas the District Superintendent's program will be to a degree governed by his knowledge of district finances; be it resolved the District Treasurer submit a report to him quarterly. 1960
- 19. Whereas the time of our Pacific Northwest District Conference was placed at the beginning of camp to permit the same general official to preside over it as presided over the Idaho-Washington Conference occurring earlier in the same week, and whereas the Idaho-Washington Camp has been moved up to a date earlier in the summer making such cooperation impossible:

Be it resolved that the Pacific Northwest District Conference be held the day following the close of regular camp services. 1961

- 20. Be it resolved that plans for all new buildings and all major repairs on buildings of and on the district be authorized and approved by the District Council. 1961
- 21. Be it resolved that a committee be appointed by the District Superintendent to investigate group insurance programs for District pastors and families and report to the District Council with authority given to the District Council to inaugurate if deemed advisable. 1962

- Camp -

- I. Be it resolved that Pilgrim Park Camp Meeting Association be governed by the following:
 - 1. The association shall be amenable to the District Council, who shall make the rules governing the camp.
 - Membership in the association shall be open to any Christian who believes in and wishes to help promote the doctrine of entire sanctification.
 - 3. A membership fee of one dollar per year is to be paid during camp or prior thereto; said fees shall be used to promote camp interests.
 - 4. The Treasurer shall be charged with the responsibility of all camp funds.
 - 5. The Secretary shall provide all camp publicity and shall send proper advertisement to each pastor and to the membership of the association not less than thirty days prior to the camp, along with a request urging members to send in their dues at that time.

- 6. The Secretary shall act as Camp Registrar.
- 7. The Camp Meeting Board shall be composed of: District Superintendent as chairman; the following to be appointed by the District Council: Secretary, Treasurer, Purchasing Agent, Dining Hall Manager, Housing Manager, Electrician and Plumber, and Manager of Grounds and Buildings.
- 8. Be it resolved that each church board appoint a local camp association steward to promote camp interest. 1958
- 9. Be it resolved that the District Superintendent on his first call enlist each church to provide or underwrite a substantial amount of one or more of the following categories: produce, canned goods, meat and poultry. 1958
- II. Be it resolved that the portion of Pilgrim Park fronting Williams Avenue be for the building of cottages. The District Council shall determine a uniform lot size and shall provide a uniform lease contract, said contract to include these provisions:
 - A uniform building code of type and size of buildings, adequate wiring and necessary considerations for plumbing shall be observed.
 - Cottages shall not be occupied, except for camp and conference, without the permission of the District Council.
 - 3. Leases shall not be transferred to another party without approval of the District Council.
 - 4. If the lease contract be broken, the leasee shall forfeit all rights; and the lot, or lots, with existing improvements, shall revert to the Camp Meeting Association.
 - 5. In event the owner shall be absent from the camp, he shall notify the Camp Meeting Secretary and the cottage or cottages shall be utilized by the Housing Manager during camp and conference.
- III. Be it resolved that the District Council care for the landscaping and maintenance of Pilgrim Park and secure a caretaker on contract.
- IV. Be it resolved that the District Council shall schedule the annual camp and conference; be it further resolved that the camp start on a Thursday night providing that the Youth Camp is on a separate date. 1958
- V. Be it resolved that those other than ministers and their dependent families, delegates, and workers shall pay for their entertainment at conference the same as during camp.
- VI. Be it resolved that the Bible School Meeting be held at another time than Sunday afternoon.
- VII. Be it resolved that the District Council be empowered to negotiate a loan, if necessary, to finish the camp dormitory project.

- Sunday School -

- 1. Be it resolved that each Sunday School of the District count as present those who are attending the camp.
- We recommend that time during the camp be given to the District Sunday School Promotional Secretary to present the Sunday School work. 1954
- 3. Be it resolved that the District Sunday School Promotional Secretary shall arrange and superintend the camp Sunday

- School sessions; these sessions to start at 9:30, 1958
- 4. Be it resolved that each zone devote one zone meeting each year to Sunday School promotion. 1958
- 5. We recommend that the District Sunday School Promotional Secretary be invited to conduct the zone Sunday School Promotion meeting if possible. 1958
- 6. Be it resolved that each pastor send to the Promotional Sunday School Secretary on Monday, following the last Sunday of the month, a report of his Sunday School attendance with that of the same month of the preceding year. The Sunday School Promotional Secretary shall send a monthly report of the same to each pastor. 1956

- Zone -

- 1. Be it resolved that there be one Zone Chairman in each zone appointed by the District Council; he shall promote all zone interests. Be it further resolved that this appointment be made prior to the last Saturday of camp and that the District Youth Executive Secretary and District Sunday School Promotional Secretary be informed of the same. 1958
- We recommend that at least six zone meetings be conducted during the conference year under the direction of the Zone Chairman.

- Youth -

- Be it resolved there be a District Youth Board, composed of the District Superintendent, District Youth Executive Secretary and District Youth Secretary-Treasurer; the purpose of this Board is to promote District Youth work.
- 2. Whereas the young people have an important part in our District, therefore to promote youth activity, be it resolved that a District Youth Rally be held during the year; the District Youth Board shall have charge of arrangements.
- 3. Be it resolved that the District Youth Society project for the year be to provide suitable recreational facilities at the Pilgrim Park Camp Ground. Same to be decided upon by the District Youth Board and approved by the District Council. 1958
- 4. Be it resolved that a District Youth Camp be conducted at a suitable location. Be it further resolved that the date and place for the camp be set by the District Youth Board, with the approval of the District Council. 1958
- 5. Be it resolved that the annual Youth Conference be conducted on the first Saturday of camp meeting and that delegates be selected from each church. These delegates shall be the pastor, youth society president and one other young person from each church.

- Missionary -

- Whereas there is a need of promoting the work of our missionary societies on the district; Be it resolved that a District Missionary President and a Secretary Treasurer be elected. Two or more names shall be nominated for the offices by the District Council.
- Be it resolved that the Missionary Society be permitted to send pledge money to be applied upon shower stalls for the camp grounds. 1958

- Educational and Examining Boards -
- We recommend that all candidates who are to come before the Educational and Examining Boards shall do so before conference convenes, if possible.
- 2. Be it resolved that a library composed of books pertaining to required study courses be collected. Persons pursuing said courses shall be permitted to rent these books. The Library shall be housed and administered at the discretion of the District Council. 1959

WAYS AND MEANS COMMITTEE'S REPORT

- 1. Be it resolved that all stationed ministers on the district send their ministerial tithe to the District Treasurer for district expense.
- 2. Whereas the 10% of the Sunday School offerings has been more than enough to pay the General Conference expense: therefore be it resolved that the District Treasurer be instructed to pay the transportation of our representative to Central Pilgrim College board meeting, as well as the expenses of our District Superintendent to the Superintendent's Conference, out of the General Conference expense fund. Be it further resolved that we continue to collect 10% of the Sunday School offerings.
- 3. That 10% of the regular church offerings be sent to the District Treasurer for district expense.
- 4. That birthday offerings be used for district church extension.
- 5. Be it resolved that the District Superintendent and evangelists pay three-fourths of their ministerial tithe into the district budget and the district pay their 4% pension when desired.
- 6. Whereas the United Stewardship Fund is \$8.00 per voting member; Therefore be it resolved that the Church Treasurer be instructed to send that amount to the District Treasurer. The same to be raised at the discretion of the Pastor and local Church Board.
- 7. Be it resolved that we continue the call card plan of \$1.00 per call for District interests.
- 8. Be it resolved that the District Superintendent be paid \$250. per month plus \$70.00 per month traveling expense. Be it further resolved that he be allowed five revivals per year either on or off the district from which he may keep the offerings.
- 9. Be it resolved that the District Statistician be paid \$15.00 per year plus supplies.
- 10. Be it resolved that the supplies of the District Sunday School Promotional Secretary be paid from district funds.
- 11. Be it resolved that the District Treasurer be paid \$75.00 per year plus stationery and postage.
- 12. Be it resolved that the District Secretary be paid \$15.00 per year plus stationery and postage.
- 13. Whereas the Board of Directors of Central Pilgrim College have set a goal for each district in our school zone for the necessary financial support to carry on our school; Be it resolved that we as a district set our goal of giving for the year at \$5.00 per member.
- 14. Be it resolved that the travel expense of Council members when traveling for the district be paid from district funds at the rate of 5ϕ per mile.
