CONFERENCE PROCEEDINGS

The Twenty-seventh Annual Conference of the Pacific Northwest District of the Pilgrim Holiness Church convened at Pilgrim Park, Pilgrim Holiness Church, Salem, Oregon, August 1, 1966, at 9:45 a.m.

The conference opened with scripture quotation of the 1st Psalm by Rev. E. L. Larson.

Rev. H. G. Briggs, District Superintendent, called on Rev. Martin Swinney to lead in prayer.

Rev. John D. Abbott, General Superintendent, was introduced to the Conference by Rev. Briggs. Rev. Abbott read II Thessalonians 3:1 and spoke concerning the work of the church and the need of prayer for it.

The conference was called to order, and the roll call was read. Agreement was given by the conference to the seating of Vondell Delyria as the delegate from Aurora with pastoral appointment.

The conference bar was set to include the first five seats and the platform.

The Reception Committee presented Rev. Lowell Weller, a ministerial transfer from the California district, as an ordained minister. He was accepted by the conference with a vote of "aye".

Mrs. John Abbott and Mrs. Ruthanna Futrell were presented to the conference, received and granted honorary seats in the bar.

Rev. and Mrs. Calvin C. Dawes were presented to the conference as members of the Puyallup Church and as new pastors at Marysville; they were received and given honorary seats in the bar.

The hours of sessions were established as 9:45 to 12:00 noon and 1:30 to 5:00 p.m., or the conclusion of business, if no night session proved necessary.

The District Superintendent, Rev. Harley Briggs, read his report, which was received with sincere appreciation.

A motion was made to give Rev. Howard Pierce, pastor at Clatskanie, an honorary seat in the bar.

The Reception Committee presented Rev. Merrill Fox who has been in charge of the unorganized Corvallis work for the past year. He was given an honorary seat in the conference bar.

The Assistant Superintendent, Rev. Walter Cole, read his report which the conference accepted with a hearty vote.

The Auditing Committee report, read by Rev. Clarence Jackson, was accepted.

Rev. Donald Mack, District Treasurer, read his report, which was accepted with approval.

A motion was made and carried that copies of the Treasurer's report be given to the conference next year.

The Statistician, Rev. Verlie Arnett, read his report which the conference limited to totals, and was accepted as to be purified later by completion of blanks.

A discussion arose concerning the Pilgrim Holiness Church

and membership in the National Council of Churches, which membership was denied emphatically by the Chairman, Rev. Abbott.

The conference was adjourned with prayer by Robert Knotts.

Second Sitting

The second sitting opened at 1:45 p.m. by singing "My Faith Looks Up to Thee".

The minutes of the first session were read by the Secretary and approved by the conference.

The Reception Committee presented Rev. Dale DeField as a minister from the Idaho-Washington District and he was given an honorary seat in the bar.

The Sunday School District Promotional Secretary's report was read and accepted by the conference.

The District Missionary Society President's report was authorized to be accepted when it was received by the District Secretary. Mrs. Woodruff was called east by the illness and death of her brother.

The Chairman read the manual change of the International Conference deleting minister's reports from annual conference, after which a motion was made and carried that this action be omitted from the agenda.

The Reception Committee presented Rev. Bachellor, local minister from the Wesleyan Methodist Church, who was given an honorary seat in the conference bar.

The District Youth President, Rev. Doyle Brannon, read his report which was received by the conference.

A motion was made and carried that the Secretary be instructed to write Duane Cole a letter of thanks for the work done on the lunch stand.

The Memoirs Committee report was not given because of the illness of a committee member. A motion prevailed that the District Secretary receive the report when presented.

The report of the combined Educational and Examining Boards was read and received by the conference.

Rev. Clifford Hacker reported for the Resolutions Committee. Resolution #1 carried. #2 carried. #3 carried. #4 carried. #5 carried. #6 carried. #7 carried. #8 had a substitute motion made which was tabled. The second substitute motion, to delete zone resolution #1 carried.

The Chairman referred to the action of the International Conference to the creation of District Christian Education Council to coordinate District and Zone activities.

A motion for a ten minute recess was made and carried, after which the report of the Resolutions Committee continued. #9 had a substitute motion to delete #2 under Zone and retain #4 under Youth, which carried. In #9 the Chairman suggested that there was a conflict of authority in the motion as the youth conference has this power. A motion was substituted that the District Council and the District Youth Council review #s 1-9 of the Youth Adenda and have power to act in presenting recommendations to the Youth Conference when it next meets and to the following District Conference in order to coordinate

actions of the two conferences. The substitute motion carried.

The editing committee was instructed to leave the Youth Adenda in the Minutes until such action is taken.

#10 a substitute motion "Be it resolved that the missionary societies be urged to send pledge money to be applied on camp budget". Carried. #11 lost.

New Resolutions: #1 lost. Amended - carried. A second amendment added "immediately", carried. #2 carried. #2 was amended to read "if any report is not in by that time, the District Statistician is authorized to make a collect call to the pastor to remind him of his delinquency", amendment carried, motion carried. #3 carried. #4 carried. #5 carried.

A motion was made and carried that the time of reconvening be 6:30 p.m.

The report of the Ways and Means Committee was read by Rev. Arnett: #1 carried. #2 carried. #3 carried.

The session adjourned with prayer by Rev. Fox.

Third Sitting

The conference was reconvened by singing choruses. The Chairman asked for silent prayer.

The minutes of the second sitting were read and approved.

Rev. Arnett spoke in an effort to encourage each church to give its quota on the district budget. Many responded, pledging, by God's help, to pay their district budget this coming year.

Ways and Means resolution #4 carried.

The District Missionary Treasurer's report was read by Mrs. Briggs and was received by the conference.

The Camp Meeting Secretary's report was not ready and the District Secretary was instructed to receive and incorporate it into the minutes.

The Memoirs Committee report was read and approved.

The District Superintendent appointed the following tellers; Reverends Brannon, Weller, Hickam, and Hacker.

Rev. Harley Briggs was elected as the District Superintendent for a two year term.

Rev. Walter Cole was elected as Assistant District Superintendent.

DISTRICT SUPERINTENDENT'S REPORT

To our beloved chairman, General Superintendent John D. Abbott, delegates, and friends of the twenty-seventh annual conference of the Pacific Northwest District of the Pilgrim Holiness Church, greetings in the precious, matchless name of our risen Lord.

God has been good to us this year. Our church membership is up sixteen members over a year ago; our Sunday School is up an average of ten; our total giving is up nearly ten thousand dollars; per capita giving stands at \$245.83 per member for the year. District budget payments are up but still \$1,200.00 short. United stewardship fund contributions are up over \$400.00 above a year ago. The Pacific Northwest District stands seventh in the denomination with 87.5% of this budget paid. Our district is third in the denomination in percentage of Advocate subscriptions per membership. For these blessings and more we give Him the glory.

It has been a pleasure to work with our Assistant Superintendent, Rev. Walter Cole, for the past year. He has given invaluable assistance, helpful advice, as well as capable supervision of district affairs during two extended absences of the District Superintendent.

The District Council has been most cooperative especially in those areas directed to extending our Pilgrim witness in this great Northwest of ours. With their help 14,000 booklets have been purchased and distributed, or are available for distribution. Every pastor should plan if he or she has not already planned for a concentrated forward thrust in the area of personal evangelism and Sunday School enlargement beginning with the start of school in September. Our time is short, we must press now.

It was with the help of the Council that we were able to launch the "Dollar a Month" Club early this year. We pray with God's blessing and our consistent effort to be able to start new churches as the doors open. The Pacific Northwest is wide open now to evangelism. The population movement of the United States is northwest. We must do our utmost by God's grace to meet the challenge.

On April 4, 5, and 6 we enjoyed God's marked blessing on our joint ministerial meeting with the Oregon conference

ministers of the Wesleyan Methodist Church. These services were favored with God's presence from the beginning to the final "Amen".

With the cooperation and help of the Department of World Missions, we were able to conduct a series of zone and local missionary conventions. Reverends M. L. Peterson and Jack Duckworth accorded us a fine ministry with special insight into the operations of the various mission fields of the Church. The District Council has already approved the setting up of more conventions of this type for the coming year.

I must here confess that it has been the cooperation of a fine group of pastors that has made this a successful year in our Zion. We commend the laity for the fine help they have given. Without the support of all we can make little progress either temporally or spiritually. Someone has observed that there is no "I" in "team".

Let us not look back for the simple purpose of writing history; this is not our business. Our work is ahead of us. Let us use the past to plan for the future, and plan we must. God's whole universe, past, present, and future is operating according to a plan. We must fit our plan into His plan and "press toward the mark". To quote another "God's work done in God's way will never lack His support". Brethren, tomorrow lies ahead of us; let us vigorously occupy until He comes. Let us, as Isaiah says "take root downward and bear fruit upward". Isa. 37:31.

Personal Report

Sermons preached - 73; prayer meetings - 6; other addresses - 1; calls on churches - 50; with numerous other calls on pastors; council meetings - 5; church board meetings - 16; annual meetings - 14; I attended the school board meeting in Bartlesville; the Church Leaders Conference in Indianapolis; visited three of our bible schools, and attended the International Conference of the Church; miles travelled in district interests - 31,596. My salary has been paid in full.

The accomplishments of the churches of the district have been purposely omitted from this report. This will be given by the pastors in their personal reports.
