MINUTES OF THE THIRD ANNUAL ASSEMBLY OF THE  
PENNSYLVANIA AND NEW JERSEY DISTRICT OF THE  
INTERNATIONAL HOLINESS CHURCH.

The Members of the Third Annual Assembly of the International Holiness Church convened at the hour of 9.30 A. M. on March 14th, 1922 in their Meeting House of Glassboro, N. J.

The Session was called to order by the District Supt. J. L. Sutton. A Scripture Lesson was read with timely and inspiring remarks, which was followed by a united season of prayer characterized by fervency, faith and liberty. Then the song, "I Feel the Fire of Pentecost," was sung.

Determination of the Conference bar was fixed at the first seven seats.

The Registration of Preachers and Delegates took place.

As one of the delegates was suffering in body, a Divine Healing service was called at this time by the Supt. and God marvellously met with us and answered prayer.

Rev. Wm. Heslop Pastor of the Milton Church, and Chas. Cassler from same were introduced to the Assembly by the Supt. and granted an honorary Seat in the Conference Bar.

Reading and Approval of the last session's minutes of the 1921 Assembly.

A direction of the Supt. to the Delegates and Preachers was given to the effect that they report their carfare to the R. R. secretary W. J. Crider at once, in order to effect the equalization of their carfares.

The Secretary reported for the 1921 Minute Committee, showing a publication of 300 copies at the cost of \$60.00, with about 75 copies on hand.

Bro. Paul D. Ford reported for the State Charter Committee showing the incorporation of an amendment covering the desired changes, in the name of the Church, from "Apostolic" to "International Holiness"; in fixing the business center of the Church at Sunbury; in changing the number of trustees from five to seven; and in granting our churches the privilege of acquiring and controlling local cemeteries or burial grounds. The cost of the same to the State amounted to \$10.15.

After discussion and remarks the report was accepted and the Committee dismissed with a vote of thanks.

A motion was made and carried that the Chair appoint the necessary committees for the Assembly at this time.

Resolution Committee Appointed was Bros. Clough, King and Straub.

Auditing Committee appointed was Bros. McIntyre, Ford and Hankins.

A motion was made to the effect that we have the Minutes of this Assembly printed, with the understanding that they shall be gotten out within thirty days after the Assembly closes if possible. Seconded and Carried.

Appointees on Minute Committee, Bros. Saneholtz, McIntyre and King.

The time for the sessions of the Assembly was fixed at 9:00 and 11:30 A. M. and from 2:00 to 4:00 P. M.

#### TUESDAY AFTERNOON SESSION, MARCH 14, 1922.

The Session was called to order by the District Supt. and opened by singing "Down at the Cross." Scripture Lesson was read by the Supt. from Eph. Ch. 1, with remarks upon the same; followed by a united season of earnest prayer.

Reading and approval of the last session's minutes.

The Resolution Committee reported. Resolutions Nos. 1, 2 and 3 were read and accepted.

The hour for the election of officers were fixed for Thurs. at 9:00 A. M.

But with it all God's blessing followed their labors of faith and love at each of the places of service. As befitting their summer's experience on the field, they then sang "Living for Jesus" which touched a responsive chord in every heart.

Bro. Dubendorf gave the official report of the year's work.

This was followed by a motion to lift a free-will offering from the Assembly floor, which was accordingly done, with results to the amount of \$22.48.

As the reports of the preachers and delegates reporting yesterday, were not accepted during that session, a motion was accordingly made that they be accepted now. Carried.

By motion the reports of Bro. King and delegates of Glassboro and Clayton Churches were accepted.

Bro. Geo. A. Andrews reported and same was accepted.

Bro. Lishman for the year's evangelistic services for himself and wife, with results attesting the validity of their call to the field.

Sr. Lishman reported as deaconness, and both reports were accepted.

#### WEDNESDAY P. M. SESSION, MARCH 15, 1922.

Song Service for the opening followed by united prayer.

Scripture lesson and exhortation by Superintendent.

Reading and approval of last session's minutes.

Moved to postpone the orders of the day, relative to the reports of the Beulah Park Bible School and Finance Committee to Thursday at 2:00 P. M. Carried.

The Auditing Committee's report of the District Supt's. books relative to monies sent to the General Fund was heard and accepted, as follows:-

Total Receipts \$152.57; Total Expenditures \$135.72;  
Balance on Hand \$16.85.

A motion was made to the effect that the railroad fares of the ministers and delegates be equalized to and from the Assembly to the place of their residence, and that is to be kept separate. Seconded and lost by vote.

A second motion followed to the effect that the fare of the preachers and delegates, each being kept separate, shall be equalized to and from the Assembly to their place of residence: while the evangelists shall have their fare prorated from their last place of service to their next point of service following the Assembly, providing it be within the district. Carried.

Sr. Ferguson's verbal report was heard and accepted.

Bro. Gardner reported as pastor of Howard Circuit.

Bro. Earnest Gardner, Delegate from Howard and Summit Hill Churches.

Bro. Goss, Church delegate from Ashland.

Sr. Beulah Faughner, S. S. delegate from Ashland. Also for the Young People's Missionary Society at Ashland. Reports accepted.

Bro. Harris Bechdel, Church and S. S. delegate from Beech Creek.

Sr. Behrent, reported a year's work of blessed victory, witnessing some old-time meetings of revival power, in which God gave a goodly number of souls for her hire. Accepted by motion.

Bro. J. E. Wolfe's report as Home Mission Worker and Colporteur was heard and heartily accepted.

Sr. Blanche Ford reported and accepted.

The action of the District Council relative to granting the local churches the privilege of deeding their properties to the local trustees, to be held for the local congregations of the I. H. Church, was then taken up, and discussed generally. The recommendation was then adopted.

The hour for adjournment had already passed, but the above action was ratified by a legal session on Friday, P. M.

By request Bro. Slater sang, "Give Me Jesus." Uplifting and inspiring as the song ever is when heard from our brother's lips, it was yet to be climaxed, by his subsequent narration of the victorious entrance of our beloved Bro. Rose of McKeesport, into his final rest. Dying not unto himself alone, but the communication of his faith became effectual to the inspiration of the entire Assembly, and filled with joy the wells of Salvation in many a heart.

The time of adjournment was extended to 11:50 A. M.

Advisory Board elect was Bros. D. A. King, Wm. E. Straub and S. J. McIntyre.

Trustee elect was Wm. Gallagher for 7 years.

Bro. Andrews made a statement to the Assembly, relative to his properly taking a stand against worldly conformity, which clearly vindicated him before the Assembly. Following this there was a discussion of the relation between Salvation, Church Membership and getting rid of all worldliness and useless adornments.

THURSDAY P. M. SESSION, MARCH 16, 1922.

This Session was opened by Singing, "When the Battle's Over." Followed by a Scripture lesson with remarks by the Supt. from 1st Thess. 5th Chapter. Prayer was then engaged in, followed by the song, "I Love Him."

Reading and approval of last session's minutes.

Roll Call, which showed a continuation of the splendid attendance, which had characterized the Assembly thus far.

Bro. Slater gave a verbal report as pastor of the McKeesport Church showing a gracious work of revival power during the year.

First ballot for member on examining board showed no election.

Upon request, Bro. Slater sang with all his old-time vigor and spirit, "Get a Transfer."

At this juncture Rev. Leo. M. Johnson from Paoli, Pa. was introduced to the Assembly, and given a seat within the Assembly bar.

Bro. Saneholtz was elected for three years on the Examining Board.

It was moved, seconded and carried that we elect a Home Missionary Board of five members, who shall represent the entire District for the ensuing year.

Followed by a motion to have the two members of the Advisory members of the District Council, excepting Bro. Straub who is one of the evangelists, to serve on this board. Carried.

The first ballot for the board showed no election.

As Bro. Heslop, returned missionary from Japan and Korea and a regularly ordained preacher in the I. H. Church, was present with us and considered a proper candidate for service on the Home Mission board, he was accepted by vote of the Assembly, thus legalizing his right to become an officer in this district.

The second ballot showed the election of Bros. Ford and Heslop.

The third ballot resulted in the election of Bro. Clough. Thus the Home Board consists of Bros. King, McIntyre, Ford, Heslop and Clough.

Bro. Slater, next reported for the Committee, appointed last year on a "Children's Dedication" blank, showing a publication of a 1000 copies, of a very beautiful and pleasing design, at a total cost of \$126.65. The report was accepted and the Committee dismissed with a vote of thanks: followed by a motion that the District Secretary issue an order on the District Treasurer for that amount (\$126.65) in favor of Bro. Slater, and that we sell the blanks to our preachers and workers, at the rate of 15 cents a piece, which will cover the cost and postage, with the exception of Bro. Slater's order of 300 copies, which shall be given at actual cost, excluding the postage cost, in view of his services on the Committee. Carried.

By motion the secretary was instructed to cast a unanimous ballot for the present Foreign Missionary Board, with the exception of Bro. Slater, who expects to leave this district.

A ballot followed for the other member, and resulted in the choice of Bro. Heslop. The board as then elected comprises the following:- Bros. Heslop and Rose, and Sisters Davis, Hatcher and Ferguson.

Bro. C. L. Slater rendered his report as District Treasurer, which showed the treasury in the best condition it has been for the last five years, with all old notes and hang-over indebtedness paid off.

As Bro. Slater had fulfilled every duty of his office so acceptably and willingly for the past two years, the Assembly felt constrained to express their heart-felt thanks by a rising vote of grateful appreciation.

By motion the Secretary was also given a vote of thanks from the Assembly floor, for his services.

By vote the Secretary was instructed to cast a unanimous ballot, in favor of Straub and Dubendorf, as our District evangelists for the ensuing year.

In view of their faithful services in opening up new work on the field in the past; as well as their assistance to their Churches already established, it was moved, seconded and carried that we recommend our other field workers, namely Bro. and Sister Lishman, Sr. Adlene Behrent and Bro. J. E. Wolfe, Home Mission Worker and Colporteur, to the consideration of the Home Mission Board.

The hour of the session was extended by motion to 5 P. M.

In this session it was moved and carried to hear the Reports of the Beulah Park Bible School Board and Finance Committee Friday Morning.

As this morning had been set for the hearing of the reports of the Summer Bible School and Finance Committee, a season of prayer was entered into for the blessing of God to rest upon the same.

At the request of the Secretary Bro. McIntyre reported a blessed season of victory, along all lines at the Summer School. Seven children were enrolled. Several scholars were sanctified in the school, and both teachers and scholars felt well repaid for the time so pleasantly spent at Beulah Park.

The receipts all told were \$304.77, with expenditures of \$291.21, leaving a balance of \$13.56, which was turned over to the B. P. Finance Committee Treasurer.

Bro. Gardner reported the condition of Beulah Park, when the Finance Committee took over the raising of the indebtedness, and the erection of the School Building, July 8, 1921, showing an obligation of \$34676.82.

Bro. M. L. Dries of Reading, next reported as Chairman of the legal status of the Grounds, showing the cancellation of three old mortgages of \$1500.00 each, by a loan of \$4500.00, thus securing us the gift of \$5000.00 worth of stock from T. L. Wieand; also the sale of the \$8350.00, the balance of the bond issue.

Bro. Baker reported in the matter of adjusting the streets with the Allentown City Council, with very beneficial concessions to the Church.

By motion the time limit was extended to 12:00 A. M.

Bro. Gardner, then rendered his report as Secretary-Treasurer of the Committee, showing a total receipt of \$13681.29, in payments on pledges, gifts and loans, and an expenditure of \$13530.75, for School building, labor, old mortgages (\$4500.00) and interests to date.

Bro. Marvin as contractor, reported on the constructive status of the buidng, showing the same now up and enclosed, with the rooms partitioned down stairs, and the floors all laid, but about 2500 feet. The estimated cost of completing the building, including basement concrete floor, plastering of walls and stuccoing the outside was figured at \$4000.00.

Reports accepted and to be placed on the minutes.

By motion the time was extended to 12:30 P. M.

A resolution was read to give our sanction to the call for a special session of the General Assembly, in the near future, and that the Secretary write to Rev. Emerson Smith, to support the call as issued. Adopted.



The motion of Wednesday, P. M. relative to the deeding of Church property was ratified.

Adjournment with prayer by the Secretary.

Bro. Crider, as R. R. secretary reported, showing the average of the preachers' fare to be \$5.06, and the delegates fare 9.64.

Bro. Cox spoke to the Assembly, recommending very highly, Wm. Smith's book on Prophecy, receiving a number of orders for the same. Bro. Slater received some subscriptions for the Church Paper, the I. H. Advocate.

Report of Bro. Gorman read and accepted by motion.

Bro. Dubendorf reported for Zerby. Accepted.

Reports read by the Secretary: Lawrence Neff, Edna M. Carr, James M. Parkins, W. B. Neff, W. R. Fitch, Mrs. W. R. Fitch, L. J. Park, Harry Sension, J. P. Miller, R. W. Ives and Wife, Emma M. Garman, and the Delaware Run Church report. All reports were accepted.

Motion was made to proceed with the election of the required number of delegates to the General Assembly.

As no election resulted from the first ballot, and Bro. Gallagher withdrew in favor of Thos. Ferguson, a second ballot was cast for a choice of two out of the three remaining highest names of Bros. Dries, Wagner and Ferguson, resulting in the election of Bros. Dries and Ferguson.

The election of the Ministerial Delegates resulted in the choice of Bros. Crider, Clough, King, Straub, Ford, Heslop and McIntyre.

A motion was made, seconded and carried that the Secretary cast a ballot in favor of the present Beulah Park Finance Committee to continue in office during the coming Assembly year, with the exception of Bro. Rose, whose place shall be filled by Bro. S. J. McIntyre.

Discussions of Bible School matters followed. By motion time was extended to 5:00 P. M.

A motion was made and carried, that we proceed to raise pledges from the churches to the amount of \$600.00 for the support of the Home Mission work, and that our preachers be asked to support the District work, by contributing at least 20% of their tithe.

Solicitations for Home Mission Funds.

By motion we pay the excess funds in the hands of the R. R. Secretary, into the Home Mission funds.

Resolution No. 10 read and accepted. Resolution of thanks to the entertaining church was read and accepted by a rising vote.

We, the examining board have examined and do report to the Assembly, Miss Blanche Ford for license to preach: Walter F. Hubb, Harry Handwerk, and Alton Marvin for local preacher's license, and Mrs. J. F. Hilbert for Deaconesses license. Report was accepted and the licenses granted.

Motion was made to have our next Assembly at Beulah Park, at the same time, the opening session at 9:00 A. M. on the second Tuesday in March, and continuing over the following Sunday. Carried.

Motion to have 300 copies of the minutes printed. Carried.

Motion was made to ratify the action of the Dist. Council, in the consolidating the former Bethel Herald with the General Church Paper. Carried.

Motion was made and carried that Bro. King be permitted to use the name of "Bethel Herald" if he so desires.

Motion was made to express ourselves that we stand unanimously in favor of our General Church Paper. Carried.

Report of the Trustee Board elect read and accepted as follows:-

Foreign Missionary Board elect reported, which was accepted and made a part of the minutes, as follows:-

The Foreign Missionary Board elect met and elected the following officers for the ensuing year. Chairman, Rev. Wm. Heslop, and Rev. Bessie L. Hatcher, Sec'y.-Treas.

It was decided at the meeting of the Board, that we adopt a plan, whereby we may show a greater co-operation, and to stimulate fellowship with our workers on the field.

It therefore was agreed upon to send a box every quarter to one of our three mission fields, the contents of which shall be contributed by our local churches. The Board making themselves responsible, for the transportation of the same to the field.

This is not obligatoy, but a free will offering.

We, as a Board plan to have meetings during the year, especially for prayer and fasting, among our churches to stimulate greater missionary zeal.

tions incurred in the above are the obligations of the International Holiness Church of the District of Pennsylvania and New Jersey. Carried.

It was moved, seconded and carried that we extend to our Financial Committee the privilege of disposing of lots, using their judgment to the best advantage for the improvement or betterment of the financial situation of Beulah Park Camp Grounds. This report was ratified by the Assembly unanimously.

The Auditing Committee reports on the Trustee Board Treasurer's itemized report and is accepted as follows:-

On hand Mach 1, 1921, \$3.47. Receipts during year \$29.00, making a total of \$32.47, March 1st, 1922.

By motion the Foreign Missionary Treasurer's report was accepted, on conditions, that it be audited by the proper officials.

It was moved and carried to present the following resolutions to the special called session of the General Assembly:-

*Resolved*, that we have three General Superintendents, one of whom shall have charge of the Foreign and Home Missionary work.

*Resolved*, that the Missionary Board shall be elected by the General Assembly.

*Resolved*, that each district should elect a missionary board, to work in conjunction with the General Board.

*Resolved*, that business may be brought directly to the General Assembly without passing through the General Council.

*Resolved*, that the property of the local congregations shall be deeded to the trustees of the local congregations and their successors in trust for said congregation, which shall be in harmony with the congregational form of government.

*Resolved*, that we are opposed to the budget system as outlined in the I. H. Advocate for the handing of our finances.

Sister Zimmerman, Sr. Davis and Sr. Carrie Young reported. All were accepted.

Miscellaneous remarks, reports and advices.

Motion was made and carried to extend an invitation to our General Superintendent, or his assistants to attend our District Assemblies.

Motion followed to make a free-will offering in favor of the District Secretary for his services. Carried. Offering amounted to \$10.58.

Closing Charge and Admonition by the District Supt.

By motion we adjourned sine die.
