REPORT OF DISTRICT SUPERINTENDENT

Greetings to the Thirty-Third Annual Conference of the Pilgrim Holiness Church of the West Virginia District!

We have come to the close of another Conference year and we are looking for that Blessed Hope, and the Glorious appearing of the Great God and Saviour Jesus Christ. Let us therefore fear, lest a promise being left us of entering into His rest, any of you should seem to come short of it.

First of all, I wish to thank the District Council and all the preachers and churches for your spirit of co-operation. Truly it has been a year of wonderful harmony and unity among our preachers. We have enjoyed the fellowship and fraternal sympathy of all. God has seen fit to bless our humble efforts in the District this year as we have labored together for the advancement of His Kingdom. The Lord has been pleased to give some of our Churches gracious revivals. A number of our preachers have painted and re-decorated their church.

We have erected three parsonages on the District this year—one on the Camp Ground for the District Superintendent. Williamson has built a nice six-room parsonage in the back of their Church. Nine Mile is building a five-room cinder-block and hope to have it ready for the pastor to move into by September 1st. We have built two new Churches. They are being run now as missions but have good prospects of being organized into Churches in the future. Three Churches have been organized—Ravenswood with 13 members; Terra Alta with 9 members, and Van with 23 members.

I have made quarterly visits to each Church and some more where adjustments were needed, held annual business meetings in each Church. I held a revival at O'Toole and a week's meeting at Ravenswood, attended three

Y. P. S. Zone meetings, worked 20 days on District parsonage. I preached 141 times, had 56 seekers, baptized 4, conducted one funeral, traveled 18,690 miles, received for expense \$571.09 and on salary \$1,460.64 at the time of the writing of this report.

REPORT OF CAMP MEETING GROUNDS COMMITTEE

To the Thirty-third Conference West Virginia District Pilgrim Holiness Church, Greetings in the name of our Lord and Saviour Jesus Christ.

Your District Council in meeting August 28, 1941, asked our Superintendent Rev. Musser to appoint a Camp Ground Committee with himself as chairman. He appointed J. H. Cottrill with Rev. J. F. Woods as honorary member and E. W. Miller as secretary. Further, in accordance with your Ways and Means Resolution No. 7, they appointed Rev. Musser as representative to look after this work on his first quarterly visit to the churches, therefore we submit to you the following report:

1st. After the District Trustees had exhausted their resources in trying to borrow the \$5,281.35 you ordered them to borrow, without success, your District Superintendent negotiated a loan of \$3,000.00 from the Barboursville State Bank by the endorsement of D. B. Nelson of the Nelson Lumber Company under date of Oct. 27, note secured by a lien against the camp property and to be curtailed \$300 every four months with 6% interest per annum.

2nd. We took the \$3,000 borrowed and paid off the \$3,281.35 indebtedness you ordered paid, by giving the Miller Paint Mfg. Co. a note for the amount owing them, including the accounts they had stood good for being Emmons-Hawkins Hardware Co. and the Beswick Lumber Co., which totaled \$675.33, this note to be curtailed at the rate of \$50.00 and interest at 6% every 60 days; then we immediately proceeded with the work on Log House for district parsonage and pursued this until finished as per specifications, at a cost of around \$2,700.00 completed. We also purchased an electric deep well pump, installed it and built a house over it with 6-inch side walls stuffed with saw dust to keep out the frost. We further laid gas and water lines to the log house and water to the dining room where we installed a hot water tank, kitchen sink, etc., thus equipping our kitchen with hot and cold water.

3rd. Rev. Musser, as your representative to collect in the old pledges secured by Brother Woods previously and to raise money for the camp ground expenses, handled this on his first quarterly visit to the churches, collecting \$1,031.25, thus saving the expense of sending out a special representative. This money enabled us to proceed with the work in hand uninterrupted.

4th. Due to our failure to borrow the full amount of money requested we did not build the women's dormitory, as we felt it would please you not to add this extra burden in as much as our present facilities were adequate to take care of the camp this year. However, we recommend that the District Council appoint another Camp Meeting Committee, or retain the present one, to raise funds for, and erect the women's dormitory, finish the present buildings, build a reservoir or dig another well for adequate water supply, and any other necessary work the Committee may judge advisable and necessary, just as soon as materials can be obtained at a reasonable cost.

While the present indebtedness stands at \$4,025.36 as of August 22nd, we have pledges taken at the Camp of \$1,000.00 due by October 15th, from which amount and the balance on hand, we expect to pay the Nelson Lumber Co. open account and the two past due payments on note due at the Bank, thus reducing this indebtedness to \$2,925.00 and this covered by notes running over the next two years, which we should be able to take care of along with the further improvements necessary.
